

**RESOLUTION
TO RECOGNIZE THE ROCK 'N' ROLL LAS VEGAS MARATHON
AND HALF MARATHON
AS AN ANNUAL EVENT BENEFICIAL TO CLARK COUNTY, NEVADA**

WHEREAS, the Rock 'n' Roll Las Vegas Marathon and Half Marathon is an exciting event showcasing the properties on The Strip and other local attractions; appealing to both the local community and visitors from throughout the United States and around the world; and

WHEREAS, based on similar-sized events in American cities, the Rock 'n' Roll Las Vegas Marathon and Half Marathon has positively impacted the local economy; and

WHEREAS, the twenty-second annual Rock 'n' Roll Las Vegas Marathon and Half Marathon will take place the morning of February 27, 2022, offering ideal weather for runners; and

WHEREAS, Ironman, Inc., owner and operator of the Rock 'n' Roll Las Vegas Marathon and Half Marathon, developed an extraordinary marathon, half marathon, and other related athletic events for the Las Vegas area in 2009 that brought in a minimum of 28,000 runners; and

WHEREAS, Ironman, Inc., wishes to start the course of each future Rock 'n' Roll Las Vegas Marathon and Half Marathon on Las Vegas Boulevard and maintain a relatively flat, loop course designed to showcase portions of Clark County and the City of Las Vegas; and

WHEREAS, Clark County owns right-of-way on a portion of the desired course for the Rock 'n' Roll Las Vegas Marathon and Half Marathon, and is willing to help identify roadways in which the Rock 'n' Roll Las Vegas Marathon and Half Marathon could take place subject to conditions set forth herein.

NOW, THEREFORE, WE, the Board of County Commissioners, do hereby resolve as follows:

- A. To recognize the Rock 'n' Roll Las Vegas Marathon and Half Marathon as an annual event beneficial to Clark County; and
- B. To work with Ironman, Inc. to identify roadways to which the Rock 'n' Roll Las Vegas Marathon and Half Marathon can take place; and
- C. That pursuant to Section 16.06.150 of the Clark County Code, good cause exists and no unreasonable burden upon the County or its citizens exist and, therefore, waives the 120-day time limitation on filing applications for a Special Event for the Rock 'n' Roll Las Vegas Marathon and Half Marathon on the last Sunday in February in the years 2022 through 2032.

- D. To grant a waiver of Section 16.06.060 of the Clark County Code for portions of the marathon route approved by Clark County which occur on Las Vegas Boulevard South so long as the Rock 'n' Roll Las Vegas Marathon and Half Marathon event takes place on the last Sunday in February in the years 2022 through 2032.

FURTHERMORE, WE, the Board of County Commissioners, do hereby provide that the waivers granted herein are subject to the condition that Clark County's portion of the desired Rock 'n' Roll Las Vegas Marathon and Half Marathon course located in Clark County may not be available for use by the Rock 'n' Roll Las Vegas Marathon and Half Marathon due to interests which, in the sole determination of the Board of County Commissioners, impact the public health, welfare, or safety issues, including; but not limited to, damages, reconstruction and/or repair of the roadway, utility work or any other work in which case Ironman, Inc. must submit an alternative route acceptable to Clark County.

This Resolution is not intended to waive any other requirements of the Clark County Code nor any other standards, conditions, permit requirements, laws, ordinances, and regulations.
