The project will take a few weeks to complete with minimal outages.

9. Receive a report from Kyle Myers regarding current road conditions and Public Works concerns. (For discussion only)

Kyle Myers provided the following report from Public Works.

"Cottonwood Cove Trail / sidewalks is at 35% design. We modified the design to include sidewalks on both sides of the street. The south side of the streets has some drainage issues and utility conflicts that will need to be addressed. This has doubled the original cost estimates that was budgeted for and we are identifying next steps to increase funding for the project.

We are in the process of ordering the poles to install ten streetlights. Once the materials are procured, we will work on the next steps for installation.

The Searchlight – West drainage project is in early phase design."

Kyle Myers said the maintenance division informed him that Public Works will have four major projects this year at Cottonwood Cove and said all are funded and ready to go. Before Labor Day the sewage force main will be replaced in the developed areas and re-drilling one of the water wells and replacing the water line to the storage tanks.

After Labor Day; the roads rehabilitation project. Federal Highways will be working on the road from the entrance station to the water, including the section traversing BLM land

between the entrance station and park boundary. As a part of this, the two sharp curves near Black Mountain will be re-aligned. Construction of the flood diversion structure in the wash west of the developed area.

Concessions division said the projects to issue a lease for the concessionaire facilities at Cottonwood Cove has been approved by NPS (National Park Service) headquarters and should be moving forward. As of now the Protection Division at Cottonwood Cove has a full staff with two additional seasonal rangers this summer.

Gas Line: Public comment period is open until March 24th on the Southwest Gas Corporation's project proposal to install 69.5 miles of natural gas pipeline with-in an existing permanent right-of-way.

Michelle Brown provided the following report regarding the Searchlight Mountain Flag Box:

"After speaking with Chris Wardlaw (Clark County Senior financial Analyst) I was given direction on how to proceed with RPM (Real Property Management) and contacted Robert Tomiyasu. I provided all state and federal verification for the Searchlight Betterment Organization and a contract will be drafted by RPM and the DA for the SBO to sign. The contract will be for maintenance and permission to be on the property. The next step is the allocation for funds from Fund 422 to purchase the mural and lighting.

The SBO is purchasing T-Shirts with the SBO logo and will be available for purchase at the Searchlight Treasures Thrift Store or any board member. The cost is \$20 per shirt and comes in Black or gray. All proceeds go to the funding of future projects."

The SBO will facilitate a town clean-up soon starting with the lot north of the horseshoe pits. There will be a trash collection clean-up on the lot west of the Thrift Store. Any parties who would like to volunteer please contact the SBO for more details.

Extreme Tours, a non-denominational Christian group has offered a free Concert in the Park this June. A group of 25 people will arrive on a Monday evening and do a street outreach on Tuesday and have the concert on Wednesday evening and possibly a skate competition at the skate park. Jim Stanger said the Friends of Walking Box Ranch is back on site. The Friends of Walking Box Ranch is a 501C3 non-profit who partners with BLM and helps steward the Walking Box Ranch. The goal is to help BLM to fix up the site and put together some programs to open up to the public.

The public open is to be determined due to COVID but hoping in a few months. It's anticipated to be open on weekends to start. Next week they are hosting a Backyard Astronomy Evening and have flyers to pass out to the community on the back table.

Volunteers will be needed when the ranch opens, which includes grounds keeping and cleaning of the house.

2. Discuss the request from Searchlight Betterment Organization regarding allocation of \$6,555 from fund 4370.422 for the Flag Box Project Proposal (Solar LED Lighting & Heavy Duty Canvas Murals) on parcel 243-35-310-083 and take appropriate action. (For possible action.)

Kyle Myers open to the public for comments. The flag box model was requested to be seen again and Michele Brown provided the model and explained the mural and lights.

Ms. Brown stated that once approved it will take about two weeks to complete.

Patricia Mayne said this will be a canvass mural and guarantee to last 10 years or replaced.

Kyle Myers and Patricia Mayne both disclosed they are members of the SBO but will not be abstaining from the vote.

Kyle Myers motioned to approve using Searchlight fund 422 and allocate \$6,555 to the Flag Box Project. Upon a voice vote motioned approve 3-0. Applause from the audience.

VIII. Public Comment:

Kim Means, Searchlight resident. She said she owns Mystery Ranch on Grandpas Road where she invites artist from all around the world. Ms. Means said she would like to invite some of the organizations in town, to include the SBO, the Library, and Walking Box Ranch to come and see what they are doing. She said she is also available if an artist is needed and to collaborate for workshops.

Ms. Means said she is one of the people who been talking with the organizers of Avi Kwa Ame National Monument and said that was a very important proposal to look at. She said she found out there is another wind farm project that has been proposed for Crescent Peak. If anyone is interested in the research she has done you can contact her to help you with the information she has.

Judy Bundorf, Grandpas Road. She stated Aeolus Wind Company has filed with BLM for plans of development. If anyone would like copies, email Judy Bundorf for more information. The area will be 14 square miles with 68 turbines with 50 miles of new roads throughout the mountain area if approved. This would be about three miles from Walking Box Ranch and your view to the west will be flashing red lights with turbines reaching 800 feet tall. The company would like to have the entire system up and running by 2024.

Ms. Bundorf updated regarding the burglary ring from two years ago, the suspect will be going to trial in June.
