Officer Levitt said there is a lot that needs to be done at the park and trailers are not legally registered and it's tough to track down the owner. But if there is a problem, he said by all means call us. If the person who made the call is located, that person can sign the complaint and a citation can be written. Ms. Mayne inquired about unlicensed cars. Officer Levitt said if the car is on private property there is nothing they will do.

Searchlight's usage for March 2021 was 3.3 million gallons.
Searchlight used 600,000 gallons less in March 2021 than in March 2020.

Update:

Update from last month, they are replacing the pipes on Orlando Street and Desert Sage. Mr. Jackson said these are older mains and had some breaks and are under sized. A fire hydrant will also be installed on the corner. The project started Tuesday and some prep work was done to insure customers have water on those streets. Tomorrow there will be a short shut down for customers on the two blocks. The project could take up to eight weeks.

Patricia Mayne inquired about the number of fire hydrants that are in Searchlight. Mr. Jackson said approximately fifty.

Kyle Myers inquired about how it's determined where the fire hydrants go. Mr. Jackson said there is a planning division and they are the ones who deal with the ISO (Insurance service office) surveys and determine where the fire hydrants would go.

Kyle Myers inquired about the capacity levels, Ms. Talamo said each County starting May 1st will decide if the six foot social distancing can be removed or if not by June 1st. Keeping to the social distancing she said they had to close off every other row.

Mr. Myers asked if Silver Rider would provide maintenance for the bus shelter in Searchlight. Ms. Talamo said there is a service worker who goes to all the stops in Laughlin and the bus shelters would be cleaned periodically. She said Silver Rider can use the shelter as the Vegas Express and every day someone can see what needs to be done. Trash would be an issue since there is nowhere to put the trash. Kyle Myers said the back board has been damaged and if this was something that could be repaired. Ms. Talamo said she will find out who would be do the repairs.

Maria Jensen introduced herself and said their goal is to help low income families weatherize their homes and save money for other needs. Ms. Jensen explained the process when an application is sent in. If approved a letter will be sent and an assessor will call to set up an appointment. Besides house's, mobile homes and renters are also eligible. Swag bags are available in the back with applications.

9. Receive a report from Kelli Carlson with Searchlight Library regarding current and upcoming programs. (For discussion only)

Kelli Carlson provided the March report.

- The library is currently open for all library services, and will continue to have curbside services for patrons who request it. Masks or other appropriate face coverings is required for entry into the library and social distancing is practiced. The library is operating at 50% capacity.
- Wi-Fi is available 24 hours a day in the parking lot.

Children's activities:

- Snacks are being provided by Three Square and are being distributed after school at the gate and not in the library.
- Take and Make, which is a Craft along with the snack, will be given out for additional at-home enrichment. Approximately 15-18 crafts are distributed daily.
- With the easing of restrictions the Library will resume the Thursday after school programs beginning the first week of May. A paint class with Ali is being planned for grades 3+.
- The library district has booked summer performers. In Searchlight Magician Adam Landon will be here July 8th at 2:00 pm. Fratello Marionettes and other performers including Jim Gill will be at various urban branches.

Kelli Carlson said the Safe Place signage has increased and the Library is considered a safe place. The Safe Place Program is for children ages 12-18 who are at risk for whatever reasons.

13. Receive a report and updates from Alan O'Neil, advisor to the National Parks Conservation Association to discuss the proposed Avi Kwa Monument. (For discussion only)

Kim Means started the presentation. She is here to speak about the National Monument and explain why this is of great concern to the Searchlight community. She said she has a number of people here tonight to help provide the information.

Judy Bundorf provided the history of the wind projects and explained why the national monument would help protect the area and the conservation for the endangered animals, and historic resources. Ms. Bundorf provided pictures and maps of where the wind farms would be if constructed. She said the turbines are over 400 feet tall.

Ms. Means stated the wind mills are so tall that you could see them from three states, Arizona, California and Nevada. She spoke about the proposed monument area and why this area is being proposed.

Alan O'Neill spoke about some of the history of the area and why the urgency to propose the monument.

Ms. Means commented on how important it is to have community involvement and to have a voice.

Berta spoke about the advantages of having the monument in the area and the economic benefits towns that are adjacent.

Gabriel di Chiara spoke about the need for the monument and support from the community. He said either the President or Act of Declaration can declare the monument. Once the monument is created, a managing agency is chosen and in this case the BLM (Bureau of Land Management).

Leland Means spoke about the disadvantages of wind farms and said there would be no advantages for the community. He said there are opportunities for local business and tour companies next to a national monument.

Kim Means said the public can support the national monument by public speaking, sending postcards and signing a letter.

Kyle Myers commented about his concerns of BLM changing the structure of the agreement and not allowing ATV's and OHV at the national monument. Ms. Berta said the monument would protect the existing roads with no changes with the uses. Mr. Myers inquired if the BLM would be able to close any roads if the monument was approved. Ms. Berta said no. The roads are mapped out to ensure no changes are made to the existing roads. It was also stated the once designated it becomes law and BLM would follow that law that congress passed.

Mr. Myers asked if this proposed monument has been sent to the current presidential administration or congress and Ms. Berta said they have communicated the values of the landscape to all the congressional delegation in Nevada.
