The rural division has ten volunteer fire stations in the rural outlying communities, which include Trout Canyon, Bunkerville, Sandy Valley, Goodsprings, Mt. Springs, Blue Diamond, Cold Creek, Indian Springs, Searchlight, and Cal-Nev-Ari.

Median age is 55 years

23.5% of households has someone 65 years or older in the home. That leaves 241 homes, in theory, with residents fit to volunteer, yet only 2 percent do.

A program Chief Haydu developed about 5 years ago allowed people interested in volunteering to do so without having to live in a rural community. Previously, only residents could be volunteer firefighters in a rural community. Now, anyone 18 years or older with an Emergency Medical Technician certification can apply. They must, however, commit to volunteer a minimum of 24 hours each month at their assigned fire station. Some of the Non-Resident volunteers assigned to Searchlight routinely volunteer in excess of 80 hours per month.

Busiest Rural Fire Station in the County for the past three years.

272 Calls last year

Rescue 75 ran 229 calls, most of any rural rescue

44 "Alpha" calls (Not run in town- Community medicine)

67 "Bravo" calls

44 "Charlie" calls

74 "Delta" calls

25 Fires

18 Other/Miscellaneous calls

27 Members

20 are Non-Resident Volunteers (65% of your local fire department does not live in the area)

As Non-Resident members they are required to staff their assigned fire station 24 hours/month.

Sue Lanseadel recently retired after 18 years. Sue ran many of the calls, no replacement.

Marshall family - 3 out of 4 are volunteers. Rick Marshall serves as the Fire Chief and is one of the best Volunteer Chiefs in the County. Buie family has both brothers and a wife who volunteer.

Steve Fetter, a volunteer for 22 years from fire station 84 in Cal-Nev-Ari passed away. He was the only resident member of that fire station.

There is a lack of new local members. We will train willing new members including medical training. Contact the station if interested.

### **Medial Response**

When no one is available from Fire Station 75, dispatch will respond Engine 76, 85 and/or Rescue 76 and/or AMR from Laughlin, 38.2 Miles and 36 minutes away, or Community Ambulance from Henderson (43 miles or 42 minutes on all "Charlie, Delta and Echo" calls. In addition, an Air Ambulance from Mercy Air is either put on stand-by or if the call seems severe enough launched to the airport. Only AMR and Community Ambulance are sent on "Alpha" and "Bravo" calls. Calls are prioritized by our dispatch using national EMS dispatch standards.

CCFD responds Laughlin units as well as units from Las Vegas on all structure fires to support Stations 75 and 84.

### **Full Time Coverage**

The annual staffing cost of a CCFD Rescue to the taxpayers is approximately \$1.5 million and the annual costs for an Engine about \$3 million. These costs do not include the cost of the fire station and the apparatus.

Searchlight's total Revenue for 2018 was \$436,840.

### **New Equipment**

Due to the call volume at station 75, CCFD is in the process of moving a newer Squad (2017) from a slower station to Searchlight, this is a 14 year newer vehicle, and a newer medium duty Rescue (2008) (ambulance) to Cal-Nev-Ari to replace the 1999 ambulance (9 year upgrade).

### **Medical Needs**

As with the other 9 Rural Communities, Emergency Medical Services must rely solely on a corps of dedicated volunteers as there is simply not enough tax base to support paid personnel. Our motto for the Rural Division is in fact "Neighbors helping Neighbors". Our

volunteers, while committed to serve, must also work full-time jobs to support their families. If you have serious medical conditions, the only way to ensure a 3-4-minute response 90 percent of the time is to live in an urban community where those resources are available. Your Fire Department is made up of your neighbors who volunteer and have made a commitment to help in a time of need.
