AN ORDINANCE TO AMEND TITLE 7, CHAPTER 24.010 OF THE CLARK COUNTY CODE TO PROVIDE THAT A CERTIFICATE TO OPERATE A BUSINESS UNDER AN ASSUMED OR FICTITIOUS NAME MAY BE FILED WITH THE COUNTY CLERK WITHOUT NOTARIZATION; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

## CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title 7, Chapter 24 of the Clark County Code is hereby amended to

read as follows:

## 7.24.010 - Certificate required.

- (a) Nevada Revised Statutes ("NRS") Chapter 602 requires that every person doing or intending to do business in this state under an assumed or fictitious name must file a certificate with the county clerk of each county in which the business is being conducted. The information required in the certificate is described in NRS 602.020. The certificate need not be notarized if it is signed under the penalty of perjury by the person(s) required to sign the certificate pursuant to NRS 602.020(2). [it is signed by an authorized person showing official governmental identification at the county clerk's office in the presence of a deputy county clerk.]
- (b) Clark County Code 6.08.010 requires that all applicants for a business license provide proof of compliance with the provisions of NRS Chapter 602 to the Clark County department of business license.

SECTION 2. If any section of this ordinance or portion thereof is for any reason

held invalid or unconstitutional by any court of competent jurisdiction, such holding shall

not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
