The project continues operation of a dedicated HMIS for Northern Nevada that networks service providers and provides real time data regarding the utilization of programs and service for households at-risk of or experiencing homelessness. The goal is to expand the utilization of HMIS within the community while empowering stakeholders with the ability to assess outputs and outcomes in formats that were previously inaccessible. This dedicated HMIS application supports implementation of coordinated entry and establishment of a community queue to facilitate rapid assessment and placement of individuals in services while allowing for reporting and data analysis. The project includes securing base access to the Clarity Human Services system to support 90 users to utilize HMIS, with the State of Nevada ESG providing match for the 90 licenses. Additionally, monthly system administration and project management services facilitates and coordinates all activities in the successful operation and implementation of the HMIS. The System Administrator acts as the liaison for the HMIS with the Continuum of Care and its community partner agencies. They assist in the generation and submission of program and community-level reports from the HMIS, including the Exhibit 1 consolidated application to HUD, the Longitudinal System Analysis (LSA) report, System Performance Measures, and the Point-in-Time Count for shelters. Technical Support services will be provided to system users at participating provider agencies along with technical assistance. Technical Support includes end-user training, data quality assessment, help-desk email/phone support, and support tasks necessary for the successful operation of a multi-agency collaborative system. By establishing a dedicated HMIS, the CoC funds the infrastructure necessary to continue the integration efforts of coordinated entry to track the full service cycle of clients. As clients are assessed, prioritized, matched, and placed into housing, the HMIS ensures prioritization and tracking of all services. It creates a value-added model that encourages organizations not currently mandated to participate in the HMIS. The HMIS provides the CoC with the ability to collect and report performance measurements, provide expanded reporting options, provide housing/program inventory control, and coordinate referral routing.
