

ASSIGNMENT AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS ASSIGNMENT AGREEMENT (“Assignment”) is made and entered into as of this 17th day of May, 2022, by and among the County of Clark, Nevada, a political subdivision of the State of Nevada, hereinafter referred to as “COUNTY” and R2H Engineering, Inc., R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc., and Horrocks Engineers, Inc. collectively hereinafter referred to as “ENGINEER”. Each of the above is a “Party” and collectively are “Parties.”

WITNESSETH

WHEREAS, on August 2, 2016, the COUNTY and R2H Engineering, Inc. entered into a Professional Engineering Services Contract for the Jones Boulevard between Blue Diamond Road and Windmill Lane Project (No. PW.R033QFT); and,

WHEREAS, on December 21, 2021, the COUNTY and R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc. entered into Supplemental No. 1 to the Professional Engineering Services Contract for the Jones Boulevard between Blue Diamond Road and Windmill Lane Project (No. PW.R033QFT); and,

WHEREAS, the aforementioned Professional Engineering Services Contract approved on August 2, 2016, and the aforementioned Supplemental No. 1 to the Professional Engineering Services Contract approved on December 21, 2021, between the COUNTY and R2H Engineering, Inc. for the Jones Boulevard between Blue Diamond Road and Windmill Lane Project are hereinafter referred to as “CONTRACTS;” and,

WHEREAS, R2H Engineering, Inc., effective March 31, 2018, was acquired by Horrocks Engineers, Inc., merging R2H Engineering, Inc. into Horrocks Engineers, Inc.; and,

WHEREAS, the COUNTY is willing to consent to the transfer of the aforementioned CONTRACTS from R2H Engineering, Inc. to R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc. so long as R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc. and Horrocks Engineers, Inc. commits to being bound by this Assignment and the CONTRACTS and accepts and complies with all of the terms, conditions, rights, interests, restrictions, duties, liabilities, and obligations of R2H Engineering, Inc. under the CONTRACTS.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, it is mutually agreed by and between the Parties as follows:

PARTIES AGREE

1. R2H Engineering, Inc. hereby assigns and transfers to R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc. and Horrocks Engineers, Inc. all the rights, obligations, terms, conditions, restrictions, interests, duties, and liabilities it has in the CONTRACTS.
2. R2H Engineering, d/b/a Horrocks Engineers, Inc. and Horrocks Engineers hereby accepts the assignment and transfer of all rights, obligations, terms, conditions, restrictions, interests, duties, and liabilities under the CONTRACTS and agree to be fully bound under the CONTRACTS and this Assignment.
3. Upon execution of this Assignment, R2H Engineering d/b/a Horrocks Engineers, Inc. and Horrocks Engineers, Inc. will be responsible for all liabilities, terms, conditions, obligations, commitments, and duties under the CONTRACTS and those arising from or connected to the CONTRACTS, including, but not limited to, those that pre-date this Assignment and those relating to the insurance and indemnity requirements.
4. R2H Engineering d/b/a Horrocks Engineers, Inc. and Horrocks Engineers, Inc. agree that there will be no changes in the staff, employees or personnel assigned to perform the services of the CONTRACTS, except with written permission of the COUNTY.
5. The COUNTY consents to the transfer/assignment of the CONTRACTS to R2H Engineering, Inc. dba Horrocks Engineers, Inc. and Horrocks Engineers, Inc. subject to the terms and conditions of this Assignment.
6. Except as set forth in this Assignment, all terms, conditions, and provisions of the CONTRACTS are unchanged and remain in full force and effect, and shall be binding on R2H Engineering, Inc. d/b/a Horrocks Engineers, Inc., and Horrocks Engineers, Inc.

IN WITNESS WHEREOF, the Parties hereto have caused this Assignment Agreement for Professional Engineering Services to the CONTRACTS to be executed by their respective duly authorized agents as of the date first set forth above.

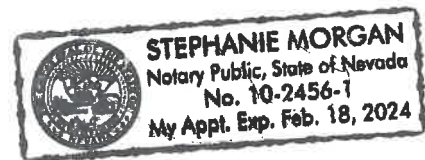

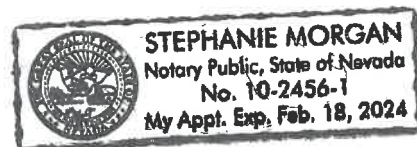
