**BACKGROUND:**

Bid No. 606131-22, for Annual Requirements Contract for Septic Tank/Leach Field and Lift Station Services Countywide was advertised on March 3, 2022 and opened on April 6, 2022. The Bid Amounts are as follows:

The following are the pertinent provisions of the Contract:

- The term of the Contract is from date of award through June 30, 2023 and includes the option to renew for 4, one-year periods.
- Includes the option to increase the award amount up to 10 % based on possible increased user requirements for the renewal terms and approved budget appropriations.
- Includes the option to increase the award amount up to 3% for possible price increases for renewal terms.
- Includes the County's option to terminate for cause, convenience or default and suspend the Contract with advanced written notice.
