

**RESOLUTION TO PROVIDE A GRANT TO  
HEAVEN CAN WAIT ANIMAL SOCIETY**

**WHEREAS**, Heaven Can Wait Animal Society, DBA Heaven Can Wait Spay/Neuter Clinic, located at 546 N. Eastern Ave Suite 175, Las Vegas, Nevada 89101, hereafter “Recipient,” works toward eliminating animal overpopulation in the Southern Nevada community through sterilization; and

**WHEREAS**, Recipient, at its own expense has developed the Spay/Neuter Clinic and set a goal to provide 10,000 cat and dog sterilizations valley-wide during each calendar year, and pursuant to this resolution, will provide unincorporated Clark County citizens and their animals 1,600 low cost to free pet sterilization services; and

**WHEREAS**, pursuant to NRS 244.1505, the Board of County Commissioners may expend money for any purpose which will provide a substantial benefit to the inhabitants of the County or grant money to a private organization, not-for-profit, to be expended for the selected purpose; and

**WHEREAS**, Recipient is a nonprofit organization created for religious, charitable, or educational purposes as defined by NRS 244.1505 and NRS 372.3261; and

**WHEREAS**, the Board of County Commissioners hereby determines that the purpose for which the funds are expended will provide a substantial benefit to the inhabitants of Clark County.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Clark County, Nevada, to grant Recipient up to \$200,000 following execution of this resolution subject to the following terms and conditions:

1. For the period of July 1, 2022 to June 30, 2023, Recipient shall hereby provide unincorporated Clark County citizens and their cats and dogs at least 1,600 low cost to free pet sterilization services. If the County refers an individual to the Recipient, the individual will be given a discount at the discretion of the Recipient. Additionally, if a citizen shows a Supplemental Nutrition Assistance Program card (SNAP), a Temporary Assistance for Needy Family card (TANF), Medicaid card, Social Service Medicaid card, or a Nevada Check Up card along with proof of identification, the low cost sterilization and vaccination service shall be provided for a maximum charge of \$10 for cats and \$20 for dogs. It is reserved to Recipient’s discretion to deny services to any referred individuals for a lawful reason, animal condition, or lack of proof to show that the citizen cannot afford the cost of sterilization.
2. For the period of July 1, 2022 to June 30, 2023, Recipient shall set a goal to sterilize at least 7,000 feral or community cats in order to further mitigate the number of unwanted and free-roaming kittens in the community.

3. Recipient shall reserve capacity for priority pet sterilization referrals from Clark County Animal Protection Services. These animals will be scheduled at the first possible appointment to complete the required procedure. If microchips are provided free to the Recipient, Recipient will agree to implant them at no additional cost.
4. Recipient will provide reports to the Clark County Administrative Services Department and Clark County Animal Protection Services monthly during the period beginning July 1, 2022 and ending June 30, 2023. These reports will contain, but are not limited to, the information contained in Exhibit "A", "Monthly Progress Report to Clark County," including any narrative report to delineate the benefit realized by the County for the Program support.
5. The County shall have no relationship whatsoever with the services provided, except as otherwise specifically provided herein. To the extent, if at all, that any relationship to such services on the part of the County may be claimed or found to exist, Recipient shall be an independent contractor only. Nothing herein shall be construed to imply a joint venture, principal and agent, or employer and employee relationship between the County and the Recipient, and no party will have any right, power, or authority to create any obligation, express or implied, on behalf of the other. Each party shall be responsible for its own acts or omissions arising out of or related to this resolution.
6. Recipient may not assign any functions required under this resolution without the express written consent of the County. In the event that Recipient is allowed to assign some or all of the functions required under this resolution, Recipient will abide by all state and federal laws governing workers compensation benefits and employee taxes, as they may be applicable.
7. Recipient will protect, defend, indemnify, and save harmless the County from and against any and all liability, damages, demands, claims, suits, liens, and judgments of whatever nature, expecting those proximately the result of the County's acts or omissions, in connection with, or arising out of any activities undertaken pursuant to this resolution. Recipient's obligation as set forth in this paragraph shall include any and all reasonable attorneys' fees incurred by the County in the defense or handling of said suits, demands, judgments, liens, and claims and all reasonable attorneys' fees and investigation expenses incurred by the County in enforcing or obtaining compliance with the provisions of this resolution. In the event that the County incurs any expenses in this regard, it shall have a right to charge said expenses made in good faith to the Recipient. An itemized statement of expenses shall be prima facie evidence of the fact and extent of the liability of Recipient.
8. Recipient will not use any funds or resources that are supplied by the County in litigation against any person, natural or otherwise, or in its own defense in any such litigation. Recipient agrees to notify the County of any legal action that is filed by or against the Recipient.

9. Recipient shall keep and maintain in effect at all times any and all licenses, permits, notices, and certifications which may be required by any County ordinance or State or Federal statute.
10. To the extent permitted by law, Recipient shall not institute any action or suit at law or in equity against County, nor institute, prosecute, or any way aid in the institution or prosecution of any claim, demand, action, or cause of action for equitable relief, damage, loss, or injury either to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past, present, or future, arising out of , in any way, the terms of this resolution.
11. Funds shall be made available to Heaven Can Wait Animal Society, quarterly or otherwise, in increments of \$50,000 or portions therefore as mutually agreed upon, as funds become available to the County.
