Previous APN as a result of SID 158 Reapportionment #12

⁽¹⁾ Original fontage for the Assessment is from SID 158 Unit 1 Provisional Order Assessment Plat and carried through reapportionment #12. Frontage allocation based on Parcel Map 123 Page 38; Actual total from PM is 426.7.

Per Creation Ordinance 4357 Section (6), the assessments in Unit No. 1 will be levied on a front foot basis.

Per Assessment Ordinance 4470 Section (7), should any lot, tract or parcel of land within each assessment unit be divided after the effective date of this Ordinance and before the collection of all of the assessment installments for such assessment unit, the Board may require the County Treasurer to apportion the uncollected amounts upon the several parts of land so divided. If two or more lots, tracts or parcels of land within each assessment unit are combined or combined and redivided into two or more different tracts after the effective date of this Ordinance and before the collection of all the assessment installments for such assessment unit, the Board may require the County Treasurer to combine or combine and reapportion the uncollected amounts upon the part or parts of land that exist after the combination or combination and redivision. The report of such an apportionment, combination or reapportionment, when approved, shall be conclusive on all the parties, and all assessments thereafter made upon the tracts shall thereafter be according to the subdivision, combination or redivision. The report, when approved, shall be recorded in the office of the County Recorder of Clark County, Nevada, together with a statement that the current payment status of any of the assessments may be obtained from the County Treasurer. Neither the failure to record the report nor any defect in the report as recorded shall affect the validity of the assessments, the lien for the payment thereof or the priority of each lien. For the avoidance of doubt, reapportionments processed pursuant to this Section 7 shall be performed on a per assessment unit basis (i.e., separately for Unit No. 1 and Unit No. 2) and not a District wide basis.

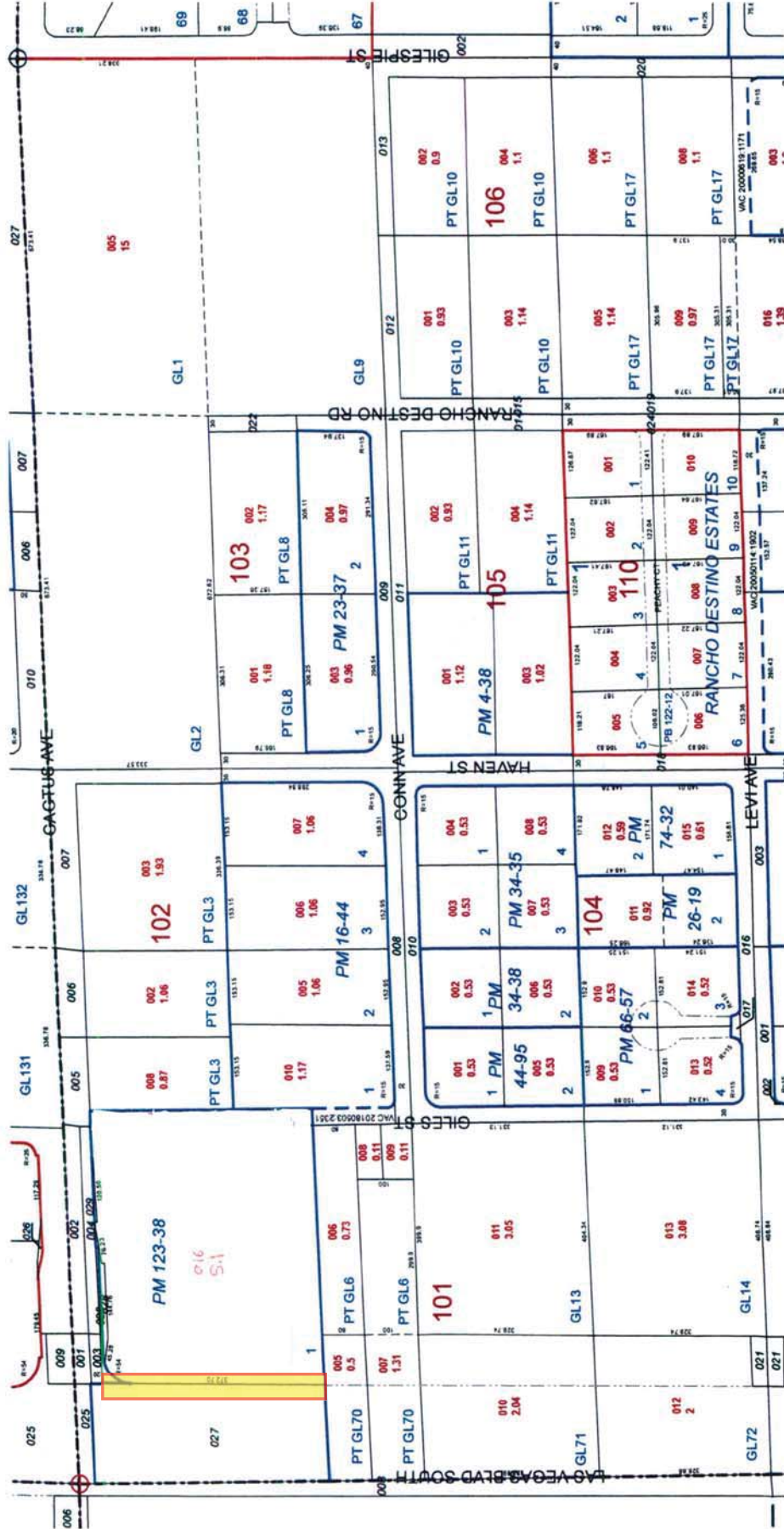
