I also heard many stories from our customers that came from California to buy a puppy that there were even more scammers online since the puppy store ban in California. I am also an avid believer on adopting dogs from shelters, but I also know that this is not for everyone. Also, people do not give up their puppies that are bought from stores to the shelters. They are mostly from illegally bought pups from the internet. Dear Sir/Madam,

I hope this correspondence finds you well. Puppy Heaven is a dog retailer operating in Clark County, Nevada, and will directly be affected by the proposed rule changes in the manner described below. Puppy Heaven has been in the puppy business, in various capacities and locations including Nevada and California, for 18 years and we offer below comments based on our vast experience. Especially relevant to the proposed changes is Puppy Heaven's experience with the same rule change which was enacted in California. Unfortunately, as a direct and unfortunate result of the California code change (which is largely the same as the subject proposed change), we were forced to shut down all of our retail businesses in California.

Our comments/observations with regards to the proposed rules changes to Clark County Code Title 10 Chapter, 10.04 and 10.08 are as follows:

1. The proposed change will not achieve its intended purpose. Specifically, many puppy customers want to be able to choose a specific puppy. For that reason, many customers, instead of choosing a rescued dog which is the intent of the rule change, will turn to purchasing puppies online, out of state, and sometimes even from other countries. For example, in our Nevada retail store, we have customers from California, who have come all the way to Nevada, in order to buy a puppy of their choice. This is a daily occurrence. So in essence, the same number of customers will continue to want to purchase puppies of their choice, but will not be able to do so in Nevada and will seek to purchase them out of state. Such result will reduce all aspects of business gains from Nevada – revenue from the retailers, continued employment opportunities for their employees, and tax revenue from the State of Nevada.
2. Puppy customers purchase puppies for specific purposes. When bringing a new furry friend home, many people would like to know the puppy's history and would like an opportunity to train their puppy for their family's needs. Puppy Heaven has many customers who are looking to purchase a puppy as a support dog (for themselves or for a child in need), and need a particular breed of a puppy for such a purpose which cannot be found at a shelter. In addition, in those scenarios, it is of imperative importance that the puppy be of certain health and behavioral habits/background which can not be chosen or ascertained at or by a shelter. The only way to ensure that the right dog is chosen for those specific situations is through licensed and knowledgeable retailers.
3. Spread of diseases and uncontrolled breeding. Eliminating pet retailers will result in an unchecked increase of unlicensed and inexperienced "backyard breeders" which will cause many

other issues. Primarily, such breeders are not formally trained and do not have the knowledge to maintain their puppies healthy, vaccinated, dewormed and safe. Also, as untrained, unlicensed and unchecked sellers, these breeders will not subject the puppies to the necessary and legally required veterinary checks. As such, this will result in proliferation of unhealthy dogs developing and spreading diseases to both other animals and potentially humans. In addition to the health concerns, this form of underground sales of puppies by unlicensed breeders will result in further tax revenue loss to the State of Nevada.

4. Increase in scams and fraudulent sales. The proposed law will not change the tastes, preferences, and the needs of puppy purchasers – they will still want a puppy of their choice. As mentioned, eliminating puppy retailers will simply cause the consumers to get creative with obtaining puppies they want and/or need. We have heard so many horror stories from our California customers, about various online pet sales gone wrong and consumers being scammed out of thousands of dollars. Unfortunately, this occurrence is most common with elderly and disabled customers.

5. Adverse economic effect. As explained in greater detail above, eliminating puppy retailers will have a significant adverse economic impact. Retailers will be forced to shut down causing both the retailers and all of their employees to become unemployed. Also, elimination of pet retailers will result in a decrease of State of Nevada tax revenue.

We hope you will take the serious implications explained in this correspondence into consideration when ruling on the suggested proposed rule change. We strongly believe that the proposed changes would not have the intended effect of forcing consumers to obtain puppies from shelters and would simply open other avenues of obtaining puppies which would endanger the health and the well-being, as well as finances, of Nevada consumers and the State.

**Regarding:** Pet Store New Ordinance

Greetings, Commissioners and Animal Protection Services,

We are respectfully responding to a proposed ban and economic impact on Pet Stores in Clark County. I appreciate you taking the time to read through the information I am providing which includes my decades of experience in the industry. I will address the impact to businesses and offer a new proposal for all of us to find a medium agreement. I will also address impacts from banning pet stores from other cities, counties, and states as well as disclose critical information about some rescue organizations and shelters and how it really means a profit to them rather than the wellbeing of animals. I will make this brief as possible as there are tons of information which is not included in this letter.

First let's answer the main question:

**Where do pet stores get their puppies?**

We use Government Regulated Breeders who are inspected by USDA/APHIS, registry companies, state inspectors, city inspectors, veterinarians, colleagues of the industry and even pet store operators.

Since 1992 I have owned and or operated pet stores. My objective is and always has been to ensure that consumers would have a safe place to obtain a new family member without judgement. I also wanted to ensure the consumer would have the ability to receive financial assistance in the case their pet may become ill like all life forms do on God's planet. Additionally, I have joined up with various members in the pet industry to ensure pets were not being mistreated or overbred as they did before the 1990s. There is still work to be done. But let's not ignore the fact that thousands of unscrupulous breeders have already been shut down dating back to the 90s in part because pet stores refuse to work with unscrupulous breeders.

Since then, we have accomplished educating, and created responsible breeders to ensure each adult pet has human companionship, daily exercise, as well as freely entering indoors and outdoors on their own free will. The parents of puppies are also placed on a retirement plan and adopted out to homes and given nutritional foods. We have always frowned and dismissed people that believe pets should be in stacked up cages all their lives only to be overbred or neglected.

Medicine and vaccinations to prevent the spread of illness is enforced and mandatory to prevent the spread of illness or disease. Much like human scientists, housing, people, companies, government bodies and the pet industry are always seeking ways to improve. My point is every industry on the planet finds ways to improve. We too in the animal industry practice are always finding better ways to improve our industry.

It concerns the Pet Industry which include Rescue Groups, Shelters, Show Breeders, USDA/APHIS Government Regulated Pet Store Breeders are in constant battle instead of finding ways to work with each other. Rescue groups want to take away the right for humans to choose where to obtain a pet. They claim Pet Store breeders are the biggest contributor to over population and mistreatment of animals. All of which is not true as proven in shelters.

There is proof in the links below which will show you how these bans have increased the profits for some non-profit organizations making them multibillion dollars through the years. This proposal of banning pet stores from selling pets by the radical animal activist movement will create an extinction of a lot of life forms and deepen their pockets. Is this what we really want to do?

The other claim is there are a lot of specialty breed rescues sources. If this were true, then why are some of these groups going out of the country to obtain these specialty breeds like they did in Illinois? 35 of 500 French Bulldogs died while being imported from Ukraine. In 2015, animal rescuers introduced Asian dog flu to the United States for the first time. Ground zero was Chicago, where over 1,000 pets ended up getting sick and several died. Asian dog flu has since spread across the country courtesy of reckless rescues. The link goes into more detail of these types of issues.

Another article to read is regarding some of Nevada Rescue Groups. A draft ordinance was to be introduced by Las Vegas City Councilwoman Victoria Seaman which would require rescues to be licensed.

She quoted "It shouldn't be so easy for anyone to get a permit, rescue an animal, announce they're a rescue, and start soliciting for donations," says Wylderich. "There should be some accountability to prevent some of the worst outcomes for animals by any bad players." The article also talks about how PETA believes these animals should be euthanized rather than live in some of these rescues.

I understand there are still irresponsible people that breed locally and nationally but it doesn't mean Pet Stores are a contributor to those types of behavior or support them. One of the respects I have for Clark County and most of Nevada is they make every pet owner responsible for neutering or spaying pets. I have yet to find a state other than Nevada and specifically Clark County to ensure this rule is enforced. The neuter spay rule reduces the number of pets that could end up in Shelters or with some rescues.

Clark County pet stores pass out information to purchasers and express the law and importance of neutering and spaying. In addition, Pet Stores must abide by health laws to protect the client if a pet should become sick. The client is given options of obtaining a refund, paid medical bills or even trade for a healthy pet. Naturally pet stores would not want to sell sick animals. The propaganda that a pet store only sell sick pets is a flat out lie. It would make no financial sense to the pet store.

Through the years I visited many shelters and rescues and have found most of the breeds the general population wants are not available for a variety of reasons. Another fact is, Rescues, Private Breeders and even some shelters have proven to me time and time again they discriminate against the type of people that could adopt a pet. They are even rejecting pet stores. How does this help a pet in need of a home?

I have approached several private breeders, rescues and even some shelters with a concern of euthanasia. I proposed to have their pets to come into my stores so we could prevent euthanasia without the store making a profit but rather have any adoption fee go to the shelter or rescue. **This concept gives the public the opportunity to adopt a pet or choose to purchase a Government Regulated Breeder pet in a retail store front location.** On many occasions I have been told they would rather euthanize a pet than to deal with competition. This blew me away



to hear that people would rather kill an animal than work with a source that is regulated by all governing bodies on Pet Store.

I cannot tell you how many clients have come into my stores and shared a story of being a remote worker, stay at home spouse, or have kids but were still denied adopting a pet. It always amazed me if we have an overpopulation problem anywhere in the USA then why are people being denied adopting a pet? Why are pets being imported into cities, counties, states and being adopted out for thousands of dollars from rescues? Why can't our industry work with each other instead? The reason all parts of the industry which include some shelters, rescues, private breeders, and pet stores do not work with each other is because they are all a business and viewed as competition.

It isn't a secret anymore to say that we all know that non-profit organizations such as Humane Society of the United States (HSUS), People Against the Unethical Treatment of Animals (PETA) and ASPCA are multibillion dollar companies. They may not be able to take the net profits of their business for personal use, but they certainly can pay themselves hundreds of thousands of dollars per year. (It is still for a profit business no matter what your tax category is). A current petition started on the CEO of ASPCA because he is earning \$750,000.00 annually. Why would an non-profit organization pay that much money to one person when it could help pets in need?

Family operated pet stores simply do not have the funds to fight off a multibillion-dollar organized criminals such as HSUS, PETA and ASPCA or other copycat organizations. It's already proven across the nation seeing good operating pet store owners being accused and sued for things they did not do. Some had to settle because they couldn't afford to pay for the 6-to-7-digit figures to prove their innocence in court.

You will be amazed by all the money made from HSUS, PETA, and ASPCA. Did you know that HSUS, PETA, and ASPCA had started banning pet stores in cities without a pet store present? Government Regulated Breeders must abide by APHIS, City, County, State, Registration Companies, and public standards. Pet Stores by law must stand behind each of their pets in the case they become ill along with a laundry list of regulations. Activist propaganda states Pet Stores sell pets from mills and send home sick pets. It makes no economic sense since pet stores are already liable for illness and sources. A sensible pet store owner would not want to do business with mills. All other organizations are not regulated like Pet Stores and their breeders.

HSUS, PETA and ASPCA promote veganism and vegetarianism. However, their lifestyles kill animals at the same time. What about the animals that feed off our crops and farms? Those animals may not be pleasant to the average human eye, but they die because of the recently known plant-based imitation meat. Pet Stores are an honest law-abiding business while radical groups mislead the public and legally steal money from our government. It is clear having control and regulation of a business is far more effective then eliminating them. Clark County and Nevada has a chance **to not make the same mistake** that California, Chicago, and other parts of the USA did from banning pet stores. Instead, they created more backyard breeders and people smuggling pets over the border to sell to the public through the internet or papers. Diseases such as Rabies have also been introduced in dogs again since the banning because of the importation from some rescue groups. Irresponsible people are the main cause for overpopulation, not pet stores.

This proposed ordinance will create more corruption in our cities, counties, states, and our country by the real mills which include backyard breeders and irresponsible pet owners not neutering or spaying pets.

Ask yourselves, why would we deregulate an industry that has to abide by many laws. Instead, enforce pet stores, Government Regulated APHIS breeders, Rescues and Shelters to all work with each other in store fronts so we can accomplish finding homes for all pets without taking away the rights of people to choose to adopt or shop.

The proposed ordinance to ban pet stores from selling pets will add to tax dollars and overworked Animal Protection Service Officers.

Again, black markets will be created in the city, county, and state. Our country will literally have very little control in the industry much like what happened during the prohibition of alcohol sale in 1920.

There is no verifiable proof all pet stores obtain their pets from Puppy Mills. If they do, then their license should be revoked. It isn't morally correct to punish good people. Even good people such as I have been accused of wrongdoing with no merit. Regardless, the purpose of Government Regulated breeders inspected by numerous parties ensures the public they are receiving pets from a reliable source through pet stores.

HSUS, PETA and ASPCA have had outdated information and pictures for years now. Some unscrupulous breeders still exist, but they stay clear of pet stores because in the last 2 decades Pet Stores have been shutting them out including the public being aware of Inhuman breeders. Everyone in the industry has been improving themselves for years.

#### **The Impact:**

- The General Public will no longer have the freedom of choosing to adopt or purchase a pet from a specialty pet store.
- The ordinance will create overworked Animal Protection Services which creates more expense for the county.
- The county will no longer be able to control the number of pets in shelters or rescues creating the county with more expenses.
- The county will unintentionally contribute to black markets which means the county will need to invest more money to Rescues, Shelters and Animal Protection Services.
- Honest pet store owners will have to file bankruptcy because they are in leases.
- Landlords and creditors will hold all persons with or without their business to their financial responsibility because there is no law that ends a lease or credit upon the forced closer of business.

- Most current business owners will not be able to obtain a job to support themselves because of bankruptcy, their age group, financial hardship and destroyed names on the internet.
- It is known employers do not hire individuals with names that have been falsely destroyed on the internet.
- Other types of business opportunities are not offered to people who go bankrupt or are head deep in debt. This opens the opportunity for business owners to possibly suicide which will impact loved ones. What choice do they have if they can no longer support themselves?
- Homeless count increases on the streets which will cost the city, county, and state more money.
- The county would be frowned on because they allowed pet stores to open a few years ago while knowing or not knowing the intent was to close Pet Stores anyway. It can be viewed as a trap to destroy and bankrupt pet store owners' names.
- Trust in other businesses could be discouraged from entering Clark County or even Las Vegas knowing that they too may be shut down for no justifiable cause.
- Veterinary Hospitals will lose revenue
- Groomers will lose revenue
- Pet boarding facilities will lose revenue
- Pet Trainers will lose revenue
- Pet Walkers will lose revenue
- Pet Stores being banned from selling pets will affect other businesses, the city, county, and state in revenue.

HSUS, PETA and ASPCA have already made their billions through the years so impacts on small businesses, cities, counties, states, and humans will have no effect on them except to continue to make their pockets deeper for their next movement. Their proven motive is not for animals, it is for financial gain. They may help a few shelters, rescues, and other animals to stay legit in the public's eyes so they can continue to convince us all they are helping animals. Moving forward there are good hearted people that truly care for animals in the shelter and rescue industry. But that does not mean pet stores don't have a heart too. Pet Stores, Rescues, Shelters, and Government Regulated Breeders are actually a great way to use as a source of ensuring the public is getting pets from a reliable source. Please continue to read as I have a proposal that will appease to real rescues, shelters, and pet stores.

### Proposal

- Pet stores are allowed to stay open provided they follow similar rules already set in Las Vegas City but this time the county makes it mandatory for Shelters, Rescues, Government Regulated Breeders, and Live Animal Pet Stores to work together. Neither one however can dismiss joining forces. *California almost had this perfected, but they didn't make it mandatory that Shelters, Rescue's, Government Regulated Breeders and Pet Stores had to work with each other. Instead, Shelters and Rescues wanted nothing to do with family pet sales. In addition to their attempt, one of the States Special committee members banning pet stores "wife" oversaw an animal shelter. That was a bias decision to choose that committee member. They also included during the hearing that California leads and influences the United States legislators.*
- Clark County could limit the amount of Pet Stores to operate in each district. Clark county can copy the same rules of the number of licenses given to Tabaco, Alcohol and Arms Industry. (Example of 2 to 4 pet stores per district).
- Pet Stores can be fined and possibly lose their license if they do not adhere to working with Government Regulated Breeders with a "no-direct" violation within 2 years on inspection reports.
- Each Pet Store must provide Animal Protective Service with Puppy Breeder Inspection form provided by APHIS during each inspection at least once a year or month.

- Pet stores must donate \$10.00 to their local shelter or local rescue each month for every pet sold. (These shelters or rescues must obtain a 501c3 tax form). This proposal will ensure additional revenue to help Animal Protection Services, Shelters or Rescue overhead costs within our community. The Pet Store should be limited to one Shelter or Rescue group.
- Local Shelter or Rescue must accept donation from Pet Stores who work with USDA/APHIS Government Regulated Breeders
- Local Shelters and Rescues can no longer deny live animal pet stores from obtaining shelter or rescue pets so they can be adopted in the live animal Pet Store location.
- Retail live animal pet stores would need to pay the shelter or rescue group any adoption fees charged by the shelter or rescue.
- Pet stores must use 10% of their kenneling systems for adoptable pets that are healthy to prevent the spread of disease.
- Additionally, Pet Stores has an official one full "Adoption Day" event each quarter for strictly adoptions with no pet purchase sales in their location for the day. The Shelter or Rescue agency must be present to monitor and complete their adoption forms.
- Shelters and Rescue agencies no longer can judge a potential pet from being homed. This will prevent overcrowded pets in Shelters and Rescues. This also ensures all pets can be adopted.
- The adopter should have the ability to return the pet in the case they can no longer care for the pet. The Adopter must have a justifiable cause or will be fined and suspended from adopting or purchasing another pet for a period of 3 years if the release of the pet back into the system is without justifiable cause. (The causes can be written and determined by the committee).
- All parties of the industry should financially unite and educate the public about the proper care of pets and encourage neutering, spay and how to care for the life of a furry family pet.



- These local shelters and groups cannot deny the pet store donations, store space provided, adoptions or an adoption day event.
- To ensure accuracy and integrity; a **five-person committee** of individuals will consist of an Animal Protection Service (who will take the role as the non-bias final decision on the other four members' votes and counts). The committee should consist of a Pet Store Operator, Pet Groomer, Veterinarian, Pet Trainer, or anyone affiliated within the pet industry in our community to ensure integrity and self-regulation. These members would do it voluntarily or voted in by the public every 2 years. There will be quarterly meetings for observation of reports and enforcement of current law.

These are just a few things that can address Shelter and Rescue issues including dismissing unscrupulous Pet Store owners but not eliminating honest pet retail stores that work with USDA/APHIS Government Regulated Inspected Breeders.

It is best all of us in this shared industry work with each other, not against each other. Together we can create a new standard for the Pet Industry to adhere to.

Your consideration of these proposals will help all pets and keep good Shelters, Rescues, Government Regulated Breeders and Pets Stores in existence to find homes for all pets. People deserve to receive unconditional love from pets. People also should not be robbed of their freedom to choose where they obtain their pets from. Majority of the public are not even aware this right may be taken away from them.
