**Action 1:** Section 5 of the General Conditions of the Contract, entitled "CONTRACT RENEWAL" shall be deleted in its entirety and replaced with the following:

## 5. CONTRACT RENEWAL

OWNER reserves the option to renew this Contract for an additional four (4), one-year periods. At the expiration of the initial term, or if any renewal options are exercised, at the expiration of the last renewal option exercised, OWNER shall have the right to extend this Contract as indicated below. Notwithstanding the foregoing or anything to the contrary contained in this Contract, Owner shall have the ability to exercise up to three (3) additional one-year renewal options effective on or before July 1, 2023.
