This has impacted our programs ability to utilize housing and maximize HUD program funds leaving some available for recapture. New Beginnings experienced less client turnover and in turn led to decreased service numbers and fund utilization.

The New Beginnings (NB) program is a permanent supportive housing project that serves chronically homeless individuals (CHI) with immediate placement in permanent supportive housing and a connection to needed resources to support their success in transitioning to self-sufficiency. Using a housing first/harm reduction model, New Beginnings focuses on two core areas: intensive case management and permanent supportive housing. Funds requested in this application will support rent for CHI while match funds from partnering agencies will provide supportive services and intensive case management. As a permanent supportive housing project, the duration of rental assistance is based upon the household's ongoing housing needs.

NB is a partnership between HELP of Southern Nevada, (the direct client service provider), and Clark County Social Service (fiscal agent). The NB collaborative is improving the lives of 113 chronically homeless households by providing \$1,395,696 in tenant based, scattered site, permanent supportive housing based upon a housing first harm reduction philosophy. Intensive case management at a 20:1 client to case manager (CM) ratio is supported by a cash match contract with HELP. CM provides housing assessments, housing navigation, supportive services, and the routine intensive case management to support a robust individual service plan.

The goals of the project are to provide client-centered and evidence based permanent supportive housing practices to support the needs of the client, support ending chronic homelessness by 2017 as outlined in the federal plan 'Opening Doors' to prevent and end homelessness, and reduce incidences of utilization of high cost public systems. Best emerging practices used to develop this project include Housing First/Harm Reduction, and Intensive Case Management (ICM).
