STAR RRH (Stability, Tenancy, Access, Restore Rapid Rehousing) & STAR PSH (Permanent Supportive Housing) are complementary programs that meet the needs of Veterans & households experiencing chronic homelessness; high vulnerable individuals, families & transition age youth (TAY) experiencing literal homelessness who may have a mental illness, substance use or co-occurring mental illness & substance use disorder (SUD); & highly vulnerable homeless frequent users of high-cost public systems such as jails & emergency rooms. Through supportive housing, tenancy support, access to treatment & health care benefits, STAR restores lives & provides resources to allow households obtain self-sufficiency. Utilizing housing first, harm reduction, trauma informed care, client-centered strategy with motivational interviewing, households achieve stability & wellness while addressing the underlying causes of homelessness.

STAR RRH clients access effective mental health & SUD treatment, medication management, medical care, psychosocial rehabilitation & an array of recovery support services designed to stabilize tenancy, maintain treatment gains & engage clients. Contracted managed care organizations (MCOs) provide medical case conferencing for clients and support them with any ongoing health issues and help obtain self-sufficiency. Peer mentors help clients navigate through complex social service systems and acquire important basic living/self-management skills, family reunification & support systems. Case managers (CM) partner with local service providers to ensure participants have access to assistance with moving costs, educational services, employment assistance, food, legal services, transportation and other services working toward self-sufficiency.

Utilizing a 1:20 CM to client ratio & receiving referrals from coordinated entry, STAR RRH supports the needs of the client & Functional Zero sustainability efforts for Veterans & ending homelessness of all subpopulations as outlined in Home, Together, the plan to prevent & end homelessness. STAR RRH aims to serve 93 households in RRH in collaboration with the NV MCOs who have committed to provide medical case conferencing. STAR TH-RRH, which served as a model for this project, served 93 clients with stable housing placement in RRH, outreach case management & supportive services to increase participant success rate during the past fiscal year.

Of the 93 project participants, STAR RRH seeks to target 74 clients (80% of population) to remain in permanent housing (PH) at the end of the operating year or exit to PH during the operating year. 70 clients (75%) will be targeted to maintain or increase total income at the end of the operating year or program exit. Using housing as a foundation for recovery, SOAR certified CMs assist 74 clients (80%) with applications for mainstream benefit programs such as TANF, SNAP, WIC, for which they may be eligible, in order to stabilize tenancy & increase self-sufficiency.


