### If so, which one and what was your experience?

I currently Chair the Paradise Town Advisory Board. It has been a privilage to have played a role in the dynamic growth and diverse development of Paradise, a township I have lived in from the very first day I moved to Las Vegas in 1987. The most recent Board Meeting was on Tuesday, 10/25/2022, in which we heard agenda item 1 regarding the development of the Formula 1 (F1) racing facility. Such a development will have a positive major fiancial impact for Clark County and Southern Nevada and one we, as a Board, approved. This experience Tuesday night was yet another highlight of so many other Board experiences as Chair and as a Board member throughout my time on the PTAB. I just completed being on the Stake Holder Advisory Committee for the Maryland Parkway Corridor Transit-Oriented Development Plan (TOD). This is an enhanced High-Capacity Transit System that will replace and expand Rout 109, through the Medical District, Downtown Las Vegas, involving 6 that include Winchester and Paradise, Sunrise Hospital, Boulevard Mall, UNLV, and Harry Reid Internantion Airport. Over the years I have been on the Paradise Town Advisory Board, I have also served on the Community Developement Block Grant Advisory Board, and the Nevada Department of Transportation Citizen Advisory Committe for the widening of the 95/515 widening from Downtown south to Railroad Pass.

### Why are you interested in becoming a member of your TAB or CAC?

The Paradise Township includes a vast diversity of people and cultures with many needs in most every neighborhood, particualry with infastucture, the renewal of older neighborhoods and homelessness. In addition, Paradise is unique in that within its boundaries is most the Las Vegas Strip and the Harry Reid International Airport. It's clear that over the next decade Paradise will see major changes and additions that will have a major impact on our community. I would like the opportunity to continue to play a role in these changes. The current PTAB members have a lot to bring to the table to assist the PC and BCC with their historical knowledge of Paradise and it's developement, with back grounds in property management, community developmentand planning and County government. ### Work experience

### 1991 – 2019 (Retired) Las Vegas Municipal Court, Las Vegas, Nevada **Judicial Enforcement Supervisor**

- Reported directly to the Las Vegas Municipal Court, Criminal Division Chief Marshal, had direct responsibility for the development and implementation of an in-house Judicial Enforcement Unit (NRS 176.064) for the Las Vegas Municipal Court and Warrant Service Program. Supervised 6 Enforcement Officers and 2 Court Clerks, locating and interacting with defendants in warrant status, resolving cases, increasing misdemeanor criminal and traffic case resolution and collecting \$6 million annually in delinquent monetary sanctions. Refer uncooperative traffic and criminal defendants with outstanding warrants and specific location information to the Las Vegas Municipal Court Marshals for the defendants' subsequent arrest.
- Project Manager for collection service agreements on delinquent misdemeanor traffic cases to be serviced by a vendor Collection Agency for First Party Receivables Management and Third-Party Debt Collection. This process resulted in additional case resolution and \$2.5 million annually.
- Nominated by the Las Vegas Municipal Court, appointed by the Nevada State Supreme Court, and elected Chairman of the Administrative Office of the Courts, Nevada Judicial Collection Task Force 2000-2001. Established by State Senate Concurrent Resolution 10 to review and make recommendations for Minimum Accounting Standards for Courts and Best Practices for enforcement of judicially ordered monetary sanctions in Nevada courts and currently used in Nevada courts today.
- Member of the Municipal Court Leadership Team. Worked with the Administrative Office of the Courts Nevada State Supreme Court, Las Vegas City Attorney, Clark County District Attorney, and the Nevada League of Cities and Counties, to provide subject matter expertise and testimony on Standards for Collections in Nevada courts to the Nevada Assembly Judiciary Subcommittee on the collection of fines, administrative assessment fees, fees, and restitution in 1999 and 2001.
- Wrote and recommended amended legislation for the 1999 State Legislative session to improve and expand the ability of Nevada courts, cities, and counties to enforce monetary sanctions and improve case resolution on Failure to Appear cases.
- Developed and implemented written Policy and Procedures for Fine and Fee Enforcement Training Programs, to improve enforcement of court ordered monetary sanctions.

- Developed policy and assisted in the implementation of the Municipal Court Judicial Enforcement Team (JET) initiating a grant funded program through the U.S. Department of Justice to enforce collection of monetary sanctions owed, or arrest defendants who fail to cooperate with Court Judicial Enforcement Officers to resolve their delinquent cases.
- Implemented the use of on-line credit bureau reports, Internet based vendor data bases and other skip tracing resources, to enhance the enforcement of monetary court ordered sanctions and improve the collection of judicially ordered fines and fees.
- Developed and implemented the Parking Collection Enhancement Program for the collection of delinquent civil Parking Infraction cases, collecting over \$1.3 million annually, increasing parking installment payments by 135%, and overall parking revenues by 35% from 1991-1995.
