I am applying to serve again on the Red Rock Citizen's Advisory Council (RRCAC). I was first appointed to the RRCAC in January 2021. I hope my service to date has been satisfactory. I take the duties of the position very seriously. I prepare for each meeting so I can address issues appropriately.

I have lived in Calico Basin for 17 years and plan to stay for the foreseeable future. I moved to the Basin shortly after arriving in Las Vegas from Los Angeles.

My strong interest in Red Rock Canyon, the Spring Mountains, Calico Basin and beyond in every direction began a very long time ago. My first experience in this area was hiking and rock climbing while on a road trip in the early 1980s and have been passionate about it ever since. CBWG stays in touch with Calico Basin residents regarding relevant issues so perhaps I have a good sense about their interests and inclinations.

I am widely read and have a large skill set. My career started as a self-taught technologist.
