1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

Clark County Social Service (CCSS), as the collaborative applicant of the Southern Nevada Homelessness CoC, continues to pursue activities in the areas of Monitoring, Facilitation, Compliance and Coordination. Under Compliance, the CoC will continue activities towards strong reporting and data analysis in various arenas of the CoC. This includes measuring racial disparity and inequities in service access, continuously improving coordinated entry for all subpopulations, performing gaps analysis, and evaluating and refining the Southern Nevada Regional Plan to End Homelessness. To best serve this effort, CCSS has employed a Data Analyst that will oversee some of these activities, and analyze data from various sources towards aligning, measuring, and evaluating the activities of the CoC. This includes measurement of efforts towards ending homelessness per the new Federal goals provided by USICH.

Under Coordination, CCSS will continue educating the community and its stakeholders via the HelpHopeHome.org website and newsletter. The website advertises activities of the Southern Nevada Homelessness Continuum of Care (SNHCoC) Board and its Working Groups. This includes information on what the SNHCoC is, available funding opportunities, upcoming events including volunteer opportunities, and resources available to assist those currently experiencing homelessness. The newsletter summarizes noteworthy highlights and upcoming community events, such as the local CoC Competition and community trainings. CCSS also provides evidence-based best practice training and capacity-building experiences for providers towards equal access, coordinated outreach, mental health first aid, affinity to housing first, trauma informed care, critical time intervention in service delivery, or practices of housing problem solving towards standardization of case management practices in service delivery. There is also the provision of funding to those with lived experience who participate in Board and related activities that impact the CoC.

This project would also include Project Monitoring activities to include monitoring of projects funded through the CoC and ESG to evaluate outcomes and performance. Creation of monitoring policies and procedures enhanced oversight of the performance and heath of funded projects. A neutral agency is providing the monitoring and technical assistance on an annual basis. CoC Application Activities are also implemented that includes neutral facilitation of the local application process. This will include annual evaluation of project applications, scoring, ranking, and assistance with development of the recommendations to HUD.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Upon notification of award, CCSS staff will work to continue contracted activities for activities listed under Coordination, Project Monitoring, and CoC Application activities. Compliance will be able to continue as we retain employment of the Data Analyst. CCSS staff will work with local partners to determine suitable and qualified technical assistance vendors available to provide expertise during the period of the grant. During the time period between notification of award and receipt of the executed agreement, staff will work with the Southern Nevada Homelessness Continuum of Care Board (SNHCoC) Planning Working to assist in selection of vendors in anticipation of up-to-36 months of service delivery. Staff will work within County and State statutes and procedures towards securing qualified vendors to deliver the services. Staff will work closely with selected vendors on setting and meeting reasonable timelines, receive regular reporting from vendors on completion of tasks, review vendor invoices prior to payment.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The CoC is conducting ongoing evaluation of projects through its Monitoring Working Group. This working group oversees a 3rd party vendor to conduct annual monitoring of CoC and ESG projects. This activity will provide continual feedback to agencies and the SNHCoC Evaluation and Monitoring Working Groups on areas needing technical assistance for improvement, as well as assist in determining if lower performing projects need to be reallocated in subsequent competitions. Monitoring and evaluation activities are also ensuring that the project scorecards are measuring the most relevant data elements and outcomes to determine project quality. This enhances the ability of SNHCoC Evaluation and Monitoring Working Groups to make data-driven, outcome focused funding decisions, therefore improving the CoC's ability to fund and provide high quality, high producing, and effective homeless service projects. This performance improvement will also meet the needs of our community by reducing the length of time persons experience homelessness and reduce the recidivism rate of those returning to homelessness. With the assistance of capacity building and coordination activities under this planning grant, organizations will be able to improve the quality of their service delivery funded by the CoC and ESG by participating in training and group technical assistance.
