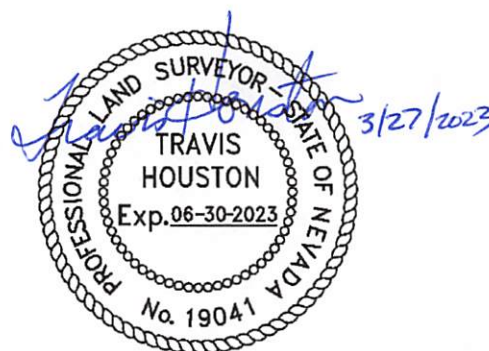

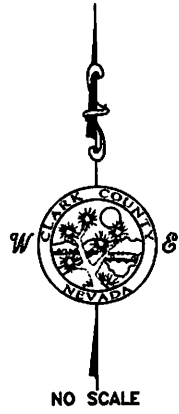

That portion of the North Half (N ½) of the Northeast Quarter (NE ¼) of the Northwest Quarter (NW ¼) of Section 26, Township 19 South, Range 60 East, M.D.M., Clark County, Nevada, more particularly described as follows:

**BEGINNING** at the southeast corner of said North Half (N ½);

Thence North 88°24'56" West, along the south line of said North Half (N ½), a distance of 40.00 feet;

Thence North 1°10'19" East, departing said south line, 76.54 feet, to the beginning of a curve, concave southwesterly, having a radius of 14.50 feet;

Thence northwesterly along said curve, through a central angle of 48°23'02", an arc length of 12.24 feet, to the beginning of a reverse curve, concave easterly, having a radius of 51.00 feet;

A radial line from said point bears North 42°47'17" East,

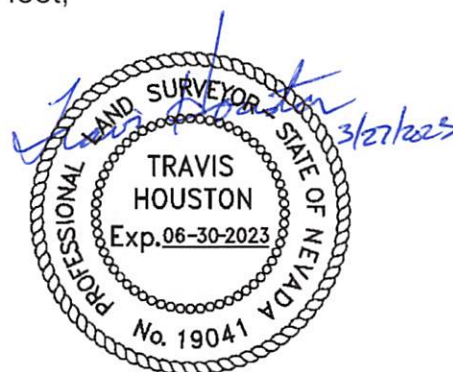
Thence northerly and easterly along said curve, through a central angle of 150°50'27", an arc length of 134.27 feet, to a point on the east line of said North Half (N ½);

Thence South 1°10'19" West, along said east line, 175.60 feet, to the **POINT OF BEGINNING**.

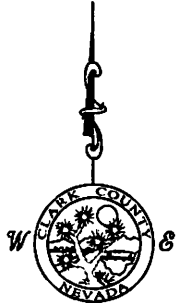
