SUMMARY – An emergency ordinance extending the effective period of Clark County Ordinance Number 4799, adopted by the Board on August 4, 2020 as an emergency, and amended by Ordinance Number 4829 adopted on November 17, 2020, imposing a temporary cap on delivery fees and other service charges imposed upon restaurants by third party food delivery services, through the effective period of the Governor’s March 12, 2020 Declaration of Emergency regarding that pandemic.

AN EMERGENCY ORDINANCE EXTENDING THE EFFECTIVE PERIOD OF CLARK COUNTY ORDINANCE NUMBER 4799, ADOPTED BY THE BOARD ON AUGUST 4, 2020 AS AN EMERGENCY, AND AMENDED BY ORDINANCE NUMBER 4829 ADOPTED ON NOVEMBER 17, 2020, IMPOSING A TEMPORARY CAP ON DELIVERY FEES AND OTHER SERVICE CHARGES IMPOSED UPON RESTAURANTS BY THIRD PARTY FOOD DELIVERY SERVICES, THROUGH THE EFFECTIVE PERIOD OF THE GOVERNOR’S MARCH 12, 2020 DECLARATION OF EMERGENCY REGARDING THAT PANDEMIC; AND PROVIDING OTHER MATTERS RELATED THERETO.

Whereas, on August 4, 2020, the Board of County Commissioners passed an emergency imposing a temporary cap on delivery fees and other service charges imposed upon restaurants by third party food delivery services; and whereas that ordinance was amended on November 17, 2020; and

Whereas, the ordinance as amended was set to expire February 1, 2021 unless expended by the Board; and

Whereas, the conditions fiving rise to the emergency ordinance continue to exist and have

in fast worsened;

NOW, THEREFORE, the Board does hereby ordain as follows:

SECTION ONE. Clark County Ordinance Number 4799, adopted by the Board on August 4, 2020 as an emergency and amended by Ordinance number 4829 adopted on November 17, 2020, imposing a temporary cap on delivery fees and other service charges imposed upon restaurants by third party food delivery services, shall remain in effect through the effective period of the Governor's Declaration of Emergency issued March 12, 2020.

SECTION TWO. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION THREE. This ordinance shall be published thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks, and shall be effective immediately upon passage by the Board.
