



A fifty-six year resident of Southern Nevada, John J. Delibos was an early arrival to the Las Vegas community in 1959. Having moved from Wisconsin with his parents, he attended elementary school at Red Rock and Rose Warren, junior high at Gibson and Garside and high school at Clark. After completing his secondary education, he attended Cornell, graduating with majors in: Political Science, German and Education and minors in: French and Dance.

After graduation he followed in his father, John S. Delibos' footsteps into the gaming business; first with Sam Boyd at The Union Plaza Hotel, next with Major Riddle at The Silver Nugget Casino and, finally, for eighteen years at The Riviera Hotel; first for Ed Torres and then for Meshulam Riklis. In 1986 Mr. Delibos started Concepts In Design---a firm that provides commercial and residential construction services. His projects have taken him to: La Jolla, California; Reno, Nevada; Park City, Utah; Cedar City, Utah; Atlantic City, New Jersey; Cabo San Lucas, Mexico and Washington, D.C. His commercial and residential projects have garnered widespread recognition and have appeared in industry publications.

Currently Mr. Delibos is involved in a high-profile project on the Las Vegas Strip, is working with Construction Attorney, Noah Allison, on a mass transportation company to relieve the employee traffic congestion in the resort corridor, as well as, working with several private clients in Las Vegas and Denver, Colorado.

Mr. Delibos is in his tenth year as President of Imago Dei, the diocesan chartered, LGBTQIA+ ministry representing the Roman Catholic Diocese of Las Vegas and based at The St. Thomas Aquinas Catholic Newman Center @UNLV. He has performed for the past four years in the Guardian Angel Cathedral Choir, has been a soloist @St. Joseph Husband of Mary Roman Catholic Church and is a third and fourth degree Knight of Columbus. He is President of The Stonewall Democratic Club of Southern Nevada and was a county and state delegate to the 2016 Democratic Convention. He was again appointed for the fourth year to the Community Development Advisory Commission (CDAC); has just been reappointed to a two year term on The Winchester Town Board where he's served for the past five years, having been elected last year to a two year term as Chair; is a member of Regional Transportation Commission's Citizen Advisory Committee and is serving on the board that is rewriting Title 30 for Clark County. He is a member of The Nevada Preservation Foundation and had served for a number of years at The St. Rose Dominican Health Foundation.

STATEMENT OF INTEREST




I am grateful to be considered for this appointment and, if selected, would be honored to serve.
