

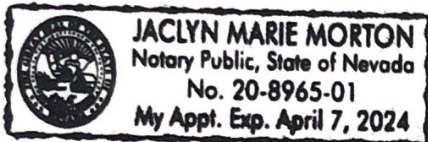

Dear Ms. Walpole,

I write to you and the esteemed Clark County Commission today because of my interest in being appointed to represent District 10 in the Nevada State Senate. Please find my resume and application attached. I have been a resident of District 10 for close to ten years and have a long history of serving this constituency. First as political director and special assistant to Congresswoman Dina Titus (NV-01) to most recently representing District 5 on the Nevada System of Higher Education Board of Regents. Public service is a calling and the opportunity to give back to my community during these unprecedented and challenging times is both an honor and privilege that I do not take lightly.

In Senate District 10 I have strong relationships with the community because I have worked side by side with them for many years. This district has rich and diverse cultures: from the thriving Hispanic community and growing AAPI community that enrich the Las Vegas Valley, to the small businesses that strengthen our economy. Constituents in District 10 have been hit hard from the pandemic. Working families are struggling to keep a roof over their head and food on the table, students are falling through the cracks at alarming rates due to the digital divide, and small minority owned businesses are shutting their doors unsure how they will reopen. If I am lucky enough to represent District 10 in the Nevada State Senate I promise to use my voice and be an advocate for the people I represent every day. I am committed to working with stakeholders so together we can heal and recover from these difficult times, and come out of the current public health, social, and economic crises stronger.

Home means Nevada for me, my longtime partner Andrew Woods, and our treasured shelter pets Lacey and Samara. I attended the Clark County School District from kindergarten to graduating with honors from Sierra Vista High School. While my mom worked the graveyard shift in the service industry on the Las Vegas Strip to provide for her family she encouraged me to become the first in the family to graduate from college, where I earned a bachelor's degree in political science and master's degree in public administration from the University of Nevada, Las Vegas (UNLV). I continue to take classes in the evenings as a student of UNLV's public affairs doctoral program.

Cutting my teeth in politics working as a community organizer for a presidential campaign, I later spent a decade working for Congresswoman Titus on her political campaigns and serving in her Congressional Office for Nevada's First District. There I helped with constituent service outreach and policy issues ranging from gender equity to healthcare, and from immigration to education. That experience demonstrated to me how public servants can be effective in helping their constituents directly, while shaping public policy problems into solutions that profoundly impact people's lives.

After working in politics and government I wanted to learn the business side, too, and in 2018 I joined IGT's public affairs department. Working for a large employer in Nevada has provided me a deeper understanding of gaming, manufacturing, and economic and workforce development. In addition to my job duties I chair the company's philanthropic Las Vegas Leadership Council and serve on the executive committee for their Women Inclusion Network.

Governor Steve Sisolak appointed me to represent District 5 on the Board of Regents after the passing of my friend and public servant Sam Lieberman. During my time on the Board I saw up close the hardship people are going through due to the pandemic. I fought for stronger protections for victims of sexual violence and discrimination, I advocated for commonsense solutions to cut wasteful spending and invest public dollars back into the classrooms without putting the burden on students, I successfully intervened when I heard several college students were going to be evicted from campus housing, and I worked with struggling students who were fearful of losing scholarships. I am proud of the work I did while on the Board of Regents and will bring that same passion, determination, and dedication to doing good as a state senator.

Making a difference through community service was instilled in me early on. I try to give back, as the late Sam Lieberman would say, by giving my time, talent, and treasure to causes that help people succeed, especially those most vulnerable and underserved. With the rise of food insecurity many are facing I volunteer to deliver food for Three Square, Battle Born Progress's food pantry, and Delivering with Dignity. I also strongly believe that education is the pathway to the American Dream which is why I am active with organizations working to elevate mentorship and increase access for students; I am a founding member of Million Women Mentors of Nevada and serve on the Public Education Foundation's board.
