

## Statement of Purpose

I am applying to be nominated for the Nevada State Senator seat for District 10, currently held by State Senator Yvanna D. Cancela. Senator Cancela has successfully represented Clark County and its constituents well in the State Senate focused on opportunity for all residents and immigration reform, given her prior experience as a community organizer and work with the culinary union.

2020 has been a catastrophic year for all residents and citizens of Clark county, with the economy drastically devastated by the Covid-19 Pandemic. Unemployment has reached an unspeakable peak of over 34% in 2020, and it is only with the hard work of the Governor, the state legislatures, as well as the County Commission, that residents have been able to survive with the limited resources and aid that have been provided.

If I am picked as State Senator, I will leverage my experience and relationships to work with the Governor and State Legislature to turn this vision into reality, bringing much needed employment and financial relief for my fellow residents and constituents.
