As our state emerges from the economic turmoil of Covid 19 it is more important than ever that we look at smart government and find ways to produce more revenue for social programs without increasing taxes. The demand for a state lottery is high and if properly introduced this could be a great opportunity to fund important programs like education.

3. Improving the DMV & DETR

We spend a lot of money funding our state agencies but they don't deliver the level of

service our citizens deserve. The technology currently being used by our DMV and DETR and other state agencies falls behind other more technologically advanced states. Just looking at the DMV for example the online interface in the state of Florida is light years ahead of what's currently being offered in Nevada and that is just one example.

- 4. Represent the needs of poor, minority, and disadvantaged families, immigrants & hourly workers
- 5. Promote Nevada Tourism & Bring More People to our State
- 6. Strengthening & raising awareness regarding consumer protection resources in the state
- 7. Contributing to efforts targeted at ending human trafficking, elder abuse, and the waste of taxpayer dollars through mismanagement, corruption & fraud.
