Reference GIR-21-18- BUDGET MODIFICATIONS			
Required Changes: Modify contract to reflect additional funds granted through DCFS in the amount of \$97,937, and adjustment of budget categories to reflect anticipated actual expenditures. Personnel is decreased due to partial vacancies during recruitment. Unexpended personnel and additional funding will be utilized to enhance existing services to Clark County youth ages 14-20. Increased services include transportation, driver's education, tutoring, expansion of FAAYT, on-line individual development, and will fund additional stipends for youth who have aged out of care or are participating in an IL agreement to provide financial assistance during the economic recovery period. Stipends will not exceed 30% of the grant per Chafee regulations. This also funds one additional Family Services Supervisor and purchases equipment for Step Up staff.
