

**AMENDMENT NO. 2  
RFP NO. 604763-18  
INMATE TELEPHONE SERVICE**

**THIS AMENDMENT** is made and entered into this 1st day of April 2020, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and SECURUS TECHNOLOGIES, LLC (f/k/a Securus Technologies, Inc.) (hereinafter referred to as "PROVIDER").

**WITNESSETH:**

**WHEREAS**, the parties entered into an agreement under RFP Number 604763-18, entitled "Inmate Telephone Service" dated November 20, 2018 (hereinafter referred to as CONTRACT); and

**WHEREAS**, the parties desire to amend the CONTRACT.

**NOW, THEREFORE**, the parties agree to amend the CONTRACT as follows:

1. Paragraph 5, Page 1  
Originally written:

WHEREAS, PROVIDER has the personnel and resources necessary to accomplish the SERVICE within the required schedule and with a minimum annual guarantee of \$2,500,000, including all travel, lodging meals and miscellaneous expenses; and

Language as Modified:

WHEREAS, PROVIDER has the personnel and resources necessary to accomplish the SERVICE within the required schedule and with a minimum annual guarantee identified in Exhibit A, page A-19, Paragraph E as revised in this Amendment No. 2, including all travel, lodging, meals and miscellaneous expenses; and

2. Exhibit A, Scope of Work, System Overview, Page 1  
Originally written:

The total average daily population for all three facilities ranges from about 3,800 to 4,200. The Clark County Detention Center holds about 3,000 inmates, the North Valley Complex holds about 1,100 inmates and the Tucker Holding Facility generally holds fewer than 5 inmates. The average length of stay varies but is generally about 25 days. The facility books about 165 arrestees per day and the historic call volume is about 1.1 million calls per month. Inmates are currently allowed 7 free phone calls while in designated booking areas.

Language as Modified:

The total average daily population for all three facilities is approximately 3,000. The Clark County Detention Center holds about 3,000 inmates, the North Valley Complex holds about 1,100 inmates and the Tucker Holding Facility generally holds fewer than 5 inmates. The average length of stay varies but is generally about 18 days. The facility books about 165 arrestees per day and call volume is about 110,000 calls per month. Inmates are currently allowed 7 free phone calls while in designated booking areas.

Original Language:

The PROVIDER, upon execution of this CONTRACT, shall pay to COUNTY \$46,450 annually or actual annual costs for Victim Information Notification Everyday (VINE) program in addition to the percentage or minimum annual guarantee amount for each year of the CONTRACT. First VINE payment would be payable in February of each year that the CONTRACT will be in effect.

Revenues paid to the COUNTY shall not have been offset by any taxes, fees or license charges that may be levied, assessed or charged by any governmental entity or PROVIDER or the COUNTY.

PROVIDER, upon execution of this CONTRACT, shall pay to COUNTY \$46,450 annually or actual annual costs for Victim Information Notification Everyday (VINE) program. The payment for VINE Program is in addition to the Minimum Annual Guarantee amount for each year of the CONTRACT. First VINE payment would be payable in February of each year that the CONTRACT will be in effect.

\*Revision above results in \$425,701 reimbursement from COUNTY to PROVIDER for the period of April 1, 2020 through December 31, 2020.

Revenues paid to COUNTY shall not have been offset by any taxes, fees or license charges that may be levied, assessed or charged by any governmental entity or PROVIDER or COUNTY.

This Amendment No. 2 represents a reduction to the minimum annual guarantee and reimbursement of \$425,701.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
