BACKGROUND:

On June 15, 2021 the Clark County Planning Commission held a public hearing on an amendment to the Clark County Trail Map - Las Vegas Valley of the Clark County Comprehensive Master Plan, and after taking appropriate public testimony, adopted and forwarded the amendment to the Board of County Commissioners for consideration at their July 7, 2021 meeting at which time the Board of County Commissioners adopted the amendment.

Staff recommends that the Board of County Commissioners authorize the Chair to sign a resolution amending the Comprehensive Master Plan by adopting an amendment to the Clark County Trail Map - Las Vegas Valley, and direct staff accordingly.

**RESOLUTION
OF THE CLARK COUNTY BOARD OF
COMMISSIONERS ADOPTING AN AMENDMENT TO
THE CLARK COUNTY TRAIL MAP – LAS VEGAS
VALLEY OF THE COMPREHENSIVE MASTER PLAN**

WHEREAS, the Clark County Board of Commissioners (hereafter referred to as the Board) may adopt long-term master plans for the physical development of the unincorporated portions of Clark County, Nevada as specified by the Nevada Revised Statutes, Chapter 278; and

WHEREAS, on June 15, 2021 the Clark County Planning Commission did adopt an amendment to the *Clark County Trail Map – Las Vegas Valley* of the Clark County Comprehensive Master Plan and forwarded a copy to the Board for their consideration; and

WHEREAS, on July 7, 2021, a public hearing was held by the Board in accordance with Nevada Revised Statute 278.220 regarding the Comprehensive Master Plan;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners:
That the Board does adopt and amend the *Clark County Trail Map - Las Vegas Valley* by:

PA-21-700001 - Amending the *Clark County Trail Map – Las Vegas Valley* of the Recreation and Open Space Element of the Clark County Comprehensive Master Plan by removing the existing equestrian trail alignment on Belcastro Street between Pebble Road and Agate Avenue; and adding new equestrian trail alignments on Pebble Road between Tenaya Way and Belcastro Street, and on Tenaya Way between Pebble Road and Agate Avenue.
