


ARPA and Other Federal Funding

Previous Use of Federal Funds as of January 2021

- CARES Act passed in March
 2020
 - Allocated \$150 billion to state and local governments
 - Total of \$31.7 million in rental assistance funds awarded to Clark County
- Clark County received and allocated over \$275 million in federal funding

Total Dollars through December 30, 2020 in millions





Key Outcomes of Previous Uses of Federal Funding

Financial Assistance

- 16,000 households received rental assistance
- 63,400 utility accounts paid
- 1,300 eviction mitigation referrals
- 314 evictions mitigated

Basic Needs Assistance

- 2.1 million meals/food to individuals and households
- 5,200 distance learning services
- 4,400 households provided rent and/or utility assistance
- 5,900 individuals and households provided counseling services
- 248 individuals provided shelter services



Key Outcomes of Previous Uses of Federal Funding

Congregate Care

- 4,200 bed days provided
- 358 individuals sheltered
- 180 medical services provided
- 12,600 meals provided
- 100% occupied as of December 31, 2020

Emergency Leasing and Shelter

- 48,800 bed days provided
- 760 individuals and households housed
- 290 medical services provided
- 146,400 meals provided
- 105% occupied as of December 31, 2020



About the American Rescue Plan Act (ARPA)

- ✓ Signed into law by President Biden on March 11, 2021
- ✓ Provides \$1.9 trillion in funding over the next several years to help the US recover from the COVID-19 pandemic
- ✓ Clark County to receive **\$440 million** from ARPA over the next two years
 - ✓ First interim report due August 31, 2021



More Uses are Authorized in Qualified Census Tracts (QCT)




- Half (50%) or more of households with incomes below 60% of the Area Median Gross Income <u>or</u> a poverty rate of 25% or more
- Expanded uses of ARPA funding within QCTs
 - Address Educational Disparities
 - Invest in Housing and Neighborhoods
 - Promote Healthy Childhood Environments

Public Health Impacts of COVID-19




- ✓ Cases declining since peak in December 2020, but recent rise as of July 2
- ✓ As of June 28, 2021, population age 12 and over were 43.53% vaccinated



Unemployment

- Unemployment rate has been declining since March 2020, but not yet to pre-pandemic levels
- Unemployment rate reached more than double the national rate in Spring 2020 and is still higher than the national rate
- Clark County has lower average weekly wages than national average
 - U.S. = \$1,339
 - Las Vegas Area = \$1,141
- Tourism business in Las Vegas is returning quickly, with major organizations like Cirque du Soleil resuming operations this summer










County Poverty Rate by Education Level







Housing Overview
