# SECOND AMENDMENT TO CONCESSION AGREEMENT BETWEEN

### DOUGLAS PARKING LLC AND CLARK COUNTY

This Second Amendment t	to Concession Agreement ("Second Amendment") is entered on this
day of	2021 ("Effective Date") by and between Clark County, a political
subdivision of the State of Nevada	("County"), and Douglas Parking, LLC ("Contractor"), collectively
known as the "Parties".	

WHEREAS, Contractor entered into a concession agreement ("Agreement") with Clark County on June 20<sup>th</sup>, 2017 to operate a valet parking service located at the garage of 330 S Third Street Las Vegas, NV 89101 ("Premises"); and

WHEREAS, on March 13<sup>th</sup>, 2020 Governor Sisolak declared a Declaration of Emergency in the State of Nevada due to public health event COVID-19; and

WHEREAS, On March 15<sup>th</sup>, 2020 the County Manager of Clark County declared a State of Emergency which provided certain emergency powers ("Clark County DOE")

WHEREAS, on March 20<sup>th</sup>, 2020 Governor Sisolak ordered all non-essential businesses to cease operations; and

WHEREAS, Contractor ceased operations at the Premises on March 19<sup>th</sup>, 2020 and their revenue stream has been severely impacted;

WHEREAS, on June 2<sup>nd</sup>, 2020, the County and Contractor entered into a First Amendment to Concession Agreement ("First Amendment") which provided for a abated rent and extended the term of the Agreement subject to any Options to Renew, as defined in the Agreement; and

WHEREAS, the Agreement is set to expire August 31<sup>st</sup>, 2022 ("Expiration Date") with no remaining options to renew; and

WHEREAS, the Parties desire to amend the terms of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants and agreements herein contained, the Parties agree the Agreement shall be amended as follows:

- Contractor shall resume operations and all duties outlined in the Agreement at the Premises upon the Effective Date.
- All unpaid Rent from March 19, 2020 to the Effective Date of this Second Amendment, shall become null and void.
- 3. Contractor shall pay to County as Rent on a monthly basis in arears at a rate of fifty percent (50%) of any gross revenue received by Contractor. Gross Revenue shall be defined as any revenue received by Contractor through the valet operation of the Premises, minus any labor expenses incurred by Contractor. The Contractor shall provide to the County a Gross Revenue statement, as defined above, along with the Rent payment no later than the 15<sup>th</sup> day of each month following the month of valet

- service beginning on the Effective Date of this Second Amendment. This shall continue in effect through the Expiration Date of August 31, 2022. The obligations of Rent hereunder shall survive the expiration or earlier termination of this Agreement.
- 4. Any provision of the Agreement and First Amendment not amended or deleted by this Second Amendment shall remain in full force and effect.
