# AMENDMENT NO. 1 RFP NO. 603986-16 CONTRACT FOR MEDICAL SERVICES FOR DEPARTMENT OF JUVENILE JUSTICE SERVICES

#### WITNESSETH:

**WHEREAS**, the parties entered into an agreement under RFP Number 603986-16, entitled "Contract for Medical Services for Department of Juvenile Justice Services" dated July 26, 2016 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Section I, Page 1, first paragraph

#### ORIGINALLY WRITTEN:

COUNTY agrees to retain PROVIDER for the period from August 1, 2016 through July 31, 2017, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VIII herein.

#### REVISED TO READ:

COUNTY agrees to retain PROVIDER for the period from August 1, 2016 through July 31, 2017, with the option to renew for four (4), one-year periods and an 8-month extension on a month-to-month basis, subject to the provisions of Sections II and VIII herein.

2. Exhibit A, Scope of Work, Page A-2, Article 1, Healthcare Care Services

#### ADD:

- 1.0.7 Trained Spring Mountain Youth Camp personnel shall coordinate and distribute medications to COVERED PERSONS as medically necessary, when trained medical personnel are not on shift. Trained Spring Mountain Youth Camp personnel shall comply with all documentation requirements to include when a medication was not administered and the reason therefor.
- 3. Exhibit A, Scope of Work, Page A-5, Article II Health Care Staff, 2.1 Staffing Levels

#### ADD:

2.1.1 COUNTY and PROVIDER agree that the staffing for Spring Mountain Youth Camp will require conversion that will cost the COUNTY an additional monthly fee as shown in Attachment A2.

- 6. The revisions contained herein are effective as of August 1, 2021.

This Amendment No. 1 represents an increase of \$760,988.32.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
