THIS AMENDMENT is made and entered into this ____ day of _____ 2021, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and J AND J ENTERPRISE SERVICES, INC. (hereinafter referred to as "SUCCESSFUL BIDDER").

WITNESSETH:

WHEREAS, the parties entered into an agreement under Bid Number 604679-17, entitled "Annual Requirements Contract for Asphalt Concrete for Las Vegas, Laughlin, and Moapa Valley Area" dated February 6, 2018 (hereinafter referred to as CONTRACT); and
