The Fire Investigation Division is requesting four laptops for the Division. The laptops requested are four Dell XPS 15. The four laptops will be provided to the on-duty, shift investigators (2), the day shift investigator (1) and the Assistant Fire Chief, Fire Investigation Division (1).

Why does your organization need the requested funding?

When investigators arrest a suspect, they bring him/her to the Clark County Detention Center (CCDC) for booking and processing. In the past, the investigators used common desk top computers that were provided by CCDC for the booking. Since COVID, CCDC has removed the common computers and has all police officers complete all their paperwork via their in-vehicle computers. Our units don't have in-vehicle computers that will allow us to write the declaration of arrests or the myriad of other required reports. With the purchasing of the four laptops, one for each response vehicle, the investigators will be able to comply with the new regulations at CCDC, while protecting themselves from additional exposure to COVID-19.

How will funding enhance your current/future fire prevention, pre-incident planning or investigation efforts? Recidivism is a recognized aspect in arson crimes. By arresting suspects who intentionally set fires, we have the possibility of reducing future arsons that might be committed by the individual. Additionally, with an active arson enforcement program, the word might spread that committing an arson in the county will be met with harsh criminal prosecution.

What is the expected impact funding will have within your community, both immediate and long-term? By purchasing the computers, the immediate impact will be additional suspects being arrested, booked and eventually prosecuted. This will lead to fewer arson incidents. When a commercial business is damaged or destroyed by fire, the business may temporarily and/or permanently go out of business. This effects the tax base for the municipality that is affected, in this case, Clark County. By reducing arsons, more businesses and residences will be operational, which increases the tax revenue generated.

What other relevant information do you believe will support the need for funding?

This funding is, in part, a direct effect of the pandemic. Due to the seriousness of the virus, and thus the pandemic, the safety of the investigators is paramount. This is the reason that the CCDC closed their booking stations. These laptops will provide much less exposure of the investigators to the suspects they have arrested.
