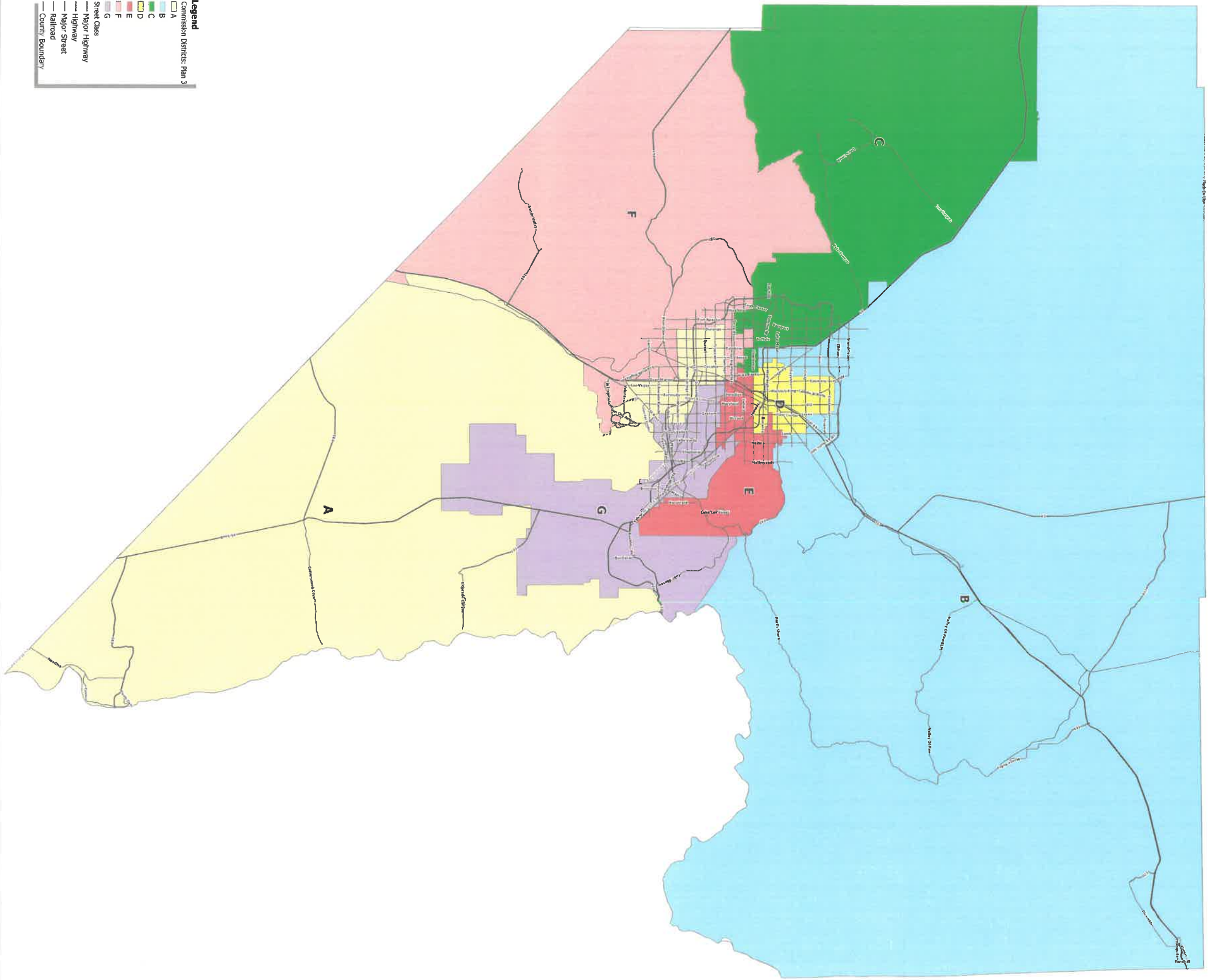

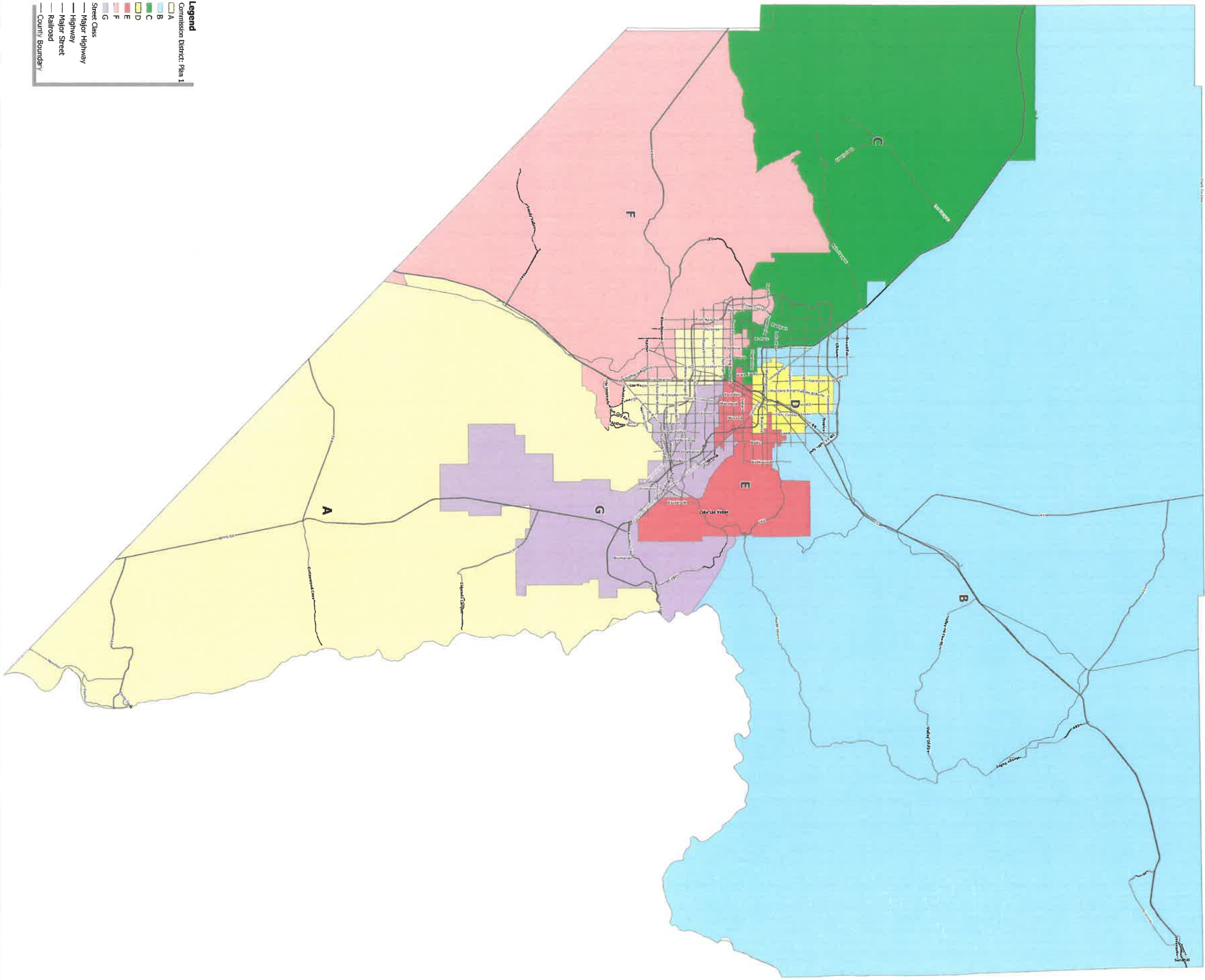

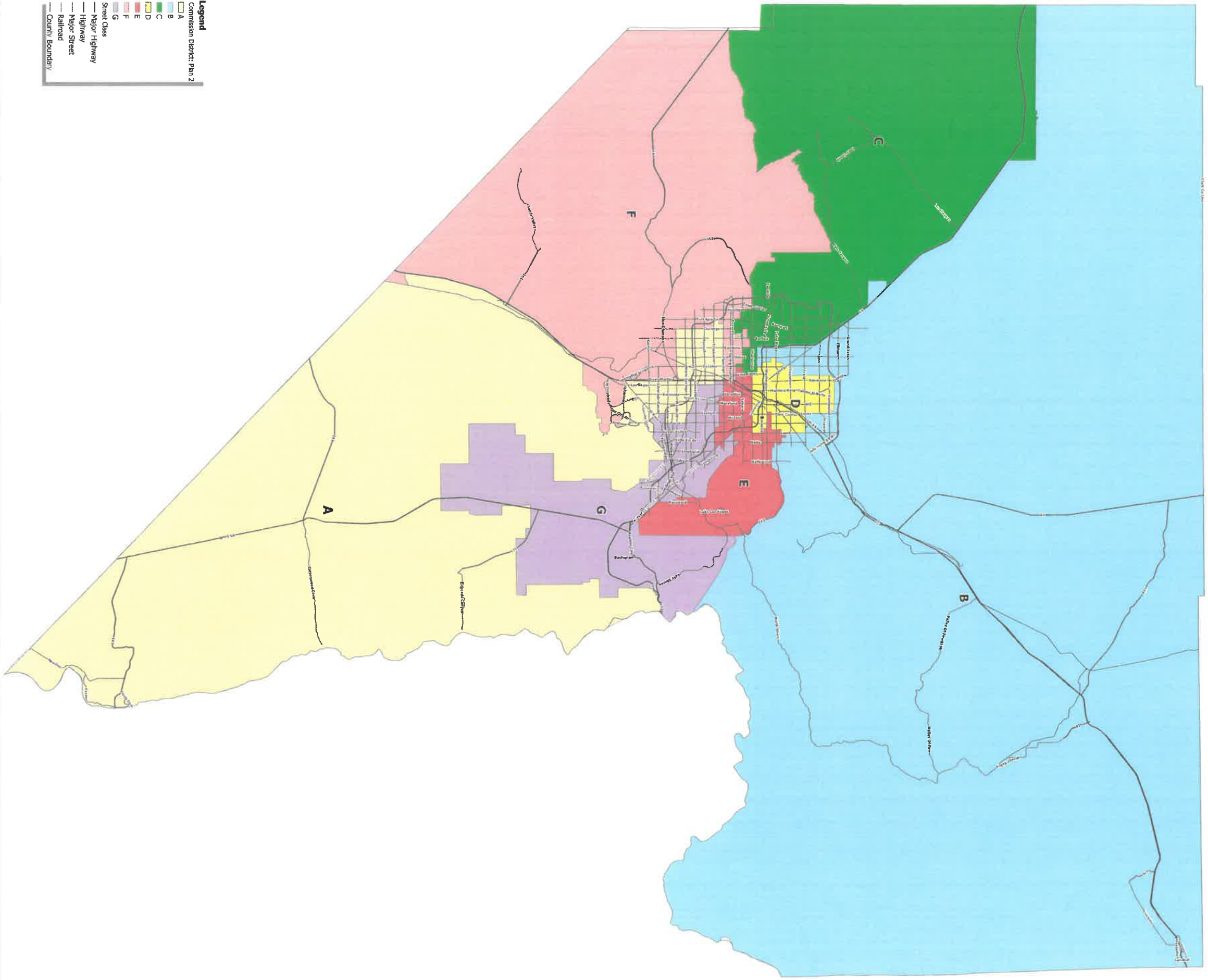
Exhibit 1, Redistricting Plan 2

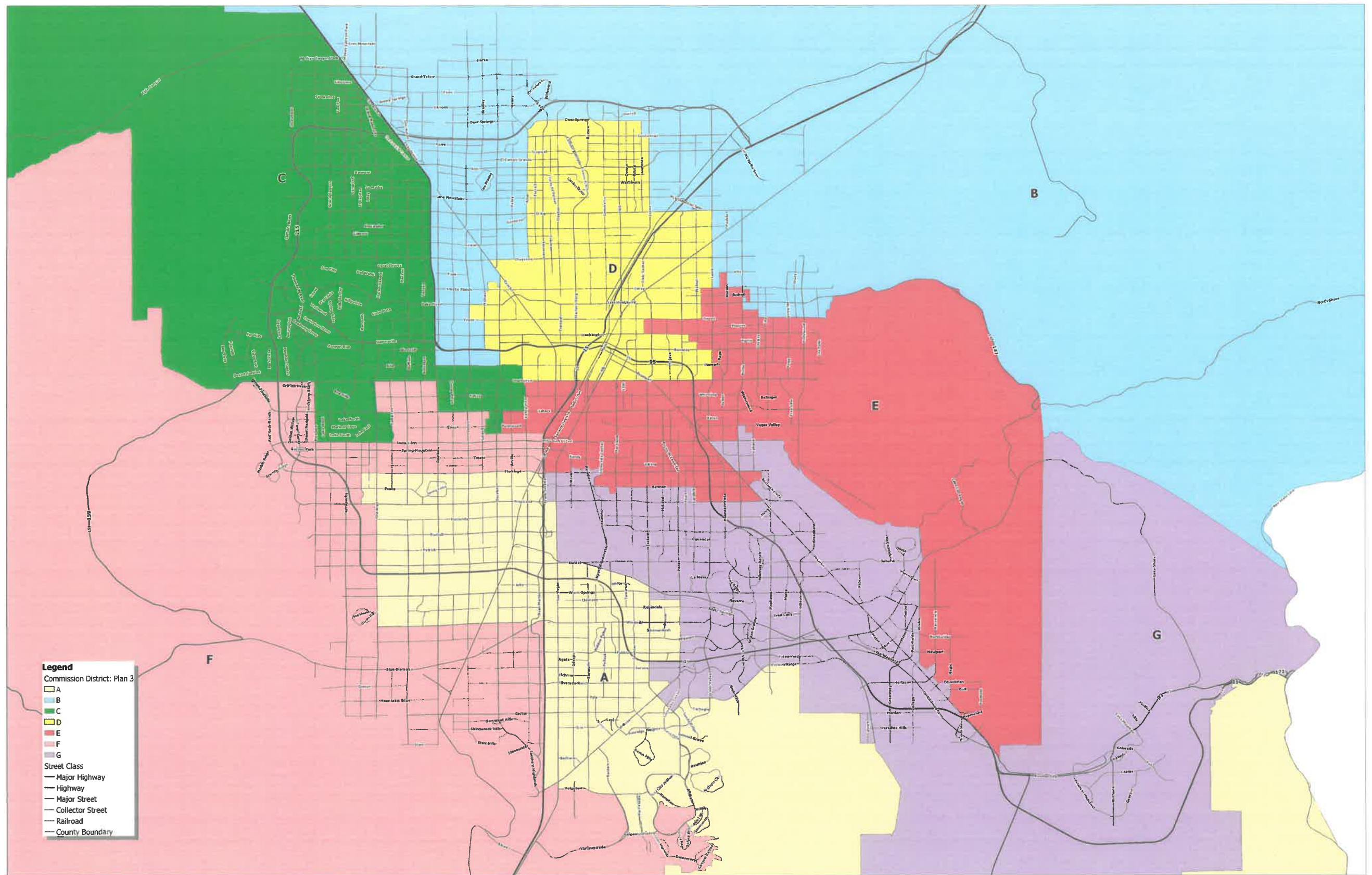

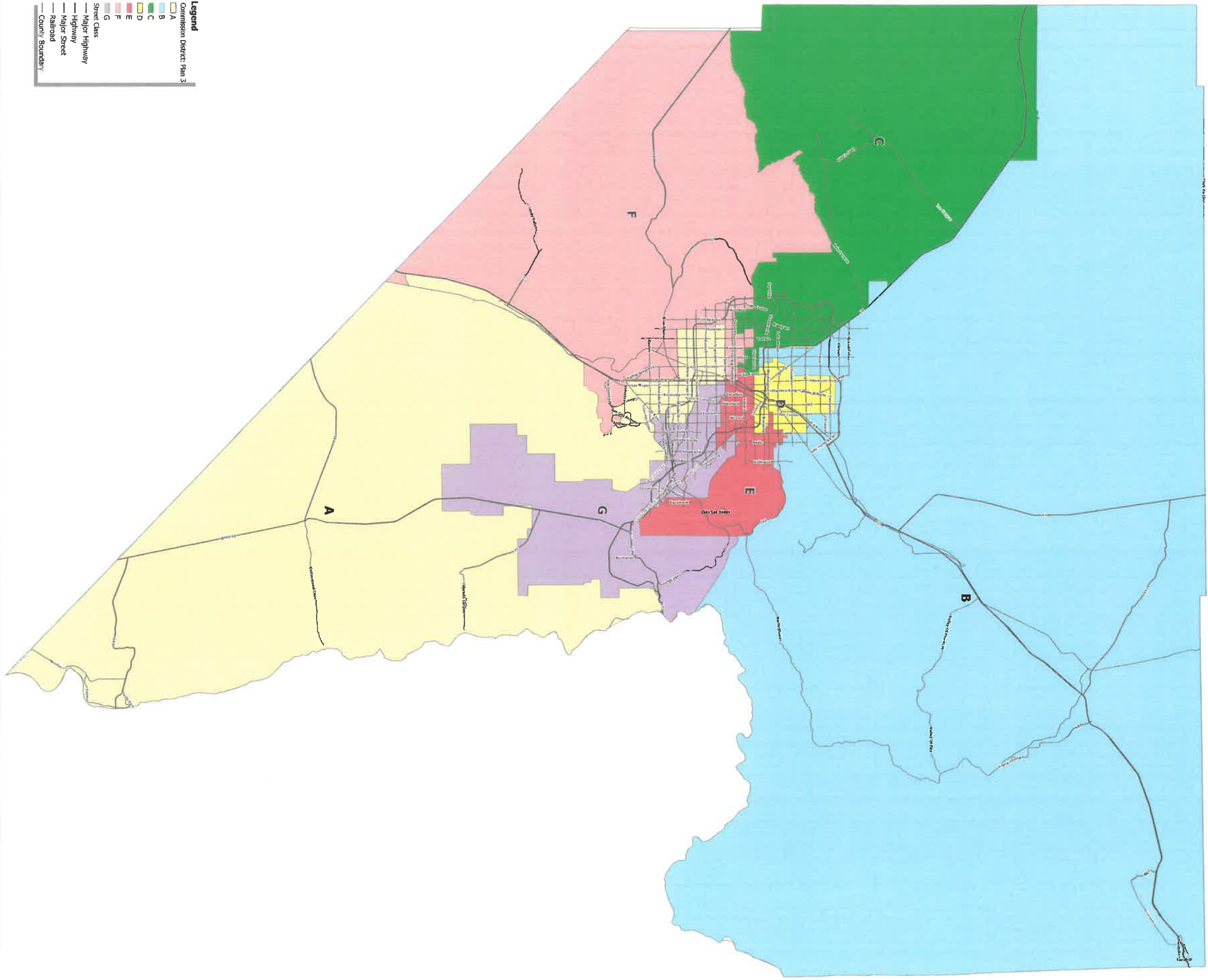
