### **BACKGROUND:**

On November 2, 2021, the Clark County Planning Commission held a public hearing on an amendment to the Transportation Element (Map 1.3) of the Clark County Comprehensive Master Plan where they adopted and forwarded the plan to the Board of County Commissioners for consideration. On November 17, 2021, the Board of County Commissioners adopted the amendment.

Staff recommends that the Board of County Commissioners authorize the Chair to sign a resolution amending the Transportation Element of the Comprehensive Master Plan, and direct staff accordingly.

WHEREAS, the Clark County Board of Commissioners (hereafter referred to as the Board) may adopt long-term master plans for the physical development of all unincorporated portions of the Clark County, Nevada as specified by the Nevada Revised Statues, Chapter 278; and

WHEREAS, on November 2, 2021, the Clark County Planning Commission (hereafter referred to as the Planning Commission) did adopt an amendment to Map 1.3 of the Transportation Element of the Clark County Comprehensive Master Plan and forwarded a copy to the Board for consideration, and:

WHEREAS, on November 17, 2021, a public hearing was held by the Board in accordance with Nevada Revised Statute 278.220 regarding the Transportation Element;

NOW, THEREFORE, BE IT RESOLVED that the Board does adopt and amend the Clark County Transportation Element Map 1.3 (Las Vegas Valley – Southwest) by:

1. PA-21-700003 - Amending Map 1.3 of the Transportation Element of the Clark County Comprehensive Master Plan by removing a portion of an 80 foot right-of-way (Grand Canyon Drive), between Pebble Road and Ford Avenue in Enterprise.
