Hello, my name is Alex Harper, and I am honored to be able to apply for such a position. I officially became a resident of Nevada in early 2018, but I first familiarized myself with Clark County back in 2015, when I got my first contract as an avian biologist at a solar facility near Primm.

Back in 2016, I became involved with Red Rock Audubon Society, the local chapter of a national organization that aims to engage citizens through birdwatching and a shared desire towards grassroots solutions for localized issues. I began as a volunteer trip leader, but am now currently working out an agreement with the organization to lead their education and outreach initiative. I would do this through my LLC, Nature in Mind, which I created to help me create legitimate nature-based programs for kids and young adults.

As for my work with wildlife, it is quite varied. I have dabbled in avian and desert tortoise work in all of the SW states, and am now fairly familiar with policy on USFS, BLM and NPS lands. I am fortunate to have spent five summers and several falls in Alaska as a natural history guide and interpretive naturalist, where policy is so intertwined with the dayto-day lives of the state's populace. In Alaska, I've befriended many outdoorsman and anglers, most subsistencedriven, with some for sport.

Because of my passion for wildlife, wild places, smart conservation policies, and a compassionate approach to people, I believe that I'd be a great addition to this team. I am ready to help shape Clark County's future for three years, should I
