WILLIAM MCCURDY II

Uh - thank you, Mister Chairman. Uh - it is my honor and privilege to recognize the greatest fraternity known to mankind, Kappa Alpha Psi Fraternity Incorporated – uh - for their service to our community. Um - Kappa Alpha Psi was founded as Kappa Alpha Nu on January 5th, 1911 by 10 African American college students, and those 10 were Elder Watson Diggs, more affectionately known as a dreamer, Doctor Ezra D. Alexander, Byron Kenneth Armstrong, Henry Tourner Asher, Marcus Peter Blakemore, Paul Waymond Caine, George Wesley Edmonds, Guy Levis Grant, Edward Giles Irvin and John Milton Lee.

Kappa Alpha Psi has over 1 - 160,000 members with undergraduate and alumni chapters in every state of the United States, including international chapters in over six countries. Kappa Alpha Psi sponsors programs providing co - community service, social welfare and academic scholarship, and is a supporter of the United Negro Fund and the Habitat for Humanity.

Locally, the Las Vegas alumni chapter sponsored events like Gobble for Good, Shop with the Kappa, Kappa Derby, just to name a few. The Las Vegas alu - alumni chapter of Kappa Alpha Psi Fraternity Incorporated was chartered in September 1964 and was the first national Black Greek letter society branch on the college level to be established in the State of Nevada. When I - when I went there to Jo Mackey 50 years ago, you could see that the area was becoming neglected and run down and, and almost abandoned. And today, it's vibrant and you see the Pearson Community Center and you see the other things that are being done there and it's just wonderful to see that our community is - is being looked after as an entire community and not just select areas. So, again, Commissioner McCurdy, thank you so much.

ITEM NO. 3 Recognize the Human Trafficking Awareness Task Force and proclaim January Human Trafficking Awareness Month in Clark County.

Item 3 is to recognize the Human Trafficking Awareness Task Force and proclaim January Human Trafficking Awareness Month in Clark County.

MARILYN K. KIRKPATRICK

Um - thank you - uh - Mister Tarr. January - um - is proc - uh - Human Trafficking Awareness Month here in Clark County, and this year we really wanna highlight - uh - many of the things that are going on - um - in our community, as well as reminding people what resources are available - um - out there. So, it is my pleasure to recognize January as the National Human Trafficking Awareness Month. The time to raise awareness, educate our community on how they can prevent and respond to human trafficking, and it does happen right here in our own neighborhoods.

So, just a reminder that you should always know and be asking your children, your neighbors, your friends. And it's not just young girls anymore unfortunately. It's young boys, too. Uh - so we wanna remind people that – um - it's anybody and everyone and it never hurts just to ask how people are doing or what they're doing. Um - there is a video, but it's rather long, five minutes – uh - Commissioner. So, maybe we could just put it on the website – uh - instead. Unless you all want to hear it. Um - but just a reminder that if you believe that you are a victim of human trafficking ... We've done a lot of work. So, when I was in the Legislature, Commissioner Jones and I, we passed legislation to put signage up in bathrooms, at truck stops and all kinds of different places. And now at the airport we'll be increasing our signage.

Um - as we have these big events come, we want everybody to know that not only are we working hard to protect our community, but all of the tourists that – um - come forward. So, I'm gonna let Commissioner Gibson speak and then we'll invite some folks up that work really hard – um - to ensure that – uh - people know where to go, the resources are available, and so we'll invite them up in just a minute.

Thank you, Commissioner. This is an important time for us to reaffirm our commitment to protecting and empowering survivors of human trafficking in our community. We are responding at Clark County. Uh - the responsibility for child survivors of sex trafficking found within Clark County – uh - is the responsibility of the Department of Family Services, our local child welfare agency, and in preparation, Clark County – uh - has made large investments of resources in building our programming to best ne - meet the needs of these children.

Our strategic plan is focused on system improvements in areas of prevention and training, identification and response and the CSCC Continuum, Continuum of Care. In addition to prior year's investments in training staff and innovative programming, Clark County is pleased to announce three new programs that will focus on building Clark County Child Sex Trafficking Continuum of Care and ensure access to appropriate housing and treatment for these youth.

Today, Clark County is awarding four million dollars of Clark County Recovery

Funds to Saint Jude's Ranch for Children to support the Healing Center, which will be a first of its kind residential center which will include housing, on-site therapy and

an on-site school. Saint Jude's broke ground on the Healing Center in October of this past year and the Healing Center is expected to open in the summer of next year. Uh - I was there and participated in the groundbreaking and there is broad community support for the Saint Jude's program and its facilities.

In February, Clark County also anticipates the approval of funding to support two specialized foster homes to house and support these youth prior to the opening of the Healing Center and to create other options for these youth once the Healing Center opens. So, there is an awful lot that we're working on and that we're doing. Lots of funds have been committed to support the activities of Clark County, but we can never do enough and we encourage the entire community to learn what the indicators are and to keep their eyes open and you see something, you say something. Commissioner.

Thank you, Commissioner Gibson. And I don't see all of the folks that are on my list, but if you're filling in for someone, just come on up. So – um – uh - Deputy Chief Fred Haas from Metro. I don't see him. Okay. Captain Roberts. Okay. Britney, I don't wanna butcher your name, Hobble from Sign - Signs of Hope. Ginger Land-Van Buuren from SHERO Foundation. And I know we have other task force members, and if I could just have them stand, that would be great. So, if you're other task force members. So, we have a lot of different tasks force. It's a really important issue and we wanna celebrate a lot of progress that we made.

Back in the 80s, this was something that you couldn't talk about. And today, we do talk about it to ensure. So, good morning, who wants to be my speaker? Okay.

UNIDENTIFIED SPEAKER

Thank you so much for recognizing — uh - this important day and backing all of the work that we do through the taskforce. It's been amazing to work alongside the community and everyone up here with us to make sure that we — uh - do everything we can to eradicate human trafficking here in Las Vegas. So, throughout the month of January, it is — uh - National Human Trafficking Awareness Month. Uh - look into the websites. Check out the videos. Do what you can to educate yourself and be part of the task force here. Thank you.

KIRKPATRICK

Thank you. And so, on behalf of Clark County Commission, January is declared as Human Trafficking and – uh - what I encourage people to do, as you notice, we have little blue – uh - ribbons on, please we – uh - wear a blue ribbon to signify so that people know that you're a safe person that they can come and talk to. Have folks call 911 in the event that they think they're in that situation. Um - and never be afraid to ask. It doesn't matter. We talk to ... I talk to my six-year-old granddaughter about it – uh - because the earlier you can get them to be aware of their surroundings and so that they don't get caught up in something that they really weren't – um - trying to do, is really a responsibility of our community pulling together.

The great thing about this task force, I don't wanna speak for all y'all, but it's - uh - kind of a passion of mine - uh - that I work on the side because there's a lot of little, little girls and today, unfortunately, a lot of little boys that get caught up in it that don't realize - uh - how that works. Uh - but this is a real community partnership. Metro's always been a big part of it because we need the officers and the detectives to be able to go in and sift through the information to make sure that we can - uh - put the bad folks away, but it takes a private sector and the public to just be engaged and ask those questions.

So, on behalf of Clark County, thank you for what you do $-\,\text{um}$ - and know that

MARGARET ANN COLEMAN

Good morning, and Happy New Year. All of you happy? Well, I'm not. My sister passed away, and as you know, you held me up. I could not see her due to the fact my income is in your control that I've been trying to receive. This lady here, that is Sue what's that – um - I can't pronounce her last name. Um - Boonhome. Anyway, you know how. Um - she is the Controller...

Well, as you know, you haven't set ou – uh - information concerning attorneys and people that is controlling our State with you and having professional – uh - input. They also are destructors of my living arrangements due to the fact they are important people. Not that they earned it. Because of theft and the conspiracy – uh - with Shannon Mulhughes. I have been in their presence.

My name is Margaret Ann Coleman and as I say, Happy New Year to myself as well. Let's take – um - a minute here and concerning the passing of my sister, Gertrude Marie Williams. She's to be buried on the 17th of January. I'm as a whistleblower here due to the fact you have created discrimination against my equal rights to be a receiver and a resident in the State of Nevada as a citizen and a working class who is entitled. To be a productive citizen, to be res- to be able to be a receiver t- upon my workman's comp and my pension. Due to the fact of trying to be a part of the seat of the Board of Commissioners and be productive during the time of 2001 to this point here.

Do you have a check for me? Because I have to move on. I gotta go out of town. I need money. I call each one of you. Do you have a key? I need to go indoors, get out of the streets. Due to the destruction of you programming the people and the citizens, she's sleeping outside. Since I've been here, I've been a working class citizen. I worked in 12 casinos. You have created co- programs for the homeless party that support that shelter. As you know, places you have sent me are not up to par. They're all Covitus-19 [COVID-19] to get sick. And you have, and taken my - my equal rights to have. I have pictures of a house that I have chosen and want you to pay for it. Do I have more minutes?

GIBSON

If you ch - please, just wrap it up, Miss Coleman.

COLEMAN

COLEMAN

As you know, I've been placed out here to do this up on your part and be - doing public comments to speak upon my living arrangements and to receive and get my reimbursement from you due to the fact you did not give me the seat. My name is Margaret Ann Coleman. My daughter and I need to go to a better place to live. I want my house and my money. Thank you.

GIBSON

Thank you, Miss Coleman.

COLEMAN And Happy New Year. Do you have a donation to give to me?

GIBSON Thank you, Miss Coleman.

DOCTOR SONDRA **COSGROVE**

Uh - good morning. My name is Doctor Sondra Cosgrove. First name is S-O-N-D-R-A, last name is C-O-S-G-R-O-V-E. My address is 917 Apache Lane, 89110. Um today I'm here to speak in favor of agenda Item 56, and that's the creation of a Community Education Advisory Board. Um - I support the creation of this because I think civic engagement and direct democracy are really important in our state, and we need more Nevadans being engaged so they know what's going on. But I'm also here because I'm a professor at the community college. And I'm telling you, I've been there for 20 years, what's going on at CCSD is getting worse, it's bad, we've got to do something. And so if we're gonna just throw everything in the kitchen sink, then this is probably a good first step. Thank you.

GIBSON Thank you.

DIANA WALKER Good morning and happy New Year.

GIBSON Thank you.

WALKER My name is Diana Walker for the record. Um - I'm here in favor of Item Number 56,

it's also the CAB agenda item. In this spring, I will be... um - I will have had the opportunity to serve on the Moapa Valley CAB for 10 years. And I'm here to tell you how I've seen our CAB transform into the crucial education resource that it's become today. CCSD has not always been able to recognize or provide the services and support that our rural area - area has desperately needed. As CAB can rapidly identify local or community needs and institute real time support and assistance directly to the schools and students instead of resources being filtered through time consuming bureaucratic processes. Resources go right where they are needed when they are needed. How have we done this? Through vital community partnerships. Our CAB partners with our local schools, Clark County Parks and Rec, even our extension 4-H and Moapa Valley Rotary. The list goes on and on. We consistently meet with and involve all of our school administrators and parents. Basically anyone who wants to support education in Moapa Valley, we want to work with you. We work within our bylaws to form subcommittees to take on larger scale local projects and pro - programming.

And – um - the pandemic is where we actually realized and recognized new potential for the expanded scope of CAB capabilities. For just a few examples of what we've done, we were able to offer free student tutoring and – uh - parent Canvas trainings, thanks to our partnership with John Stastny at Clark County Parks and Rec, Ca - and Carol Bishop at the UNR extension 4-H office. Uh - we are - offer tutoring at three separate locations for over seven months. This tutoring gave hope to many of our students who were suddenly thrust into the online hybrid learning model. A quick note, at the beginning of this school year, I received an email from one of my child's schools that said that CCSD was now offering free tutoring – um - for CCSD

students, which is wonderful, but we were doing that two years ago. And I think we can all agree that on issues like education or mental health, our kids and communities cannot afford a two-year turnaround in response.

Speaking on mental health, during the last two years, our CAB was able to work with our partners and offer two community mental health resource – um - fairs. Um - we work closely with our partner at the UNR extension 4-H and their team leadership core, who Commissioner Kirkpatrick is familiar with, where - and she's been still supportive of us, and we're grateful for that. We were able to have assemblies at our middle schools, high schools and companion evening events – uh - with resource booths and mental health resources for our rural area. We were able to raise thousands of dollars and provide much needed rural mental health support, and we were able to reach over 2000 members of our rural community. And in our small community, that's a big impact.

How did we work with the funding? Well, since CAB is not a 501(c)(3), we utilize our nonprofit partnerships – uh - the Moapa Va - Valley Education Foundation, sometimes the Moapa Valley Booster Club. This ensures fiscal transparency and gives us checks and balances.

So finally, what can a CAB look like in Clark County? Oh, can I just have

GIBSON Sure, please finish.

WALKER Um - well in my opinion, it has two roles. Of course, we advocate for our schools

and community with CCSD. But CAB is so much more than just going to meetings and writing letters. Um - the second role is also to pinpoint local student and community needs and act in real time and step up, roll up our sleeves, and work to

bridge the CCSD service gap. Thank you.

GIBSON Thank you.

KIRKPATRICK Mister Chairman, while Mister Gonzalez is coming up, can I just - I wanna point

something out to her. Um - she talked about the mental health, and under emergency issues I'm gonna have Miss Frierson talk about some additional resources, right?

ABIGAIL FRIERSON Yeah.

under emerging issues, so you have a little while. (laughs)

Okay, Commissioners, Item 7, we don't do this too often, thank you for giving staff a little bit of extra time this morning. We're gonna hand out to you – uh - the chart of Board appointments that we keep throughout the year. Um - on this chart - uh you'll notice that the – uh - Chair and Vice Chair is left blank. The only other changes from the last year appointments is Ross Miller will be on the Family and Juvenile Justice Service Policy and Fiscal Affairs, and on Liquor and Gaming License, it is William McCurdy.

With that, I'll read the agenda item. In light of the - the way that this form has been prepared, there's no recommendation as to the Chair and Vice Chair. We should take those separately. It looks like everything else – uh - conforms to the discussions that have been had in terms of the briefings. Uh - is that correct?

That is the recommendation of staff, yes.

Okay, so the - there would - it would seem to me then, unless someone has a different view, that we could take a motion and deal directly, exclusively, with the Chair and Vice Chair of this Board, after which we would take a motion to do all of the rest of it at - per the handout that we've been provided. And are the - do these constitute then the recommendations of the staff for purposes of the motion we would make?

Yes.

GIBSON Except for the open one, which is the Chair and Vice Chair?

That would be correct.

Then I'll entertain a motion. Commissioner Kirkpatrick.

We're – we're making a motion just for the Chair and Vice Chair at this point? KIRKPATRICK

GIBSON Yes, it's a separate motion.

TARR No, I thought you were making a motion for the entire list except for Chairman and

GIBSON Well, I think what we'll do, I think what I said was we'll do the Chair and the Vice

Chair -

KIRKPATRICK That's clarifying.

TARR Okay.

KIRKPATRICK Uh - so I would make a motion for Commissioner Gibson and Commissioner Jones

to be the Chair and the Vice Chair.

GIBSON Any discussion on the motion?

JONES Mister Chair?

GIBSON Yes.

JONES Um - I - I wanted to clarify – uh - with regards to the Chair and Vice Chair position,

according to our – uh – our - our handout that we have here and also according to the rules of procedure handbook that was adopted in - in 2018, the term of the Chair and Vice Chair – uh - is a two-year term to be elected at the first meeting in January after

an election year. Um - so I - I guess, I - I need to understand from the - the movement – uh - is this a motion to – uh - appoint the Chair and Vice Chair for a

term of two years?

GIBSON One year.

JONES Okay. Um - so that would be varying what's – uh - stated in the – in the rules and

procedure handbook? Okay. Um, I- I- I just wanted to clarify on the record, because quite frankly there's been some miscommunications amongst the Board – uh - with regards to what the terms are of - of the Chair and Vice Chair – uh - over the last two election cycles. Um - by voting today on a one-year term, that will require, again – uh - if we vote in one year and then again one year, and if we're talking two years,

then we'll have to vote again in one year. Is that- is- is that the intent?

KIRKPATRICK So, well I'm gonna back up here because I kind of screwed this whole thing up, and

not on purpose, because COVID was a mess. Um - but I served on this Board when we were handed our Boards that we were - were allowed to sit on, and there was only one Chairman – um - for a long time. So I - when I became the Chairman, I want - I think everybody on this Board should have an opportunity to be the Chair. I just think that it's not all that it's cracked up to be, you don't get anything extra out of doing it, you probably have less life, right, because you gotta always do things. So I – um - did two years, and then we were in the middle of COVID, so I did an

additional year, and this Board gave me an additional year. During that time, people asked, would now then everybody wanna do three years? And I said, "No, I think

KIRKPATRICK

everybody should do two years." Um - and so Commissioner Gibson, we voted for him for one year. I do think we have to change the policy to get back on track within the procedures, but my thing was everybody should serve two years. And ironically, when I was the Chair, I didn't get to do anything that I wanted to do (laughs) because I was so focused on COVID.

So, I think that it should be two years, every person, and if we have to bring a subs - a follow up – um - agenda item, which I think that we do, to do that, but it should be for a one-year term, and I've con - I've conveyed that to Commissioner Gibson and anybody else that's asked. And I said that to you, Commissioner Jones, two years ago that that's what I thought, and I stand by my word.

SEGERBLOM

Well, so, Mister Chair, can I -

GIBSON

Commissioner Segerblom.

SEGERBLOM

Just to follow up, I-I-I do support the motion with the understanding that this for is for one year. Um - my understanding is even though we're voting on a two-year term, the – we – the - we can basically pull somebody back at any time. But I would ask that we have staff, we direct staff to change this policy so that going forward, it'll be two years starting next January, that will be the - the rotation going forward – um - because I think everyone should have two years – um - in order. This – if - if this motion's approved – uh - Commissioner Gibson would have one more year, so that would fulfill his two years, but this - my understanding is this is - that's what this is, this is a completing his two-year term – um - and going forward, each of us would have an opportunity to serve two years.

KIRKPATRICK

I guess, are you okay with that Commissioner Gibson?

GIBSON

Well, I-I-I never intended to try and stretch it out. I'm-I-uh - felt at the time that I was - um - doing what was in the best interest of the Board and the community by e - extending Commissioner Kirkpatrick's service for a year. Uh - I was elected a year ago but imagined that that was the tail end of the two-year term. Uh - I acknowledge that - um - this is a little different because now we've got a situation where we can do an election for two years, I guess, if that's what the pleasure of the Board is. But I'm seeking only, and - uh - expect to be elected to one more year - uh - so that I serve two years. Now, if it turns out that we can't do that without first changing our policy, then I guess the - the legal question is, can we, in the motion for - uh - approval of - or the nomination, effectively - um - can we also include a change to that policy? And that's a question of whether there was adequate notice. If there wasn't adequate notice and we can't do that, then the motion would have to be for a two-year term.

LISA LOGSDON

Commissioner – um - your – your Board rules do require the - the Chair to be a two-year term, but so you could do the motion for a two-year term and then we can just, you know, you would step down at, you know, the end of... and we'd redo this again in January. Um - or you could – um - you can amend your... Um - we would have to bring a different agenda item back to amend your Board rules – um - but you can – um - you could deviate from these rules – um - with a motion – um - clarifying that it is going to be for a one-year term.

GIBSON

So, at a minimum, we need to bring something back to accommodate whatever the mess is that's been created.

LOGSDON Correct.

KIRKPATRICK Thanks. I feel good about that. (laughs)

GIBSON So – um – what - what other discussion is there? Commissioner Naft?

MICHAEL NAFT Thank you, Chairman. I - I guess I would just offer, we - this is a perpetual cycle w -

we will continue to be in, I'm not sure any of that's been addressed here or will be addressed – uh - by changing the policy to one year. Because, one, I don't think it's a good, from a policy perspective, it's probably not good habit to be out of cycle with elections. You'll have new Board Members coming, I- I don't think that's realistic. But – uh - nonetheless, it's certainly not my intention to support more than - more than a year's term – uh - extension, because that, as my history recalls it to me – uh - that was the understanding, that there would be – um - a continuation of the Chair's term, we would all agree to have – uh - rotating Chairman – uh - and people would get on a - a two year cycle. Um - so I'm not sure that anything that's just been suggested remedies that. Um - but I do think it's important that the record reflect it.

KIRKPATRICK May I ask a question – um - of the attorney? So, I know, but why can't we just – um -

redo the two-year cycle? Um - you know, get the date back on track, right? Because then - then, I mean, two years, I think everybody here agrees t - it's a two-year term. And look, hey, at some point, maybe somebody wants to keep the same person for a long time. I just, I - I didn't – um - I think everybody deserves an opportunity. So what is the easiest way without... I don't wanna do one-year cycles because you need stability for this Board going forward for everything else, and honestly, all the other committees that we sit on. Um - and I don't want it to be a campaign nightmare, right? Um - so how do you just get us back on track. It... Wouldn't we just, couldn't

we just... We can always bypass our own rules wi - with a motion, right?

LOGSDON Yeah, I think your motion would just be for a one-year term and then knowing then -

KIRKPATRICK Which is what we did last time for me -

LOGSDON Which is what you did last time.

KIRKPATRICK ... an additional one year.

LOGSDON And then in 2024 it would be a two-year term -

KIRKPATRICK A two-year cycle.

LOGSDON - so that we can be back on cycle.

TARR Commissioners, if I may. Um - what Commissioner Naft pointed out is the election

starts with a two-year term on the odd years following the election, if there were appointment next year, there's not an election of new incoming, so how do you get back on a cycle? And I don't know that- how you do it — uh - without additional one year or the next term would be a three year, or the cycle becomes where it's out of

sync with the election, and that's what Commissioner Naft is pointing out.

KIRKPATRICK Yeah, but the election changed as well, right, for the cities and everybody else, so

we're - this is not a new thing. I mean, everybody had to readjust because the cities, they went five years without - I mean, I - here's what... My motion is for one year – um - for Commissioner Gibson and Commissioner Jones. And then I guess we figure

KIRKPATRICK

out how to get back, that's...

TARR

O-o - or do you accept that you don't have to get back and it will be out of sync with the election, but generally the Chair is someone who's been on here at least a term?

SEGERBLOM

I don't have a problem with - with having the election in the even year, I mean the odd year. I don't see why it has to follow... I - I actually think it's better to change it f - as - from - from the way it is now, where the people are elected and then they immediately pick a Chair, and give everybody a year to - to get into the mode, and then pick a Chair, which is what's gonna happen if we go to a two-year cycle after this year.

TARR

But with the direction for a motion, we can bring back the Board's rules and procedures with modifications that we're hearing today, and it may take a little conversation from the Manager's Office with you guys to get it right. But the motion that you have made is for a one year today.

GIBSON

So, it - just to be clear – uh - implicit in the motion is that the rule is – um - disregarded. In other words, so, do you have a legal problem with that?

LOGSDON

No, that's fine. Just make it clear that your motion is for a one-year term.

GIBSON

Alright, well that's been clear. What further discussion do we have? Commissioner Jones?

JONES

Mister Chair, I guess - um - I - I understand the motion, I guess my - my concern is if we - if we just keep varying the rules in order to maintain power, then it just creates more opportunities in the future for whoever it may be. I - I know that we got thi - this, not to criticize Commissioner Sisolak, that was the way he did things, but that's how we got here in the first place. And so, you know, since I've been on this Board, I've - I've - uh - I've looked for opportunities to - uh - to help others lead. My outgoing Planning Commissioner is now on the State Assembly. My outgoing CDAC member's now on the State Assembly. Um - and so I do hope that there will be opportunities, as I think was the intent, for others to actually step up and - and lead on this Board, and on - on other Boards.

Um - and I do also wanna just make it very clear, 'cause – uh - the chair position, I - I think, like you mentioned, Commissioner Kirkpatrick, you look at the rules here and - and the procedures that were adopted – uh - by the Board, including Chair Gibson and – uh - Commissioner Kirkpatrick, it makes very clear that the power of the Chair is to direct this meeting. There's no power to squelch another Board Member's ability to put something on the agenda, that is held by the County Manager. Um - there's no ability to – uh - violate open meeting laws in order to round up votes for a particular – uh - motion or agenda item. There's no ability to delay votes on items because the Chair may not agree with them personally. And so, I - I guess with that understanding – um - I will go along with whatever the Board decides today.

GIBSON

Is there other discussion?

SEGERBLOM

Can - can I just clarify? The reality is, if four of us vote to change the Chair, we can do that at any meeting, right?

LOGSDON I mean, I think you could always bring an agenda item back to remove somebody

from a - from a chair position, but it'd have to be agendaized -

SEGERBLOM Right -

LOGSDON ... prior to that. Like, we can always request -

SEGERBLOM - the reality is, it's four votes, and whatever – to whatever the term is. Alright, thank

you.

JONES M - Mister Chair, one - one last point. I know, as I understood it, when – uh -

Uh the proposed ordinance would amend Title 8, Chapter 8.20, the liquor license code to include spirit-based products and allowable for sale by certain licensees for on premise consumption only, and define spirit based products for any alcoholic beverage that is sell - sold and served in an original container wherein the alcoholic content does not exceed 17% by volume or 34 proof and clearly labeled as such. Definition is consistent with package beer and wine regulations, and will provide consistency as package beer and wine licenses also allow for s - the - the sale of spirit based products. This change will allow license types such as karaoke clubs, interactive sports facilities, billiard parlors, wine cellars and restaurants currently licensed to sell and serve beer and wine to expand to include the above described spirit based products for on-site consumption only. This will benefit businesses that are limited in space and unable to meet that minimum seating requirement in order to qualify for a liquor license to sell hard liquor. And finally, the establishment choosing - the establishments choosing to expand their selection to include spiritsbased products will not be required to submit any new applications or pay a fee. Thank you.

MCCURDY

Uh - this is a public hearing, is there anyone – uh - wishing to testify during this time period? Hearing and seeing no one else. We'll close the public hearing portion. And are there any questions from the members of the committee? Commissioner Kirkpatrick?

KIRKPATRICK

Yeah, thank you Commissioner – uh - or Chair McCurdy. Can I ask a question, though? So why - why are we doing this and what was the genesis? I mean, I get now that there's all kinds of crazy drinks out there, Trulys, Whiteclaws, whatever - those foo-foo seltzer drinks are. But how does – um - how... Wh- why are we doing this, or is there a problem that we're not aware? I mean, we - we just don't make a lot of liquor changes.

QUEANO

Uh – yes – uh – Commissioner. Vince Queano for the record. Um - well, the one is to... for allow consistency with package beer and wine spirits-based products, so when... so store, convenience stores, and other – uh - licensees with a package license, we... this package beer and spirits-based products, but then for the retail side, for on-premise consumption, it's only- only limited to beer and wine. Um - there are a lot of – um - restaurants that have been – um - expressing their frustration as they're only allowed to sell beer and wine because of the size of their location, and depending on... There's some high-end restaurants, certain types of restaurants that - that have a certain theme. For example – uh - it could be a margarita or some type of mixed drink that goes with the - with the menu, with the food items, and so this would just expand their - their menu. Still keeping it under that 17% or 34-proof, but just adding a nor - a little bit more variety to their beverage menu - menu.

KIRKPATRICK

And then, so how do we – how – here - here's what I - here's my concern is we have a lot of people who push the envelope. They go to the ver - bitter end. So how do we enforce that to ensure that it really is staying to the 17% and not all this other stuff?

QUEANO

Uh-yes so -um - it's... We - we wrote into the ordinance that it has to be in the original container that it came from -um - and it has to be labeled as such by the manufacturer. So -um - a licensee would not be able to mix their own beverages, just so we wouldn't be able to -to-um - to verify the alcohol content.

KIRKPATRICK

Th - thank you – um - Mister Chair, and I'm just trying to get some stuff on the record because when we were looking at old ordinances, in 1986, there was no discussion, so I just like to make sure that 40 years from now my grandkids will know the reasoning behind what we did.

MCCURDY

Uh - thank you. Are there any other questions or comments? Seeing none. Uh - we'll entertain a motion.

JONES

Make a motion to approve the ordinance.

MCCURDY

We have a motion for approval by Commissioner Jones, and we'll vote.

GIBSON Thank you. Good morning.

KELLY BLACKMAN Good morning, Commissioners. Happy New Year.

GIBSON Happy New Year to you.

BLACKMAN For the record, Kelly Blackman, Senior Deputy Chief for the Fire Department. This

morning we are asking to adopt – um - a new... some new sections into Title 13, Chapter 13.04 of the Clark County Code as – uh - Mister Tarr said to recognize FM Global Property Loss Prevention Data Sheets as prima facie evidence of compliance, revise the permit fee calculation methodology for some permit types, and include fire personnel and equipment costs for special events. The – uh - minimum permit fee is being – uh - changed to \$90 within Table 106-A, so that will be our min - minimum permit fee. And – um - \$540 minimum permit p - fee for special event types in Table 106-F. And then – um - we will be changing the special event – uh - apparatus standby fee from \$300 per hour to \$500 per hour in Table 106-G. We're also – um - streamlining and simplifying some things within the co - within the code – uh - to make it easier for our developers and contractors that are trying to do business with

Clark County. And I'm here to answer any questions that you may have.

GIBSON Thank you. Are there questions of – uh - the Chief? Do we have any questions?

There being none -

NAFT Oh, I'm sorry. I have - I do.

GIBSON I can't see. Okay.

NAFT Sorry.

GIBSON I see the light on your microphone now.

NAFT Thank you, Chair. Chief – um - just in Section 106-A with the line items being

deleted, what's an example of – um - something that would come in as a minimum fee? I just don't know what that would be. That would qualify for the \$90 fee.

BLACKMAN Any of the fire code permits that are required, such as -

NAFT Well, so anything?

BLACKMAN Uh - let me just... So – um - access gates – uh - floor finishing – um - filming, things

like that, that would come in.

KIRKPATRICK Commiss -

BLACKMAN Open flames and candles.

KIRKPATRICK I think Commissioner -

GIBSON (unintelligible)

KIRKPATRICK

Um, thank you, Mister Chair. I think Commissioner Naft – uh - what we had before was very complicated, so you never knew what your starting point was. It was all over the board, depended on the square footage, or this, or... So what they did is said... So there's a lot of fire prevention permits that are required, so when you put up electric gates at a HOA, we know for sure that it's gonna be \$90. That - that's... You get a fixed cost that you can count on, and then if you add all that other stuff – uh - then that's when your - your price changes. But we were not, one, keeping up with the cost of actually processing the permits, but, two, the community itself had no idea what to even set aside in their budget, so this was a way to get some basic fire prevention permits that you have to have sign off – uh - on with the basic – uh - starting fee.

NAFT

Okay. No, I support it. I think it's got to reflect our... (laughs) at minimum our costs, so I appreciate it.

KIRKPATRICK

Right.

NAFT

Thank you, Chief.

BLACKMAN

Previously, a lot of the costs were based on per device, so number of sprinklers, number of fire alarm devices, number of hydrants. Um - it made it difficult to estimate costs if there were changes by the developers or the contractors as they were doing design builds and things like that, so this - this is more along the lines of what the building department, how they charge per square foot, so it's a little bit easier to

BLACKMAN

figure out the fees.

GIBSON

Thank you.

BLACKMAN

Welcome.

GIBSON

Thank you very much. We'll... This is a public hearing. Is there anyone here who wishes to speak on this item? If so, please come forward. There being no one, the public hearing is closed. And I'll entertain a motion.

JONES

(unintelligible)

GIBSON

There's a motion by Commissioner Jones for approval. Any discussion on this motion? There being none, please cast your votes. Motion carries.

ACTION:

TARR

Item 56, conduct a public hearing and approve, adopt, and authorize the Chair to sign an ordinance to adopt a new chapter of the Clark County Code to establish the creation of Community Education Advisory Boards and provide for other matters properly relating thereto or take other actions as appropriate.

GIBSON

Commissioner Segerblom, I think you placed this item on the agenda.

SEGERBLOM

Yes -um - this is - is the early testimony was that - uh - this is already occurring in

SEGERBLOM

Moapa Valley, although, I guess – uh - informally. I know Henderson has one. Um – but – um - I think it'd be a great idea for my district – uh - in East Las Vegas and-and truthfully, it was... it's - it's a concept, so the - the details haven't been worked out, but this would allow us to create this - this kind of a structure.

GIBSON

Okay. So, the way that the language is drafted it says it permits the Board of County Commissioners to create Community Ed - Education Advisory Boards for any area in the County in which a local school precinct is located and which is not a city. And so, it - it sounds very much like it's... uh - it would facilitate district-by-district – um - boards

SEGERBLOM

That-

GIBSON

Is that what you have in mind?

SEGERBLOM

Yes, absolutely. And so - uh - if I thought - uh - of a great idea and the Board approved it that would not be binding on anyone else. (laughs) Um - they could create their own or they don't have to create one, but - um - just I - I felt - um - the - the last couple years we... that we've gotten out of our silos and if I can... if there's any way I can work with - with the schools in my district to help them out, as- as the person from Moapa Valley talked about - um - I just think it's a great idea.

GIBSON

Alright, thank you. This is a public hearing. Is there anyone here who wishes to speak on this item? If so, please come forward, give us your name, spell your last name for our clerk.

ED GONZALEZ

Um - thank you, Mister Chairman. My name is Ed Gonzalez. Uh - E-D. My last name, G-O-N-Z-A-L-E-Z. Before I speak, I do have some public comments for people who are unable to attend, especially educators since it's the first day of school, Mister Chairman. If I'm able to give this to staff.

SEGERBLOM

Could - could somebody -

GONZALEZ

Yeah.

SEGERBLOM

- grab those comments from -

GONZALEZ

Just to enter it into the public record. Thank you. Uh - Mister Chairman, like I said, my name's Ed Gonzalez. I'm the committee member of the Hickey Elementary School Organizational Team. Um - that's over in Sunrise Manor in the northeast part of Las Vegas Valley, next to – um - Sunrise Mountain High School. Um - I appreciate – uh - Commissioner Segerblom for bringing this forward. Um - I wanna read some of the... part of the comments that some educators who have been working with him onto this.

This idea... genesis of this idea was actually meeting with – uh - Commissioner Segerblom and saying, "How are there ways for the County Commission to be able to help on education?" As we know with AB 469, the CCSD reorganization law, it allowed for cities and coun- counties to be able to have more input into processes with the Community Education Advisory Board. As – uh - Commissioner Segerblom talked, there are three that – uh - currently exist. One in Moapa Valley, one in Mesquite, the Virgin Valley – um - CEAB, and then the one in Henderson.

And so, I wanna highlight at least some of the - the conversations that happened

GONZALEZ

previously 'cause this has been educator-driven. So my chair, Jessica Jones, at the institute, she mentioned in her letter, which I submitted to the record, "Back in September Commissioner Segerblom met with myself and other educators to listen about the needs of Lynch Elementary and other schools in his district. During this meeting, educators expressed a need for me - mental and behavior health services -"

UNIDENTIFIED SPEAKER

(unintelligible)

GONZALEZ

"... for our community and our schools. When it comes to education, often the east side gets overlooked and sometimes feels like our students and our families aren't represented or heard. During this meeting, Commissioner Segerblom made us feel like he was there to help and bring forth much needed change. Educators were part of how the conversation about the Education Advis – vis - Community Education Advisory Board started. We felt valued." And that's what this does. It allows for the input.

Um - since the reorganization when it passed at AB 469 in 2017, as you are aware, part of the sales tax can now be used for items such as workforce development, adult education, incentives to retain and to – um – to - to retain and to hire teacher- recruit teachers. And so, there's an opportunity for to have hear... to have commission to hear from schools if it chooses.

I - one area that I wanna highlight from Behavioral Mental Services, so in Henderson, they have a CEAB, so they had a presentation during COVID about mental behavioral services from the district similar to when they do their quarterly presentation here. Over where we're at, we're on the same block as Bailey Middle School and Sunrise Mountain, so there was a- a clinic there. It took us four years to try to get that open, and currently, it only serves one school, Bailey, in there. So we're next to them and we don't have the services of it because we weren't organized, but we fought for it.

Martinez in North Vegas was also gonna be part of the process. They weren't organized, no one fought for them, it wasn't, so there are many benefits to make sure that the community is involved and to help people out. So my time is low, I got three seconds left. Thank you, Mister Chairman. Thank you, Commissioner Segerblom.

Thank you. Are... Is there additional public comment on this item?

GIBSON

ED UEHLING

Yes. Uh - my name is Ed Uehling. Uh - I'm curious to know how this is going to be any different since the at - your attitudes are the same as the School District's attitudes, that everyone should work in the casino industry. We should give all the benefits to the ca - casino industry and to the Culinary Union, and that there shouldn't be any individual businesses, entrepreneurs should be crushed. Uh – uh – what – uh - what's going to be different? Uh - I know that when I went to high school in Boulder City – uh - we had a district – uh - right in the city – uh – where - where the – uh - the head of the schools was – uh - Mister Edwards right in Boulder City. And – uh - and then – uh - we had our own principal and all that, and I know that in – in – uh - my graduating class of 60 – uh - 60 kids – uh - three of them were national sch - scholarship winners. Three out of 60. Not me, I'll say that – uh - but (laughs) but – um – uh – uh – I - I'll bet – uh - I have the idea that there are barely three in the entire – uh – school – uh - school district of the... of Clark County today out of 300,000 students. Uh - and I'm wondering – uh – what - what is going to be different here?

Uh - it's... For - for me, it's proven - I- I recently looked at the rating of schools,

UEHLING

which Boulder City was usually in the pretty high ranking. Now it's rated 81st of all the schools in the worst district in the... one of the worst districts in the United States. And you even allowed the schools to be closed. You have no respect for – uh - students' learning. You don't want – uh - people to – uh - to excel or to do particularly – uh - particularly well, de – de - despite all the hoopla in – uh - in the – uh - the ear - early part of this meeting. So I'm wondering, how - how is this going to be different? What are you going to do? What – uh - what... How much authority you're going to have. When are the people going to be able to take charge of their schools?

Fortunately, we're seeing a movement toward – uh – toward – uh - charter schools, which are, in spite of their religious – uh - prejudices and biases and all that, are doing a much better job than the entire – um - multi-billion-dollar empire that's being created in Clark County since I graduated in 1958. Uh – it - it seems to be destroying education. So, I'm - I'm really curious to see... (laughs) to know how is this going to work?

GIBSON

ANNA BINDER

Is there anyone else who wishes to speak dur - during this public comment period?

Uh - good morning. Uh - my name is Anna Binder. A-N-N-A B-I-N-D-E-R. I live at 684 Finch Island. I do live out in Henderson and I do try to pay attention to our EAC as much as I can. Uh - during the pandemic – um - the City of Henderson came together and implemented a program I believe called "One Tree", which was – um - a mental – um - support system for the staff – um - and educators. Um - and our staff, as we know, needs all the support we can get.

Um - about a little over a year ago, I actually forwarded – uh - Commissioner Kirkpatrick – um - a very broad idea of what this Commission could do with - with an EAC. Um - and then over the past summer at the Joint Interim Education Committee – um - I asked them to explore why NRS 388-G provided the vessel for the EACs but no mechanism for access to accountability. As I stand in support of this item, we need to lobby with the legislature to, one, give jurisdictional EACs authority; two, ask the legislature to expand on NRS 388-G.500 to continue decentralization without further delay.

I look forward to watching this develop as it is in the best interest and benefic - and benefit to our community and our children's welfare. As many know, I am not a proponent of charter schools and private schools, as I am the mother to last year six kids in the district, three of which were special needs. We tried charter schools during the pandemic, but they – um - were insufficient in being able to accommodate my children's needs, and so we were basically forced back home until school reopened. At the time, I had my youngest was non-verbal, hid in his room the entire pandemic, and the only thing that he could say was, "Legend needs school." And I stood from that day forward and I fought to get schools reopened for him, and now he's a first grader. He's in the 71st percentile in reading, math because he got to go back to school because he needed school, and children like him needed school.

So-um - thank you guys for bringing this forward, and I do very much look forward to what we can make happen with it. Thank you.

GIBSON

Thank you. Are there others who wish to speak on this item? Then the public hearing is closed.

NAFT

Just a quick question.

GIBSON Yes?

NAFT Uh - just a quick question so I understand what we're voting for. Is the intention for

this to be a - um - a board that falls under open meeting law and held publicly?

LOGSDON Yes, it will.

KIRKPATRICK Yes. That's always... That's the way it's done in Moapa. Moapa Valley.

NAFT Okay. Thank you.

GIBSON So, Commissioner – uh - Segerblom, you - or excuse me, Commissioner Kirkpatrick,

you had a couple questions.

KIRKPATRICK I have two questions. Um – so – uh - Lisa, this - so in Moapa Valley it works 'cause

it's all, like – um - Bunkerville, Moapa, Logandale, and - and it was formed and kinda been working, but so what do... So, does this preclude – um - you... a commissioner having two? Because then I have other parts, which I'm gonna point out to Hickey Elementary – um - you know, that's in my district, and so is Bailey.

And I did fight for that medical center to be open, but the principal won't call me

back to do things and we do several things in about 50 of our schools. So does that preclude us from having more than one? And is there a report that they're gonna give us so that we can bring them forward? I'd much rather hear from these committees

than the report that we get every quarter.

GIBSON (laughs)

KIRKPATRICK

KIRKPATRICK Just sayin'.

GIBSON You wanna hear something?

LOGSDON So, this – this -

KIRKPATRICK That's the legislation we need to fight for is to get rid of that report.

LOGSDON This ordinance just provides you the framework, and so in the ordinance, each

commissioner can bring back a resolution kind of creating more of what you're talking about. Setting up how many members, what areas, and so yeah, a commissioner, depending on their district, could have multiple – um - Education Advisory Committees – um - within their district as long as it's not within a city. So

it'd be your unincorporated areas.

GIBSON Anything more from Members of the Board?

SEGERBLOM Sorry, William, you don't have any unincorporated areas. (laughing) You're welcome

to sit on my Board though.

UNIDENTIFIED SPEAKER (unintelligible)

NAFT I told him he could co-chair Laughlin's Board with me. (laughing)

UNIDENTIFIED SPEAKER (unintelligible)

GIBSON I'll entertain a motion on this item.

SEGERBLOM I would move for approval.

GIBSON There's a motion for approval by Commissioner Segerblom. Any discussion on his

motion? Please cast your votes. The motion carries.

MCCURDY Uh - thank you, Mister Chairman. Um - on December 19th we had the privilege of

treating our seniors at Robert Gordon Plaza, as well as Marion Bennett Plaza to a delicious holiday meal – uh - in partnership with the Southern Nevada Regional Housing Authority. Uh - and it was actually pretty awesome. Uh - we know that any time you incorporate games during these holiday events it can get really spirited in the building, so – uh - we just thank all of our seniors and the staff at the Southern Nevada Regional Housing Authority for joining us, and we can't may... can't wait to

GIBSON Thank you. Commissioner Naft?

NAFT

Thank you, Mister Chairman. Just wanted to give a quick thank you to everybody who helped make Hanukkah in Clark County so much fun. Uh - we celebrated here in the rotunda – um – uh - along with Chabad of Southern Nevada, Rabbi Harlig – uh - lighting, I believe the fourth – uh - fourth candle there – uh - celebrating Hanukkah. Just wanna thank – uh - Assistant County Manager Tarr who helped start this and

helped initially find the menorah – um - four years ago now. Thank you, Randy.

NAFT

Uh - next up is just a recap of – uh - the New Year's Eve – uh - area command, which was held at Switch. Uh - I wanna thank – uh - well, Commissioners McCurdy and – uh - Chair Gibson – uh – uh - attended that. Um - this is now the fourth year that we've launched from Switch. Uh - they've been a really, really helpful partner to us – um – and - and by us, I mean the County, but also Metro – uh - in helping... and the Fire Department in helping host the command center. They have a - a big space. Uh - they have the technology that helps us make sure – uh - that it's done safely.

Um - that conference was led by our brand new Undersheriff Andy Walsh, who I just... we all congratulated at the time, but just wanna publicly, for this Board, congratulate him. He's been a really good supporter of the County Commission and all of our Clark County departments and glad he's in that role. Uh - want to highlight and maybe - maybe Commissioner Jones, you're doing this too, but – uh – uh - we... Commissioner Jones and I will be jointly hosting a – uh - I guess it's now since it's the second one we can call it annual, but our annual Coffee and Conversation – um - January 21st, that's a Saturday, in Inspirada. Commissioner Jones and I, after redistricting, now split Inspirada – um - so it's a great opportunity to come and discuss Clark County, all of our agencies and departments.

Um - and then lastly, working with the Clark County Arts Department, we will be hosting the Pet Portraits Exhibit. I hope that everybody here has taken some time to walk through the amp - the - uh - rotunda - uh - and see all of the beautiful artwork and pet portraits that are on display. We'll be having our reception in honor of the artists on January 11th from 6:00 to 8:00. Hope to see you there.

Oh, and I'm sorry, la - Chairman, lastly, I just wanted to thank the Board. Item 21 was the next step in moving forward. Uh - this Board supported it today – uh - in the Laughlin repaving project. That is – uh - I can't over-emphasize how significant that is for – um - the southern portion of Clark County. A lot of the roads there haven't touched in more than 20 years, and this repaving will provide new roads for nearly the entire residential area. Thank you.

Thank you. Commissioner Jones?

Thank you, Mister Chair. Uh - I wanted to make sure we start of the year – um – really – uh - talking about what more we can do – uh - when it comes to employee recognition. Uh - our employees are really the heart and soul of – uh - Clark County and – uh - there are other organizations out there like RTC that I think do a better job of really focusing their efforts in - in these types of meetings – um - and on the ground on making sure that employees feel special. Um – uh - I had the opportunity to - to join our County Manager Kevin Schiller on Christmas to go visit Child Haven – um - and it was a great experience, but also – um – sobering – uh - to walk into the – uh - infants room and - and see more than 30 – uh - children under the age of – uh - two years old. And – uh - I think that we need to have in front of us more frequently – uh - reporting as to the - the number of kids that we have at Child Haven, perhaps at Juvenile Justice, and - and other parts of our - our system – um - because we're entrusted with – uh - their care – um - and we

need to find more ways – uh - in order to help those kids find temporary or permanent families – uh – and - and definitely do a better job of foster care recruitment, and – um - all of us on this Board participating in the efforts for – uh – finding – um - families for - for these kids who are at Child Haven currently.

Uh - and then last – uh - there have been – uh - movements afoot for funding of the SNAM's campus. I know that Commissioner Kirkpatrick, you worked on this for (laughs) a long time. Banged your head against the wall – uh – with - with the State on this, but we - we definitely saw some - some movement over the last year. The State committed to – uh - to initially funding a master plan – uh - update for that campus. Uh - a needs assessment working with all – uh - these county, city – uh - College of Southern Nevada, and many others to identify what the needs were, and as a result of those efforts – uh - I know some of you already saw, there was a commitment at least in the - in the Governor's recommended budget for – uh - more than \$30 million – uh - for a transitional housing – um - and crisis stabilization – uh - facilities on that campus.

I think there's opportunities for us at the County since we have a vested interest in — um - in — in making sure that we provide for, again, those kids that are currently at Child Haven or sitting in — uh - ER at - at the — um - UMC that we should consider options for — uh - using our resources to - to fund additional — uh — construction — um - on the SNAM's campus. So — uh - I will work with — uh - Miss Frierson on an opportunity for this Board to get an update as to that master plan — um - because I think it's going to be very important as we go into legislative session — uh — to — uh - to educate both the new administration and legislatures on the importance of — uh - what is possible — uh - on that campus to - to address the needs of - of those who are most in need when it comes to mental health and crisis.

GIBSON

SEGERBLOM

Commissioner Segerblom.

Thank you, Mister Chair. I think I have a little... Here we go. So – um - on the December 26th, day after Christmas I was honored to – uh - go to the Peppermill for the... to celebrate their 50th anniversary, and some of us probably remember back 50 years ago. Um - but as - as we said, my grandson Will, Mister McCurdy probably doesn't remember it then, but he's probably been there a few nights, late nights in his - in his - in his own career. But – uh - anyway, it was very exciting to - to do that 'cause it's such an institution – um - and the woman here on the right – uh - Peggy Orth has been there... of the 50 years, she's been there 48 years, and she's the general manager now, so... And that's her son to the right who's the chef, so it's - it's - it's a real family tradition, but it - it was so much fun. And I also heard, I guess – um - Mister Naft is gone, but I heard a rumor that his parents were actually engaged there – uh - 46 years, so he has a special relationship to the Peppermill, too.

And I'm not sure if - if - uh - if I can bring this up, but I - I know there's been a lot of publicity out there about us - uh - the County trying to track down, after a DUI, track down where - um - the person used their alcohol. Uh - in reaching out and... and looking at this issue, I think it's probably premature to do an ordinance, so I was wondering if we could - if I - if it's possible I could ask staff to try to look at some type of - um - uh - informal committee. We could get the players together and start to talk about how we could do this realistically, 'cause we ought to do, make sure the cities participate. So if... is that something I can do without having it be on the agenda? To ask staff to do, to propose that?

LOGSDON

Yes, that's fine.

SEGERBLOM

Alright. Thank you.

GIBSON

Thank you. Commissioner Kirkpatrick?

KIRKPATRICK

Thank you, Mister Chairman. Um - I only have a couple things, so not to forget that January 9th is Law Enforcement Appreciation Day, so we'll be turning the lights blue. Um - so we always remind – um - our kids and family members just to say thank you for what they do. Um - we put them under a lot of – uh - unique opportunities – um - and some, you know, people don't realize that in our community they do mental health, homelessness – um - they respond to anything and everything. So – uh - we'd just like to say thank you, so we'll be turning the lights blue, so come out and support.

Um - the Health District. We – um - been working pretty hard to come up with some new things to get people back on track. First of the year's always great to do that. Um - as you know, diabetes is a growing issue in our community, so at the Health District we put – um – uh - on the website and online, and we'll be sending more stuff out on diabetes. Prevention, things that you can do, maybe if you have five Cokes a day you might give up two of them, and – uh - get out and walk, drink more water.

Um - but we also have – um - a really – uh - cool app that we've had for years. Um - and it's getting more and more used. We had over 100,000 people use it, but it's – um - Neon to Nature, and it actually, you can click on the app, and it'll take you through all the little trails that we have – um - throughout the community. And then – uh - lastly, one of the things we've really been focused on is a nutrition challenge. Uh - so this year it's an 8-week course, and one of the things – um - to point out is, you know, a carton of eggs is a good source of protein, but it's \$7.29 for 12. It's concerning – uh - that our families are probably not buying that source of protein anymore, and what are they switching to? So this is actually an opportunity to give them other ideas on how to get all the good nutrition that they need. So - so I wanted to point it out, 'cause the Health District is really working hard.

Um - I did the "Girls on the Run", which is a Health District sponsored thing, and did it with my granddaughter, and as you all know – um - she's a pistol. And she told me that Nana has no pace and I can't keep up with her, and I said "You have no pace. You run fast and you walk." Th - to me, you're a 50-yard dash girl." (laughs) "Nana's a long runner." But that's one of the programs that we have out there that encourage so many of our young girls to get out and be active. And at the Health District – um - that's really one of the directions that we want to go is put more information out so that people know – uh - where we, what we can do, and the small things that we can change. So, that's all I have.

Oh - and then the last thing is – um - Miss Frierson – um - for the Board you know I brought up last week, or the last meeting that in the Overton area, my roll c - area, we had 57 attempted suicides – um - and eight, unfortunately, successful ones. So I've asked the State, as well as Miss Frierson, to look into some thoughts and the person I wanted to hear it for the SIA Board left, but – um - just so that – uh - there's a lot of people that watch Channel 4 is, we can tell them, some of the resources that we're going to bring in wrap our arms around them. That is a lot, and probably the highest in the State, for a community of 5,000.

GIBSON

Thank you.

ABIGAIL FRIERSON

Um - thank you Commissioner. Um - sorry, later. Now or later? Thank you, Commissioner Gibson, — uh - for bringing — uh - light to this issue. Uh - suicide is the second highest cause of death for Nevadans age 10 to 34, and the 9th leading cause of death across all age groups. Uh - if you or a loved one are in crisis, please call, text, or chat 988. They have trained counselors that can connect you with resources. They can listen, support as well. Um - if you are a professional or a parent who's interested in learning more about crisis support or suicide prevention, there are wonderful trainings that are being offered. Uh - please go to suicidepreventionnv.gov to get in more information about that. And if you're just — uh - a regular individual that would like to get to know more about what you can do, there's a wonderful — um - Take 5 To Save Lives campaign. And if you Google it, that'll come up. It'll give you five easy things you can do to help prevent suicide.

GIBSON

Thank you for that. Just a - a brief comment – uh - on the tourism industry. The results are that – uh - October and November sustained our growth while we remain about seven points behind 2019. We grew significantly in terms of the number of people that were here. We – uh - and year over year, of course, we would've expected, and we saw 5% growth in visitor volume and about the same – um - a litt - maybe a little more than that in terms of the city-wide occupancy. ADR is up – uh - that is the average daily room rate, is higher than it was before the pandemic, which has enabled the revenues to continue to flow from the – uh - activities on Las Vegas Boulevard.

So the expectation is that - uh - this year will enable further recovery as the Far East has lifted some of the travel restrictions. It will enable participation in things like CES and other shows that are scheduled to have significantly larger numbers in attendance in Las Vegas than in p- uh - the last couple of years. And we're happy for that, and we expect that kind of recovery to continue on.

Um - want to – uh - congratulate Sheriff McMahill – uh - who was sworn in yesterday – uh - at a program at the Blind Center. Uh - we want to thank Chief Steinbeck for keeping us informed of what was happening on – uh - New Year's Eve. I was communicating with a couple of mayors who weren't getting reports, and so we kept them current so they could understand what the County was going to do, particularly with the Boulevard and - and Fremont Street. And – uh - really appreciate the work that the Fire Department did to enable... Well, to ensure that we didn't do something that would be silly – uh - or even – uh - worse. Um - and it - the weather cooperated, and we were able to have a magnificent display of fireworks on New Year's Eve on a safe – uh - relatively safe, and now even a clean Boulevard – uh - after 16 – um - trucks moved up and down that Boulevard with an army of people to clean it. Want to thank all those on our staff who worked to do that. It's a – uh - significant mess and with the moisture it made it even tougher. Uh - but they got the job done and we appreciate that.

Um – Mister Tarr, our next item is item -

GIBSON 58.

TARR Receive an update on the 2023 Nevada Association of Counties activities and priorities from Vinson Guthreau, Executive Director.

GIBSON Good morning.

VINSON GUTHREAU Good morning and – uh - Happy New Year, Commissioners. Um - I was surprised to learn that the audience wasn't here for me – um - this morning, but that's okay.

Um - just want to take a moment. I'm Vinson Guthreau – um - I'm the Executive Director of the Nevada Association of Counties, which is – uh - your statewide association – um - that represents – um - Nevada counties on collaborative issues. Um - wanna also mention – uh - Jennifer Berthiaume, who's our Government Affairs Manager – um - for NACo. She's actually down here in Southern Nevada during the interim, and she'll be up in Carson City – uh - during the legislative session. So, thank you so much – um - again for the time.

Um - we're trying to get out to our member counties annually. We did pause that a little bit during COVID, but we're happy to return – um - and appreciate Clark County's membership – um - in NACo. And I do have a presentation - I don't know if I have a clicker or...

All right, I'm not seeing it. (laughs) Oh, right here. Great.

I thought I'd start out just by – um - introducing our Executive Committee and our Board – um - for NACo. Um – our – uh - the NACo Board is made up of at least one commissioner from each member county – um - you see our Executive Committee there. Your representatives are Commissioner Kirkpatrick and Chair Gibson – um - they've done a great job representing your county on the NACo Board. Um - and they both have represented Clark County effectively.

Um - like I said, these are- these will be our current officers, they'll actually be sworn in at our January Board Meeting – um - at the end of this month. Um - so Commissioner Higbee from Lincoln County will serve as our President. If – uh – uh - we have in our bylaws to bring balance to our Board. There's at least one – um - representative from our urban counties – um - so we'll be swearing in an at largemember from Washoe County – um - also with the January meeting.

Our – uh - the NACo board, it also includes those affiliate members, and you have quite a bit of Clark County – uh - representation on those. Um - our Clerk's Association, your Clerk Lynn Goya was the – uh - president of their association. Um - we have the DA's Association as well, Sheriff and Chief's Association, and your Assessor's Association – um - which was headed up by – um - Briana Johnson – um - most recently. Um - and Tim Burch also represents – um - the Human Services Administrators. All those folks have a non-voting seat on the NACo Board.

So, this is our – um - mission as outlined. We encourage good governance at the county level, at the local government level, and we work – um – to – uh - bring collaboration to – um - to Nevada's counties. Um - and just a little bit of – uh - what we're doing at the association level. We are building capacity. We're planning for the future here at NACo. As counties change, as our State changes and our communities change, NACo is responding.

GUTHREAU

Um - I already mentioned – um - Jennifer's role. Like I said, she is down here in Southern Nevada during the interim – um - and she'll be up – uh - with me every day at the – uh - legislative building when that begins. Um - NACo also recently hired a Public Health Coordinator. We were able to do that through a grant partnership with the state – um - they support all counties on – uh - the Public Health Coordinator supports all counties on opioids needs assessments. They're also working to tell the county story on public health. Um - I think more than ever, folks saw that and were doing more – um - than ever in helping to – um - support counties in that realm as well.

We're also working on health – uh - healthcare workforce. Um - currently undertaking a project with the Nevada's – uh - Economic Assessment Project to discuss the impacts of healthcare workforce across the state. Um - we also have a Natural Resources Manager. Every county in the State has public lands in Nevada, and we support areas in the – um - we support counties in the area of economic development, outdoor recreation, also impacts to federal – uh - actions on county infrastructure. And most recently, working on some renewable energy – uh - policy there.

So, here's some resources for NACO, and just like I said, a - a brief – uh - overall summary of sort of what we do – um - on your behalf. Um - again, we - we serve as a form of collaboration. Um - we work on common issues that affect all counties. Um - our Board meets once a month, addressing various issues. Um - recently some of those topics included federal aid to counties. Um - we did provide a legislative update – um - as the upcoming session is just around the corner to approve the NACO annual budget.

Um - we also – uh - visit counties to hold board meetings throughout the year. We - we'll be in Clark County in June – uh - we try not to come in the middle of summer, so with the legislative session, we'll be out here in June. So – um - we also provide educational resources to counties – uh - workshop topics - we did one on county revenues – um - recently, we also did one on how to testify at the Legislature and then after the session's over, we usually do one on – um - implementation of the past Legislature.

Um - want to mention our annual conference. That's also a great place to – um - to collaborate and to network with your fellow commissioners across the State. Um - we recently had – um – one – uh - in September. It was hosted by Storey County, so all, ev - we had a great turn out, a record level of attendance – um - at that conference. And we had some great programs on housing and workforce – um - among other things – uh - and it was well - like I said, well attended. Um - next year's conference will be hosted by Elko County. Um - it'll be at the end of September, so 26th through the 28th.

Um - want to talk a little bit about our website. I know Clark County undertook this, I think about a year ago, but we're also undertaking our own – um - top-to-bottom update of our website. We believe that's key in reaching legislators and policymakers and telling the counties' story as well. Um - kind of reaching audiences where they are. Um - and we advocate, of course – um - on behalf of counties at the state – uh - legislature. We also work on federal issues.

So this is sort of a rundown of - of those items. Um - like I said, we provide critical advocacy on behalf of all counties during the Nevada legislative session. The 120-

GUTHREAU

day session is nearly upon us, begins February 6th of this year. Um - we also work in the interim to monitor regulations and implementation of passed bills from previous sessions. Um - we also monitor regulatory hearings, and we serve on a number of working groups. Um - we also – um - advocate and work on behalf of counties at the federal level. We do that – um - by supporting our National Association of Counties – um - there will be a National Association of Counties legislative conference in February. Um - that's a great way we plan a day of advocacy on Capitol Hill – um - we do some Nevada-specific events for folks that are attending. So that's being held – um - February 11th through the 14th.

Um – also – um - to bring county, the county voice to critical state-wide issues and state-wide boards – um - NACo appoints to several of those. Um - one important – uh - committee is the Committee on Local Government Finance, and your CFO – um - Jessica Colvin, is NACo's appointment to the Committee on Local Government Finance. We also have an appointment from Washoe County, and also a rural appointment – uh - county finance person there. Other board appointments include the Board of Indigent Defense Services. We also appoint to the Off-Highway Vehicle Commission, Board on Outdoor Recreation – um - Nevada Commission on Nuclear Projects, and Commissioner Miller is our appointment to that board.

Um - we also – um - have an appointment to the Executive Committee on Traffic Safety, and I know that Clark County recently – uh - created their own department there, so Andrew Bennett actually took over my appointment to that. We thought that was more appropriate. Um - so he is NACo's appointment on that board as well.

Want to talk a little bit – um - for all of you – um - on an important board – um - that NACO administers – um - it's called the Board for the Fund of – uh - for Accident Care to Indigent Persons, also known as the IAF. Um - it's taken, a significant portion of the IAF is funded through dedicated county property tax that comes through for all counties. Um - and NACo provides administrative support – um - to that board. It's a way for us to continue to provide the social safety net for our citizens across the State. Um – currently, Clark County has two appointments to that, Commissioner McCurdy and – uh - your Social Services Director Tim Burch sits on that Board as well. Um - recently, that Board made a – um - a change. Just a, like I said, a high-level overview of that is just a change to allow – um - to fund – um - sort of our long-term care and Medicaid assessments, which are required through State or that we – uh - participate in the – in the Medicaid match program.

Recently, Clark County received \$10 million from that distribution in the latest round of that. So, I want to turn our attention. For all of you, I know it's probably on your mind is the upcoming legislative session for 2023. It starts, I said, on, as I said, on February 6th. Um - NACo, the NACo Board approved five bill draft requests to be submitted. That is our maximum - um - under NRS. The Board approved those at the August meeting. Um - I believe this is a local government focused agenda. Some of the topics that were - that we are covering – um - are county oversight on commissioner vacancies. Um - we're also working on – um - I mentioned that outdoor tourism piece, working on OHV Bills – um - that will give some local authority there. Um - modernized requirements for public notice posting. We're also looking at some census updates for population caps in legislation, and then a bill that studies child welfare funding in the State and also looks at solutions to that.

Um - other things that we monitor – uh - throughout session and also in the interim. We always look at the State budget, as you know, has a huge impact on counties and local governments. Always looking at unfunded mandates, along with push down –

um - of services to local governments – um - without a sort of corresponding funding source. Um - always making sure that the county perspective is heard as those policies are considered. Every county does Human Services in this state, obviously not to the same volume across the state, but we also look for – um - impacts to those policy decisions as well – um - track those updates and make sure that the county perspective is heard on those as well.

Want to turn a little bit of our attention to the National Association of Counties – um - they are a great organization. They do our lobbying – um - on Capitol Hill and on federal policy. Um - we have two members of that – um - that we appoint from NACo. Your own Commissioner Kirkpatrick – uh - sits there, and then Commissioner Higbee from Lincoln County. Um - there are some national – uh - policy steering committees, and I do want to mention – um - something that I think is of great importance across the country, which is housing.

Um - the National Association of Counties recently created a Housing Policy Task Force. Um - the goal is to coordinate and collaborate on solutions of affordable housing across the country, bring resources and – um – uh - bring resources and best practices back to your local communities. And Commissioner Kirkpatrick was recently named to that. Um - we also have supervisor – uh - from Carson City – um - that will sit on that Housing Task Force. So Nevada will be – uh - well-represented on that Housing Task Force, as it's such a critical issue for us.

Um - there's some other things that Clark County learns a lot from the National Association of Counties. They provide resources a lot on emerging issues – um - I know child welfare, some of the staff here has mentioned that they – um - are involved greatly in the - on that issue – um - as well. Also, the National Association has a number of policy steering committees covering such things as social justice, county finances, just to name a few. Um - these are open to any commissioner, even if you're not on the State Association Board. You just – uh - simply reach out to me, I'm happy to appoint you to those. So, if there are things that – um - you're interested in – um - and beca – um - becoming involved in nationally, I'm happy to support your appointment to those positions.

Um - the policy steering committees, they help graph the American County Platform, which is the document that is used – um - to guide – uh - federal lobbying efforts by the National Association of Counties. So – um - just a little bit about what's next for NACo. As I mentioned – uh - the National Association of Counties annual legislative conference – um - we will again be – um - scheduling that day of advocacy on Capitol Hill, it's February 11th through the 14th in Washington, D.C.

And also, our State association, just want to make one more plug for that. September 26th – um - through the 28, it'll be, like I said, hosted in Elko County. Um - and then next year, in 2024, that's our hundred-year anniversary of NACo, so we'll be planning – um - a ton of events around that – um - and making that a robust conference as well. So, like I said, it's just a brief – um - overview for all of you – um - so that you sort of know what we're up to. I'm happy to take any questions. This is our building, we are located in Carson City – um - the building predates statehood, so it reflects the length of our organization – um - and the longevity of it, and – uh - it sits on the National Historic Register. We're quite proud of it. Like I said, I think it reflects – um - sort of what we're doing – um - at the association and how long we've been around.

Um - and then lastly, just our contact information. Um - I know that was brief, but

GUTHREAU I'm happy to take any questions that y'all might have – um - on this or any other

issues that NACo supports you all on.

GIBSON Do members of the Board have questions? Thank you very much. We appreciate

very much your leadership – uh - you're not all that long in the saddle but you've been really aggressive at taking the helm and we appreciate the leadership that you're showing. We're happy to be a part of and be supportive of the things that happen across the State. They affect us all, and your being here today is a good thing. Thank

you very much.

Happy new year. Daniel Braisted, B-R-A-I-S-T-E-D. Uh - I want to thank the County Clerk. I got the information on the – um - ordinances that I was looking for dealing with – uh - COVID number 4771 and 4773. I'll be following up to see how we can adjust those, because they're out of whack. Uh - was really impressed with this discussion here on the – uh – um - Nevada Association of Counties. One of the big things that we aren't doing is promoting our - our conventions, and we have CES this week. We have the National Hardware Show at the end of the month.

W - we should be promoting those. They're - they're in our backyard. We have people flying 18 hours, spending thousands of dollars to attend them, and, as I've mentioned to – uh - Commissioner Gibson and – uh - Commissioner Naft, we need some sort of a – uh - a permit that allows that permit to be shared in an office. Because we don't, you – you - the whole department here can't go to CES. But if they had one permit that they could share, that could, only one person – uh - at least ex - expose them to the information.

And what I'm thinking of is, the Vegas Chamber doesn't promote the conventions. They're so busy with all their other activities – um - consider promoting and having an individual from this organization sit on the Las Vegas Convention and Visitor's Authority. And their focus is to get the information, of what's happening here, out to all the other counties, and get the conventions in all the other counties into some central – uh - website that we can go there and see what they're doing. Because that's education. We're - we spent so much money on education, and we have so much free in ed - education.

The other thing that you might consider is each county has education, and I've walked into the education section, training section down here, and they have a great class on Stephen Covey's seven habits. That should be available to all the other counties, and they share their classes. So we increase the education level without having to spend additional money. Thank you.

MARGARET ANN COLEMAN

And good afternoon. My name is Margaret Ann Coleman. I stayed due to the fact I was not – uh - finished completely talking about the destruction of my life and who. If you can put those persons on the scanner, and this is – um – uh - Zach Conine, and also Michelle Flor, whatever her name is. Um - those two parties there, they know and they saw me over at the Royal, the Royal Way, and none of them addressed of what they was, their duties was supposed to be and perform. Now, these stocks – uh - people that has stocks, money coming in... Now, Mister – uh - Conine, he sold my property to get this – uh – two – um - trillion dollars that he spoke to you about last month that had to be spent within the 2023. Now, if you have that kind of power with

him, get him to address and give me back my money at 1316 Wizard.

This lady – uh - Michelle Flor, she has control over 1316 Wizard concerning her being on the Board, City Council, and I called her, or it was Sesamin, or someone – uh - on the City Council to – uh - help me get back in. Now, you have outreached – uh – uh - number 50 – uh - getting \$288,000 – uh – uh - Community Development Block Grant Fund. Now, and then you have then the allegation total of one million, \$981 and two – uh - \$275. So – uh - and approve and authorize the council management – Manager – uh - to his designs – uh - to sign an amendment – uh - to resolute – uh -lution, and incorporate – uh - relocation.

Now, outreach is summonsing me to have a meeting with them, and all they're doing is giving me information. I need a better response to giving me a key to the house at 1316 Wizard. As I said before, Kainan got two trillion dollars to help education of the people that is over at the Royal Way. A lot of them are old people that are, and a lot of them are just Mormon – um - people of cemetery, people wants – uh - addressed to bury people. And they got my daughter and me over there. Like I say, I can't even sleep in that, because I fear for my safety, my car being tampered with.

GIBSON

Thank you, Miss Coleman.

GRACE ALBANESE

Thank you, Commissioners. Um - my name's Grace Albanese, A-L-B-A-N-E-S-E. I probably won't be – uh - attending the Las Vegas Police – uh - appreciation day – uh - or turning my lights on to the color of blue, because I've been – uh - for two decades the Las Vegas Police have been trying to get me killed. They'll saturate the area where I go with large concentrations of police – uh - to get me killed. They swept the area of Valley View and Tropicana of all the, you know – um - vice and criminals that were there before my arrival – uh - and now, there's no vice there whatsoever.

They put up a police pole over there, Procyon and West Tropicana, with the cameras on it that none had ever existed before. Uh - Procyon and Trop now has a police pole with the cameras on it. None has ever been there before. They do this to get me killed. Um - they swept the area of Valley View and Trop of all matters of vice and prostitutions. Uh - they've, you know, they might've swept the area maybe of one prostitute or one criminal, but the entire area now is clean. They only did this after my arrival to the area, where I had storage, and – uh - to get me killed.

Uh - they'll, you know, saturate the area with these high concentrations of police. This has been going on for two decades, since around 2005, including where I would work. The police would be in the store, waiting for me. I don't know what's going on, very disturbing. So the pendulum, when I leave here, will probably – uh - swing in the opposite direction, and they'll – uh - leak misinformation about me to criminals to try to get me killed, as well as put me in the cross hairs of other criminals, you know, to try and get me killed, to go from one extreme, with the heavy concentration of police saturating the area, to – uh - you know, now – uh - just criminals – um - saturating the area.

This has been going on for about two wee – uh - two decades, before Steve Barrios – uh - made his name on the public stage – uh - as a hacker and a stalker. He was only five years old then, so this was long before him. And so – um - you know – uh - I can't have this. I can't have the police, you know, saturate the area everywhere I go with large concentrations of police to try to get me killed, to sweep the area of all these criminals. Wait until after my arrival to the area. Uh - this has been going on

for two decades to try to get me killed. You know, state-of-the-art police helicopters flying overhead now, December 31st -

GIBSON

Thank you, Ma'am.

ED GONZALEZ

Thank you, Mister Chairman. Once again, my name is Ed Gonzalez – uh - for the record. I do want to thank the Commission for approving Item 56, and I do want to thank – um - Commissioner Kirkpatrick. We do know that Hickey is in your district – um - and the help that she did to open up that health clinic. And so, I just wanted to put that onto the record. And then, finally, you guys – uh - the Board was looking at what kind of model. If I could do a suggestion possibly for the CEAB, I would do something similar to what you did with the town advisory board or the citizen advisory councils, just because it's, it's smaller. You have some areas where schools were... It might be a one-district summit zone in other ones.

So, as you look forward to this, I think a smaller model, closer to what they do in Moapa and Mesquite would be - um - a much better model in this aspect than something in Henderson, where it's just one big body dealing with the items. So, thank you, Mister Chairman. Thank you to the Members of the Commission for voting for it. Thank you.

GIBSON

Thank you.

MIKE WALTHER

Good morning, Commissioners. Have I been approved for that, Sir?

GIBSON

That isn't something that we can do, but why don't you move through it as quickly as you're able to do.

WALTHER

You know I will. [inaudible 02:14:33] these down this way?

GIBSON

Yeah – uh - place them up, face up.

WALTHER

Oh, oh, good. All right. I am Mike Walther. I live at 1325 Los Meadows, 89110. I'm a community coalition advocate, and an invested homeowner, and the former Squire Village H - HOA president for 10 years. I have a time-sensitive update regarding the small parcel of land at the entrance to Wetlands Parkway at Broadbent-Wetlands Park Conjunction Road. The surrounding communities of single-family homeowners, HOA Boards, and interested parties officially request the Commissioners and the Whitney TAB give unified support in opposing this third and most absurd request for a rezoning change for a R-3 townhouse and an R-H residential high zoning that seems to be designed to accommodate tiny home communities, yet the developers are requesting 54 rentals on this property, two and three-story high, three and four-bedroom dwellings on this small parcel.

The LLC's gone ahead and purchased this property, knowing quite well their plan for density-packed rentals could not go forward without a major zone change in a neighborhood of 100% privately-owned, invested homeowners. The zone change and code changes from the minimum safety and building requirements were strongly opposed by nearly every attending to all of the LLCs infor - informational meetings. As an analogy, this is like a size 12 person fitting t - trying to fit into a size three garment. It may be feasible, but it's not reasonable, or prudent, or healthy. The developers admit they will still need several variations to the minimum standard codes to that zoning to compensate for the mass overcrowding of 54 homes on a three-acre tiny parcel piece of land. Here is what we will do, and as we've gone

along. We, the neighborhood resident owners, conditionally would support a development of that parcel for existing zoning use, for single-family residences, to be sold to owner-residents like themselves that meet all the existing safety and building codes without variations. Also, we unanimously agree that we are not interested in a rental project in that location. It is a misnomer that a landowner can do what they like with their property. It is true that the Commissioners cannot tell a landowner what to do with the land, but zoning laws and regulations tell them what they cannot do with that land.

The Commissioners and the TAB can, in fact, require them to follow all current existing zoning, building codes, and safety standards as set forward in the initial master plan of the area. The Commissioners have no obligation to change the zoning to please one new LLC landowner, and by granting the favor, the Commissioners would be betraying the hundred, the several hundred privately-owned single-family homes in our original HUD master plan in the unincorporated area of Clark County. This being the last small vacant piece of property in this master plan, there is no reason at all to change the zoning into rental zoning in an overcrowded, poorly-designed format that is zine - designed solely for rent. It is a perfectly planned cash cow for the LLC that has no past affiliation with this neighborhood at all, and in fact, this would be their first time building any community.

Let them find a new piece of land suited for their multi-family residences with enough room for roads, sidewalks, parking, recreational areas for their residents, and to have them conform to the current zoning that meets all current minimum safety and building code requirements. Allow me. Here is the site they want to do. Here is the site over in my previous community of – uh - Squire Village. You can see that site is nearly exactly the same. They want to put 54 houses here. We, in a cul-de-sac situation... We use cul-de-sacs. There, and there are no sidewalks around here, because it got squeezed into this area. We only have 34 homes here, and they're packed in.

And they want to put 54. Down here, very limited overflow parking. Here's their - here's their view of the thing. It's - it's not townhouses. It's row houses, and they're - they go over here up to three stories high. There are no three-story buildings in our whole section. Here is the, here, they show spaces on the side. There are no spaces on their side. They're a row house. There's one space on the side. They have no backyards. They have no recreational facilities, and they only have about 13 overflow parking. As you can see in mine, I have a whole row of parking, and they're filled every night, plus the two cars in their garage. Alright.

GIBSON Thank you, sir.

WALTHER (unintelligible)

GIBSON How about 30 seconds short?

WALTHER I asked for six minutes. I would like that, please.

GIBSON Take 30 seconds.

WALTHER Okay, well, that's fair. Alright. It should be noted -

GIBSON You're, yeah, you're probably at, nearly at six minutes. That'll put you at six minutes.

Just, 30 seconds, just quickly.

WALTHER - it doesn't seem like there's anybody getting put out by it, but I see that. I'll move

faster. Alright. I'm gonna finish up real quick, but it's important what I say now. It should be noted that when asked where the school bus stop for these two to three children per 54 units, which is approximately 108 to 125 units, new students to our existing non-safe bus stop, we are told, "Well, that really isn't part of our LLC's responsibility, those 104, 135 students." The Commissioners should not even consider approving the one-off offer, ill-conceived, overcrowded, for-profit -

GIBSON Okay.

WALTHER - rental project to this too-small a project in the middle -

GIBSON Thank you, sir. Thank you very much. We heard you. We -

WALTHER (unintelligible)

GIBSON - you can't. You have three minutes to bring up anything. We gave you six

minutes to bring up what you've brought up, but - that's true. That may be true, but

you have three minutes.

WALTHER (unintelligible) thank you.

GIBSON Thank you. Is there anyone else who wishes to speak during public comment period?

There being no one, then this meeting is recessed until tomorrow morning at 9:00

a.m.

There being no further business to come before the Board at this time, at the hour of 11:58 a.m., Chair Gibson recessed the meeting to the hour of 9:00 a.m. on Wednesday, January 4, 2023, for the Zoning agenda.
