**ITEM NO. 1** Recognize Arab American Heritage Month, celebrating and honoring exceptional citizens and organizations in Clark County.

GIBSON Mister Schiller.

KEVIN SCHILLER Morning Commissioners. Item One is to recognize Arab American

Heritage Month celebrating and honoring exceptional citizens and organizations in Clark County. This is Commissioner Jones, and all Commissioners.

Thank you, Mister Schiller. I'm proud of this Board to be the first in the County's history to recognize Arab American Heritage Month. Arab Americans include many faiths, races, and ethnicities in ancestry any one of 22 Arab countries that spanned northern Africa, and western Asia. What these diverse countries share most in common is the Arabic language.

Beginning in the 1990's American Arab heritage was celebrated sporadically in various states at different times of the year, primarily in school districts. It wasn't until 2017 that Arab America, an organization based in our nation's capital began a national initiative to coordinate all states under Arab American heritage month.

Arab American history is American history. Dr. Farouk El-Baz, an Egyptian immigrant, helped plan all the Apollo moon landings. Rashita Tlaib is the first Palestinian American woman in Congress, representing Michigan's 13th Congressional District and Dr. Mona Hanna-Attisha is a pediatrician and professor who exposed the Flint water crisis and continues to advocate for children, immigrants, and women in STEM.

The number of Nevadans who claim Arab ancestry more than doubled since the Census first measured ethnic origins in 1980 and is among the fastest growing Arab population in the country. We are proud to have a rich and diverse Arab culture here in Clark County.

I want to begin by joining with Chair Gibson in honoring a family that needs no introduction: the Khalaf family. The Khalaf family's roots begin in modern day Palestine as their great, great grandfather, Abdul Khalaf immigrated through Ellis Island in pursuit of his American dream in 1912. Mister Chair.

Thank you. Alex Khalaf comes from a long line of entrepreneurs. It was his destiny to take over his family business at 18 years of age. He and his family moved to Las Vegas in 2000 and opened Kalifano in the Forum Shops in Caesar's Palace. The Grand Shops- and, most recently, at Reid International Airport. Kalifano offers the best quality crystals, gemstones, fossils, and metal art.

Fahima Khalaf is an incredible mother to four great kids and an active member of the Las Vegas community where she sits on four boards: Interfaith Council of Southern Nevada, Emerge Nevada, Battle Born Progress, and Al Mon Neighborly Needs.

Through persistence and family values, the Khalaf family continues to set an example for Arab Americans through Clark County and the State of Nevada and to all of us.

We are happy to honor Alex, Fahima, and their children.

WILLIAM MCCURDY II April of this year marks the 55th anniversary of Title 8 of the Civil

Rights Act of 1968, the Federal Fair Housing Act, which provides equal opportunity for all people in the sell, rental, and financing of housing and prohibits discrimination based on race, color, religion, sex, or

national origin.

The Fair Housing Amendment Act of 1988 added familial status and disability to those classes protected by Title 8 and added strong new rights, remedies, and enforcement procedures. Nevada State Law also prohibits discrimination based on ancestry, sexual orientation, and gender identity or expression. It is the solemn and sworn duty of government at all levels to defend the rights of all people and oppose housing discrimination whenever and wherever it occurs. Illegal barriers to equal opportunity in housing, no matter how subtle, that diminish the

rights of some people of our community, diminish the rights of all.

Whereas the Silver State Fair Housing Council actively works to ensure equal housing opportunity for all people in Nevada to freely choose where they want to live and where they can afford to live.

Now, therefore, the Board of County Commissioners of Clark County, Nevada on this 4th day of April 2023 do hereby proclaim April 2023 as Fair Housing Month and recognize Silver State Fair Housing Council for their work in pursuing fair housing in our community.

Commissioners, Item 6 is to recognize and present a proclamation to Southern Nevada Chapter International Code Council, recognizing April 2023 as Water Safety Awareness Month and acknowledge their continued role in the provision of water safety awareness and education. Commissioner Gibson.

**GIBSON** 

In Southern Nevada, warm weather is a reminder to stay vigilant and in preventing drownings. As pools become more inviting during this time of year, it's important to be aware of the safety precautions around water, for younger children especially.

Our youngest members of this community face an alarming risk. Drowning is the cause of more injury related deaths than any other cause among children under four. Today, we want to thank those involved in their focus to ensure the protection and wellbeing of our community.

We're very pleased to present this proclamation to the Southern Nevada Chapter International Code Council, recognizing April as Water Safety Awareness Month. This recognition celebrates the collaborative efforts between Clark County and its community partners to prevent drownings and increased water safety education.

Thanks to the local chapter, the Southern Nevada International Code Council Clark County, and several other jurisdictions, we have the ability to offer free swimming lessons to families that might not be able to afford them. This year, the SNICC is donating a total of \$20,000 for the Toddler Swim Grant Program, and we very much appreciate and need all of that.

We're delighted to announce that the Clark County Parks and Recreation Department has been gifted \$2,500 by SNICC, which will help us make swimming lessons available at no cost for local children. It's a wonderful gesture of support towards our mission of reducing drowning cases in our community.

And this is something that has happened over and over again in this community, and we appreciate very much the attention that you pay to something that is especially important. So, thank you very much for being here. And this is the proclamation that does what I just said.

Just a few highlights from the event include 135 employers onsite representing a variety of industries and another 20 organizations onsite to help job seekers access information about additional resources and support services, including ASL interpreters. We had close to 3,000 job seekers this year, and preliminary numbers with just one half of the employers reporting show more than 300 job seekers were hired on the spot, with an estimated 1,900 additional job offers expected in the coming weeks pending second interviews and background checks.

All in all, the event was very successful, due in large part to the staffs of Commissioner Segerblom and my staff, as well as Kathy Topp from Red-7 Communications and of course the incredible staff from Workforce Connections and DETR. A huge thank you to them for their tireless hard work and commitment over the past several months to ensure the event went off without a hitch.

Big thanks to MGM, Caesars, Resorts World, and the Pinball Museum-for helping promote the job fair on their marquees. We're most appreciative. I'd also like to thank Kids Quest for providing onsite childcare. Metro Convention Center Area Command was especially helpful, and of course, the Las Vegas Convention and Visitors Authority that provided the Convention Center space to us, an incredible partner in our efforts to bring job to people. I hope to have finalized numbers in the coming weeks to share with you, and we'll update you in the near future. Also, on March 24, I was happy to be a part of the Horseshoe grand opening, a re-opening, really. It was previously Bally's. The Horseshoe is a name we're all familiar with. The original Horseshoe was opened downtown back in 1951. I wish them all the best in their newest location. I'm confident they'll be successful, as the property sits on one of the busiest intersections in Las Vegas, with about 90,000 cars daily driving through Flamingo and Las Vegas Boulevard intersection.

I sit on the Board for the LVCVA, and I'd like to provide regular updates on our tourism indicators. In February 2023, we saw visitation approach 3.1 million, up over 17% over February of 2022. Overall, hotel occupancy exceeded 82% for the month, almost 13% higher than last year. Weekend occupancy continues to grow as well as weekday occupancy, which is supported by the strengthening of the convention and group segments.

Last Saturday, we held our annual Egg-Apalooza event at the Paradise Rec Center. It was a free event with lots of activities, crafts, and egg hunting. Thanks to Metro South Central Area Command, the first 500 kids received a free Easter basket, and it was a lot of fun for the kids.

We're partnering with Metro's Convention Center Area Command on another Easter event this Saturday, April 8, from 11:00 a.m. to 1:00 p.m. This event will be at the Harmon Crossings Apartments, located at 303 East Harmon. There will be free food, a rock wall, prizes, and of course, lots of fun.

I'm very happy to announce that on April 15, we'll be reopening the sand volleyball courts at Sunset Park, and it's time. At 12:00 noon, we'll be kicking off the event with a championship volleyball match between Metro and Clark County Fire. And at 1:00 p.m., public open play will commence.

We'll be passing out free t-shirts while supplies last, and there will be free food served from noon to 4:00 p.m. along with bounce houses and games for the kids. Please come out and join us if you can. That's noon on April 15 at Sunset Park.

On behalf of CH&R, I participated in the Clark County All-In advocate meeting. First, I'd like to thank you, Commissioners, and the Department of Sustainability for initiating the All-In Plan. Since most Nevadans live in this County, this plan should have a far-reaching impact, and I look forward to working closely with the County on the implementation.

Many of the people CH&R helps are considered underserved Nevadans. They are lower income utility customers with high energy burdens and are most likely to live in the less energy efficient homes that are susceptible to the poor indoor air quality from leaky gas appliances.

These families are also likely to live near high traffic corridors and toxic air pollution with less access to clean vehicles and zero emission transtransportation. As a result, these families are in the danger of being left behind in the clean energy transition. Making policies set in all levels of government makes it more crucial for them.

Our church has been solar powered since 2010. I drive an electric vehicle. I cook on an induction cooktop, both of which I am very excited and just happy to have. My husband and I are now looking forward to replacing our home heating and cooling systems with heat pumps. As to say (laughs) as to this, I say the benefits of clean energy technology, I know it firsthand. Again, I am in favor of the All-In Community Sustainable and Climate Action Plan, and I urge you to approve it and take even more bold and more urgent actions to help Clark County underserved benefit from clean energy in their homes, their places of worship, their places of work, and their modes of transportation. Hello, Commissioners. Good morning. My name is Andrew Sierra, the Organizing Political Director with the Nevada Conservation League, a nonprofit organization that works to protect our climate, air, water, land, and health, and I'm here in support of Agenda Item Number 51, the All-In Clark County Community Sustainability and Climate Action Plan. We are grateful that Clark County shares our commitment to a clean and healthy environment and has undertaken the process of developing a comprehensive sustainability plan with the help of community leaders, nonprofits, uh-faith leaders, businesses, municipalities, and more.

Clark County is home to majority of our state's population and thus plays an important role in helping our state achieve net zero greenhouse gas emissions and reach 100% clean energy by the year 2050. To reach these goals, we must act with urgency and boldness. Buildings and transporta- and the transportation sector are the largest contributor to greenhouse gas emissions in Clark County, contributing 41.5% and approximately 30%, 37% of greenhouse gas emissions, respectively. Many of these emissions come from the burning of methane or natural gas for heating, cooking, and other purposes.

Shifting to an all-electric future will ensure our homes, buildings, vehicles, and buses are safer while improving air quality and community health. But at the end of the day, we must recognize that the burden of pollution falls disproportionately on communities of color and low-income communities who often suffer from higher rates of asthma and other illnesses, contaminated water, and other climate related effects. Climate justice must be incorporated into the All-In Clark County process at every level and at every category. The All-In Clark County Community, Sustainability, and Climate Action plan is a step in the right direction. We look forward to working with you to ensure it's implemented with the intentions it was passed, and hope we can take further action to make a more sustainable and livable future. Thank you.

Morning, Commissioners. My name is John Wong. I'm here to speak on behalf of Section 44 regarding short term rentals. Upon a preliminary look at the County's own data, we have determined that the County allowed the following to be included in the lottery: at least 39 rentals within the 2,500 feet of a resort hotel, 20 rentals within the City of Las Vegas, 5 rentals within the City of Henderson, 5 rentals within North Las Vegas, one rental from Mount Charleston, one rental in Moapa Valley, one rental from Goodsprings, one rental from Laughlin, one rental from the City of Mesquite, one rental from the State of Florida, and one rental from the State of Washington.

The lottery is supposed to be for rental properties located in unincorporated Clark County only. Allowing ineligible applicants into the lottery makes the system flawed. This is why we had asked County to conduct a first come first serve application process to allow for each applicant to be individually vetted first in order in which they applied for the County, which should have determined all eligible applicants and

then conducted the lottery that included only eligible applicants.

The County's request to rush the process continues to result in missteps, create more confusion, complicate the process even more, essentially rendering the entire licensing scheme flawed and very likely invalid.

As of today, the County continues to make, make it up as it goes when it comes to short term rental licensing scheme. In fact, their response today to hosts about when licenses will be issued has been a specify, a specified date for the application submission has not been determined at this time. The hotline created by the County has staffed by, is staffed by personnel who are also unknowledgeable about the entire process, and in some cases provided incorrect information to hosts, ultimately admitting that they do not have a final process yet in place, and have been simply, have been told to simply state the County will be mailing a letter in the next two weeks to notify applicants of the Number that they were, that was assigned to them by a random number generator. But other than that, they have... Other than that, they admit the County staff know what's next in the process, or when licenses will be issued until you, the Commissioners, advise them.

This is because you created a licensing process that's beyond the County's ability to handle, as a result of your rushed attempt to shut people down, which by the way has failed so far, and focus on penalizing homeowners instead of focusing on bringing them into the compliance, into compliance through a logical, streamlined, and fair process. Please open up the licensing process and make it fair for everyone. It would be very beneficial for locals to participate in the whole sharing economy. You know, grocery stores, restaurants, local businesses can all benefit instead of having to rush tourists onto the Strip, into casinos, and just benefit the business there. Thank you.

Western Resource Advocates, we're a non-profit advocacy organization fighting climate change and impacts to sustain the environment, economy, and people of the west. Western Resource Advocates has been closely monitoring this effort, and as a member of the Transportation Electrification Working Group, we are happy with the progress we have seen with this plan. We believe that this plan is a great start in identifying the numerous opportunities that will allow Clark County to be a leader in the carbonization efforts in Nevada. As Nevadans begin to purchase more zero emission vehicles, the County must adopt the EV charging infrastructure necessary to meet this demand. It's equally important that Clark County works to cut harmful emissions that are negatively impacting our communities. This plan will ensure that Clark County works to reduce emissions and build the infrastructure necessary to meet the needs of EV drivers.

Clark County is one of the fastest warming regions in the Country. And according to the latest greenhouse gas report released by the Nevada Department of Conservation and Natural Resources, Nevada is not on track to meet our emissions reduction targets. This plan provides a framework on how to get our state back on track.

We thank the Clark County Department of Sustainability for working on this draft ordinance and encourage the Board to approve it so we can start enjoying the benefits of a safer climate and healthier environment. Thank you.

Good morning, Chairman Gibson and Commissioners. Amanda Moss, Senior Director of Government Affairs for the Southern Nevada Home Builders Association. On behalf of my membership, I had the pleasure of being a part of both the Transportation Electrification Working Group, as well as a stakeholder in overall discussions, uh-that are before you today in the All-in Community, Sustainability, and Climate Action plan.

I hope that these comments can be entered into the record for both Items, uh-50 and 51.

Over the last 18 months, we have been at the table to discuss the polices before you that would aid the County, our region, and our state to reach our aggressive GHG emission reduction goals. At the many TEWG meetings, we collectively came together to identify barriers to electrical, electric vehicle implementation of which the most impactful or overall grid capacity, peak load demands, and housing affordability, all which are determined at the regulatory level. We appreciate the charging mandate was placed in Title 30, as it offers the flexibility necessary to roll out transportation electrification in an efficient, reliable, affordable manner across the Valley where unique needs of that community or that part of the grid, may require the prescriptive targets to be waived for the public benefit.

We want to thank Clark County and your staff, especially Miss Henson and team for working together with us to engage with the PUCN and other regulators that impacted the regional plan for transportation electrification. Together, we secured an off-site and cost increases associated with the increased infrastructure cost not currently being considered in capacity calculations. While working with your staff and calculating the estimated cost associated with the infrastructure, we discovered cost for labor and material for the actual outlet are easy to calculate at minimal, but the overall infrastructure cost associated with grid capacity, peak demand, and more are still unknown and very complex and could impact affordability drastically.

Single family attached town home products are the way we, as a industry, maintain access to the market for working families. The adder was secured for single family detached products only, and we are unclear at the time what an adder would like for a most attainable product or for multi-family apartments and condos. While the adder will not cover the entirety of the infrastructure increases, it will alleviate some of the additional upward pressure on infrastructure cost that will then result in upward pressure on home prices.

We look forward to continuing our dialogue with you and your staff to monitor how these policies are impacting all residential development from a parking efficiency standpoint, landscaping standards, cost of utilities, and more. We hope that this collaborative trend continues as the overall sustainability and climate action plan evolves and is implemented to meet the region's GHG emission targets and look forward to our meeting at the end of this month with you and your staff to continue the dialogue on other policy recommendations outlined in the draft. That will be before this body in the future. Happy Earth month. Thank you.

Good morning. Johnny Dortch, um-speaking on behalf of agenda Item Number 44. How befitting is it that we have high school students in the auditorium today. If I were to have graded the lottery and the way it was implemented, I would have given it an F.

You have the Head of Business License sitting in these bleachers over here behind me, and they had included ineligible applications into this lottery.

You're dealing with people's livelihoods here. You made a mention of it in the lasting meeting that you hosted regarding short term rentals. You had said that this was something you guys were going to take seriously, the implementation of the lottery. You didn't do so.

And I'm not saying you, because you guys are not the ones conducting the lottery, I'm talking about your representative that's sitting over behind me. He runs the head of Business License, and he's including ineligible applications into the lottery, which effects the order of which you are assigned a number to be able to get the permit that you need.

So, if you are including ineligible applications, it affects the order. And when you affect the order, you're affecting how, who gets assigned a license into that 1,000-foot distance separation. So why would you include applications that are from the State of Florida, the State of Washington, (laughs), from outside of Clark County. You have the number one spot going to an ineligible HOA. These are just quick marks that you could have done when they took in the application at the business license office and or online. And yes, it does affect the outcome. The randomness may be the same, but the outcome will be different each and every time you run an algorithm. And when you have

hundreds of ineligible applications, those that are on septic, oh, yeah, I'm one of those people that are on septic that wasn't allowed to apply. But guess what, there was others that were put into the application pool, so their number is gonna get pulled, called up, they're not going to be eligible to get a license. They're going to move on to the next one. But that spot could have went to somebody else. That number one spot could have went to somebody who's eligible. And so each and every one of you is responsible for this haphazard failure of a lottery and needs to be redone. Otherwise, it's going to be challenged in court, along with everything else that this lottery is.

So, I'm glad these kids are in the auditorium- today, because they get to see that even as you become an adult, your work matters. And when put work into something, and you want to get a graded on something, you do it the right way the first time. And each and every one of you are responsible for that. You all failed.

-and volatility that can permeate the working environment at both places. I commend the officers' patience and professionalism in dealing with this sometimes troubled population. I'm sure the drawn-out grind of the pandemic was both taxing and exhausting at times. But the truth be told, we at Straight Ahead Ministries savor our time with the youth.

Jack Martin is the person who has offered us the privilege of spending time at each facility. Since 2018, my experience in knowing and working with Mister Martin is that he always open to programing that will benefit the young offenders under his leadership. In any conversation, almost without exception, Jack is always eager to discuss a new idea that would give the youngsters another way to succeed. His

I don't pretend to have all the information that brings us here, and I certainly don't have answers. I only understand what my experience has been in knowing and working with Mister Martin. I'm sincerely thankful for the doors opened to Straight Ahead Ministries through Jack, as well as his continued support and appreciation of what our presence means for the youth in juvenile system here in Nevada. I also know that Mister Martin has a heart and a hope for the incarcerated youth at Spring Mountain, at Youth Camp and Juvenile Detention. Thank you.

Good morning. My name is Ed Uehling. I wanted to comment on Item Number 6, and also Item Number 24, and make a suggestion for the public hearing on Item 44.

Item Number 6 was when the Southern Nevada Chapter of International Code Council, came and presented \$2,500 to the County. That donation is not free. This organization, it's estimate, this is the organization that establishes codes for buildings and all that. It's estimated that 30% to 40% of the cost of housing today is due to those codes, many of which are outrageous. And at least double that percentage, which would be 60% or 70% of the homeless people in this country are made homeless by this additional cost of housing. And the proof of that can, just go to any foreign country that permit, doesn't have these severe codes, and see that you don't have, the streets aren't filled with homeless people.

Item Number 24... is the detention basin on Naples Avenue. It's joined with the Airport. It looks like, to me, that is an extension of time to do this. There was a flood caused by that creek 10 years ago. And it's never been addressed. It's never, had, whereas that project had first priority for years is the project was never done. And it looks to me like this is just another extension of that. And so I'd appreciate more information about that.

On Item Number 44, I've made suggestions. I've sent a letter to each of you. I don't know if you received it, but here it is, as to the public hearing, getting more information, accurate information, because the staff report is not really accurate about what really happened in the court. If the attorney that is handling this can come down and tell us each of the items that she has criticized and what the recommendations are. She's calling them unconstitutional, not just unconstitutionally vague.

The amount of fossil fuels to make a windmill and deal with that iron, and to haul to the place, and install it, it takes forever to recover it. Now, I like the idea of converting dirty air to clean air and taking the carbon out at the location or at the key place and clean it there. I don't see that mentioned in that paperwork.

So, yup. Okay. So again, the main thing is government has a way of saying, okay, here's some money, you are for climate change, oh, you get the money. You are against it, oh, you don't get the money. Well then, who gets screwed? The citizens. We should have a for and against, just like you have a for and against here. Fine, that'd be fair, because then you can make a decision. But you don't get the information to make good decisions, gentlemen and lady. Thank you.

LISA LOGSDON

Good morning, Commissioners. The ordinance amendments before you today are result of the District Court's preliminary injunction of 11 provisions of your 41-page ordinance that was adopted on June 21st. The District Court found certain provisions of the ordinance to be vague and over broad. But what the District Court did not find was that your entire ordinance was unconstitutional. The County took many of the court's suggestions in drafting these amendments to ensure that the amendments address the court concerns with the ordinance. The District Court has not ordered the County or the Commissioners to work with the association, and the Nevada Supreme Court has exempted this case from the mandatory settlement conference requirement. But as with any litigation, the District Attorney's Office has tried to work with the Association's Counsel and for resolution of this matter, but in this case, many legal issues presented may not allow for such resolution.

The District Attorney's Office has been working with the Association's Counsel and has asked the Association to submit a written settlement offer, which to date has not been received yet. While the Association has

**LOGSDON** 

appealed the District Court's order, many of the provisions of the ordinance are still in effect. The County can move forward with the licensure of short-term rentals. And while the County has also appealed the District Court's decision with respect to standing and certain enforcement provisions, many of these amendments today will address the District Court's concerns regarding the vague and over- broadness of some of the provisions.

While many, since these changes are less restrictive and mostly clarifications, the additional, the requirement of a Business Impact Statement was not required for your approval. And I'm available to answer any questions that you have about specific provisions that have been amended.

This item is a public hearing. If you've not already spoken on Item 44, you're invited to come forward. Please limit your comments to three minutes. Give us your name, spell your last name. If you've already spoken on Item 44, then you've had your opportunity. And you, Mister Uehling, spoke on Item 44, did you not?

That was for the procedure. I haven't spoken on the item itself. (crosstalk)

Well, Mister Uehling, go ahead, and comment.

Okay. She says that it's not required to have to do the Business Impact Statement. Would she please quote the place in the Business Impact Statement, which is very thorough. It's, NRS 237, where it says that if the items are mitigated, therefore you don't have to have a Business Impact Statement, where did, where did she get that?

You can keep on commenting, and then at the end, we'll see if we can clarify some of the questions that you have.

Okay. Then none of you were at the court hearing. The court, the judge, did not say that these are emphasized that these are just unconstitutionally vague. She said they're unconstitutional. And she, why, can you please, as I requested in my letter, have your attorneys come down here and tell us what these items are? They're saying there are only a few items there are more than a few. There are only a few.

Okay. Can they please come down here and tell us what the items, all the items, are and what the judge said about each of these items so that we can have a fair, public hearing here? If so, the public can be informed about what's really going on.

So, this is (laughs), it's not true that this, there are only a few items This, ordinance is seriously defective. It's going to the Supreme Court. Why can't you wait until the Supreme Court rules on it before you try to patch it up, because there could be some serious consequences in the end, to this. And yet, you're proceeding as if the judge has done nothing.

Oh. Christopher Marcus. I started my vacation rental journey here in Las Vegas. I've had to move my business to California and Florida, where I've gained licenses from multiple properties in both areas. The massive difference between those states and this state, both on the processes and the regulations are considerably different in a lot of negative ways. I've, because of the regulations, moved my entire business, and I've displaced over 20 peoples' jobs here in, Nevada. And these are people with families, and kids and houses of their own that they, still to this date, have not been able to find other work. And that was over a year ago. And that's all.

**GIBSON** 

Thank you. Is there anyone else who wishes to speak on this item? The public hearing is closed. Miss Logsdon, there are a couple of questions that have been put to us. I think it's fair to respond to those. Would you do that, please?

**LOGSDON** 

Sure. The requirements under NRS 237.080, require business impact if there is a direct and significant economic burden determined. And since these amendments, are less restrictive than the original ordinance, there is not a Business Impact Statement required at this time.

**GIBSON** 

There was also a concern expressed about the court proceeding. I don't know that...we're not the court. The court will do what it does. We react to the court's order. But help us understand what you can about that, the answer to that question.

LOGSDON

So, in this case, there was a preliminary injunction that was, basically, partially granted. And so, the partially granted was on the 11 provisions that the court found to be unconstitutional for being either vague or over-broad, which are, basically, nine, I believe, nine or 10 of those are before you today to clean up language. So just to provide some clarification on what those provisions were.

The rests of the ordinance, the court did not find to be unconstitutional, is valid at this time. Now, while the association has still appealed that court's ruling, the ordinance remains in effect. And if at the time, you know, this Nevada Supreme Court or the District Court, you know, imposes any other types of orders, the County will react to those orders

**LOGSDON** and will make the requizite changes required.

> changed this ordinance, we had to change our Title 30 that did not, that prohibited, basically, commercial business in a residential area. And so, the Legislature mandated the County provide a licensure procedure for short-term rentals, which is what we've done through this ordinance.

MCCURDY Thank you, Mister Chairman. Mister Queano.

VINCENT QUEANO Hello, Mister Chair, Members of the Commission. Vincent Queano,

Director of Business License.

On November 15, 2022, the Board of County Commissioners directed staff to work with the industry to address any issues, related to liquor displays and packaged liquor licenses. And so, I'm here to report back

on our industry meetings.

Clark County Business License held industry meetings with packaged liquor licensees' including liquor stores, drug stores and grocery stores. We also met with the Nevada Resorts Association, Las Vegas Chamber

**QUEANO** 

of Commerce and the Nevada Retail Association.

The industry provided that enclosed or locked areas will have a financial impact on licensees' limited space and already small areas and will overburden the understaffed employees. Licensees already have a security plan in place to prevent minors from accessing or buying liquor. And licensees with gaming also have their plan approved by the Gaming Control Board, and the plan includes a security plan to prevent minors from accessing liquor.

Minors access alcohol by stealing it and running out and not by, bypassing licensee screening procedures. Also, the industry advised that security caps placed on the alcohol also prevent theft as well.

Since directed by the Board, our Business License agent conduct, agents conducted onsite inspections at approximately 180 businesses licensed for packaged liquor to get an overview of the current situations. I just wanted to share some of the photos that were provided by our agents, throughout their inspections. (silence)

So, as you can see in the photos the majority of our liquor licensees already have the liquor displayed in a specific area of their location. Takeaways from the meetings and inspections. Enclosed, locked areas for packaged liquor should not be required for nonrestricted gaming locations due to the space limitations. They have limited space in gift stores, at nonrestricted gaming locations versus a grocery store or drug store.

Clark County Business License can address any violations using Clark County Code requirements for duties of a licensee under 8.20465. So, we could address issues already. For example, if there are dollar shots at a register that might be a threat to public safety, we could also, we could already address those issues using that code. If the Board wishes to address... So basically, the takeaways from the meetings, we did not observe any public safety issues, but more of a level playing field issue between liquor stores and packaged liquor licensees that are non-liquor stores.

And so, if the Board wishes to address the level playing field issue, the staff's recommendation is to require licensees a designated, isolated area for packaged liquor. And basically, to avoid alcohol products being spread through the entire store and limit the likelihood of theft by minors. And the recommendation would be to have the, to require the display of packaged liquor, in an isolated area and away from non-liquor, retail products. That concludes my presentation.

Thank you so much. And was it through you site visits that you've identified that there were no significant findings. It looks like from the pictures that you provided, from your site visits that there were consolidated to specific areas within those sites. Is that correct?

Yes, Mister Chair. The findings that the majority of the grocery stores

and other businesses that are licensed for packaged liquor already have the hard liquor displayed in specific areas.

There are some that, um-that we found, maybe if some of the hard liquor, maybe if it's a specialty item or for, like, a holiday display, special display, sometimes those are found throughout, aside from that specific area where it's usually displayed.

And there is often promotional advertisements, for instance, you got New Year's coming up. They may advertise some champagne with roses or during football season or so forth, they'll offer, it might make a fullblown thing for the specific season or team. Will it be allowed, or can we give guidance to say, a certain time period, say three days before or three days after the major event that we would allow such?

**QUEANO** 

Yes, Commissioner. The majority, from what we've discussed with the industry, the majority of those promotional items are more beer and wines, spirits-based products, not necessarily spirits or hard liquor.

but definitely the Board can provide guidance as to have exemptions for holiday and set those parameters as far as the days and times for display.

I think that's a consideration that we should give to those, especially if it's a part of their business model for those times. Commissioner Naft.

Thank you, Chairman. I guess it would seem to me that if you're fairly comprehensive study of these over 180 retailers found that there's no public safety risk, or challenge or any evidence that there's an issue here, that maybe, we go the other direction and go a little bit less regulatory on this one, rather than coming up with additional burden if the goal is to level the playing field. Do you have any proposals to go that direction? I think in this process, I learned something new, which is that I can't take my kid to pick up a bottle of wine at a store. Other, at a certain store. I don't really think that makes any sense. I just discovered that in the process. So, if the goal is to come up with a level playing field, maybe we go that, less regulatory on this one. Possible, or-

Yes, Commissioner. Staff doesn't have any recommendations going that other route, but yes, definitely an item to discuss is the possibility of allowing minors into a liquor store accompanied by an adult.

That's kind of the crux of the issue. Right, as far as the level playing field, or is there more to it that I'm not...

No, it is.

... understanding.

So, Commissioner, Vince Queano, again, for the record. So, liquor stores, minors are not permitted inside liquor stores, but in a grocery stores, minors are permitted, and the display of hard liquor, there's no regulation for the display of hard liquor.

Thank you. And it would be helpful if you could just walk us through how we got here and what was the impetus for us bringing this forward.

Yes, Mister Chair. So, in November 15, 2022, Commissioner Jones brought a discussion item, I believe, there was a complaint by one of the liquor stores that there's a public safety issue as far as hard liquor being displayed near registers or just in random areas throughout a grocery store. And there was no real, secure process for supervision as far as minors having access to the alcohol. And there was also the complaint of the issue that liquor stores can, can display this hard liquor throughout their entire store without any limitations, but then, grocery stores... or liquor stores are limit- are prohibited from allowing minors inside the liquor store.

And so, the Board had a discussion and directed staff to work with the industry and see, if there's any issues that need to be mitigated or addressed.

Alright. Thank you for that. We have Commissioner Kirkpatrick and then, Commissioner Miller.

Yeah, thank you, Mister Chairman. Look, I don't think there's an issue that we have to address, so I don't know why we're even having the discussion because, I really don't want to go down the road of for holidays and events, because then it will be every holiday, every event. We do something every day. And in my district, in particular, I have a lot of liquor stores and they're not the high-end, fancy ones. And the last thing I want is those children in my neighborhood going into the liquor store. It's bad enough they got to shop at a convenience store, for their groceries. I'm not trying to get them to go into the liquor store with their parents because I'd rather them be buying groceries.

So, I'm old school, boring, but kids, there's just a place to separate kids from the liquor. And I just, I don't, I wouldn't support doing anything. I just think it's fine the way it is. And it's worked fine for years. Commissioner Miller.

I tend to support Commissioner Naft's suggestion on at least looking at that proposal, to impose fewer, less restrictions.

I also wasn't aware of that prohibition of children, going inside liquor stores. I've certainly been in liquor stores, to pick up a bottle of wine with my kids and certainly wasn't asked for my kids to show ID or or turn around at the door. So, I'm wondering how widespread that is, and if this is something that we've actually even enforced. I agree that I haven't seen any concerns out in the community relating to public safety. And so, would like to look at a proposal along those lines.

Alright. Is there anyone else? Do you feel like you have the information that you need to go back and take a look at what we can come up with?

MCCURDY Alright. Thank you.

**ITEM NO. 50** Receive the final Regional Transportation Electrification Strategy report; or take other action as appropriate. (For possible action)

Commissioners, Item 50 is to receive the final Regional Transportation Electrification Strategy Report or take other action as appropriate.

MARCI HENSON

Good morning, Commissioners. Marci Henson, the Director of the Department of Environment and Sustainability.

So, the reports that we're providing today, it's in your agenda item for backup. You've all been briefed on this electrification strategy. This is a culmination of work, from the Transportation and Electrification working group. So, you might remember that the Board asked staff to research adopting a potential ordinance to require electric vehicle infrastructure, in new building and existing buildings.

We commissioned a stakeholder meeting, had some discussions, framed up a number of issues that needed to be studied and then, convened a stakeholder working group. That working group met for over a year. One of the principal deliverables was a model, electric vehicle infrastructure ordinance. You all received that model ordinance in December and directed staff to move forward with incorporating the contents of that model into transform Clark County and the Title 30 Development Code rewrite.

This final Electrification Strategy in front of you, is a culmination of all of the research that went into identifying where our current electric vehicle charging stations are here in Southern Nevada across all jurisdictions, across the entire region. The current Number of registered electric vehicles in Southern Nevada, the projections for how the market will uptake additional electric vehicles in the light duty fleet and the corresponding, necessary infrastructure to accommodate that charging.

It also outlines a number of current funding opportunities that are available to all of our regional partners. And so, it's a culmination of all of the study that we did. I didn't dare repeat a bunch of slides from that December meeting. It was a very meaty presentation to you all.

So, with that, we'll be providing this to all of the partners who participated in that process, and it will give us a good roadmap to, potentially compete for federal grants, um-along with our other municipal partners. And if you have any questions, I'm ready to answer them.

Thank you. Are there questions or comments? Mister Jones.

Thank you, Miss Henson. I just wanted to note, thank you for convening these sector-wide meetings with the other jurisdictions and with key

JONES community stakeholders. To your comment with regard to grants,

yesterday there was a forum- with Deputy Secretary of Transportation, Polly Trottenberg, and that issue came up. And so, it's good that we are on the front end of making sure that we are ready to go on these types of electrification grants. And so, kudos for putting us in the position to receive additional money, because that money not only is going to NDOT type organizations, but she was very clear that local jurisdictions

are sort of the next step in electrification. So, thank you.

ITEM NO. 51 Approve and adopt the All-In Community Sustainability and Climate Action Plan that outlines actions to reduce greenhouse gas emissions within Clark County, Nevada, to address climate change. (For possible action)

SCHILLER Commissioners, Item 51 is to approve and adopt the All In Community

Sustainability and Climate Action Plan that outlines actions to reduce greenhouse gas emissions within Clark County, Nevada to address

climate change.

HENSON Good afternoon, Commissioners. Again, for the record, Marci Henson,

the Director of the Department of Environment and Sustainability. And I have here with me today our Assistant Director, Miss Jodi Bechtel.

So, we're going to split the presentation up into halves. Jodi will do the first half and then, I'll follow on in the back end. And at the very end, if

you would indulge us in a short video, I would appreciate it.

JODI BECHTEL Good morning.

GIBSON Good morning.

BECHTEL As Marci said, Jodi Bechtel, the Assistant Director of the department.

And start off with, a little bit of a timeline on what we've been up to the for the past four years or so. So, his kind of all kicked off in October of 2019 when the Commission joined the County Climate Coalition and signed onto the Paris Climate Agreement, that kinda set our end goal of

that net zero 2050, or net zero carbon emissions by 2050.

Immediately after that, we began planning and developing a County Operations Plan to address our county buildings, what we're doing, our own emissions, and lead by example. And that operations plan was brought to you in February of 2021 and adopted at that point. Right after that, we began implementing some of the County Operations Plan Actions, but we also began these larger community planning process. And we identified two additional planning efforts that would lead us to the climate plan, for the community. One was the Greenhouse Gas

Emissions Inventory. We updated the 2014 greenhouse gas emissions inventory that was done by the Southern Nevada Regional Planning Coalition. It hadn't been updated since 2014. So, we took that on. And created that emissions report, and outlined each of the municipality's emissions, um-and how they all contributed to the larger county's emissions. The Greenhouse Gas Emissions Inventory was released in December of 2021.

We also took on a Climate Vulnerability Assessment, which looked at what vulnerabilities we had based on hazards and risks coming from climate change and that plan had a community group that also contributed to its development. It was released in September of 2022.

And then, during that time we had begun the community planning effort. Which I'll talk a little bit more about some of those actions that took place, over this past several months and all culminating in bringing this community plan to you, for consideration.

So, as I think everyone in this room is aware, we are already experiencing the impacts of climate change. This community is no stranger to drought. We've been dealing with a drought in some form over the last couple of decades. We have more intense storms, so less rainfall but more intense microbursts that we experience. Regional wildfire, windy days like today, increase in the number of high wind events that we're experiencing. As well as extreme heat. One of the community members that spoke in public comment mentioned that we are one of the fastest warming cities in the nation, and we do expect days over 115 degrees, to increase tenfold by the end of the century. So, given all that we all recognize that the time to act is now.

So, this slide just gives a breakdown of the Greenhouse Gas Emissions Inventory. I don't think this is anything new to most people. This has been out for a while. It's reflective of what other communities are facing. Buildings, electricity and natural gas in buildings are our largest contributor to greenhouse gases followed by transportation both on and off-road, so our gasoline vehicles, combustion engines, aviation, those sorts of things. And then third-highest emissions is coming from solid waste. A lot of that is organic waste turning into methane in the landfills.

So, as I mentioned in the timeline, we have these two other plans that fed into our larger community sustainability climate action plan. So, our Greenhouse Gas Emissions Inventory and the Climate Vulnerability Assessment both provide key data points on emissions and hazards and help us to develop the goals and actions that we have in the plan before you.

As well, to help build a foundation of the plan, we took advantage of additional regional and state efforts and plans that are out there. So, the State Climate Strategy, Transform Clark County, SNWA's Water Resource Plan, RTC's Mobility Plan, Southern Nevada Strong, all of those things were taken into consideration in this planning effort.

And so, we settled on these six focus areas: clean and reliable energy; connected and equitable mobility, prioritizing low carbon transportation; diverse and circular economy, which is finding ways to reimagine waste; resilient and healthy communities; smart buildings and development, so again more efficient buildings, carbon-neutral and affordable; as well as sustainable water systems.

And then, as well, we developed these four guiding principles that would help kinda create a lens through which we would evaluate the actions that we were considering. These are the same values we use for our county operations plan. And those being of course the overall idea reducing greenhouse gas emissions, but also ensuring that we were being equitable, transparent, and providing for economic, environmental, and social resilience.

So, equitable engagement, one of the ... we're very proud of the effort we've taken to ensure that the community, all stakeholders, other government agencies, everyone had a voice in this process. We believe this is one of the largest, if not the largest, public involvement processes that the county has undertaken. And despite planning during COVID, we went all in to make sure this was a very robust effort.

We did a comprehensive look at stakeholders and conducted the stakeholder mapping exercise to identify, individuals that could represent different groups on an advisory group. So, we're looking for folks who don't normally have a voice in these sorts of processes, we were looking for folks who always have a voice in these sorts of processes experts in the focus area, experts in the guiding principles. So, we talked to all the government agencies, NGO, Sierra Club, Chispa, Las Vegas Indian Center, the Chambers, different business interests, the Resort Association, LVCVA, Las Vegas Paiute Tribe, Boys and Girls Club, Make It Work, I can't name them all. I wish I could. There was about 157 different organizations that were involved and reached as part of this process.

So, engagement took many forms. As I mentioned we, formed an advisory group, we had working group meetings on the emissions inventory as well as the Climate Vulnerability Assessment, and then particular to this plan we did round tables and then presentations and meetings. So round tables with developers, the Southern Nevada Home Builders, other builders, environmental groups, all the utilities. And we had presentations and meetings with several different community groups or government agencies to have a kind of one-on-one dialogue with them about what they would like to see in this plan and their interest being addressed.

We did a lot of briefings with government agencies. Last summer, we briefed all of you, we briefed all of the cities. We had a regional collaborative concept meeting, which Marci will talk a little bit more about. Basically, just ensuring that there's regional collaboration in the development of the plan and how we might take that forward.

We did a variety of events and virtual forums, thank you COVID, and surveys, so we had 24 different community events, seven different virtual forums, and two different surveys. We had an ambassador program where we hired members from the community, trained them on climate 101, talked to them about how to engage the community and spark different conversations related to climate change and sustainability and we pay them a living wage, to conduct those activities.

So, all that culminated in, again, 157 organizations be involved. We had 56 events and meetings. From the two surveys, we had over 6,000 people respond. And with all those efforts and social media efforts, we think we reached over 220,000 people in this effort. And I would want to take this opportunity to thank all of those that were involved, for their time, effort, there was a lot of conversations. It was a really good process, and we really appreciate all their participation.

So last slide for me. This is just a slide that shows some demographics of our survey results. We think this is pretty reflective of Clark County in the number of years people have lived here and then the race and ethnicity distribution.

So, with that, I'll pass it on to Marci to discuss particulars in the plan and I will be here afterwards to answer any questions.

Alright. So, I'm gonna spend a little bit of time getting into more of the meat of how the plan was developed and what we're gonna focus on, as high impact strategies to reduce greenhouse gas emissions and improve the preparedness and resilience of our community.

So as Jodi went over, a significant community engagement and then, the results of the Climate Vulnerability Assessment, particularly the resilience recommendations that came out of that effort and then a data-driven look at where are our emissions coming from, and how do we forecast those emissions based on business as usual. What does that look like, as based on business as usual. And then use that information to inform the goal strategies and actions in the plan.

So, this will look familiar to most of you and all of the folks who participated in the process, this is our beautiful emissions, wedge graph.

So, on the left side here, you have carbon dioxide equivalents in millions of metric tons, basically our greenhouse gas emissions. And then across the bottom is our timeline looking out all the way to 2050. And at the very top of that graph is business as usual emission projections, so if we do nothing, we can expect to see greenhouse gas emissions continue through 2050.

The rest of the colors on this graph identify with how many emission reductions, how much emission reductions, we can anticipate if we were to implement these different high impact strategies. So again, focused on electrify and upgrading new and existing buildings for more energy efficiency and reduce carbon emissions associated with the energy use in

those buildings. Switching to clean electricity sources and improving our community's generation and access to clean renewable energy. Working on transportation related emissions, so again driving that transportation electrification, particularly starting in the light-duty fleet. And then also working on organic waste diversion so that we can reduce our greenhouse gas emissions at the landfill.

So, one of the things that was very important to us as Jodi mentioned in our guiding principles is to be transparent. And so, one of the things that we all had to learn on this planning journey together is what it would mean to our community to go net zero by 2050. And to be very transparent about what we can achieve with the current technology and, with the current public acceptance of those types of greenhouse gas emission reduction strategies. And we're pleased to report that we can get to 72% reduction, just on this first initial plan.

The rest of the emission reductions, 28% we're counting on new strategies and will be achieved through additional iterations of this plan as technologies improve and as we gain more public support for the actions necessary to get to net zero fully by 2050.

So, one of the things we wanted to focus on today is we talked a lot about engagement. The engagement doesn't mean as much unless we actually take that feedback and use it to influence actions and the priorities in the plan. So, in each section of the plan, so starting with connected and equitable mobility, we revised some of the actions to focus on equity-based feedback from advisory group members and survey responses. So, it's important, in that feedback, that we make sure that we're focused on how to address access to electric vehicles and infrastructure in historically underserved communities.

We also revised actions based on feedback from meeting with the Building Trades Union on the circular economy to focus on how we can bring in workforce component to that action.

For our discussions with the utility round table so, Southwest Gas and NV Energy in particular, we were asked to prioritize supporting legislation that would allow the utilities to collaborate and provide further research on the development of renewable fuels here in Nevada. That was very important to them. We also-

would cost, the word affordable, it's gonna take it out. But when you met with these groups, did we not talk about that? Did we not ... I just feel, I'm just so frustrated and tired of people coming and saying they can't. And then they throw the word affordable in and we're supposed to do something different. So, I thought that we had these conversations. I thought we had the round tables. I know I had people in my district, and we were discussing what that looked like, and we were trying to balance it. But the home builders testified today that they can't do any of this 'cause it's just too expensive and it's gonna add to the cost. So please enlighten me.

Yeah. So, I would interpret their words maybe just a little bit more charitably than you would.

Go ahead. You try.

I'm gonna take their comments as a win. (laughs). I'm gonna put them in the category of support. And I think we all agree that we need to make sure that housing stays affordable and attainable. And I think one of the really fantastic things about this plan is that the focus on energy efficiency in particular will help homeownership stay affordable as we continue to use more and more energy in our households.

So, there are components in the plan, particularly in the community resilience section that focus on matching up with efforts that are going on in Comprehensive Planning and the County as a whole to make sure that we're making investments in efficiencies in new and existing buildings that will make the ownership and the operation of those buildings more affordable.

I think as it relates to, specifically on something like the EV infrastructure, we did a very in-depth cost analysis, in coordination with Southern Nevada Home Builders and NAHB, and learned exactly what those subdivision level costs would be. I think what we heard today was a larger concern about energy infrastructure planning and how those costs will be passed off to developers. And that happens at the PUCN and with our electric and gas utilities in particular. And so, we have been, as a result of this planning, understanding and learning more about that. And areas in which we can influence and get more engaged.

So, we've been participating in the PUCN meetings. You heard Matt and Amanda from the Home Builders talk about that today. And our involvement helped win an addition to the rule nine adder, so that is that equation if you will of what side of the equation NV Energy is gonna pay for on pulling energy to a subdivision or development versus the developer. And at least for residential, we supported the rider that was approved by the PUCN and so again, just understanding that the subdivision costs were not remarkable. They were less than 1%. But, you know, understanding that we all need to work together on these affordability issues.

So, you certainly have our commitment in that and it's something that

we all need to be cognizant of, and work on as we move forward towards implementation.

So, these are some of the other organizations that shared comments during the process. American Institute of Architects, the BlueGreen Alliance, who you heard from today. We also heard from faith-based leaders like the Mormon Women of Ethical Government, Nevada Clinicians for Climate Action, the Rocky Mountain Institute, and then of course the utilities and the home builders.

These are some of the comments in support for the plan that we received in addition to what we heard today. And then specifically, we made changes to the draft plan that we put out in December based on the written comments that we received.

So, I won't go through each of these individually. But just wanted to assure all of you that the comments that we receive were put to good use and we made some changes as a result of that. So just as an example, the Department of Health and Human Services asked that we make sure to focus on accessibility with regard to emergency communications. That's a great suggestion and something that we wanna make sure gets incorporated into our work with emergency services, as we continue to work with them on including a climate mitigation and emergency response to climate impacts planning.

So, we also heard for example from Southwest Gas on the plan making sure to stay the 2030 transportation emission reduction goal and to make that more clear throughout the document. And so, we've revised the draft that we made available in December, to reflect that change.

And then we received some general and anonymous com-comments as well. And we took action to make sure that we addressed those comments in the revised plan that's in front of you today. So, I wanna address maybe what's not in the plan. So, one of the things that we learned as staff, that our consulting team learned, that some of the environmental advocates learned, and I know that the commissioners learned, is that right now we are still receiving energy and electricity off of the grid that is coming from fossil fuels-based sources. And so, that is really what's driving the high priority action to increase clean renewable energy that we have access to in our community and to work to improve emissions that are coming off the grid, and then also energy efficiency. Those are the two highest priority actions, with regard to electricity use.

And so, a lot of the feedback we're receiving, particularly from some of the environmental groups about dealing with natural gas emissions today, we had to look at that from an objective framework of if we were to be able to magically snap our fingers and electrify everything tomorrow, what kind of emission reductions would we see. And because of the situation with regard to the emissions coming off of our grid, we wouldn't see as many emissions reductions as we wish from taking that action.

There will be a day when the last of the emissions that we have to tackle are associated with residential use of natural gas, commercial use of natural gas. We're just not there yet. And we've demonstrated, we can get to 72% reductions, based on energy efficiency and improving transportation related emissions and increasing clean, renewable energy that we have access to here in Southern Nevada.

So, we're not proposing a ban on natural gas. There's been some suggestions that this plan requires rooftop solar. It certainly doesn't require rooftop solar, but it encourages as much solar and renewable energy as we can accommodate. So, we're continuing to have those discussions with NV Energy. So, if you look at the details of the plan, the plan agrees that every rooftop should be made available and then also looking at microgrid options, pilot projects as an action, and then also improving our use of community solar.

And then there was also some suggestion in the comments that some people got the wrong idea that we were proposing to eliminate gas stations. I think they're getting us confused with California. We're not proposing to eliminate gas stations and, um-we are noticing more and more of our local operators taking more of an interest in providing electric vehicle infrastructure at gas stations as well as that transition in transportation continues to occur.

So, in terms of implementation priorities, there's a lot of opportunity to implement the actions that are in the plan and to take advantage of funding that we have coming from Congress and actions related to the Infrastructure and Investment and Jobs Act and then Inflation Reduction Act. So, one of the things that you all will be seeing at the second meeting in April is a report back on a climate pollution reduction grant that we're working with all of the local municipalities, to move forward on implementing some of our high priority actions, and then also an energy efficiency community block grant, also in coordination with agency partners.

So, some of our highest priority actions over the next three to five years are to stand up a regional climate collaborative. Jodi mentioned we had a government agency partners round tables, two of them, to talk about how we can regionally implement this plan. Instead of every municipality having a completely standalone unique plan, that we can all work towards implementation of this plan. The emissions, it doesn't matter if it's coming from the City of Henderson jurisdiction, unincorporated Clark County, Las Vegas, they're all the same actions to reduce emissions. And so, we can sort of gain traction and leverage by implementing them together.

County wide climate education program, so that's one of the things we have identified for this climate pollution reduction grant is implementing this, County wide, planning for this County wide education program. An energy program stacking model, so that's steep energy retrofits and energy efficiency, looking at creating a one-stop shop and we've identified the EECBG grant funds to help us more that forward. And the

the building disclosure ordinance, that you heard some of the advocate groups talk about earlier.

So, it's Earth month, what a great way to kick off Earth month. We're gonna have a lot of activities to get the word out about the adoption of the plan and how people can get involved. So, we are gonna have tables at different events, some of those are your events and your commissioner districts, scavenger hunt, virtual forums, daily word puzzles, and then also movies in the park.

So, I wanna take an opportunity just really quickly to thank all of our partners and stakeholders, as Jodi mentioned, I also wanted to acknowledge our consultant, Kim Lundgren and Associates. Kim is here today. Kim if you can wave. All of our colleagues here at Clark County, we had Department of Social Services, the Building Department, Comprehensive Planning, many of our colleagues here at Clark County participated in these meetings to help us shape this plan. And then, last but not least, the staff of the Department of Environment and Sustainability. We have several of them here today, so please wave so that you can be acknowledged. You did a lot of great work.

Alright. And with that, we'll run a short video and then I'm happy to answer any questions that you might have.

Scaling up renewable energy is Clark County's greatest opportunity to reduce emissions while also creating jobs. The actions in All-In aim to

More vehicles on the road mean more pollution, congestion, health impacts, and harmful emissions. All-In is helping southern Nevada transition to zero emission vehicles and providing accessible, diverse, clean transportation options.

Single-use product and overconsumption have created a waste problem that recycling alone cannot solve. And it creates greenhouse gas emissions. All-In embraces a circular approach that reimagines waste and resource use. Climate driven emergencies like extreme heat, drought, and flooding put our families and infrastructure at risk. All-In recognizes our vulnerabilities and identifies ways we can be healthier, better connected, and more prepared.

The energy we use to power, cool, and heat our homes and buildings account for nearly half of our emissions. Now are there any questions or comments from Members of the Board? Commissioner Segerblom?

I had a few, uh-I think they're questions, but maybe just comments. So do you have plans or is anything in here about trying to go into older neighborhoods to retrofit and improve, allow people to make their house more energy efficient?

Yeah. So that is the concept behind the energy program stacking model Commissioner. We are looking at other communities that have stood up one-stop shops. They're usually run by a community-based organization. And the premise there is that we can help residents and local businesses, in one location identify through an energy audit or other assessments, what are the improvements that they can make in their home or business to improve energy efficiency. And we've got those grant funds identified for that project, and we're looking towards a stacking model that this community-based organization can take the incentives that the utilities make available, federal funding, and all of the different incentives and rebates and package that up so the homeowner or business owner could take advantage of it and kind of be walked through that process. So

HENSON Mm-hmm. Yeah. That is a term. It's an action item in the section on in-

increasing clean, renewable energy. So, we want to demonstrate a model of some microgrid- grid opportunities here in southern Nevada and we've identified that as an item to work with NV Energy on in

particular.

SEGERBLOM And then finally, I know, I think the PUNC has approved or is in the process of approving a couple of natural gas, well natural's probably the

wrong word, methane gas power plants. Were we able to intervene in that proceeding? Is that something going forward we can try to prevent?

that proceeding? Is that something going forward we can try to prevent

So, a full disclosure, we wear two hats in my department on that action. So that requires an air quality operating permit from our department. So, we did not intervene in that docket, but we have certainly talked with NV Energy about the need to reduce reliance on gas fired peaker plants. Those actions received a lot of involvement from the advocacy groups as well. NV Energy did prevail on getting those approved, as they're finding it challenging to keep up with energy demand and also maneuver

utility-scale solar purchases that they need to make.

So, I think we have a commitment from NV Energy that they're working towards increasing their renewable portfolio. They have to do so by law, but, I think that's a fair comment and something that we're certainly tracking. And the plan identifies Clark County using its influence in reducing the use of fossil fuels in the delivery of energy to Southern

Nevada on the grid and will continue to do so.

SEGERBLOM Oh, if I could just follow up. So, have they already been approved for

their air quality aspect of those plants, or is that something where we,

when they come for us-

HENSON They have a-

SEGERBLOM ... for air quality we can, we can kind of tweak 'em?

HENSON

They have a permitting action in our department, for an air quality operating permit. And so, we have to treat them like we would any other application. And so long as they meet the regulations, provide all of the necessary information from the application, they will be provided the air

quality operating permit. And then, we enforce against that permit.

So, what they propose is a gas-fired peaker plant. They'll be limited on, how many hours they can run that facility and the types of emissions

that can be associated with that facility.

SEGERBLOM Alright. Well, hold their feet to the fire, please.

HENSON You can count on it. (laughs)

GIBSON Did you have a comment, Commissioner Jones?

JONES Thank you, Mister Chair. I just want to say thank you, Marci, Jodi, Sam,

the entire team, for (laughs) what is almost four years of work now, and to KLA for all they have done. 220,000 contacts is pretty amazing. I know that there was so much public engagement on this to make sure that it was something that there was a lot of buy-in. I appreciate the regional approach working with the other jurisdictions and with so many stakeholder groups to make this a priority. Plans are great, and I think now that the real work begins. Certainly, the County Operations Plan last year was a framework for us to lead by example, internally, and I think we need to continue that work as we are in budget cycle and we have capital opportunities here that we need to invest in this as a priority for Clark County, and continue the work that you guys are already doing and putting yourself, as you've already mentioned, in a great place for federal and state grant funding. This is really the framework for allowing us to do the great work that has to be done. And so, I just wanna say thank you for all of your work, and we look forward to supporting you in all the additional work that will need to be done over the next 50 years.

GIBSON Others who wish to comment? Then, we're ready.

SCHILLER Commissioners, Item 54 is to discuss amending the Clark County Code

complexes not open to the public.

GIBSON Mister Queano.

QUEANO Hello again, Mister Chairman, Members of the Commission, Vincent

Queano, Director of Business License. This item was brought forward by Commissioner McCurdy, to discuss a request from an apartment complex with a designated zoning of mixed use. They're requesting to be allowed to, for a liquor license to serve to residences and their guests for, um-beer and wine only. And currently, our Clark County Code, we don't have a liquor license category to offer residences of a residential

unit.

GIBSON So, this is a scheduled discussion about this item. Is there anything more

you need or can tell us about what is proposed?

QUEANO The proposal is for the management of this apartment complex to sell

beer and wine to the residences and along with the residences' family and friends, and it will not be open to the public. And if the proposal for a beer garden would be only ... The entrance and the exit will be only through inside the units and not through the outside where the public

could enter.

GIBSON Okay. I'm gonna turn this item over to the Chairman of the Liquor and

Gaming Licensing Board, Commissioner McCurdy.

MCCURDY Yes, thank you, Mister Chairman, and thank you for the presentation.

So, the applicant, approached us and asked if we would entertain a discussion to allow for their high-end apartment complex to have a

liquor license as indicated, by Vince. And there was a few

considerations as we were going through this entire process, and one of the questions were, "Well, do you even need a liquor license?" So, Vince, if you could just walk us through some of those considerations,

that led us to this point.

QUEANO Oh, yes. Mister Chair, so, staff reviewed the proposal, and we've

determined that a liquor license is not required to sell or serve alcohol

from management to a guest or to a resident of a apartment complex for residential unit. And then, following that, there was an issue, I believe, that the difficulty obtaining certain types of beer and wine from retailers. And so, that's when the proposal or the request came through, asking for a liquor license so that way, the licensee or potential licensee would be able to obtain the specific alcohol from the wholesalers.

And also, it is our understanding that this applicant also provides these same services to their residents in Anaheim, and one of the questions that were brought forward was, you know, "Will there be a consequence, you know, to the applicant who operates the high-end apartment complex, for them selling alcohol on premise without a license?"

And they were also inquiring as to if there would be, if there is a state prohibition for selling liquor without a liquor license, in scale as well. That was something that I think that we should have answered by our legal team here, as we move forward just so that we can be clear, yes, we do have our own code, but we should definitely know if there is, if there would be a conflict with state law as a result of this.

Yeah, that's something we'll look into for you.

Alright. That's all I have at this, at this period.

Can, may I just ask a question? So, we have a three-tiered system within our state. There's a reason that we go through the distributors. There's a reason that we do those things. So, if you had a beer garden, you could honestly go to a Costco and get what you want anyways, right? It's no different than a regular party or the way smaller residents do it.

But, one of the ... And I feel old today, here (laughs) on this Board because I just feel like we're trying to make changes to accommodate people one offs. And so, the three-tiered system, the reason that the three-tiered system works and that we've protected it for so long was because at one point, the grocery stores were coming in and they were drop shipping, and there was zero taxes that were (laughs) actually coming and funneling down from the state to then 'cause they weren't paying their fair share.

(laughs)

So, I just am ... I'm curious as to what this does to the three-tiered system. If we do this today, what stops everyb- ... And listen. I ... Highend, low-end, whatever, it applies to everybody. We don't just create an ordinance that doesn't apply across the board. So, we could talk about high-end all day, but that doesn't mean that an apartment complex in my district that wasn't open to the public couldn't come in and start this.

So, I wanna holistically look at this, and I think it starts with the threetiered system because we have a responsibility to make sure that that stays intact because we rely on it. It is a key component of our sales tax. It's a key component of how we distribute the consolidated tax. I mean, KIRKPATRICK

there's ramifications, and we're doing one thing because somebody does it in another state. But I don't know that we necessarily need to open a can of worms

But I'm ... that's ... I feel old today. You guys have dated me, making me feel like I'm old and boring, but there are some things that I just feel that we have to keep in place because they've worked for 140 years (laughs) in this state, that three-tiered system. So, I'd just like to see more about it

I just wanted to comment. I don't think you're old and boring. (laughing) 140 years is young.

Thanks. (laughs)

And also, I think it might be prudent to discuss some of the other considerations that were brought forward by the applicant around crafting such language because I had certainly, am in agreement with just opening this up and then it potentially affecting everything that's been done over time.

But if you could speak to some of those high restrictions, the mixed-use projects and so forth that were brought forward, that would be helpful for the Board as well as you go back and try to put this together.

Okay. You want me to state the .... This is Vincent Queano again for the record. So, some of the restrictions or some of the operational procedures that were submitted were, the beer garden would not be open to the general public. They have plans for age verification and issuance of wristbands, surveillance, and monitoring, training on over consumption, noise controls, and zero tolerance on criminal activity.

The management will, or the ownership will serve snacks including but not limited to nuts, chips, and vegetables prepackaged, that will be provided at no charge to encourage moderation. And then, again, I guess, it's a rooftop amenity area would be only allowed to have a beer garden based on information, and it would be beer only and not, no hard alcohol.

And then, just to Commissioner Kirkpatrick's point, staff did reach out to our liquor retailers, just to discuss any issues with a customer requesting a particular alcoholic product that they don't currently, or they don't stock regularly, and as far as the retailers that we've reached out to, they are able to obtain any alcoholic product but obviously, at a higher cost since the order would not be made in bulk.

And just finally, Mister Chairman, it is worth noting that the applicant, in their opinion, was just coming forward to be in compliance with the three-tiered system as well, and just wanted to make sure that they went about this the right way. And that's all I have at this period.

Well, I'm gonna ask for my own separate briefing on this just because I,

you know ... look, at the end of the day, what stops everybody from creating a venue like this? And I just, in my district, I just am concerned because that's part of the problem that we have on the whole Fremont thing. They've shut down all those things 'cause they were building these types of venues. And then, what happens to folks?

And I cannot afford in my district for people to not have anywhere to go. So, but they likely wouldn't come 'cause I'm not high-end enough, but it's all good.

**SCHILLER** Commissioners, Item 55 is to discuss amending the Clark County Code

**GIBSON** Let me, let me hand the gavel to (laughs) our Chair.

Thank you, Mister Chairman. We have a few items today. Vince, go **MCCURDY** 

ahead.

Hello, again, Mister Chair, Members of the Commission, Vince Queano, Director of Business License, for the record. I just wanna provide an overview presentation on liquor delivery that was adopted by the Nevada Tax Commission. So, pursuant to NRS 369.489 on December 5, 2022, the Nevada Tax Commission approved regulation LCB File No. R068-21 allowing for the delivery of liquor from licensed retail liquor stores. These regulations apply to retail liquor stores which are defined as an establishment where beers, wines, and liquors are sold to a consumer. The establishment must sell all three types, beer, wine, and liquor. This excludes convenience stores and brew pubs as they do not sell all three required types of retail products.

These regulations require the County to adopt an ordinance f- allowing for liquor delivery by third parties such as a delivery support service. The liquor must be in its original, unopened container. The delivery must occur in a jurisdiction in which the retail liquor store is licensed to sell liquor at retail. There is not a limitation on the amount of liquor that can be delivered a limitation on the number of deliveries to a specific address or a consumer per day.

State law requires any delivery of liquor to be made to a person who is 21 years of age or older at the address specified on the order as a delivery address and prohibits the delivery of liquor to a person who shows signs of intoxication. The person making the delivery cannot complete the delivery until shown an acceptable form of identification

showing that the person accepting the delivery is 21 years of age or older. Acceptable forms of identification are a valid driver's license, permanent resident card, Tribal identification, or any other written or documentary evidence issued by a governmental entity indicating that the person is 21 years of age or older.

The delivery must originate during the posted hours of the retail liquor store. The regulation requires a person who makes deliveries on behalf of a retail liquor store or delivery support service to maintain a delivery log which contains certain information for each delivery of liquor made. These records are required to be maintained for four years and must include the name of the purchaser, the name and date of birth of the person who accepts delivery as shown on their form of identification, the street address of the delivery location, the time and date of the purchase and delivery, and the signature of or other verification of the identity of the person who accepts the delivery. And that concludes my presentation.

Thank you, Vince. I believe there is one question, but before we go to that one question, I wanna make sure, that we prohibit these deliveries into the H-1 zone.

Yes, Mister Chair. I'll defer to counsel, but I believe Section 8.2 allows the County to be more restrictive.

Yeah, so, this is before you for discussion on what types of things would you like to see in an ordinance. So, things about more restrictive whether it's areas, hours, other types of things to do with minor access, and things like that. That's what we're looking for a direction on.

Got it. Commissioner Naft.

Thank you. Just a couple things I'd like to ask for. One is, first of all, I should said, Director Queano, you and your ... You guys are doing a great job. You have a full plate right now, and a lot of these issues are complex. So, thank you. I appreciate it.

But aside from that, on this item in particular, could you make sure that you work in consultation with the County's Office of Traffic Safety? I think they have some pretty good data on this topic generally that-

Mm-hmm.

... might be useful in guiding the conversation.

And then, secondly, could you either, maybe share with the Board, not at this time, but do some research on how the delivery of narcotics is being handled? I believe there's some licensing component, but delivery broadly in the last couple years has just exploded, and I think it probably is, well, part of the reason why we're here today. But I think there might be given that that's a restricted item, there might be some interesting comparables.

It's free to walk if you use passcode BA06, baker, alpha 06, or you can Google passes to NAB, and you'll see other items on it. At the, uh-they at, uh-NAB, you see everything that you need to have a, a television station, a radio station, the editing of videos, and things like that, and it's open.

You can come in and try out different cameras. Even if you can only afford a lunch break, have Google to have Uber take you to the West Hall and walk through for an hour and have them pick you up. But it's free information. That's what we build on. The cost of it is \$165 for three days, but again, it's free to attend, BA06.

The spokesmans, the keynotes, they're CEOs. I mean, you would pay a lot to even consult with these individuals. You'll have Microsoft and Google. They'll have free little seminars going on. If you can't go, send somebody from your training department to go and have them go take notes for a couple hours. They don't have to go to the whole thing.

Then, we have the might, White Label Conventions show coming up. That's May 3rd and 4th, and that's a private label. What that means is these are companies that have a product that's been approved by government that's ready to go, and if you want to, you can walk up and say, "Put my name on it." And they say, "Okay." That's what a private label does. So, they'll handle it.

Commissioner Gibson, Mister Hill, the CEO, the, the valuable and CEO of Las Vegas Convention Visitors Authority, during his evaluation, he mentioned he was get ... One of his goals is to get more locals to attend the convention. Do you know what is happening? Well, I can't ask you that. But it'd be fun to know what's, what's going on. CES had 130,000 people at-

If you can wrap it up, Daniel.

What's that?

You can wrap it up.

I appreciate that. Consider having the Las Vegas Convention fill, send out a, a weekly email to all the municipalities and all the communities in the state of Nevada and say, "These are the ones that are public. These

are the ones that are free. Consider attending." Thank you, sir.

Yes. My name is Ed Uehling. I pointed out several areas where the government is creating the problems that, (laughs) that we have. And this whole sustainability idea is another example of that.

I've been telling the Water Authority for the last 25 years that they should take the lead in preventing Lake Mead from being emptied. Well, by emptying Lake Mead, or be letting the water go down, we've lost over half of the generating ability of the Hoover Dam, which is the number one sustainability example in the entire United States, and maybe in the world.

It's...By letting the water go down, it isn't generating as much sustainable electricity as before. And this is a problem, and this is a problem created by the government.

Another problem that's being created by more recently, taking up of greenery on the east side of the county and creating a heat island. And that's going to affect us in the future. It's gonna cost billions of dollars to overcome, and it's all for the benefit of donors such as the Hughes Corporation that wants to have more water, 40,000 gallons per month, per house, up on 4,000 feet above sea level that has to be pumped 3,000 feet in order to get there. And we're, (laughs) we're not only paying for it. We're going to pay for it again and again and again. And this is, these are examples of government causing problems
