So – um - excited to actually have that branch open and going, and – um - it will make a difference. Also – um - I was invited to – uh - Strong Start Academy, at Lorenzi. Um - I filled in for Commissioner McCurdy because the date kept changing a lot. Um – but – um - Alex Ingold, who's with the Raiders – um - he was there - And I will tell you, it was - he was a very humble, down-to-earth guy. We talked and played with the kids, we read Brown Bear, Brown Bear about three times – or - the kids read it to us, actually. But – um - I just wanna say thank you, because what he did is he brought in toys, he brought in – um - supplies for the teachers, and he really spent some time. And so we - I asked him if he was so good with the little ones, you know, did he have a little brother or sister, and he said he did. So – um - he told us also that he can't wait – um - District B kids had never been in a parade. So - we always try to expose District B kids to different things – uh - across the valley. So - we always try to expose District B kids to different things – uh - across the valley. So - we brought kids from the east side, North Las Vegas, the northwest and – um - had a great time, at least for the kids. And you guys will appreciate this as parents - um - they kept asking me every ten minutes, "When's it our turn, when's it our turn," because we had to get there at 7:00 for parking; and at the end th |

and we really wanna try to expose them. But there were some folks. So - we had Sean who was our traveling DJ. He comes to all of our events, so he – um - volunteered his time to play music all the way through. We had – um - Bob Price helped us with our sign - uh, "Living the dream, setting the new standards." And we really got to talk to the kids about what that means and the future, so that they - to Commissioner McCurdy's point - so the kids really know what it stands for and - and what their role is in it, because so many of them – um - were new to it. Um - then we - we had - um - our Christian Church from the area come. And then, most importantly though, I wanna thank Will Covington, because we gave him this project and he knocked it outta the park for us, and he did a phenomenal job, and Gina and I were just, "Whatever we - whatever you need, Will. We're right there for you." So - but he really did a great job, and the - the kids said it was the best time that they'd had, and they can't wait till the next one. So, I - I'm assuming we're doing the Helldorado Parade, because we tend to follow the kids. And – um - they tell us what they would like, but they also trade us by staying in school, keeping good attendance, and doing community service. Um - next - uh - we are working on a Moapa Valley, economic - uh - development - uh town hall. So, we've been working with them for some time, for a little over a year, and as many of you will know, we have the baseball fields that were approved, which will be huge for that area out there because they play so much baseball. I don't know any kid in the Moapa Valley or Moapa area that doesn't play baseball. Um - so we'll be having a Zoom meeting with them to talk about - uh - redoing the main street, to bring up - uh - some landscaping, repair some water lines, and to really start making it at vibrant town. And what we'd like to see is something that's similar to Santa Clara or, um, a smaller town feel. So, we'll be working with them. Um - you all will remember last year that I did Clothes for Comfort. So, we are going to do that again. Um - we had great success. All of the clothes went to the Harbor. We collected over – um - six tons of clothes, from shorts to socks, to – um - coats. So, we'll be doing that again. And here's why - I'll tell you it's important. So - the Harbor was great. So many times, so many kids that need clothes - um - they just take whatever hand-me-downs. They don't ever really fit right. They don't do any of that. So, the Harbor was able to establish a boutique so the kids could actually try them on and make sure that they fit; they can look through the clothes. And so, the staff did a great job. So, we'll start that February First through March First, our community – uh - rec centers will help us with drop-off locations. So - know that all of those clothes go back into the community, and we always take new or gently used. Um - I tell people, "Don't give me anything you wouldn't put on your own kids - um - because our kids deserve the best." Um - so that'll start. Um - then - um - co - I wanna remind people, COVID testing. Uh - we were able to set up two new locations. Um - as you know, everybody was frantic: "How do I get tested?" Um - so we set up the Fiesta, as well as moved to the Sam Boyd Stadium, and we set up the Texas in what – um - I will tell you is we're processing through. We have great partners that are working with us, so if people want a test, I encourage them to go to the Southern Nevada Health District website, and there are several locations today. I looked and there's twelve different locations, plus our drive-through locations. Plus, don't forget that we have well over one hundred pharmacy partners where people can get their test. Um- and then, I would, don't wanna forget Water Authority - um- we are working to encourage people as we come into the Spring months so, anytime we get a drop of rain I get excited because it's just a little bit for us.

But - um - this is a good time of the year, as we go into the spring, to remind people to cover your pool, to reduce - um - any water that can be lost from evaporation, to check those toilets, to make sure that, um, everything is tight and there's no leaks. Uh, follow the mandatory, uh, restrictions. And, as you know, that only 50% of our community is doing that. So, we encourage everybody to do their part and, and don't hesitate to report any water
