Good morning. We want to welcome you to the Board of County Commissioners meeting. The meeting will come to order. Uh, this morning we will have, uh, an interesting prelude to our meeting. We have, uh, a couple of things that I'd like to announce to you. First of all, we have Aliyah Hibbler, who is a "Kid Mayor" shadowing Commissioner Miller during this meeting. Would you at least wave to them? There she is.

So, Aliyah is, uh, a part of, uh, The Nevada Institute for Children's Research and Policy at UNLV. Uh, she is going to shadow Commissioner Miller and, uh, he will teach her a few things, and she'll probably teach him a few things, too.

Each year, Step Up for Kids events around the Country bring together thousands of people to show widespread support for investments in children and families throughout the Country, and our State. These events focus on raising awareness of issues American children face, such as access to early care and learning programs; access to afterschool programs; poverty; child abuse and neglect; and healthcare, and the list goes on and on. It is also a way to encourage families to vote. At the local Step Up for Kids event, 4th and 5th-graders have the opportunity to run for kid mayor, collect votes, and campaign for an issue that they're passionate about. One of the "Kids Mayor" finalists at the recent Step Up for Kids event locally, in 2021, was Aliyah, who was named their Kid Mayor Pro Tem.

Aliyah recently finished 5th grade at Billy and Rosemary Vassiliadis Elementary School. As a Girl Scout, she says that she learned that if you need... if you see a need, you take action. Aliyah ran for kid mayor because she wants to live in a city where all kids grow up healthy and happy. Some of the issues she is passionate about include mental health and self-esteem, in particular... in particular, self-image and how we should encourage one another to stand against bullying; safe housing for kids, and healthy food for all kids. WILLIAM MCCURDY II Uh, thank you, Mister Chairman. Uh, Pride Month is upon us. As you all know,

the LGBTQ Pride Month is currently celebrated each year in the month of June to honor the 1969 Stonewall Uprising in Manhattan. The Stonewall Uprising was a tipping point for the gay liberation movement in the United States. During the month of June, we celebrate generations of LGBTQIA+ people, who have fought at a local, national, and global level for justice, inclusion, and equality. All across the world, Pride Month is celebrated with parades, picnics, parties, workshops,

concerts, and more, which attract millions of participants; and locally,

organizations including the LGBTQ+ Center of Southern Nevada have curated some amazing events to celebrate and gather across the Valley during Pride

Month.

MCCURDY I would like to bring up, uh, John and the entire team from the Center to present a

proclamation for Pride Month and recognize their service to our community year-

round. Please join us. (crosstalk) Doctor Wong (inaudible) excuse me.

JOHN WONG Oh, thank you. So, thank you, Commissioner McCurdy; and thank you to all the

Commissioners and all of you here today. Pride is obviously very important to us. It's our celebration of, of, uh, living authentically, which is what the Center is all about, and if you haven't been to the Center in a while, please do come by. Uh, we have a lot of amazing things going on. We're poised to, uh, grow significantly soon in our medical services, our pharmacy, which is... All of that's gonna serve all of Downtown Las Vegas, not just the LGBTQ Community, and we appreciate the support of the Commission and all of you, and so, Happy Pride, everyone.

MCCURDY (inaudible) All right, we'll pose

GIBSON The next item is, uh, a, to present a proclamation to, to Pearson Community

Center, Desert Breeze Park, Juneteenth Nevada, and Rainbow Dreams Education

Foundation, in honor of Juneteen- Juneteenth. Commissioner McCurdy?

MCCURDY Uh, thank you, Mister Chairman. Uh, Juneteenth commemorates the date of June

19th, 1865, when the remaining slaves in Galveston, Texas, were informed of their freedom by the Union Soldiers. Today, Juneteenth commemorates African American freedom, with an emphasis on education and achievement. In June 2021, President Joe Biden signed the Juneteenth National Independence Day Act, declaring Juneteenth to be a U.S. Federal Holiday. The Pearson Community Center, Desert Breeze Park, Juneteenth Nevada, The National Juneteenth Foundation, Rainbow Dreams Education Foundation, respectively, will host Juneteenth events during Juneteenth weekend to commemorate the abolishment of slavery and celebrate the positive impact of African Americans in our community and around our Country. Now, therefore, we the Board of County Commissions of Clark County, Nevada, on this 7th day of June, 2022, do hereby recognize Juneteenth the national independence day, and honor the contributions of African-Americans. I'd like invite each of the organizations up here to say a few words, and again, we thank you for recognizing Juneteenth, uh, Freedom Day

for all of us.

JUSTIN JONES As our folks are making their way, uh, down here, I just wanted to again

recognize all those that are, uh, here. Um, Juneteenth is a, is, is a very special celebration, and we are grateful for our own team at Clark County Parks and Rec for really stepping up to the plate. We've been working with Desert Breeze, which is in, uh, my District, um, in order to honor the, the heritage of those who, uh, did

JONES so much in order to preserve, uh, liberty in our Country and step up, including one

right here. Well, I'll go ahead and pass it to...

MCCURDY Um, we'll start with, uh, we have Doctor Pollard here, from the Rainbow Dreams

Foundation. Doctor Pollard, if you wanna say a few words about the work that you do and you have been doing in our community, on behalf of Juneteenth?

DR. DIANE POLLARD Sure. Thank you so much for having us. I'm Diane Pollard, and this is my

husband, Doctor Anthony Pollard, and this is our 21st year with the Las Vegas Juneteenth Festival, which will be held June the 18th at the Expo, at the World Market Center. Come out. We're looking forward to seeing everyone there. Thank

you so much.

MCCURDY Thank you, Doctor Pollard. We will now hear from Miss Dee Evans, at the

National Juneteenth Foundation.

DEE EVANS Good morning and thank you. I thank you both from Juneteenth Nevada, and as a

representative of the National Juneteenth Observance Foundation. We do Juneteenth 365 days of the year, and after 27 years of advoca-, of advocating for that holiday, we were at the table with Miss Opal, our Board Member, last year.

So, please enjoy, recognize, and pass the word of Juneteenth for all. Thank you.

UNIDENTIFIED Thank you all so much. Thank you, Clark County Commissioners, and

Commissioner McCurdy. Um, we are honored to celebrate, um, Juneteenth as a department, um, and we are excited to have you all out at our events, um, and again, we wanna just thank you for recognizing the day, understanding its significance, and moving forward we hope to celebrate with each and every one

of you.

SANDRA Hello, good morning. Um, my name is Sandra. I am representing Pearson

Community Center. I just wanted, uh, take, take the time to tell you our

appreciation for recognizing Pearson and the Clark County Parks and Recreation Department on this, um, Juneteenth event, as well as just proclamation overall. It's a big recognition for all of us, and in just recognize the, um, overall Juneteenth.

Thank you again, um... oh- (laughs)

UNIDENTIFIED Nope, just um, Desert Breeze (laughing)

MCCURDY Well, there it is. Um, uh, let's give everyone a round of applause, please.

GIBSON Next item. The next item, uh, will be to present a proclamation to Lucy Jacobs,

recognizing her as a survivor of the Holocaust. Commissioner Naft.

MICHAEL NAFT

Wanna join me in in a second? Thank you, Mister Chairman. Uh, last month I had the, uh, humbling experience of attending the Yom Hashoah Celebration, uh, Commemoration, uh, and I met at that time, along with my daughter, Miss Lucy Jacobs, who we're joined by today, m-... Miss Jacobs has an incredible story. She has, uh, made it out of tragedy and turned that tragedy into a truly, uh, remarkable life, um, and I'll, I'll give her the microphone just in a moment. But I just want her to know how much it means from this entire community that she is willing to educate the community that, particularly with increasing rates of anti-semitism, uh, Holocaust denial, she has stepped up time and time again, throughout her whole life, to really dedicate herself to making sure that the future generations, uh, know what she went through. Um, and, uh, uh, I'd like to turn the, turn the microphone over to Miss Jacobs. Lucy?

LUCY JACOBS

Good morning, everybody. Thank you for having me. My name is Lucy Jacobs. I was 14 years old when they put me in the concentration camp. My mother and father and my family was killed. They put them in the gas chamber. I was lucky because Mengele send me to the left, and my mom and sister to the right, and they were straight in the gas. I went to the right. Unfortunately, I cried after my mom, yelled, "Mom, wait for me." They were pushing her to the gas. I went to the right. I was 14 years old. My sister was 10, and she went with my mom to the gas. I happened to be lucky. Mengele send me to the right, and the rest went to the left. I came into the right crying after my mother, 14 years old.

Came a guy. I think God send him from Heaven. He said to me, "How old are you, little girl?" I said, "I'm 14." He said, "No, no, from now on you're 16." I said to him, but I never lied. "You gonna lie now." And this way, to save my life, I was taken to work. Cut my hair, bald. Took my clothing, everything, and put into the camp, with barbed wires all around. A little girl. Then they got me to work. Everybody got cut their hairs, naked. They took our clothes away, they gave us one mumu dress, and that's how I lived.

Unfortunately, all wires, barbed wires, all around. We couldn't run away. We just could kill ourselves. That's what we did. We went on with life, hungry, barefooted, naked, no soap, no toothbrush, no nothing. I lived that -that way two years for my life, and thank God, thank God, that we were liberated by the British. From Auschwitz, I went on the Dead March, because the Russians were coming closer to liberate Auschwitz, and they chased us out, the Nazis, to walk on a Dead March for a couple of weeks, until we got into a different camp, and there, thank God, we were liberated by the British. I was, that time, sick on typhus, and they picked me up from the floor, they put me to the hospital, and that's how I survived.

UNIDENTIFIED

You're lucky, Ma. (Foreign language)

JACOBS

JACOBS

Thank you very much, that you having me here and telling me my unfortunate story. Thank you so much for having me.

(applause)

AUDIENCE

I have a tattoo on my arm.

NAFT

So, so for tho-... And clearly, everybody in this room understands what they just

NAFT heard, but for those who might be watching and don't, it is more and more

uncommon and rare to meet a, a Holocaust survivor and to hear a first-hand account, and that was really special for me, to be able to introduce my two-year-

old daughter, uh, to Lucy; um, and I know for each of you, to have the opportunity to meet you. And on behalf of this entire Board of Clark County Commissioners, this entire community, we wanna present you with this proclamation, uh, Tuesday, June 7th, in recognition of Miss... In thanks to Miss

Lucy Jacobs and all you've done for our community. Thank you...(crosstalk)

JACOBS Thank you very much. (inaudible) (crosstalk)

ERICKSON Commissioner, could we hold that as straight up and down as you can? There we

go. One, two three...(inaudible)(crosstalk)

JACOBS Thank you very much. (crosstalk)

GIBSON One thing we don't have on the agenda is that today is Commissioner Michael

Naft's birthday. So, we-

AUDIENCE (applause)

MCCURDY (inaudible) It's your birthday.

ACTION: No Action was taken by the Board.

ITEM NO. 5 Public Comment

GIBSON (Laughing) All right. This is the time that we hear from the public. This is the

public comment period. Today is a, uh, we, we have an interesting meeting. There are probably some things that would evoke comment, uh, but the, that are not public hearing items. And so, if you are here on an item that is not a public hearing item, this is the time for you to come forward and speak, uh, and

comment to us.

The public hearing items are Items 48, 49, 50, 51, 52, 53, 54, 55, 56. Those are the public hearing items. If you want to speak on an item that is not on the public hearing, this is, that is not listed as a public hearing, this is the time that you must come forward. So, we would invite any who wish to comment on items on the agenda to come forward, give us the item number, give us your name, spell your last name for our Clerk, and please limit yourself to 3 minutes. Good morning.

PAUL CATHA Excuse me, Commissioner. Did you say items on the agenda or not on the

agenda?

GIBSON This is all, all items on the agenda. This is exclusive to the agenda. If you have

items on the agenda you wish to comment upon, uh, and even if it's a public hearing, if you comment now, this is the comment you get to give. In other words, you don't comment today, in this moment, and then when we call the item... Uh, public hearing items, the ones I listed, you'll have an opportunity to speak at that time. None of the other items will, are public hearing items, so now is the time that you must speak if you're here on an item that is not a public hearing. That,

GIBSON have I made that clear?

CATHA Yes.

GIBSON Okay. Just tell us what item you're here on.

MILLER You can speak on anything afterwards.

GIBSON Yeah, at the end of the meeting you can speak on anything you wish, but this, this

particular, we have a public comment period at the beginning and at the end.

CATHA Okay, so now I can do something that's not on the agenda at all?

GIBSON No, you can't.

CATHA Okay.

GIBSON This is, this is for the agenda items. Okay? (silence)

BARBARA PAULSEN Good morning, Chairman Gibson, and Commissioners. My name is Barbara

Paulsen: P-A-U-L-S-E-N, and I'm speaking on behalf of Nevadans for the Common Good regarding Items 59 and 66 on today's agenda, related to the Short-term Rental Ordinance. Nevadans for the Common Good is a broad-based community organization with 40 institutional members across Southern Nevada. We have been working with and through our congregations, neighborhoods, and social service organizations before and particularly during the pandemic to

understand the reality of today's housing crisis.

In the last several months, we've conducted numerous workshops on housing concerns, led five neighborwood... neighborhood walks, in various parts of the valley, and held three large community meetings with County Commissioners with combined attendance of 250 people, and we thank those of you who were able to attend those, uh, meetings.

We've heard countless stories related to the lack of affordable housing, tenant's rights, and the impact of short-term vacation rentals on access to housing and to neighborhood quality of life. The proliferation of uncontrolled vacation rentals is linked with the preservation of affordable housing for our residents. Regulating these properties is a necessary way of limiting this proliferation and providing housing security to our neighbors across the Valley. Nevadans for the Common Good supports the ordinance as shared on April 27th.

Specifically, we agree that licenses should be limited to one person or entity in order to stem the trend of turning our homes into hotels owned by large equity firms. We also believe that the 1000-foot distance requirement will help reduce the proliferation of short-term rentals in neighborhoods and accounts for all types of diverse neighborhoods that exist in Clark County. Additionally, the licensing of accommodation facilitators is an important step in holding the online platforms accountable for their role in facilitating potentially illegal and harmful businesses. We hope all these provisions remain in the final version of the ordinance.

PAULSEN

As I stated earlier, short-term vacation rentals are only one aspect of affordable and accessible housing for residents. Nevadans for the Common Good supports the findings listed in section three of the draft ordinance, particularly Item A, that states: "The primary function of residential development in the County is to provide permanent, affordable housing for the residents of the County. The commercial use of residential development for transient lodging is inconsistent with this purpose and constricts the availability of affordable housing." We believe that the three pieces of the ordinance that I just spoke about are in keeping with the spirit of that finding and can be effective for continuing to provide permanent housing options for our community. Neva- Nevadans for the Common Good is committed to working with Clark County staff and officials as this ordinance is implemented, and we are also committed to working with you to find additional solutions for preserving and expanding Clark County's housing supply. We thank you for your attention.

GIBSON

Thank you. Good morning.

DAN MEYER

Good morning. My name is Dan Meyer. I am also with Nevadans For The Common Good, and I'm speaking on the same two items, 59 and 66, on today's agenda that Barbara just spoke of, and I want to reiterate what she said.

I won't repeat the whole thing, because I know you have a copy of her, of her speech, but I also wanted to say that I am actually a short-term rental owner, um, one in Las Vegas, one in Henderson, and, and two out of state, and I strongly believe in the, the necessity for licensing and enforcing of the licensing requirements for short-term rentals. I think that there are a lot of abuses in this industry that are, um, harmful to our neighborhoods, and I want to, um, recommend or continue to endorse the, the proposal that you have, have made with items 59 and 66 on today's agenda. So, thank you very much.

GIBSON

Thank you. Is there a Jimmy Silva who wishes to speak? And Summer Pelletier?

JIMMY SILVA

Uh, hi. My name's Jimmy Silva, um, and I disagree with them on some of the, um, uh, comments that they made about short-term re- rental. Um, I think that it, it's beneficial for people to have another source of income, and I think that if, um, looking at it in a different way, um, it helps other people, um, uh, find, find other avenues of income and, um, and, and I think that, that if you have a house and you wanna make a little bit of extra income, you should be able to. You shouldn't be limited, um, by the regulations, especially the, the 1000-feet regulation. Um, there's another rental down the street, and it's, and it's close to yours. Um, you should be able to do it yourself. That's pretty much all.

GIBSON

Thank you.

SUMMER PELLETIER

My name is Summer Pelletier: P-E-L-L-E-T-I-E-R, and I'm speaking on Items 59 and 66. Uh, particularly post-pandemic, Air B&Bs and short-term rentals are a lifeline for residents, and also growing families who rely on income to make ends meet. I think licensing is important to bring more revenue to the State, but caps on other distance limitations only enable a few property owners to benefit from the short-term rentals, and they prevent responsible hosts from earning meaningful and supplemental income. Um, signages identifying homes as, as, uh, short-term

PELLETIER

rentals also can contribute to property crimes in the neighborhood, and, um, we hope that we can find a way to implement reasonable rules that allow responsible hosts to continue hosting, and, um, oppose even more restrictions on the short-term rental owners. I'm done.

GIBSON

Thank you.

PELLETIER

Thank you.

JOSE ABBOTS

Good morning, Commissioners. My comments are regarding Item 66. My name is Jose Abbots: last name is A-B-B-O-T-S, and address is 7824 Pink Ginger Street. As a me-, as a person who's family is ex-Culinary Union Member, impacted heavily by the pandemic layoffs, I support regulating STRs, but not in its current form. We are rebels and technology is disruptive to old world orders.

What does NASA's latest rocket, named Space Launch System, and Las Vegas's latest STR draft laws have in common? They're both use-, they both use archaic, involve waterfall systems to create. To build a rocket ship, you probably think you design the whole rocket, do some math, science, and accounting, then start building the rocket. The classic waterfall rocket design was planned to take six years, and we missed that deliverable by six-plus years, and billions of dollars over budget, with the project at risk for being canceled. Young SpaceX, SpaceX, has already immense success, and is more than likely the successor to this runaway government project.

The success is due to less regulation in the space industry and adopting new applied technologies. This is a story of old-school methodologies versus new school methodologies that embrace technological advances to old problems. The success story comes to fruition because the government agencies work with private agencies to help realize their common goal for the future. Las Vegas is attempting legislation based on research to account for everything. However, that legislation is over calculating and using a flawed set of data to generate proposed legislation. The proposed laws for STR owners will not provide incentives to apply, which means lost tax revenue for Las Vegas. STR owners want to pay taxes, but not feel threatened.

I propose you start a lax permitting process that just allows you to generate and maintain a full inventory of STR's in Las Vegas of which you can generate tax revenue from the permitted businesses. Based on this info, you can start to see the real issues and address them as appropriate. For example, tracking and banning trouble STR's and business owners, slum lord STR operators, corporations actually removing affordable housing inventory while exploiting the lack of rent controls, which is a whole other issue not related to STR's based on my data. While, with this new funding, you can create programs to make sure that the STR future is strong and bright in sunny Las Vegas, while enabling a synergistic model with the existing hotel casino industry. The current proposed legislation lacks metrics to show effectiveness and sounds clunky as it would take 6 months to create a permitting process. That's all, thank you.

GIBSON

Thank you.

SPENCER LAZARA

Hi, my name is Spencer Lazara, a resident here in Las Vegas. Um, my biggest issue with all this is that it infringes on rights that go far past the law of the land. Um, having a sign up that shows a property as a short-term rental opens up that property to being watched and robbed. And, with an influx in crime, where I myself had my catalytic converter stolen out of my driveway, having a sign that gives would-be burglars the ability uh, to see when properties are vacant and target them, uh, far too easily, I guarantee that this will happen if this motion is passed. Um, as she said, I, I think there are ways to, to make sure that things are done, but this far overreaches safety of these properties and people's property. Um, you know, neighbors, um, not all these short-term rentals are big businesses. No neighborhood. People can determine what someone can and cannot do with their home.

It is just absurd that neighbors can tell you what to do with your property. In fact, a New York court just struck down an attempt to do just what is being proposed here. And I quote "the decision today is a huge win for Airbnb and it, and its users, including the thousands of you...New Yorkers at risk of illegal surveillance who use Airbnb to make their ends meet," and Airbnb spokesperson said in an email to Fox. The court recognized the fundamental importance of the New Yorkers' constitutional rights to privacy and the security of their homes. Thank you.

Good morning, uh, Commissioner. Uh, here to comment on agenda Item number 51. Uh, My name is Paul Catha and I'm speaking on behalf of the Culinary Workers' Union Local 226. As the County is looking at reducing fees for businesses at the airport, it, it should also look at increasing wages for workers. Uh, you heard from workers a couple months ago about working conditions and wages at Harry Reid International Airport.

The Culinary Union knows that these jobs are vital to our economy and the safety of our community. Establishing a living wage for workers at the airport will benefit both by creating a more stable work force and benefit our community by ensuring that one job is enough for airport workers and their families. Many cities across the Country have already established a living wage for airport workers including Baltimore, Boston, Chicago, Denver, Fort Lauderdale, New York City, Los Angeles, Miami, Minneapolis, New, Newark, Oakland, Philadelphia, St. Louis, San Francisco, San Jose, Seattle, and Washington D.C.

The Culinary Union will be bringing forward a propo-, a proposal to establish a living wage for airport workers at Harry Reid International Airport in coming weeks. And we hope that we can count on all of you to sort, to support that proposal when we do. Thank you.

My name is Josefina, last name Rebollar.R-E-B-O-L-L-A-R. And I have been a utility porter at LSG Sky Chefs for 17 years. As a utility porter, I sweep, mop, clean, and sanitize the cafeteria, restrooms, work area, and all the equipment that is in the kitchen. I also clean areas where the food is being prepared for airline passengers. It has been difficult this past two years during the COVID-19 pandemic. The work has been stressful and I get headaches and, from all the extra work that we have to do. I work up to six days a week, with a mandatory overtime nearly every d-, every day and I have gotten, and I have not gotten a raise in a long time. After work I go home and I take care of my family.

I'm a mother of eight children, 14 grandkids. Right now I am trying to adopt one of my grandson, kids, so I'm taking care of a baby. I am exhausted, but I have to do what I have to do to survive. That is why I am fighting for a fair raise. My coworkers, I work hard and we can barely survive with the money we make. Everything is expensive these days. Our workload is increasing. But, we are making the same money. Rents are high. Groceries are expensive, and we are struggling. Clark County Commission should support a living wages ordinance that raise wages so that workers like me are able to provide for our families. Thank you.

Thank you.

Good morning, Clark County Commissioner. My name is Alfred Taylor. This is Item Number 51. Last name Taylor, T-A-Y-L-O-R. The pandemic have been difficult for all of us. My co-workers are the first line of defense against the spread of COVID-19 at work. The pandemic impact our job a lot. In order to stay open, the company puts a lot of extra regulations that we have to follow. As a utility porter, I have to clean and sanitize constantly. We are short-staffed, so we are doing double the work sometimes. It has been very stressful. Workers at LSG Chef prepares the food for the airlines. We work in 30-degree freezers and have to clean those freezers all the time for at least 30-45 minutes every day. I have to put on extra layers of clothes to go in those freezers. Clean and disinfect them as fast as I can, then come out and take off all those extra layers of clothes before moving on to the next area I have to clean.

I'm proud to work as I do, as we are essential workers. We work so hard every day to make sure things run smoothly and are cleaned well. The reason I'm here today, is because my co-workers are fighting for raises at LSG Sky Chefs. I make \$12 an hour and it is not a fair wage for all the work that I do. I have co-workers that have been at this company for over 20 years, and they make 25 cents more than I do, more than I do. Some of co-workers are barely making enough to cover their rent. But how can folks cover insurance, transportation, and bills. Everything is so expensive now, so workers deserve a raise. We have people coming all over the world to visit, and we work so hard to make sure that they have everything that they need on those flights. We are essential workers and we should have a high living wage so that we can afford to live. Clark County Commissioners, we need your help. We are here asking, for you to step up and help us by supporting as a living wage ordinance. Thank you.

Good morning, Commissioner. My name is Murray Wang, W-A-N-G. I'm here for Item 59, for the short-term Airbnb and I used to work for the hotel industry. Ever since the pandemic, my income has dropped dramatically, and I'm depend on this income to support my family and kids. Thank you.

MALI GABAN LAZARA

Hi. My name is Mali Gaban Lazara. I'm here to discuss Item Number 59. I have over 15 years of hospitality Wyndham Hotel Group training, as well as I'm a real estate agent and consultant. I'm here today to state that you can have a short-term rental, without any issues and happy neighbors with the proper procedures that work. Proper open communication with guests and neighbors, along with noise monitoring devices, help ensure seamless short term rental operations. I would be more than happy to create a host guide to educate and share these procedures that work, along with videos.

I propose a community uh, for short term rentals for support and forum with proper representation in Clark County. Um, I would also like to add to the rest of the speakers on this item, that I do not approve marking homes, creating safety issues, as homes will become targets for crimes as previously said. We don't need to make, uh, we don't need to make the criminals' jobs easier (laughter). We also don't approve limiting 1% of housing units in areas. This is ridiculous and unfair. Uh, would like to suggest, to allow short term rentals and take income for education the State so desperately needs as well. Again, you can have short term rental operations without any issues with proper education, support, and community. And I'm more than h-, happy to be of service to the Clark County Community and this process. Thank you.

GIBSON

JOHN WONG

Good morning. My name is John Wong and I live in District F, and I'm speaking uh, regards of section 56, regarding short term rentals. I'm speaking today publicly to state that you lost my vote Commissioner Justin Jones, as well as the Democratic Party overall. I cannot support candidates who cannot, who do not support locals in their interests for economic well-being. And instead, are taking donations, and would rather represent their corporate donors' interests.

With this draft in soon to become final short term rental ordinance, it seems to allow operators to host legally and apply for a permit but that is far from the truth. We know how it's designed to fail and how the City plans to taper off the total number of permits issued to hosts as the number eventually dwindles down to eventually zero after a bombardment of unnecessary and nonsensical fines will be issued to hosts, due to the restrictive, overreaching nature of the ordinance.

Do you really think that the public does not see what you are doing and how this ordinance is designed to fail, as designed? All the smear campaigns of STR operators as being nothing but party homes when barely 1% of those listings are making a bad name for the rest of us, while the rest of us are being responsible and never received a complaint. Why blanket cover every host with this

outrageous ordinance instead of pinpointing those who operate irresponsibly? Think about it. What is the hidden agenda? During times of ever-rising inflation and a looming recession, heavy restrictions in this ordinance is the last thing we need to at least try to reach economic stability. We, we have people losing jobs, losing wages, and paying more for everything in existence. We have an option to get by, by participating in the sharing and gig economy, by sharing their homes on Airbnb, vehicles on Turo, ride share, and ride sharing on Uber or Lyft. At the time when average people s-struggle to make ends meet, pay the high costs of living, pay expensive health care, prescriptions, send their children off to college, pay the mortgage, save for retirement, supplementing their income or in some cases, relying on STR's as a sole source of income is the last thing our Democratic County Commissioners and Democratic Leadership at the state level should be doing to deprive property owners the ability to rent their properties on short term and only care about the corporate profits of their corporate donors.

When my mom was laid off from her job at the MGM she took one of her spare room in her house to list on Airbnb. And she was able to supplement her lost income. She was then on the list; she then went on to list a rental property she owned which had become vacant on to Airbnb which was entirely enough to replace her lost income from her job as a blackjack dealer. She went on to host full time and continues to do so and truly enjoys doing it ever since she was laid off from 2020. She enjoys hearing and reading the reviews and comments about how much of a great time the guests had at their STR and their time at, at the Las Vegas Strip, where they gambled, dined out, purchased souvenirs. All the memos and stories we hear about which are in the guest book, uh, that we have them fill out. In the meantime, it is now 2022, she has not received a call back from her job on the strip. She would rather host on Airbnb, and I enjoy helping her out.

Do you think the casinos really care about her or anyone else they laid off? Do you think as the Commissioner, I'm sorry, instead they re-hired new workers at a lower pay and continue to make record profits? Do I think you as the County Commissioner care if my mom got her job back? No. She found another way to replace her income without harming anyone. The City did nothing for the greater good of the people during this time, and now you want to make this, uh-

WONG STR operators are victims. STR operators are being mistreated, misrepresented, demonized, harassed, and punished by their own government, all in the name of protecting corporate donors. We can no longer stand by and watch the

government exploit citizens; we can no longer stand by and allow government to

strip away our civil liberties-

GIBSON Thank you very much.

WONG It's time we hold the government accountable.

GIBSON Thank you.

WONG Thank you.

JOSEPH STEVENS

Yes, ah, my name is Joseph Stevens. That's S-T-E-V-E-N-S. And I'm here in reference to the short-term vacation rentals. I, I feel and what I've seen and heard that uh, a lot of times they've been just given a bad name because soon as you mention the word, they say oh, party house. And, basically, for the length of time I've done and dealt with vacation rentals, I've found that if you structure things properly, and you don't allow certain things, uh, you have no problem.

I've never had one complaint from anybody, from any neighbor or anything about vacation rentals due to the fact that I have a criteria that I follow and I ask all of my uh, guests, I ask them ah, five main questions. One thing that throws them out of me renting to them if they say they're having visitors because the way it should be structured to me is, uh, two people per bedroom if you have a 3-bedroom house, you allow 6 people. And if you have a 5-bedroom of course 10, and so on and so forth. But uh, it should only go up to about 12, and other than that, you're creating uh, a disaster cause you're creating a party house. You're creating a large number of people that are trying to have a good time. So, if you're structured properly and uh, and analyze properly, I think we should have some form of uh, class that people have to go through cause a lot of people don't know how to run a structure of business. So, there should be a 2-hour class that I'd definitely be willing to help in. I have a degree in business administration from USC and uh, I would love to help with that because there is a way to make it work without causing any problems.

And I don't think the City or State, or anyone has the right to tell you who can come inside your home. If I was putting a tent in front of my house I can understand the concern, but these people park, they come in the house, and the beauty is, most of the time, when you have people that are ah, coming for conventions and different things, they learn that there are so many different aspects of Las Vegas.

You'd be surprised how many people feel that Vegas is nothing but the Strip, and a lot a "Sin City" issues going on in Las Vegas, and they look and say wow, you have beautiful, gated communities, you have lovely homes and this, that and the other, and they learn a lot about our City. So, I do feel that there are advantages to it, if it's structured right. Like I said, I don't do visitors, I don't allow parties or events, and if I have more than one property, I think you should allow uh the person to have out of all their properties one other place as a rental. Other than that, it gets out of hand, and they can't monitor it properly.

I get many people that come to me and say, you're the first time I ever met a host. They come, you leave the key for 'em, they come in and, the, the host doesn't know how many people are in their home or anything. It needs to be monitored a lot better and if it is, I don't think we'd have any problems with vacation rentals. It

STEVENS would make more money for the City, and uh, it would help really generate to let

people know how beautiful of a City we have. So.

JACKLYN FLORES Good morning, I'm Jacklyn Flores, founder of the Greater Las Vegas Short Term

Rental Association. I'm here to speak on behalf of the Host Community in Clark

County.

GIBSON Ma'am, excuse me. What was your last name?

FLORES Flores, F-L-O-R-E-S.

GIBSON Thank you.

FLORES After reviewing your draft ordinance, hosts in Clark County have reached out to

us and they can't help but wonder one question. Why are you so opposed to regular folks here in Las Vegas being able to rent their own properties to welcome travelers to our City? More importantly, why are our democratic state and local officials in a war with short term rentals? With seniors who are on a fixed income, with culinary workers who still yet to have get fully employed, with families trying to make ends meet, with disabled people who can't work a regular job, with working poor, with the working poor who have to work multiple jobs and take their life savings to invest in a property or two to earn enough money to send their kids off to college, to afford the high cost of um prescriptions, um, to keep a roof over their head, to cover all their bills, to save for retirement, these are the types

of people who are doing short term renting.

These are the type of people who you are hurting with your overly aggressive regulations. Regulations which do not address neighbor concerns, but simply take away people's ability to earn a living. These are the people you are going after. These are the people the State and the County, through these heavy-handed regulations are going after with their proposed fines of \$1,000 up to \$10,000 a day for the crime of renting their home for less than 31 days.

You continue to use the excuse of party houses, affordable housing, and an out-of-control real estate market as reasons to heavily regulate. But the fact is that the vast majority of short-term rentals operate with zero issues, are located outside affordable housing, and make up a tiny fraction of the real estate market. So, we are asking you to work with us and scale down your aggressive regulations and give homeowners in the County the ability to provide for their families through short term renting and bring tourism dollars, not just to the Strip Corridor, but also to the local small business owners in our neighborhoods. Thank you.

GIBSON Thank you.

KRISTEN RYNCZAK My name is Kristen R-Y-N-C-Z-A-K. Due to information, inflation, and rising

costs, and I use the short, short term rental platform to supplemental income to Social Security. I only have one rental property and I, I, and it is my primary

residence. I used to rent out of a portion of my house using a Airbnb. Over the last 4 years I have 500 5-star reviews from satisfied customers. If I am no longer able to host at short rental term full time, it will eliminate most of my household income aside from a Social Security. Thank you.

GIBSON

LESLIE DOYLE

Either one?

GIBSON

Either one.

DOYLE

Mm-hmm (affirmative). I'm here also to speak about the short-term rental. My name is Leslie Doyle. I live in the County. A few years ago, my husband died. And with him went away half of my income on Social Security. A house, it was old when I bought it, had to be maintained. And the only option I had at my age, and I'm 82 this year, was to go and get a job to pay for the maintenance and the repair, and the rising taxes, four times since I lived in the house. I can't afford it. I can't afford to live here. I can't afford to go into a nursing home. And I'm not ready for one. But it is my income. And you're going to take this away from me and all of the other women in Las Vegas like this. While we provide a wonderful service here in giving people a place that's affordable and lovely to stay in, while they're visiting in their conventions, their families, and attending functions here.

You're concerned about the people that are coming here to gamble and party. That's not the majority of us here. Majority of us here are retired women, older women, people who are unemployable, trying to keep the rain out of their living rooms, their cars repaired, pay for their medical bills. It has been a blessing. And this County Commission should treat it as the best thing to the Residents of this County. You're approaching it the wrong way. You're here to help us. And I would like you to find a solution, a workable solution. You've got rules in place and laws ah, that we're supposed to abide by. Well, you're supposed to uphold these things and enforce them. You don't need more rules. You just need to help us. Thank you.

GIBSON

Thank you. So, while Mister Uehling is coming forward, under the rules of our body, we don't celebrate, clap, and all the rest of it. Um, I've been sympathetic to your concerns. But, please from this point forward, don't do that any longer. Mister Uehling?

ED UEHLING

Yeah, uh, um, my name is Ed Uehling. These, these people don't give a damn about your life or the- the. What they care about is the money they receive. The millions of dollars they receive from their bo, their real bosses. The, uh, the uh casinos, the corporate interests in this County. They don't care about the, and the uh, Item 66 is totally fake. The purpose of the business impact statement is to encourage business. This, this item destroys about 7,000 businesses. So, it's completely the opposite of what it's meant to be.

Uh, it, it's interesting that the whole Country is, is involved with the shooting down in Uvalde, uh, Texas, where the police waited outside while all these uh, while all these students were being killed. Well, this Commission here is acting, is worse than the police action there in Uvalde. You are actually going in and

assassinating uh, 7,000 people like this lady. And, her business, in, just because you adore the, ah, the, the corporations. Just because you're addicted to the money that these, these corporations give you. Uh, and if that, if this, if this item passes, it sends a clear message that independent thinking and financial uh, initiative is bad, or at least to be discouraged. It, it will put ah, by your own figures, 7,000 operators and their thousands of employees out of work. It will abandon to live on the streets dozens of elderly people and handicapped operators, who, who find uh, room for, who want to accommodate visitors in their home. It could cause a wave of foreclosures.

It will make possible for the Wall Street, uh, uh, Wall Street corporate interests. Do you think that MGM is, is interested in Las Vegas? Only for the money that it makes here. It's really interested in creating uh, casinos all over the world. And you're going to pour additional millions of dollars in MGM so they can build more casinos all over the world that will eventually compete with uh, Las Vegas. The, ah, this is following the ah, the uh, pattern that occurred in the mid-west back in the 70's, where and, it removed all the industry. It will create a divide ah, between the Citizens of Las Vegas, and its largest industry. None of you remember what happened in the early 50's and the four, uh 40's, and the early 50's, when the community and these people that wanted to do casinos, all worked together to create this industry. Now, you are dividing it.

Morning Mister Chair, Members of the Commission. Vincent Queano, Director of Business License. Current Code does not allow for common areas for the consumption of alcohol by uh, multiple liquor licensees. The proposed ordinance adds the definition of an enclosed area and also adds, um, allows adds language that allows for the use of a common area for the consumption of alcohol by multiple liquor licensees with certain conditions including licensees will have to submit a security plan that details the security surveillance, staffing of the enentry, and exits, exit points for each, um, common area. There'll also be limitation for minors without a parent or guardian. And each licensee that, that wants to opt in- into for one particular business area will have to submit a security plan and, um, each, each enclosed area has to be supervised and monitored by the liquor licensees.

For the record, Denis Cederburg, Department of Public Works, Clark County. Um, it's an Annual Assessment District as you, uh, mentioned earlier and it's assessed on the basis of a frontage of the properties along Las Vegas Boulevard. Uh, each property pays the same amount per linear foot of frontage. Um, the assessment for this portion, 97B, on a per frontage basis is ri-, right here. Cost per linear foot for 97B is \$5, is \$22.42 per linear foot.

GIBSON

Uh, the one, 162B is a Laughlin Lagoon SID. Again, it was initiated by those properties that abut the lagoon in order to maintain the lagoon in a navical condition. So, we dredged it the first time and annually we have a maintenance component of it to ensure that there's, if there's any siltation or buildup in there, we can address it and remove the silt as law, as well as some of the vegetation. So, all these were initiated by the property owners and there were no protests on any, anyone of them.

Thank you. Uh, on, uh, Friday, June 17th at 10 a.m. we'll be dedicating a new dog park, uh, on Lone Mountain Regional Park which is, uh, located at 4445 North Jensen Street. Uh, the new park was constructed on repurposed two and a half acres of land and consists of four enclosed dog runs with turf and native vegetation, pavilions, pathways, water fountains, and sculptures. Uh, we wanna thank the Clark County's RPM staff, in addition recognize the general contractor, MDL Group, and the landscape architectural firm, JW Zunino. Uh, after the dedication, the Animal Foundation and Metro's Police Department Canine Unit will be available with information and resources until noon. We'll have free coffee and dog treats for anyone that wishes to attend.

Then the next day on Saturday, June 18th, starting at 4 p.m., uh, Commissioner Kirkpatrick, who's been the, uh, uh, absolute rockstar in helping us get this organized, and has really shown our team the ropes, uh, will, will join us in hosting our first annual Great Northwestern Country Fest at Lone Mountain Equestrian Park & Trail, uh, which is also at the same park.

Uh, there we're gonna have all kinds of activities it's, uh, in-, including the roper that we saw this morning, free barbecue, live country music, country farmer's

market, rodeo exhibition, roping, petting zoo, bounce houses, carnival games, dutch oven cooking demonstrations, dunk tank. Uh, Commissioner Kirkpatrick has organized quite a great deal for us and, and my team has been thrilled to work alongside of her team in putting this together. Uh, we know it'll be a hot day, but we'll have several cook, cooling stations throughout the park, plenty of water and refreshments for everyone to enjoy. Thank you.

We had a, we planted some trees, we, we, um, met with Audubon Society and talked to them about doing some, some Audubon efforts, um, and all in all it was just, uh, very exciting to be outside and, and see people making Las Vegas greener. So, uh, a special thanks to Irma Varela who is the, runs the Winchester Center and her staff, and Lisa Ortega who was, and coordinated the trees.

Next, um, a couple weeks ago, I also went to, um, Commercial Center and broke the, or helped cut the ribbon, I guess I'd say, for the Square Bar, which is a new bar there in, in, Commercial Center. And, and, um, Commissioner, um, my partner here, (laughing) Commissioner was there also who he didn't quite make it to the, to the ribbon cutting. But we, we are doing some amazing things in Commercial Center, so if you haven't been there lately, you, you really should go over, it's, it's pretty impressive.

And then, uh, this last weekend I, we did, um, some more trees we ... That's one of my personal goals and, and my staff is to make, uh, East Las Vegas greener. Uh, it's a food desert and a, a heat desert. Um, so we're, we're giving both shade trees and fruit trees. Uh, we gave out over 70 and, uh, it was just very exciting to see people come and, and get the trees and, and learn how to plant trees. So again thanks to, to, uh, Lisa Ortega for and her staff and our staff at, at, at, um, um, Hollywood Park.

And finally, uh, on Saturday I attended the Las Vegas Filipino Short Film Festival, uh, on West Charleston Library. This was their first one but, uh, there, this is gonna be an annual thing. Um, so thank you, um, Margie Gonzalez who led the efforts, but it was, it was very exciting. And, um, it, it ... You can see that I'm becoming part Filipino. Maybe a little too fat there but, but I'm working on that part. Thank you so much.

Thank you, Mister Chairman. Um, it was an honor to join and address the Delta ac-, Delta Academy, uh, faculty, parents and students who are graduating, uh, who graduated on May 26. I want to also, uh, congratulate Delta Academy Graduates, uh, for all that they're going to do into the future, um, we know that the future is bright for them.

Uh, I had an opportunity to, uh, join Democracy Prep and I wanna thank them for inviting me to their community health fair that they host annually which was also on May 26 which featured over 40 vendors, food trucks, and guest speakers. Uh, I

look forward to continuing to partner with them into the future, uh, for such ex-, extraordinary event.

Um, my office along with Councilman Cedric Crear of Las Vegas hosts the historic Westside Legacy Park 2022 Honoree Celebration this past Saturday where we honored more than two dozen additional historic Westside Trailblazers, uh, into the historic Westside Legacy Park. And I was particularly honored to see my father, William McCurdy, Sr., uh, be selected as an honoree for his work in the community. And I would like to invite anyone who has an op-had an opportunity to see the Legacy Park, uh, to take some time to go out and, you know, find inspiration from some of our past leaders who has blazed the trail for many of us, including myself.

And also, uh, this past Saturday, my office teamed up with the Southern Nevada Regional Housing Authority and the Walnut Recreation Center, uh, to put on a family resource day for our community. Uh, the event featured funnel take, funnel cakes, uh, hot dogs, inflatable bounce houses, and had over 43 vendors, again, offering, uh, community resources on health care, uh, childcare, employment opportunities, and more. We also even gave out, uh, 300 Chromebooks to our families as well. So, I just want to thank all the partners, uh, in Clark County Parks and Rec for making it such a, you know, phenomenal event.

Uh, we do have some amazing, uh, amazing events coming up here soon, uh, in District D and I would like to invite all of you out too. Um, you can join us at Juneteenth in the 106 at Pearson Community Center next Friday, uh, June 17th from 6 to 9 p.m. There will be live performances, inflatables, and food, and craft vendors as well, so bring out the entire family, uh, to celebrate culture and community. Um, and there are gonna be events happening that entire weekend. But I'm also, um, my office has, um, listed many other Juneteenth celebrations that are gonna be happening. We're going to be posting on our social media and making sure we get the word out for all of you who would like to participate.

And, uh, lastly, North Las Vegas Councilwoman, Pamela Goynes-Brown, and I, uh, we're hosting a party at Walker Pool on Saturday, June 25th from 1 to 3 p.m. Uh, there'll be a live DJ, raffles, I might even hop on and DJ myself. Uh, delicial fun, delicious funnel cakes as well as corn dogs and ice cream. So come on out while supli-, supplies last it's gonna be a really good event.

And lastly, I just wanna, you know, again wish my colleague, uh, Commissioner Naft, a very happy birthday. Um, it's an honor to serve next to him and I'm, I'm so glad to have an opportunity to learn from. Happy birthday, Commish.

Thank you, Commissioners. Um, I think we have some slides ... there we go. Well, uh, we can skip forward. We've heard from Miss Jacobs earlier today. Uh, several weeks ago, we officially opened the Silverado Ranch Dog Park. Uh, we held our renovation celebration, had a variety of vendors out for it.

Uh, just wanna point out that this entire renovation was privately funded, uh, through a donor in our community. No taxpayer expenses went into that, um, and,

uh, it, it really is transformational for that area. And stay tuned for updates as we look forward to the groundbreaking of the Silverado Ranch Community Center on the same site.

Uh, our, uh, District A team was over at the summer challenge kickoff at the, um, library on Enterprise on Las Vegas Boulevard South. Uh, that's a great event we do every year to encourage kids as they enter summer to, uh, uh, to start, uh, to continue their reading efforts through the summer. And I wanna thank the Library District for continuing to sponsor and host that event.

Uh, I had the honor of joining Moms Demand Action and, uh, Every Town, uh, well several days ago. Uh, the iconic Welcome to Las Vegas sign, uh, to turn the lights orange in recognition of, uh, Gun Violence Prevention, uh, Day. Uh, and I was also joined by our State Treasurer, Zach Conine and he was there and, and mentioned something he had recently announced which is that the State will no longer invest any public funds in companies that profit off the manufacture or sale of assault style weapons.

Uh, we talked a little bit more about it. I certainly found that interesting and thought that, um, the County might consider our investment portfolio and see, um ... Doing analysis, we don't have the same setup as the State, but at least analyze whether we are investing in any of these types of, uh, funds and consider divesting from them.

Um, uh, Manager King, I'd like to ask if, um, if you and our Finance Team could work with our County Treasurer, Miss First, Fitzpatrick, um, and see ... I guess maybe come back to the Board with a report on any funds that we have, potentially, invested in such accounts?

Yes, will do.

And then if, if there are some, we might bring an item to this, I might bring an item to this Board to consider a policy change. Um, moving forward we have a couple things coming up. We, uh, are in dire need of volunteers in Laughlin at our Colorado River Food Bank. That's a food bank that this Board helps to fund and they, uh, rely on volunteers to, to run all their programs. Um, I'll be down there on July 6 but, uh, along with our team in Laughlin helping to volunteer and doing a couple hours of a shift there. Uh, but if anybody has the ability to, you can make it part of a vacation, go down south to Laughlin, have some fun and do a couple hours at the food pantry while you're at it. Uh, the number's on your screen to learn a little more about opportunities that might be available.

And then finally on June 16th, uh, we'll be partnering with, uh, Metropolitan Police Department's Enterprise Area Command for Coffee With A Cop, um, at 9 a.m., uh, at the Silverado Ranch location of ... Wait what is, uh, you ... Commissioner knows, right there, Coffee N Rock. Okay. (laughs) I should know that, I did the ribbon cutting for that place. It's great. Uh, anyway stop by if you can and look forward to it. Thank you, Mister Chairman.

Thank Mister Chair. Uh, week before last, I was able to join our Department of Family Services, uh, which had partnered with a local artist, Darian Geenen, to present a traveling art exhibit that will be displayed throughout the valley, uh, for National Fo-, Foster Care Awareness Month. Um, and it'll be actually here in the rotunda, uh, week after next in order to bring attention to the needs of foster youth and foster parent, parents. Um, that was at, uh, the, uh, Downtown Summerlin location if you're interested in, uh, checking it out there. Also, if you have any interest in, uh, becoming a foster parent, please go to Clark County, uh, Fostercare.com where you can get, uh, more information about how to become a foster parent.

Uh, on Memorial Day I was joining, I joined my colleague, uh, Commissioner McCurdy and other local government officials, uh, to honor, uh, those who have served our Country, um, and, uh, lost their lives. Uh, that was at Bunker Memorial, uh, Mortuary. It was great to see the leaders across the State for those honoring the fallen service members. And just remind us that we should all pay our respects to the families of those who have lost loved ones. Um, and uh, we mentioned it briefly earlier uh, the, this meeting. The Cookout is coming up Saturday, June 11th at Desert Breeze. I appreciate the tremendous efforts that Desert Breeze has put into this uh, this first time, uh annual celebration. Uh, of Juneteenth, um we're gonna have uh, food, music and more. We'll also have a Black Wall Street market where we're featuring black small businesses across Clark County. And you can purchase items by these businesses, so please stop by on uh, on Saturday.

And then, finally we have Summer Fest coming up. We're partnering with our Metro Spring Valley Area Command on Thursday, June 30th from 10 a.m. to 1 p.m. at the Boys and Girls club uh, over on Lindell. There's going to be free food, water safety devices for kids, water slides, Slip 'N Slides and more. And, uh education to the kids on water and heat safety.

And, uh, real quick update on RTC uh, we are very excited that uh, RTC was able to partner with the County and with the City uh, to uh, submit two mega-grants, they're calling them. Which means "big" I guess. Uh, the first grant will assist with the design of a high-capacity transit corridor uh, for Boulder Highway along the Clark County and City of Las Vegas portions. The City of Henderson was already awarded uh, funds for that. And, then a second grant application for the design of a high-capacity transit corridor along Charleston Boulevard. As many of you know, uh we received federal funding for transit which kept services open at the RTC through the pandemic. Uh, but just a reminder that those funds do run out and, so over the next uh, year or two, we're going to be looking at options to make sure that uh, we have proper funding for transit uh, for the future.

Thank you.

We experienced or, uh we shared an experience together uh, the families and the children uh, who attend the Paradise pre-school. Over 30 of these beautiful kids were either promoted or graduated. It was uh, exciting and rewarding to be there, but the thing that struck me was that every single one of those kids was there with parents and grandparents and other family members. We talked a little bit about how critical it is that these kids who have every option ahead of them, be raised,

treated, dealt with in a way that enables them to preserve the options they currently have to achieve the very best they can do. That was a lot of fun.

On uh, Saturday, May 21st you can see the Giants fan there who, uh we participated, Michelle Romero and I, who is a City Councilwoman in Henderson to clean up part of the Lake Mead Parkway Trail and the Wetlands Connector. Many thanks to the City of Henderson uh, for the tools and resources. Just Serve and the other volunteers that came out to help clean up and to Pink Box Donuts for providing delicious refreshments to the volunteers.

Um, on January, or excuse me, June 4th uh, my office, along with Heaven Can Wait, Petco Love, The Animal Foundation, and Clark County Parks and Rec hosted a free dog vaccination event at the Paradise Rec Center. Which is a set of different photographs. But these are nice, although... there we go. And, um, we had a great turn out. There's an awful lot of need for this. I know others of my colleagues have held such events. Uh, all appointments were full, and we obviously have the need to go back and do this again and again. Thank you to all those who participated and made it a very successful event.

The next item is something that we've worked on for a good long while. We've been anticipating the completion of our Clark County Museum's storage building. And, I'm thrilled to say that we'll be cutting the ribbon for that facility on this Thursday at 9 a.m. The museum has over a million artifacts to store. The new facility will be utilized to store the collection of over 22,000 items from the One October tragedy along with the articles from uh, temporary offsite storage facility that the museum has utilized before the completion of this unit.

There will also be room available to store future items as needed. This is something that the entire Commission recognized was uh, lacking several years ago, and we worked with staff to find the dollars to do it. Now we'll be able to preserve not just history, but more detail and important artifacts uh, from the past. Thanks to all who were involved in that.

Uh, Wetlands Park Nature Play Corner grand opening on Friday, June 10th at 8:30 uh, will occur. We'll be busing in about 90 school children from Sister Robert, Robert Joseph Bailey School a Clark County District, School District um, elementary school. Many thanks to Principal Grant and Assistant Principal Timothy Granger for allowing the kids to go on this field trip. Donuts will be provided by Pink Box Donuts and Wetlands staff will be providing free nature activities for the kids. Everyone is welcome to attend. This will be a fun and exciting event.

Um, on Friday the 17th, a Slice of Summer at Paradise Rec Center will occur. It's really kicking off Father's Day weekend with a community event. Will run from 5 p.m. to 8 p.m. There will be free food from Abuela's, inflatable bounce houses, carnival games, a mechanical bull. My notes say a mechanical bull for the dads, but quite honestly, it's a mechanical bull for anyone who qualifies by age to get up. Um, and a whole lot more. We encourage people to register at the front desk of Paradise Rec Center or call 702, and you can see the number on your screen. No, you can't, yes you can. It's kinda small but 455-7513. And we sure hope to see you there.

I would note that uh, Fiscal Affairs received a Homeland Security Grant. And, with that grant, after operating one week with the equipment provided, um was able to see and find present in Clark County, 901 vehicles bearing plates, license plates from vehicles that are potentially stolen or involved in crimes. This is not about getting license plate numbers from expired license plates or any other thing. It is actually ve-vehicles that law enforcement is actually looking for. Uh, will be, Metro will also be adding a one square mile spot shotter... shot spotter area in the Cheyenne Rancho area. And we're happy for that. The, uh, the cost of it will be borne by the general fund at Metro. And it will be something that will provide even more security to the neighbors in that area.

And then, uh, there will be uh cameras installed at the bridge to Havasu in Laughlin. Clark County Public Works will be assisting with the installation. This has been something that's been long overdue, and we're really pleased to be able to move in that direction.

There's, there's one other thing that I would wish for and maybe we could have RPM take a look at cameras in our, at our rec centers and at our parks. Uh, there are a whole lot of activities that happen there, mostly wholesome. But, in some of our facilities there are also issues. And, uh, we ought to take a hard look at what we might do to provide more security for the people who go to recreate there. And I'd ask that you take a look at that and bring something back. Um, the, we could start working immediately on cost estimates to do something. Between Real Property Management and Parks and Rec we ought to be able to come up with something that I think would be useful there. And that's something that I think is important.

Finally, the LVCVA reports that visitor volume is up uh, both, well is up against last year, of course. Nearly 3.4 million people visited. Um, and we're just under 5% behind April of '19 which is pre-COVID. Uh, overall, hotel occupancy reached 84%. We're only 7 points behind where we were pre-pandemic and we don't have any international visitation occurring. And, weekend occupancy is, exceeded 93%. Only three and half percent behind what happened pre, uh, COVID. So, uh, the destination is recovering and we're happy for that. And, we're happy for all of those who have been contributing to the successes that we're having there. Before long, we imagine that the, that COVID will uh, enable, or the recovery from COVID will spread across the world in a way that will enable international travel and that will be a great, a great thing for this destination.

So, that, I think takes care of emerging issues. And we're on to the next item. I'm gonna yield the gavel to, uh, Vice Chair Jones.

Yes, I authorize... I apologize. Can I just approve or actually, Mister Minwegen I'll point, turn it over to you.

TOM MINWEGEN

Members of the Board, Tom Minwegen with the Clark County Reclamation District. Members of the Board I, as sitting as the Board of Trustees for the Water Reclamation District, we would like to thank you for your past and ongoing support of our organization and our mission. I would also like to take a little time and reach out to the men and women of the Water Reclamation District who do a phenomenal job on a daily basis, to meet the challenges of a very needed resource at this time in this community.

Uh, Commissioners, as you might be aware, I know a number of you have taken the tour and been out. And, one of your comments was, "Where are all the people?" The Water Reclamation District is a very lean organization in terms of our staffing, okay? Um, we currently have authorized 387 full time permanent positions that operate and maintain the largest wastewater collection system and water treatment plant within the State of Nevada. And, we are also responsible for serving the towns of Searchlight, uh, uh, Laughlin, uh, Blue Diamond, Indian Springs and Moapa Valley.

Much of our lean staffing plan has been done intentionally to maintain, as well as uh, look at our cost containments. They also uh, lead to basically managing our efficiencies. With that being said, we have to make sure that we do have adequate staffing to meet our mission. And, that mission is to make sure we provide wastewater services to Unincorporated Clark County. To capture that water and bring it, reclaim it, and return to Lake Mead as a return flow credit.

Over this last year we've been looking at and, basically where are the challenges in the organization. We've identified a number of positions that we would seek your support of this item to uh, advance for this next budget year.

A couple of those items, specifically we are requesting two positions in our Customer Service Section uh, to meet the needs of a growing customer base, as well as just generally improve our customer service with the additional staffing help. So, we need two additional, uh, folks in our IT, Information Technology Group, to keep up with the operation and maintenance of an evolving IT infrastructure and our advanced applications.

And lastly, we're looking for two construction inspectors. One engineer to support our ambitious Capital Improvement Program. So, Commissioners, it's been summarized uh, with water reclamation and return flow credit to being only more important in time as time goes on. We would appreciate your consideration and support for these position requests. Uh, Mister Chair, I turn it back to you to see if there's any questions on me, maybe able to answer for you.

MINWEGEN Mister Chair, Members of the Board, Tom Minwegen with the Clark County

Water Reclamation District. Uh, Members of the Board, this is an item that is part of the process, uh that we introduced in our May 3rd meeting with you, where we have an attention and proposal to uh, change, modify a few of our certain rates, charges or fees in our service rules. And, doing so we basically go through the business impact statement approach. We did reach out to our stakeholders uh, specifically those that may be affected. We also posted in the RJ and General Terms and we also went to the specific sectors of the, uh, community as well. We did not receive any feedback on these uh, recommendations that we will be advancing upon your approval today of this business impact at the next meeting June 21st of 2021. Mister Chair I'll be glad to answer any questions you might

have on this business impact statement.

SEGERBLOM Any questions by the committee? Oh, um, just a motion to approve.

JONES Move approval.

SEGERBLOM All in favor? Thank you again Mister Minwegen.

MIKE HARWELL Good morning, Vice Chair Jones, Commissioners. I'm Mike Harwell with the

Business License. This was uh, brought to us by the Nevada Securities

Association. Uh, they wanted to try to update the language we have on burglar alarm systems to uh, a more modern term, which is electronic security systems. This um ordinance, or similar ordinance has passed in the City of Las Vegas. Um, we uh sent the notification out to all the burgler alarm companies, all the

we uh sent the notification out to all the burglar alarm companies, all the locksmiths, uh the associations, other, other parties that would be interested in this type of uh, um, uh this chapter. Uh, we've received no comments but, uh we believe that the um, the current practices of the day are, are more in line with what this ordinance is doing. Also, this ordinance is uh, allowing more flexibility to the Sheriff's Office in approving a work card for um, the burglar alarm

employees. So, um, I'm here for any questions you might have.

JONES Thank you, Mister Harwell. Any questions from the Commission? Hearing none,

I'd entertain a motion.

Next, we have Item Number 66, which is to consider and approve the business impact statement pursuant to NRS 237 for the proposed amendments to the Clark County Code Title 4, Chapter 4.08 to the subject short-term rentals to the combined transient lodging tax. To amend Title Six, Chapter 6.12 to exclude short term rentals from the definition of vacation homes. To amend Title 7 by adding a new chapter 7.100 uh, and a new chapter 7.110 to establish regulations pertaining to the licensing and operation of short-term rental units and accommodation facilitators including license eligibility, operational requirements, fees, fees, penalties and enforcement. And, to amend Title 30 Chapter 30.44 to allow licensed short term rental units in residential zoning districts and, providing for other matters properly related thereto. And, for such other requirements deemed necessary by the Board.

Mike Harwell again for business license. Um, this is a um, we sent a notification out to um, various interested parties. The resort hotels, the NRA Nevada Resort Association, The Commission Facilitators um, other electronic type, um, facilitators such as TNC, the um, operators as well. Uh, we received... and we also published in the RJ, the Review Journal twice uh, over a 2-week period. We received 136 comments during the comment period which ended March... I mean uh, May 18th.

Um, and I grouped them in, in the backup material. There were 14 received, uh, four the ordinance in support of it or for more restrictive provisions. Uh, 108 were opposed to it or wanted less restrictive provisions. And were 14 that didn't really address the ordinance itself directly, but it seemed to support the industry. Uh, for example, people that come here and use the Airbnb's, they didn't want that... they didn't want us to be able to do that, so um, of the ones that were opposed, um, most of the concerns were about the 1,000-foot buffer. Uh, they'd like it to go back to 660 where the state has required or have none at all, which we cannot do.

Um, 27, um 27 disagreed with the one license per person. They said, they think it should be more than that. Uh, occupancy capacity was another issue that they had a problem with that we had set it at 10 to try and eliminate large parties and large groups. Uh, the state um, would allow us to go up to 16. Um, the 1% of available housing limitation on the license availability, they don't think, many thought there should be no limit at all. Um, and that uh, that is to try to protect the affordable housing and then not so a corporation would come and buy a lot of houses and use it for short term rentals.

HARWELL

Uh, this is 1%, was also what uh, San Diego uses in their ordinances as a deterrent to protect the neighborhoods. I mean uh, to protect neighborhoods.

The um, random number selection, they didn't like that. A lot of them, they wanted a first come first serve in the bill, AB363 we're required to keep a, to have a 6-month window for applications of short-term rentals that have an operating as of June 1, 2021. If we did a first come first serve, which is what the, they uh, many of them had suggested, those would all be snatched up within the first week or two. And no one in the last, the remainder of the 6-month period would even be able to get a license. So um, we feel that the um, random number selection after the 6-month period would be the best way and the fairest way of, of selecting them.

And, then um, there's a few people that didn't like the septic prohibition there in the area. Some of them are in rural areas or have a septic tank and um, one comment was that they couldn't afford a \$54,000 hook up fee. Uh, these, they're on a fixed income so, those were some of the issues.

Since the, uh, comment period has closed we received 62 uh, comments since then. Most of them were uh, of a generic nature but, they're mainly just looking for fair and equitable um, treatment of the ordinance and that's what they're requesting. And I'm here for any other questions you might have.

Uh, thank you Mister Harwell. I know you and uh, the entire Business License Team have uh, put a lot of effort into this over the last several months, and our Attorney's Office also. Are there questions or comments from the Members of the Board? Mister uh, Commissioner Naft.

Thank you. I, I just have a procedural question. Probably applies to all BIS. Um, do... I'm looking over some of these. Some of these have comments or just have things that are totally false or not being considered at all. Generally speaking, do we respond to people who post their comments through BIS or is that kind of a...

Normally, we don't respond to the comments in the BIS. Sometimes they'll ask a question like um, when's it gonna be on the, on the, on the, on the agenda, or something like that. We may respond at that and the, and the one case someone said, please let me know by email that you've received this, and we did. But we didn't really comment on the content of the comments.

Okay. Thank you.

Thank you, Mister Harwell. I know there was uh, let's say an accusation before about uh, this Board being on the take from the Resort Association and resort industry. Were there any comments made during the BIS process by the resort industry.

No, we received nothing from the NRA or any of the resort hotels we sent the notice to.

Great. Thank you.

HARWELL And we received one comment from um, a facilitator, Expedia. Um, they had a

few concerns about some of the language as far as uh, the time that we have in there to, for them to remove a listing. Uh, we have 48 hours, they were asked for

5 days.

JONES So, there were no comments submitted by Airbnb or VRBO?

HARWELL VRBO is part of Expedia.

JONES Okay. Understood.

HARWELL But, uh Airbnb it was not... we did not... through the business impact statement

we did not get it.

JONES Understood. All right. With that I would uh, entertain a motion. Oh,

Commissioner McCurdy.

MCCURDY Thank you, Mister Chair. Just for clarification purposes for those who may be

watching. This will come back before the Board one more time. If you can also

clearly articulate that on the record as well.

HARWELL Yeah, the ordinance was introduced today, it'll be in a public hearing is, it was set

for June 21 at 10AM. That'll be when the time the public can comment on the

actual item.

JONES Great. Thanks for that clarification. With that, I'd entertain a motion.

NAFT There's nothing more. I move for approval of Item 66.

KING Next, we have Item Number 67 which is to discuss amending the Clark County

Code Title 2, Chapter 2.90. To remove the requirement for an annual audit for funds allocated um, for the Clark County Arts Plan. Vice Chair, this was a

Commissioner Naft request.

JONES Thank you. Commissioner Naft.

NAFT Uh, thank you Vice Chairman. I, this just came about at an audit committee

NAFT meeting. Um, Commissioner Miller and McCurdy and I serve on that committee.

This is really, to my knowledge, one of the only um, accounts that is required to be audited on a yearly basis. We have uh, uh limited resources within our audit staff and a whole lot of departments and entities that need to be audited routinely. Um, so it was my suggestion that we remove the annual audit. It doesn't prevent either this Board, Senior Management or the Audit Staff themselves from auditing

this account uh, at any time they so choose.

JONES All right. Any comments, uh, from the Board? No? Support? Okay. (laughs) I got

some thumbs up so uh, Commissioner Naft you want to give some direction?

NAFT Let the record reflect, thumbs up. Uh, I guess, Manager King, what would be the

process to move this forward?

KING We'll move forward with um, introducing an ordinance to remove that

requirement um, from Clark County Code. And, then have a public hearing item

on it. Uh, probably within the next couple of months. Thank you.

NAFT Okay, thank you. Just for the record it's... you're feeling this is kind of redundant.

Uh well, I'll let you speak to it but...

KING Yes, it is and obviously we have um, other risks within the County that would um,

you know, allow for our Audit Department to pay more attention to and, as you noted earlier, this doesn't preclude them from um, auditing uh, but, uh it does allow them to audit when uh, we, we honestly see the need, that there's a need for

an audit. So, thank you.

NAFT Thank you very much.

JONES Thank you, Madam Manager.

ACTION: Staff was directed.

ITEM NO. 68 Discuss utilizing American Rescue Plan Act (ARPA) Funds for implementing a dedicated broadband connection for the University of Nevada, Las Vegas (UNLV) and Clark County to connect to the supercomputer located at Switch. (For possible action)

ACTION: Deleted from the agenda.

ITEM NO. 69 Go into closed session, pursuant to NRS 241.015(3)(b)(2), to receive information from the District Attorney regarding potential or existing litigation involving a matter over which the Board has supervision, control, jurisdiction or advisory power, and to deliberate toward a decision on the matter, and pursuant to NRS Chapter 288.220, to receive a report on the status of ongoing labor negotiations; and direct staff accordingly. Public Comments:

KING All right. Um, Vice Chair Jones, Item Number 68 has been deleted. We have Item

69 which is a closed door. We do not have any closed-door items. So, you can

now move to the second portion of the public comment.

UEHLING

Thank you, Madam Manager. This is the second time set aside for public comment. Anyone wishing to uh, provide public comment on any uh, item please step forward to the microphone, state your name, and spell your last name for the record. And, uh, please stick to the 3-minute limit. I have a couple cards here. Mister Uehling, you coming back up?

Yes, my name is Ed Uehling. And so, the Business Impact Statement which is, which is created by the State to protect businesses. Was just approved uh, which destroys businesses. What sense does that make? What are you... it's just unbelievable what you are doing and, and once again the, the, the reason is money. If the money wasn't there, you wouldn't be doing this. That's the bare facts. And, uh, Commissioner Segerblom has made that very clear in his interviews on the radio and in other places. And, uh, uh, do, for you guys to be doing this is just a total outrage. And it's interesting that it occurs on the day of a, of a lady who was, who was uh, uh, in, in, put in a concentration camp and almost murdered. And it's interesting that the State, if, if the Jewish people had had guns, uh they wouldn't, would not have been put in these concentration camps. Interesting today that you support the notion that guns should be eliminated. 95% of all deaths by guns are created by governments, not by private people. Yes, these private people create a lot of sensation but, uh, but the real cause of death through guns in the world is through governments. And, uh, and the lesson from World War II from the Nazis is, how good people, perfectly good people like yourselves turn into monsters. And the, the people that ran the concentration camps, the year before were perfectly uh, decision makers, bureaucrats, doing about, going about their business. And that's what should be learned from World War II, is how the, the good people where turned into acting very, very, very badly and, the example today, that we saw here was a very emotional and, and uh, true example of that.

And, here you are supporting that for...uh, uh, doing something similar against uh, against perfectly normal people. All because of money. That's really what it's about. And, for one of you the Commissioners here, to make this statement. That this has nothing to do with the casinos. That is an outrage. There is a circle around 500 acres around each casino. That, that was not created because... just out of thin air. It was created because of the, of the casino industry. That now they have control of, of our properties. Thousands of properties. Uh, uh, of how they can be used.

Thank you, Mister Uehling. Anyone else wishing to provide public comment? Hearing none, I will just say that it is disgusting uh, to compare rental... short term rental regulations to the Holocaust or to mass shootings. And, also for the record, the distance separation requirement for short term rentals was set by The Legislature, not us. If there are no other, uh public comments we'll go ahead and close the public comment period. And we are in recess until tomorrow at 9 a.m.
