ITEM NO. 1 Public Comment

JIM GIBSON

Good afternoon. This is the time set for the special meeting of the, of the Board of County Commissioners. The meeting will come to order. Uh, we welcome you all here. The first order of business is public comment. Uh, what we would invite is for you to line yourselves up in the middle, that way we won't have to wait for people to leave their seats. And for those who wish to speak this- uh, today. Uh, under our rules there's a 3-minute limit. We'd ask you to abide by that. We invite you to come forward and uh, speak. There's only one agenda item. Typically, we ask people to name the agenda item, there is but one. And uh, we're ready to go with public comment now. So, give us your name, spell your last name so that our Clerk can have that down and then proceed to take 3 minutes. Sir?

Wh- while you're making your way up, wh- we, we'd appreciate it if the decorum of the meeting could be that we don't clap and yell and stuff like that but we, we hope that you'll abide by that.

WALTER SEIP

I Promise

GIBSON

Yes, sir.

SEIP

You're ready?

GIBSON

I'm ready.

SEIP

Very good, sir. Uh, my name is Walter Seip. I live in Sunrise Manor. Uh, good afternoon. First, I'd like to thank Commissioner Seg-

GIBSON

Would you spell your last name for us, please?

SEIP

I thought I had. I'm sorry. S-E-I-P. I didn't have any, they didn't have any cards.

GIBSON

Thank you.

SEIP

Thank you. I'd like to thank Commissioner Segerblom for his RJ article addressing Colorado River water. As a chemical engineer working with the Army Corps of, I sometimes had interfaces with the river and dams' folks. So, I read it with interest expecting something substantive and perhaps forward looking.

Second, as once before, I again address election integrity, this time from the perspective of my own canvassing of County Election in-person voting protocols and mailer ballots accountancy. I shared my observation, uh, observations with the chairs of both county major parties, Law and Roberts, neither has responded. The same can be said for several other activities that embrace the EI term but must be hiding any avert actions other than enlisting poll watchers. There were two at one poll, and there were four others when I went to 965, uh, Town Drive to observe mailer ballot County procedures. There was a political piece that allege the County was avoiding transparency at 965. I found just the opposite. I applaud the use of the smaller mail ballot drop boxes at each in-person polling locate, poll, polling location. There were knowledgeable guardians present, and the mandatory shields were obvious. The boxes were driven to 965 Town Drive by a pair of election workers. KLAS showed a video that included such a delivery.

SEIP

While an observer at 965, I was told that these drop box contents were stored in a ballot vault overnight. An Election Department employee then inferred that the seals and numbers were checked as Section 30 of AB321 directs but could not confirm that there was a count of the contents. I was not shown any reports. All poll workers allowed an hour of their orientation was the state's mandated forensic signature verification training. Each poll worker advanced that they were an Election Board Officer because they had signed an oath on the 2018 Election Department form then had been notified by the cl, County Clerk Registrar in accordance with Section 68 of NRS 293C.220. This further directs that the Registrar should deputize an officer for each polling place. I saw no such person. I contend Mister Gloria has ignored this personal responsibility. I reported this including specifics in my emails to both major parties. In my opinion, his present proto, protocol undermines the Nevada Legislature's design of the oversight of polling and valid processing procedures.

At my polling place, I was shown the County's training manual pertaining to affirming that I knew it was a felony to vote more than once. Actually, the affirmation required by Section 6 of AB321 is directed at whether I had already voted. I'd like my presentation attached to the meeting minutes.

GIBSON

Thank you, sir. Next, is there someone who, anyone else who wishes to speak at this time?

MINDY ROBINSON

You ready? My name is Mindy Robinson. I'm actually a candidate for Assembly 35. I'm already on the November ballot. And yet, I'm here because this concerns me and my community. Now, I could go on with the weirdness that just occurred with the primary elections and how establishment candidates, some who didn't even campaign, beat popular grassroots candidates who did and who were favored, or how a sheriff who's so hated by his own voters, he couldn't show up in public without getting booed and heckled, somehow magically won against a guy who was filling rooms and leading rallies.

But I'm not here to prove fraud. I don't have to. What just happened wasn't even close to a valid election. Let's start. What do we got here? So even after you guys got sued for it, poll watchers were not allowed to properly, pro, properly observe the election. They had their views blocked by boxes, 6-foot walls around the Judaification room which if you don't know, is where workers can change your vote on you, and you have no idea. Yep, no one was allowed to look at that. You had people blocking things with racks, temporary walls, and sometimes they had to be 50-feet away because apparently there's supposed to be eagles.

You had 44,000 voters who had their ballots changed to Nonpartisan by the DMV because whatever, so they couldn't vote for their party. They may not have even known that had happened. You've got, huh, oh, and this is my favorite, you've got a box of thumb drives disappearing out of the back room. I don't know if you knew that. You, we had people watching boxes of ballots being loaded into a van, and boxes being loaded from a van into it at night because, hey, more than one person can stay up that late, late at night if you want to pull it this way.

We had, Repub, some Republicans were told to vote on different machines and put their votes in different boxes, which I'm sorry, kind of weird. We had observers rush, oh, gosh, at, at election night, observers were ushered out of a facility at 11:30 PM even only 10 percent of the votes were actually counted. I think I've seen that movie before in 2020. In total, there's about 293 violations, and I'm sure

that number will only go up.

I'm a registered Libertarian. Technically this primary doesn't even affect me. But even I can see something is wrong. Everyone thinks something is wrong except the people who keep magically winning their seats even though they're despised by their own people and can't even look at me right now.

We've got a problem. This is not a valid election. You are angering people. People will become more desperate as you indoctrinate and endanger our children, as the economy continues to crash, as you continue to do everything you do against the will of the people. We will become angrier. And you're gonna need a bigger room to hold us. So good luck with that. Do not certify this invalid election.

AUDIENCE

(applause) (crosstalk)

GIBSON

We'd ask you refrain from doing that. Please come forward. What, why, wait, just a minute. Just a minute, please.

AUDIENCE

(applause) (crosstalk)

GIBSON

No. The, the reality is that I don't know if everyone here is on the same side or not on the same side. It doesn't really matter. But what we don't want to do is get in the way of comment. So, let's just comment, and have a seat. You can, you can clap, uh, without smacking your hands. But the noise and the rest of it, we don't really need here. We're adults, let's act like it. Yes, ma'am.

ERIN GOMEZ

Hi, my name is Erin Gomez. I was a candidate for a State Assembly District 2. Surprisingly, I lost by, my, uh, 25 percent. It's really funny how in 2020, I decided to run because I got three ballots in the mail. My husband got a bunch of ballots in the mail. I looked at my voter history, and his voter history. It says we dual voted, both of us. It says we early person voted, and we sent it in our, sended, sent in our mail-in ballot. As you know, I don't normally like to speak in front of large crowds.

This was super important to me because all I hear is conspiracy theorists, conspiracy theorists, nothing happened, nothing to see. Nothing to see. I reached out to Secretary of State. Nothing. I reached out to Aaron Ford, nothing. Nobody gives a crap. I know people who just got their primary ballot 2 days ago. Tell me how this keeps happening, and tell me how, like Mindy Robertson just said, hated candidates won by 90 percent of the vote. Really? 90? You really think we're gonna believe that?

It's, it, it strikes me as odd that nobody wants to talk about it, not even Democrats. It's not a Republican, Democrat. But I even think some Democrats got, you know, stolen, their, I don't think that's legit either. If you guys certify this election, then it is fraud. 'Cause we're telling you there's a problem. We're telling you we're getting extra ballots. We are telling you there's double voting, dead people voting. We are telling you what's wrong. And you guys are closing your eyes and going, nothing to see. That's the problem. That, that's exactly the problem. So, what you guys can do today is you can hear us. I spoke at a school district board for masking my kids. Nobody cares about us. If you guys cared, you would not certify. This is not a legitimate primary. Even people, left, right, center, are going there's something to see here. We need to investigate. That's all I ask is that you investigate. Thank you.

GIBSON Did you bring with you today the multiple ballots that you say you rece-

GOMEZ I have a picture. So, I also filed my affidavits, and my husband filed an affidavit with Joey Gilbert's team. Um, we did document it. I did send Aaron Ford all of the research, Secretary of State.

GIBSON So, you, you have still the three actual ballots?

GOMEZ I do not. That was in 2020.

GIBSON Oh, okay.

GOMEZ So, for the double voting was in 2020 and that's why I ran for Assembly.

GIBSON All right

GOMEZ Because nobody was doing anything. And I thought I could.

GIBSON Thank you. Next.

MARY ELLEN DAVIS Hi, my name is Mary Ellen Davis, D-A-V-I-S. I'm a, a Nevadan for 57 years. I, um, never really got into this stuff. But, um, I, uh, I was having issues with my mail-in ballots 'cause I was categorized as a Democrat. Two weeks my sister had got her ballot. I hadn't got my ballot. I'm like, where's my ballot? Where's my ballot? I ran outside to the mailman, like, where's my ballot? And they're like, well, they're coming, you know, like in spurts and this, and this, and this. And he, and he shows me a stack of ballots that he had already had. And I'm like, well, where's my ballot? So, I still haven't gotten a Democratic ballot in the mail.

So, in the process of this, I switched over my party to Republican. Boom. I get my, my ballot in the mail. Um, because of this I was like, uh, this is kind of sketchy and all those ballots that that postman had in his car already. So, my coworker said hey, you want to go down and be a poll watcher? And I'm like, yeah, let's go down. I'm willing to do this. So, I worked my 8-hour shift. And then after that I went down with her to work from 4 to 7 to observe what was going on at the polls.

Well, let me tell you, okay. I was on the one at Cheyenne. So, it says A training. So we go into the building, we look around, and we're like hey, where you guys got the training? And they're like oh, it's not here. It's all the way down to, um, it's all the way down to F which I don't know if you guys have ever been to that building, but it's pretty far. So, we're like, oh, okay.

Um, so we walked down to F and in the process of that we're ringing the doorbell, knocking on the door, pulling the handle, And nobody is coming. So, I'm sitting there ringing on the doorbell, ringing the doorbell. Finally, some guy comes out and like, um, can I help you. I'm like yeah, we're looking to, um, be poll watchers. We want to get trained. And then he goes wait a minute. He goes to the back another guy comes out. He's like oh, it's down at the other side where the sliding glass doors are. It's like really. So, we go in there. We walk down this little corridor it says training. We walk down and they have a training center, three rooms with people in it. What's wrong with us? We don't fit in any of the categories that any of these people are getting trained in? And, um, it's kind of like really sketchy to me. So, she sends us off and says, we don't need anybody until 7:00.

MARY ELLEN DAVIS

So, we're saying, okay, no problem. So, I get out. We're driving around the building. As we're driving around the building, a little vehicle pulls up, backs into a, a door, a, a loft, unloads all these boxes. And these two guys come out of the building. They take the boxes, unmarked, brown boxes into the building. And then he says, this is the last batch. The guy's car wasn't even from Nevada. It was an Idaho license plates. I got it all on video. And so, this is kind of sketchy to me.

GIBSON

Thank you.

SHAWN MCGRAW

Good afternoon, sir. Good afternoon, folks. Uh, my name is Shawn McGraw. Um, I'm here today, um-

GIBSON

Could you, could you spell your last name?

MCGRAW

McGraw, and like, you know, Tim McGraw, Tug McGraw.

GIBSON

Spell it.

MCGRAW

Phil McGraw

GIBSON

No. I know how they spell their name. But I'm not really sure our Clerk does so would you mind just spelling your name, please?

MCGRAW

M-C-G-R-A-W.

GIBSON

Thank you.

MCGRAW

All right. Um, I've never been in the, into really politics. I served, uh, over a decade in the United States Military. Um, and I never voted because whether I liked the, the person I voted for or not, it never really mattered. And I know most of my, uh, service members felt the same way. Um, but when I came out, the first time I voted was in 2020 in, uh, my adult life. And I'm almost 40 years old. And, um, you know, I, I felt, you know, kind of cheated. But I kind of brushed it off. And then never wanted to get into politics. And then I started working for Mister Gilbert, um, about 6 months ago. And I saw some, uh, some pretty, uh, shady things going on, uh, behind the scenes. And, and as we got closer to, to, uh, uh, the primary election date on June 14th, more and more started coming up.

Um, went to the observation, uh, to be an observer at the, uh, counting facility. And it felt like I was, uh, like in a theme park, you know, tour, kind of just being rushed along, you know, um, and never really got to see. And every question I asked was, I don't know. I don't know. How do you work at a facility like that, and you don't know? I asked head directors or, or whoever, supervisors, answer was, I don't know. How do you, how do you get in these positions, and you don't know? How do you not know these questions?

When I asked why there were single-sided ballots being put out, pulled out of the envelopes, singled-sided ballots, Democrat and Republican, not just one side or the other, Democrat and Republican, I don't know. How is that?

And there is more, hundreds of discrepancies not being, denied access to going and visually seeing, you know, certain areas that were obviously being worked. Uh, discrepancies on the last day of bins full of ballots that haven't been counted yet on the last day of these count, of the counting. And oh, uh, those are, uh, you know,

we, we've already contacted these people, and they have to come in to, to get these, uh, to recer or sign their ballots or, or whatever. And but initially when asked, I don't know. I don't know why there's bins full. How do you, I just, that, that boggles my mind. I mean, I'm not the smartest man in the universe, but, you know, I can see, you know, there's, there's, there are shady things going on. And if you don't know, and you're a supervisor or a director or whatever you want to call them, but you don't know something going's on there. Um.

GIBSON

Thank you, sir.

MCGRAW

Al-right, thank you.

GIBSON

Thank you.

TRAVIS EBARB

Travis Ebarb, uh, T-R-A-V-I-S E-B-A-R-B. Um, right off the bat, this, uh, I suggest that this does not become certified whatsoever. I have, uh, nine discrepancies that are absolutely non-partisan of why this should not be certified.

Number one, the Nevada Revised Statutes require ballot secrecy. And right off the bat, we had five violations before the ballot was even opened. You guys have been served this evidence. You guys already know.

Number two, ballots received by the Registrar Of Voters did not have a proper chain of custody. We had no non-bipartisan chain of custody. There is no written documents. We've asked for them. There is nothing. We have absolute surveillance of this, too. You guys have been served this.

Number three, the internet or the Mifi has been hooked up to all EMS machines and all voting machines confirmed by certi, Registrar Of Voters not only in this county but other counties across this State.

Court orders, number four, court orders regarding the observation of our election process has absolutely been violated.

Um, we'll go to, uh, that's not this county, number 6, there was a violation of, uh, NRS, NRS requirements for equal representation from both parties which was stated prior for election workers. We had, uh, election workers that were bused here out of state when we had constituents in our county that were denied to be a worker in our electoral process. Why is that? We'll never get answers to that, I assume.

Well, let me go back here. Anyways, uh, there's more, but at the end of the day, I don't see how, uh, you guys can absolutely certify this crime. And I really don't want to hear a disclosure statement of how you're separating yourself from accountability. 'Cause at the end of the day, you can't certify this crime. It's unreal, absolutely unbelievable. This is a non-partisan issue. We had it on both sides of the aisle. Thank you.

GIBSON

Thank you, sir. Next.

BRIAN DAVIS

Brian Davis, B-R-I-A-N D-A-V-I-S. We the people, in order to form a more perfect union, do so raise up our citizens to be servant leaders by a contest of voting to find the most populous person to represent the people in our republic through a democratic process of voting to find the best of us to represent the

government for the people, by the people. If this process ever- ever comes under attack or is in jeopardy of failing from these attacks, we must take every precaution, go to any lengths to assure the validity, validity and sanctity of the truthfulness of our democratic voting process. If we fail to achieve a truthful and honest election, then we no longer have a republic by the people, for the people. We left kings and queens as our rulers, and founded this Country inspired by our creator, enshrined in our Constitution. We the people, do not consent to be ruled by kings and queens, by tyrants, or any other power. We demand transparent and honest elections. We demand a forensic audit to find any and all problems or subversion of our democratic voting process. We do not believe this was an honest and secure election. We call on the Commissioners, appointed leaders, to not certify this election. Thank you and thank God for letting me be the man in the gap.

And I can, and I can confirm everything they've said. Um, I was at the Elections Office for many days. I spent many hours there. And, uh, the default response from everybody except for two people, Mister, Mister Gloria and another individual there, uh, their default answer was, I don't know. Hey, what's happening today? I don't know. What's happening tomorrow? I don't know. What's that over there? I don't know. If that's the standard that we go by, it's completely inadequate. All right. If only two people can answer basic questions and anything beyond that, then we need to go and clean house, get some more people that know what their job is, know what they're doing, and can answer basic questions. Literally, I would question whether they knew where they were at because their default answer was, I don't know, I have to go find out. Find out from who? Why don't they know how to do their job? Why they don't know basic questions about their job? What's going on? What's going on tomorrow?

If I asked anybody here that same question, I guarantee you would have an answer, and a mildly one or a very competent one. I'm sure anybody here would have the same answer. So could, that combined with a lot of other things that these, uh, folks have said, and I can confirm that, uh, this was not a transparent and, uh, clear... Thank you.

GIBSON

Thank you.

SUSAN PROFFITT

Susan Proffitt, S-U-S-A-N P-R-O-F-F-I-T-T.

I would like to tell you that when we came in to, uh, observe and, um, we had to get a court order to do that. And unfortunately, we were denied, um, the opportunity to observe without obstruction, without being removed from the, um, the area before the ballots were removed from the area. We saw so many violations. This is only a fraction of what I and my team put together. If you would like to read some of these, they're pretty shocking.

I'm not gonna talk to the fraud that I witnessed because you have all that documentation already. But I would like to thank whoever it was who warned a friend of mine that Joe Gloria, the Registrar, was out to get me and, and remove me. And he did without any evidence at all. I gave my phone to them, said here, I just showed everybody I wasn't doing anything but talking to text. They claim I took pictures. Well, you know, pictures wouldn't prove very much but eyes do, and we have corroborating evidence. Not just one eye, not two, but about 50 eyes and some of them are sitting in this room.

PROFFITT

But I would like to ask you, please, to remove this man, Joe Gloria, because he's a thug, an absolute thug. And he did not receive us in the, um, manner in which we came to him. We came to him as good people trying to set a baseline for the November election. Not to find something wrong, but unfun, fortunately we fought, we found way too much wrong. And most of it started with him and his abuse of the people in our organization. He put a sick woman on our detail and refused to remove her for three days. And the only way she got removed was having to contact Barbara at the state of, um, you know, Secretary of State. Okay.

He had a, I had to file an OSHA report. And it was legit. We have two witnesses. And he refused to speak to those witnesses, but he claimed, in front of a lot of other witnesses, that he had a Metro Police officer who refuted all of those claims. But the strange thing is, that man doesn't exist. He was not there. So, if there is a man in the Metro Police Office, I'd like Lombardo to find out who he is because he's perjured himself. And that's against the law, too.

Please, gentlemen, lady, I would like to see you do the right thing. We really did want to set a baseline and try to improve the optics that are so horrible. And the optics only got worse. Really, really worse. And this man over here is an abomination, and he needs to be removed. And there are a lot of people who can testify to this. Thank you.

GIBSON

Next.

JENNIFER BANDIERO

Good afternoon, Commissioners. My name is Jennifer Bandiero, B-A-N-D-I-E-R-O, candidate for Board of Regents, District 13. I've been a proud Nevadan for 20 years. When I voted in this past, the current election, I personally experienced multiple election violations. I was told that my signature wasn't on file at the DMV. It took 20 minutes for the poll workers to find a solution. The computer in which they were trying to sign me on, kept saying reset, reset, reset, and just kept spinning, and finally they just let me go and go vote. I guess it didn't matter that my signature's not on file with the DMV for some reason.

The poll worker asked for my mail-in ballot. I didn't have it 'cause I hadn't received it yet. It wasn't delivered to my house until June 21st in which I did make a video of that happening. Before opening my mail-in ballot, it showed right through that I'm a Republican voter. Our State doesn't allow this because the risk is too high, someone could interfere with the mail-in ballots being delivered if the political party is visible on the outside of the envelope. I also posted that video on Facebook as I saw it coming in.

Both candidates and constituents are contesting the election result and the people of Nevada are demanding a recount. There are election violations which you've already heard from Mindy, from Travis, and multiple other people in this audience, such as chain of command being violated, mail-in ballots delivered late and no verification of signatures.

So, this past election does not comply with our state laws where statutes were clearly violated. I personally believe there are gross absurdities that have made this election uncertifiable, and I contest these election results. Thank you.

GIBSON

Thank you.

SOCORRO KEENAN

Good afternoon, gentlemen. My name is Socorro Keenan, I ran for Secretary of

KEENAN

State. And I want this on record. William McCurdy, Michael Naft, Jim Gibson, Marilyn Kirkpatrick, Kirkpatrick, Tick Segerblom, Ross Miller, they're present today. I think the camera's usually on, on the audience. So, we want to make sure that everybody who's here is, is counted.

I, I need to know from all of you who are the four County Commissioners that certified 2020 elections. I don't know who they are. We don't know who they are. That's all that's needed to certify that the records for 2020 elections. So, we want that answer. And then moving forward, um, there was, this is whole, this whole voting system was about integrity all the time. That's why we were in the United States of America. And we need to be united. And we keep playing that fake it to you make it game. I've been here 39 years. I know a lot of the people here already from the past. But with, this is today. God's talking, today's a very important day.

Roe and Wade, guess what, we won. Finally, we won. Thank God, for that because if it was up to the people that are in Nevada that think that they are in control, they're out of control. The ones that are in government, a lot of them. The other ones that don't want to stand up and they have, they don't have the courage to stand up, we got problems. But this whole thing is about integrity.

Number one, I pulled this list of all the candidates from the Henderson Library in Green Valley, on Green Valley Parkway and Sunset. Now, I started with, on, June 15 with 3,400 and so votes. I looked at my voting record on, two days ago, it's, I'm a thousand, a, a thousand votes less. So, you can't fake, how, how can that be? Now, everybody knows the casinos, if we cheat in the casinos, what happens? If we cheat in any ball game or any sport game, what happens? We're out, out, out. But voting is the most important thing that has to go on for all of us. That's the only thing we can all participate in that's our inalienable right. And I'm asking all of you to be prudent, to be prudent and to have a conscience this time. And to do what's right for everybody, not for yourselves, for your pockets. It's over. God's talking to us. You need to do what's right. Get the number right. If you didn't get them right, let's just go right. And let's vote again one ballot, one person, and paper. Let's do it one day and we can get, we, we can all agree to that, I believe. So, if you get, if you get together and do what's right for everyone because you, you, we worked, when I worked for the Governor, your dad, Ross, I had to do what your dad said. Thank you.

GIBSON

Thank you.

MICHAEL KANE

Hello gentlemen and ladies, Commissioners. My name is Michael Robert Kane, K-A-N-E. I'm one of the physicians here in town. I had the pleasure, privilege of being able to go and observe at the tabulation and adjudication center, um, several times during the pre, uh, what should we say, the early mail-in, um, elections. Um, what I wanted to make mention to you of is, um, first of all, uh, at one point and time during the, uh, period in which I was there, um, I was, first of all, I was sent around with ambassadors to several different areas, but only when they allowed us to go. The, this had to be done on specifically their time schedule not open observation even though we had an ambassador with us and available each time. At a certain point in time midday, we were told that we needed to spend time in a conference room. We were there for a good hour, hour and a half.

I had asked several times if I would be able to just take a quick walk around the rooms to see, um, with the ambassador, if nothing was really going on in these different areas. There were about 5 or 6 different areas where things were going

KANE

on. I was specifically told no. So, I asked if they would ask those higher up. I was told the gentleman, Mister, uh, Joseph that's here, um, told them no, by the gentleman who is sitting next to him named Dan. Uh, even though I had asked. So, I was refused to be allowed to go and observe the different rooms even though we were there and supposed to be observing, according to a court order. Um, I witnessed that myself. I cannot understand how that's, um, transparency. As far as, uh... I, I'd like to make a suggestion to you. I, I'm really, uh, when I, well, when I observed what was going on there, going from the different rooms, especially in the signature verification room, that was clearly connected to the internet. Um, we were never able to see the signatures. We were never able to see the ballots close enough to verify they were real ballots. What I wanted to see was, I wanted to see the little circles filled in by human hands to know that these were real ballots, you could tell that there was a real process going on.

I was never closer than 15 to 20 feet away from a ballot. I do not think that's truly observation, nor do I think that was the intention of the court when they allowed us, um, the, uh, ability to observe. Uh, what we really need is a paper ballot. We need a one-day voting except for the special exceptions that should be verified, um, somehow as far as a mail-in ballot is concerned so that we can actually have honesty and transparency. When I observed the system as it is now, I was shocked at the stupidity that you must, uh, think we, um, uh, uh, that, that we, the, the stupidity you must think of your, uh, constituents because no one in their right mind would've accepted what I saw.

Uh, the money, by the way, that's, you're gonna use to defend all of these things that have been, uh, the different things you've been served with, that money could better go to the, uh, to the schools instead of having to defend you all. Uh, I wish you good luck.

GIBSON

Next speaker.

JOHNNY JACKSON

Hi. Aloha, Johnny Jackson, J-O-H-N-N-Y J-A-C-K-S-O-N. If you guys certify this election, you must be smoking as much weed as t-Mister Segerblom over there, okay? Uh, y- let me give you an example. I decided to vote at the East Las Vegas Library. I'm the only one in there. The rest of the crew that, that's there is looking at the lights, or whatever it is they're doing. I gave him my mail ballot. The woman goes, "Oh, John Jackson. Republican," so everybody can hear it. Well, me and the other people the only ones in there. Okay, no problem. I decide to walk to one of the machines, and this guy says, "No, sir. Come use this one." I said, "What's the difference?" He said, "Use that one."

Right now, my company, Aloha Consulting, is doing a poll, which I'm going to be releasing on Monday. Okay, 1,000 interviews, 62 percent at this point feel there's something wrong with this election. And some of you d- are really unfavorable rates. Like, that's you there, Commissioner Segerblom. But anyway, it's coming out. Do not certify this election, please. Thank you.

GIBSON

Next speaker. Appearing there is no other speaker-

AUDIENCE

Wait. (inaudible) (crosstalk)

PAM BENNETTS

I don't have anything prepared, but I'll talk.

UNIDENTIFIED

Take a breath.

BENNETTS

Pam Bennetts. I'm back. Nice to see your faces. How's the COVID vaccine going for everybody? Oh, that's right, people are dying lately every day. So you already know how you're gonna vote. You voted yesterday just like you do every time we come here on a Tuesday, you vote on Monday. I already know how this goes. You're not listening to us, but it's gonna be interesting 'cause I got a box full of fun stuff that there's no way you can certify this election. I have payroll records that your employees just dumped in the dumpster. I have, um, instructions on what to do with the Dominion machines that they dumped in the dumpster. Um, I have video of people pulling up to the election facility. Only one person at a time with big batches of ballots. Chain of custody, not much. This is about as believable as the man that can't even ride a bicycle right now that is the President, or pretend President of the United States of America.

We, the people, know what's going on, and you have the opportunity to do something about it, but you won't because Sisolak gave you your orders, and somebody gave him his orders. We know what's going on. Please, for the love of God, do your jobs, cause otherwise it's going to court and it's not gonna look pretty for any of you that certify it. I can, I 100 percent can tell you that's happening, cause I have proof. Thank you.

DANETTE HYT

Hi, my name is Danette Hyt. D-A-N-E-T-T-E, last name is H-Y-T. I just, um, would like to point the American Flag behind y'all. And we all stand, and we pledge to that flat our allegiance to that flag. And in that pledge allegiance, we say one nation under God, is that correct? It's under God, this nation. And I just like to remind, maybe not remind but inform you that God hates unfair and unjust balances. It's in the bible. He hates unj- unfair and unjust balances. And this election has not been fair. And I just ask that you please in the name of God, do not justify this election, because we do not want to have unfair, unjust balances as God would. Thank you.

HELEN OSEGUERA

My name is Helen Oseguera, H-E-L-E-N O-S-E-G-U-E-R-A. I am also a candidate for Clark County. I have going to... I am going to the general election straight. I did not have to deal with the primary, however, I'm also a voter and I'm also a mom. I was very upset in 2020 when my son's vote was stolen from him for his first time voting when they told his ballot was provisional when we voted at the same time, the same day, at the machines at the same location. Then on top of that, I watched the shenanigans in 2020. And then it happened again in 2022. I personally have screenshots of Wi-Fi at 10 different polling locations, 10 of the same Wi-Fi. I also have evidence of my son's ballot, which I still have in my possession showing that he is a Republican on the envelope. When I went to vote, they also announced my party at the voting center at Sunset Galleria. They said, "Oh, you're a Republican," very loudly. Then they turned around and tried to direct me to a certain machine. Fortunately, I am smart enough to realize what they were doing. I went to a different machine.

So, here's the thing. You guys are liars, your cheaters, and I'm disgusted with the way you guys have propagated this election. You stole ballots, you've mailed out ballots to people that don't even have ballots, they're Independents that are been changed through the DMV, you have the 40,000 ballots that can't be corrected because the signatures don't match. Come on, give me a break. We all know that was the 2,000 mules. You guys had people collecting signatures to steal this election. We know it, we have proof, and we have documentation. If you have any idea what's gonna happen to you, this election in 2022 in November, you only know what's gonna happen if this gets happening again. If you s- try to steal the

OSEGUERA election in November after verifying this election, it's not gonna look pretty. So, I would think twice before you concede on this election and give us a certification. We don't want the certification. We want this overturned, and we want a revote on paper ballots one day only. Thank you.

GIBSON Next speaker.

CHRISTINE FORESTA Hi, my name is Christine Foresta, F-O-R-E-S-T-A. And I'm just here to let you know how my experience went on election day. This is the first year as a Republican. I've been bipartisan, however in 2020 when I voted, there was an issue with the machine that I went to, and it was that it was on the wrong date and time, and that was in 2020. 2022, I turn up at the same middle school in my district to vote. Of, it was announced very loudly, "Republican." I was like, "Oh, I don't recall that happening in the past." I went, I got my card, and I went up to vote. And when I hit print, it was just a blank sheet of paper rolling around, rolling around. And I thought, "I know there's supposed to be something printed on there," not that I get a copy of that printout. It's, it's kept secret anyway, but it was empty. So, I had to go get a poll worker, which I thought it was strange because here I am, again, and there's an issue with my, you know, my vote.

I had to revote. So, my concern was, am I going to be found to have an illegitimate vote, my, my ballot is illegitimate because now I voted twice? I'm also a property manager, and I've been at these same property for 13 years. In 2020, I cannot tell you how many ballots turned up in the trash can by my mail room. I noticed none of the names, and I know the names of all my residents. 232, it's not a lot, and I've known people from the past. I can tell you people who've lived there 10 years ago. I can tell you people that lived there before I worked there because their mail does turn up. These names were unrecognizable. They had nothing to do with my addresses. So what could I do? Return to sender? Shred them? What am I supposed to do when I find these illegitimate ballots being sent to people? These are the things left, right, in the middle, whatever it is, people are fed up and, and people are gonna get louder. And it just depends on how loud you want them to get. We know that this has been illegitimate. Please do not certify this, because it's all on your heads. You're looking like fools if you certify it.

We don't want our leaders to be fools. We want you to be strong and be there for us and support us in our will, not in whatever political party has been, you know, contributing to you and, and your livelihood. We need you to represent us. And, and people are getting very fidgety, and it's scary. It's a very scary world. I was afraid to come here today because of two things, the gun legislation bill that went through and also Roe ver- versus Wade. We already know people are losing their minds left and right due to what? I can only say the political climate. Thank you.

GIBSON Excuse me. Just one question. What, if anything, did you do with those ballots that you saw in the garbage?

FORESTA I returned to sender.

GIBSON Okay, thank you.

FORESTA Mm-hmm.

GIBSON Next.

PAM NORMAN Pam Norman. P-A-M N-O-R-M-A-N. Um, I would just like to know, um, how come Tick is allowed to vote when he's on the vallot, um, on the ballot?

AUDIENCE (Crosstalk)

NORMAN Conflict of interest?

GIBSON So, your question is, he's sitting on this, and he is a candidate. Is that-

NORMAN Yes.

GIBSON ...what you're saying?

AUDIENCE Yes.

GIBSON And eventually, maybe all of us sit, uh, under the law because we're candidates to b- to get seated, right?

NORMAN Mm-hmm.

GIBSON So, um, we can ask Lisa if she has, uh, a response other than I don't know.

UNIDENTIFIED Typical.

LISA LOGSDON Thank you, Commissioner. Um, so under the Nevada rules of, um, ethics that you're bound by, you would make a disclosure if it has a significant, um, pecuniary interest for you. So, since this is global and applies to everybody, um, that disclosure's not necessary. So, he's allowed to vote.

GIBSON Okay, so at the appropriate time, then, a Commissioner who is actually on the ballot would have to disclose so, so that it becomes a part of the record. But that because of the global nature of the vote, it isn't something that is unique to him, and he is not precluded from casting a vote on the question.

UNIDENTIFIED It's not global. It's our state.

LOGSDON That's correct.

GIBSON Okay. Go Ahead.

UNIDENTIFIED It's state, not global.

GIBSON That's the answer.

PAM NORMAN Okay. Thank you.

GIBSON Any other comment?

UNIDENTIFIED He needs to remove himself. Yeah. Fined. Fire him.

AUDIENCE (Crosstalk)

UNIDENTIFIED Yeah. Fined. Fire him

AUDIENCE

(Crosstalk)

UNIDENTIFIED

Justin, I don't know (inaudible) Mexico's nice this time of year.

NICK DEVEREUX

My name's Nick Devereux, D-E-V-E-R-E-U-X. It's nice to have some more people here this time. First time I came was two years ago when, uh, right after I found out that, uh, Justin Jones spearheaded a lawsuit to get rid of our, to get rid of our signature verification, but, uh, or at least minimize it down to a very minimal verification. And, uh, all the mail-in ballots started happening. And I don't know about you guys, but every single person in this room... I was by myself last time, and at least now we've got a nice little group of people that are waking up to what's going on. And we know it's cheating. Um, it's obvious that if you introduce this type of thing, it's like putting fertilizer on a lawn. It's gonna happen, and it has happened, and that's why there's more people here. And, you know, it's happening throughout the whole, all of the United States, not just here in Clark County, but the whole... You know, America's waking up to this open invitation to cheat. And we actually have now real proof.

The sad part is, is that most of the people in government that are here now won't look at the proof. They would just dismiss it as being false and not, not real, and we're all making this stuff up. Well as you can see, we're not making this stuff up. We're all here, and we know it's true. And my Commissioner, Justin Jones, was here two years ago when I brought this up, the fact that the, it was, you know, this type of cheating, this type of fertilizer for cheating was being introduced. And I was just completely disgusted with that back then.

You know what? It's really our fault. We let this happen. We let people, like, stay in government too long and not do what they're supposed to be doing, which is serving us, serving the people of the United States. You know, we see the corruption. It's not even... You know, the average person who has half a brain can see it. I can sit there and talk to many, many people that want to, you know, spew the talking points about how we're just making all this stuff up, but you sit there and you try to debate with them, and they lose the debate every time. And the end of the debate, they call us all racists and bigots. That's where we end up. And, uh, I am not a racist. I've never been a bigot. My best friend was a different color than me growing up, and yet that's their defense. That's what we have to deal with, the average American citizen now, instead of the real truth about what's going on.

SHARON ABILA

Good afternoon. My name is Sharon Abila, A-B-I-L-A. I only have a question about the transparency of this process. This is, uh, s- so important to the Americans here in Nevada and our Country. One of the things, I was an os- uh, observer, and one of the things that I saw, there was not any cameras in the election building in all the process. So, if there's transparency and there's cameras everywhere, there's cameras here, uh, on the street, in the stores, you can't go anywhere without being observed. And I found it very odd that there wasn't a camera, um, documenting what was going on there. So that's a, a big question, why? So, if that could be answered, uh, I'd like to know. And I, I'm sure everyone else here would like to know. This process is so important to the lives of our children and, um, it should be completely transparent. That's all. Thank you.

UNIDENTIFIED

We want our answer. Where's the answer?

DANA ALLEC

Dana Allec for the record, like smart allec, A-L-L-E-C. Just put a smile on your face, Marilyn. (laughs) a little smirk (laughs). I'm just here to, uh, let you know

ALLEC

exactly what happened to me on, uh, the day that I voted. I went to, uh, my precinct, and it was over off of, uh, Sahara and Precinct Number 5571 to be exact. I was one of the first in line at 7:00, and at 7:30, the line started growing larger and larger, and we were starting to wonder how come we, and we asked a poll worker, how come we're not starting at 7:00 p- uh, a.m. like we're supposed to. And the poll worker came out and said, "We do not have the flash drives to plug into the computers for the Wi-Fi to begin the process." Well at 7:45, those flash drives finally appeared to be able to boot up the machines.

And so, I went through. And then I went to the poll worker and pulled up my records from the DMV. And they, uh, said that "You are not registered. You're a non-partisan." I said, "How could that be? I've always been a registered Republican." And they said, "Well, according to our records, sir, you're only gonna be able to vote non-partisan." And he said, "The only way that you're gonna be able to vote today is if you fill out a provisional ballot." So, I filled out a provisional ballot and casted my vote. And as of last night, I checked with the Secretary of State, and my provisional ballot has been put in the mail to me. Same thing happened to me in 2020. I was filled out, the DMV had switched my party, and they said, "provisional ballot was in the mail." For you, I know Ross Miller, how many years did you put into the law, uh, Nevada State Bar Association? Are you an attorney yourself as your father was? My fa- grandfather was an attorney for 60 years. I was not an attorney, but I was very close to my grandfather. And he ir- reiterated to me that in a court of law, that you only have to be proven beyond a reasonable doubt to be able to be convicted of a crime or to be found guilty. And the evidence that was submitted to you guys that you guys have in front of you and all of the testimony that we have from everybody from the poll workers, we've proven beyond that reasonable doubt that this election shall not be certified. And I ask you guys to make a motion to have this election to be not certified and to have a paper ballot so we can have a fair and honest election. Thank you.

GIBSON

Next. Someone else who wishes to speak?

CAROLYN ST. JOHN

My name is Carolyn St. John. My last name is spelled S-T with a space, and then J-O-H-N. I'll just like to remind you all of True the Vote and the two patriots that are actually in possession of a lot of evidence in the 2020 election. Possibly, they might have l- evidence in this one, as well. Um, and I'd also like to let you know that they are working with sheriffs across the Country, and of course, they're not working with our sheriff-

AUDIENCE

(laughs)

ST. JOHN

... because he's a crook who actually covered up the death of 58 people, and many were injured on his watch. He never investigated that. Mindy Robinson had to put together the information for what happened there. Though this year, we don't even have a lesser of two evils to vote for. (laughs) But I'd like to remind you of all of that because they're making headway. And even though they're not gonna be in this State getting help from this sheriff, they're gonna be all across the Country doing it. We're getting our Country back, and all of you people that are voting against the people, you're not gonna be able to walk down the street just like that piece of crap Democrat was threatening all of us and all of our, you know, representatives. Maxine, remember her, and she got away with it. They get away with all that stuff, you know, but whenever a patriot says something, they go to jail like Simone Gold. She's got to spend 60 days in jail for talking in the U.S. Capitol after they opened the doors that can only be opened from the inside. And she was invited in

like all the other patriots.

And then mad cow on MSDNC, she actually admitted that none of the people from Trump were even there at the time when they, all this commotion was going on. They were still over there with Trump. She admitted it live on air. So, the truth is coming whether you all see it or not. It's coming. And I would do the right thing, because God is watching. And I don't know if any of you even believe in God the way that you behave. It's sickening. It's demonic the way you treated children. Wow. It's just beyond, beyond my wildest imagination that people are so rotten and stinking evil. And you, lady. You, you're showing it on your face 'cause you are pretty horrific.

GIBSON

You know, so I, I get that people get overwhelmed, but there's no reason for it to get personal like that. None. There's just no-

AUDIENCE

(laughs) (crosstalk)

GIBSON

... no justification whatsoever. No, no I... No it... What you feel is personal to you, that's fine, but you're, w- what you're doing is you're flipping it, and you're deciding that you're going to get-

UNIDENTIFIED

It's personal.

GIBSON

No, that kind of st-

UNIDENTIFIED

It's personal.

GIBSON

That stuff isn't helpful.

UNIDENTIFIED

(inaudible) It's personal.

GIBSON

I ha- we haven't-

UNIDENTIFIED

This is our country. We (inaudible)

GIBSON

So, so, is there anyone else who wishes to speak? Come down please.

CHRISTINE BARRELLO

Hello. My name's Christine Barrello. I know you guys just saw me the other day. I love this place. Um, Christine Barrello, B-A-R-R-E-L-L-O. And I just want to say if the tables were turned, how would you feel? This isn't about Democrat, Republican. It's just about a fair election. That's all we're asking.

Um, I was also observing the ballot counting, and, um, as I was leaving, 'cause they asked us to leave at a certain time, there was a woman in the lobby running with her cell phone, and the phone was on hold. And I was, thought it was a little odd. And she said she was on hold for hours because her ballot wasn't, uh, properly, um, looked at. And, uh, they had issues with her signature. And, um, she came in running in the lobby and said that she got hung up on twice, and that she, um, never had, you know, a chance. And then literally, it was like 10 minutes before they closed, so if it's only one person, it could be 1,000 people. And I know there's about 4,000 ballots that weren't, uh, properly vetted. Um, it's on the website. It's all public. And, um, also on observation, they let us see everything about ballots, but no- nothing about the machines.

BARRELLO

So, when we asked about the machine and the software, we were pretty much denied any, um, viewing. So, if it's fair and transparent, we never saw anything in that transparency. But I'm asking you guys, please, to reconsider this because if the tables were turned, um, you guys would be upset, as well. Thank you.

GIBSON

Okay. Next speaker.

CHANCE BONAVENTURA

Chairman, how are you? Commissioner Kirkpatrick, I just wanted to... I was watching on, at home, and, uh, people are s- not saying, you know, what I found out. Uh, so just wanted to stop by and, uh, just found what I found. So, after 2020, I got a walk team together.

GIBSON

Could you tell us your name, please?

BONAVENTURA

Chance Bonaventura, uh, B-O-N-A-V-E-N-T-U-R-A. I got a walk team together. And what we did is everybody received a primary ballot, and it was retur- in the general, and it was returned as they don't live there. Um, but I'm sorry, in the primary, and it was returned 'cause they don't live there. But in the general, they voted from that address. Those are the address we went to. And it's a universe of about 2800 houses across the Valley. Um, we managed to get to about 800 of them over the course of a week, you know, with an answer rate of about 15 percent, so 150 people answer. Well, uh, we went in under the, uh, philosophy of proving that there was no fraud. And well, it turns out, I ended up having 63 affidavits, which I have here, for the Clerk. Um, and it was instances like this where you say, "Hey, does blah, blah blah live here?" "Oh, no. They haven't lived here in two years. They haven't lived here in three years. They haven't lived here, um, in 8 years," right?

And it wasn't willfully malicious, um, most of them that I could find, but it would be, for instance, like this. I go to an apartment, and I say, "Hey, does blah, blah, blah live here?" "Oh, no. That's my sister." It's like, "Okay, well does she live here?" "Oh, no. She moved to Henderson two years ago." Well okay. So now you look at these, and you say, "Okay, well I haven't found enough evidence to show that any of the statewide or national races, there was enough discrepancy for them, um, to be turned over." But if you look at all of our local races that come down to less than 100 votes all the time, Stavros Anthony, um, 15 votes, 136, uh, irreconcilable votes that they couldn't account for. I walked for six hours in his district, and I have three affidavits in here of people who don't live in that district, um, who voted in that district. And so I just wanted to come down and say that we need to look at, um, you know, the voting machines, whatever, is one argument, but we need to look at the individuals who may be voting under, you know, good will, uh, in the district, but they don't know that they moved out of the Assembly District or the County Commission District or the City Council District.

And unless we're purging those roles, and we have races that come down to, you know, 1/10,000th of a percent of a margin of error changes the race, um, unsolicited ballots are the reason or could be the reason, and that's the problem of altering, uh, these local, state and then, uh, city races. So, just wanted to stop by and just say my peace, 'cause I didn't hear anybody talking about that. And I did the work, so might as well submit it. So.

GIBSON

If you brought those, then you can hand them over the glass there.

UNIDENTIFIED

Hope you have copies.

UNIDENTIFIED Yeah, hope you have copies.

BONAVENTURA If you want, you can have them.

GIBSON Thank you. Next speaker.

MARILYN GREEN My name is Marilyn Green, G-R-E-E-N. I'm a relatively new resident to Nevada, and this was my first election here. As soon as we were able after a 6 week wait, we were able to register our vehicles. And we did register to vote at that time. As the election day came closer, we checked frequently to make sure that we were indeed registered to vote. But what we noticed was our party affiliation changed four times without our permission.

AUDIENCE Oh. (crosstalk)

GREEN We wrote that we did not want a mail-in ballot. We wanted to vote in person, because we aren't trusting the election system in Nevada. We've only lived here a little more than 6 months. But you, the County has given us good reasons not to trust with that sort of thing going on for us. We voted at Del Webb. And what we noticed when we went in, yes, it was announced that we're Republican, and yes, we were directed to machines. Little did we know until my husband, and I talked later that for both of us, the results would not print. And we said, "Oh, okay. You know, that's fine. It'll... We know what we voted." But it seems real odd that for Republican voters, the results would not print.

We also noticed that, yes, there were observers and that polling place at Del Webb, there was an orange tape on the floor. And it was as far distance from the machines and from the Poll Workers as it could be. There was no way any Poll Watching could have seen anything from where they were seated. So, I ask you just with the information from this new resident, how you can allow this voting chaos to continue. It's obviously non-certifiable when people like me are saying, "I didn't know I should get a printout." I didn't know that if they shouted Republican, if they shouted Republican about me that I would be directed to a certain machine. I'm very disappointed, and I think you should be disappointed, too, as it's your Responsibility as County Commissioners to make sure that we have fair, open, trustworthy, transparent elections. And as far as I can see, you have failed.

AUDIENCE (Applause) Thank you

GIBSON Next speaker. Is there another speaker? Come on down.

VEM MILLER Hi, my name is Vem Miller, and I, I just want to point out some-

GIBSON What's your last name s-

MILLER ... areas that I-

GIBSON What's your last name, sir?

MILLER V-E-M Miller. So, uh, throughout this process, I've been knocking on quite a few doors, um, about 10,000 in total. And I can't tell you how many families who I spoke with that, for example, were 3 and... 3-person households were receiving 6, 7 ballots. Uh, you have, uh, many instances, and I think, um, this is just a matter of canvassing if there was, uh, a serious desire to investigate these issues, where, uh,

MILLER

you have, uh, you know, 3-person household that's still getting ballots for grandma that passed away years ago, that's still getting ballots for the 3 kids that went to college and now live in a different state. And I kept hearing these complaints.

Other things that I've, uh, noticed, uh, considerable amounts of issues with are, um, people that were trying to register Republican had gone through the actions of registering Republican, only to find out when they showed up to the polling booths that they were now registered as Nonpartisan, and this was happening en masse. I don't understand why, when some of these, uh, races came down to 10, 15, 20, 30, 50, or 100 votes, um, these kind of... you know, there's a general sloppiness with this mail-in balloting that, uh... and also with these machines that are just so open to these inconsistencies and errors, that I don't know how we could look our-... at ourselves as a first-world nation and running literally third-world elections. We have a country like Mexico which finger... not only gets a voter ID, but they thumb print every individual, in Mexico. You have somewhere like France when in 24 they count all their ballots, and these are, you know, hand ballots, and, uh, you know... um, paper ballots, and why do we have elections that are running 3, 4 weeks and are so open to so many errors?

Um, obviously we know about the 44,000 individuals that were different... disenfranchised because of machine issues, and, again, in races where people won by 50 votes, this is literally the differential that would've caused another individual to potentially win.

Um, this process just has so many issues. I mean, this is like a third-world process. This, for anybody that's slightly intelligent and il-... intellectual, you look at this and you say there's literally 100 points where issues could occur, fraud could occur, or errors could occur. None of that's acceptable in a first-world country, especially as we sit here as the United States of America, uh, you know, we're supposed to be leaders in this World. We're supposed to be an exceptional nation. We're supposed to have American exceptionalism, yet our, um, you know, elections are the sloppiest, the messiest, the most open to these errors, inconsistencies, and I just don't think that's acceptable. And these issues are gonna keep happening, people are gonna get upset, and it just... this is a very destructive process. So, overall, that's my point, that this process has to be changed. There's no reason why we should have so many errors and such a problem

GIBSON

Another speaker? Come down, please.

DONNA WITTEMAN

My name is Donna Witteman, last name W-I-T-T-E-M-A-N. I've been a resident of this State since 1960. I'm ashamed of this way that this, this City, the State has become. It's a disgrace, definitely a disgrace. I was an early-voting worker. I saw many things that were wrong. People came in. Um, the screen on this one person went blank. They just said, "Well, that's okay." They called the lead; the lead didn't know anything. They didn't know what to do. They had to call... th- waited 15 or 20 minutes to call the Election Department to find out what to do. That- that's terrible. Also, another thing that people don't know is when they go to vote, they can change their party at the minute they vote. They don't have to wait for anything to come in the mail. You can change your party, right then and there. That is not told to these people. They don't tell them. I don't know whether they're told not to tell them or what. But you can change your party when you sit down at that pad and you want to change your vote. That is not being told. Also, people are not being told that they can opt out of the m- mail-in ballots. That needs to be told.

WITTEMAN So, there's a lot of questions going on that need to be answered. But I don't understand why that this department and you people don't put out this information, especially, that man sitting over there. He's the biggest crook there ever was.

UNIDENTIFIED Amen

WITTEMAN That's it.

GIBSON Let me ask you a question, ma'am.

WITTEMAN Yes.

GIBSON You, uh, you said the screen went blank and you waited 15 or 20 or 25 minutes to get an answer. Did you get an answer? Did you get resolution?

WITTEMAN No. No, they did not. They just told the lady that it's okay. They didn't... they didn't gi-... they didn't do nothing. The screen went blank. They said, "Don't worry about it."

GIBSON So, the lady waited-

WITTEMAN Nothing was done.

GIBSON ... the lady waited. You were told... did she-

WITTEMAN She... I was right there.

GIBSON So, she-

WITTEMAN I was standing right there.

GIBSON She voted.

WITTEMAN She voted.

GIBSON Okay.

WITTEMAN The screen went blank after she voted, and they, they didn't do nothing. They called the lead. The lead didn't know what to do. So they just let it go through.

GIBSON And I, I don't mean to belabor this, but the screen went blank. So, the screen we-... that went blank was the vote, the print vote that was being-

WITTEMAN No, the whole screen.

GIBSON The whole screen.

WITTEMAN The whole screen. So, she didn't... She wasn't able to go back and check to see that what she had voted for actually went through. And, and there wasn't even a printout on it.

GIBSON All right. Thank you.

WITTEMAN And that wasn't... That particular machine, which was on the right-hand side, the

WITTEMAN third machine did it more than once.

GIBSON Okay. Thank you.

WITTEMAN And they did not take that machine off. They just kept using it.

GIBSON Did you register a complaint with the, the lead person?

WITTEMAN They don't know anything. They didn't know anything. They were on the phone for an hour with one lady because they didn't know what to do. I mean this poor lady stood there and waited and waited and waited. I- I'm not even sure she even stayed to vote.

GIBSON Thank you.

WITTEMAN It was disgusting.

GIBSON Thank you.

WITTEMAN Thank you.

GIBSON Next speaker.

ALEXANDRIA SLACK Hi. Uh, my name is Alexandria, and my last name is Slack, S-L-A-C-K. Um, I, um, I do multiple things within this... within this election, and one of the things that I do is voter registration. Um, and, with that... I do that inside of our church, and so we make sure that all of our, um, church congregants are registered to vote. Um, a-and, you know, going through the process over the last couple months, one thing that we really press is to make sure that everybody is checking their voter registration, making sure that their voter registration is correct, whether it's their address or their party affiliation, whatever that may be, um, but to make sure that everybody has that chance to vote.

Um, coming up to election, when everybody started getting their ballots, uh, we did press forward the... um, the Ballot Preference Forms, um, and we had, uh, all of our church sign for the ballot-preference forms at which over 70% still ended up getting their ballots. Um, nobody knows why. Nobody knows where all those papers ended up going, um, that were turned in. I actually hand-delivered those, myself, to the election's office. Um, but nobody knows what happened to those... to those papers that were submitted.

Um, the other thing, though, that I wanted to talk about, um, in addition to the poll watching and all the fraud that everybody has kind of expressed is, um, something interesting that, that we experienced is that some of our congregants, um, were getting the Democrat, um, ballots, even though they were registered as a Republican. Um, so we would check their registration on the, um, s-... the Secretary of State's sites only to find out that wer-... they were actually registered as an Independent. So, as an Independent... registered as an Independent on the site, they still got a Democratic ballot, even though they were supposed to be Republicans. How that ended up happening, we don't know. Um, but that's something... like an anomaly as well. And that's happened to quite a few people.

Um, I want to ask that you guys' contest against this, uh, election. Mostly because, not everybody was able to vote. Uh, whether it was the efforts of stopping people

SLACK from being able to submit who they really wanted to vote for or stopping people's registrations altogether. All in all, it's not a fair vote when the citizens in Nevada are not able to accurately be counted for in that sense. So, thank you.

GIBSON Can you give us a name of a c... of maybe two people who received, um, a, a sample ballot or a ballot in the mail whose... who had... you had registered so that we could look at those documents. Can you provide that for us?

SLACK I can provide you that. However, I will save that for court. So, thank you.

GIBSON Okay. All right. Is there anyone else who wishes to speak?

DR. ROBERT BROWN Hi. My name is Doctor Robert Brown. I want to tell you my experience at the Department of Motor Vehicles two weeks before the election. I wanted to transfer a title on a car, and the DMV girl says, "I got your paperwork ready for you. You need to register." I said, "I'm already registered." Three minutes later she says, "I got the paper filled out. You need to register." I said, "What part of this conversation don't you understand." I've got my register receipt in my pocket. I pulled it out and showed her, and I says, "What is the problem?" She says, "Well, we're supposed to get everyone to re-register." I said, "Not today."

A few weeks later, I read in the paper there's over 44,000 questionable problems at DMV. Maybe we should look into that one, too. Thank you, sir.

GIBSON Okay. Anyone else?

TASHANA THAXTON Tashana Thaxton, last name, T-H-A-X-T-O-N. Somebody mentioned the poll-watcher observation areas, so I wanted to come up here and talk about that because I was a poll watcher, and that was one of my biggest complaints. Um, the law states that the designated area must allow for meaningful observation. At least polling location Town Square on June 7th, they had me confined to a chair next to an entrance where no meaningful observation could take place. If a voter had been flagged as already voted and needed a provisional ballot, I wouldn't know because I was confined to a chair by the entrance. If a voting machine were not working, I wouldn't know because I was stuck at the entrance. The only requirement is for workers and poll watchers to be located in such a way that ballot privacy is maintained, so poll watchers should be able to observe from behind the workers checking in voters so they can actually hear what is being said. And the poll workers had an aisle to walk down in between the voting machines that were facing out. Poll uh, workers could also walk in there to be able to observe, but we are not allowed to. And my question is, why? I'm just... It's like, we're being lied to and then we get mocked when we get upset about it. So, um, there is no transparency. There is the illusion of transparency. And then we point out how that's not true, we just get mocked and ridiculed for that. That needs to stop. Thank you.

GIBSON Thank you.

SANDIE HERNANDEZ Hi. My name is Sandie Hernandez, S-A-N-D-I-E H-E-R-N-A-N-D-E-Z. I am also a candidate for State Assembly District 10, and I will be going to the General. So, where do I start? Um, on Election Day I was standing in line to go vote and I noticed the sign where it says you can go in this line to vote or you can go over here to drop off your mail-in ballots. And I had some mail-in ballots that I was going to drop off as well as go vote. And I noticed this lady who was suddenly

HERNANDEZ

appearing to, uh, receive some ballots, and, uh, she was speaking harshly to the people as they went to go drop off their ballots. And she wouldn't let them drop off the ballots as there were two boxes. And I'm thinking to myself, "Why are there two boxes. Why isn't there just one box?" And she grabbed the ballots away from these people and say, "You can't put the bo... the ballots in the boxes." And she's... She was just, like...

So anyway, I, I said, "Why are you taking these, uh, bo... these ballots away from the people?" And she's like, "I'm checking the signatures." And afterwards... I'm going to tell you this really quick because I only have three minutes. She, she told me she's checking the signatures, and we already know she's not checking the signatures, because when you look on the ballots there's the little peaky hole that, and on my ballot, you can see it says, Republican. Why is there a hole on the ballot? Why is that hole there? It's a cheating hole. So, anyway. You've heard all the testimony from everybody here, and it's... you guys can't certify this election. You just can't. Do the right thing. And that's all I'm going to say.

GIBSON

Next speaker.

AUDREY MCCARTNEY

My name's Audrey McCartney, M-C-C-A-R-T-N-E-Y. As many times as I've been here, I am not a public speaker, but I did observe down at the counting facility and, I can attest to everyone, pretty much everything that they have said what had happened. Uh, when I first got there they said that all the areas were filled and people would need to be removed in order to have new people go in. So I feel we were being corralled um into a certain area. We never got to see the other areas that they said were full and other people never came out of those areas to have new people fill them in.

Another area that was kind of ridiculous to me was the signature verification, which there were two computers, two sets of people behind us that we weren't even able to see what they were doing and then there were groups of people up to the right-hand side. I, with a stopwatch, noticed that some people, you couldn't tell if they were rejecting them or approving them, and some of them were going 14 to 16 signatures in one minute where as another group of people, or two ladies, were taking up to a minute to just verify one. So, I just... I don't understand. These aren't signature experts. They might have gone through some training, but, listening to their discussions about, "Oh, do you see the loop of the P and the this and the that," and it was all about perspective and whether they agreed or not. And it wasn't... I don't know. I don't know what else to say. I'm just begging you guys, please do not certify this. There is no way that this was transparent at all. I beg you, please. Don't certify it. Do what's right.

KATRIN IVANOFF

Hi. I have a question because I'm not very familiar with all these rules. Uh, can I use my time for somebody else to talk?

GIBSON

No. Next speaker

UNIDENTIFIED

Say something. (inaudible)

IVANOFF

Okay. Katrin Ivanoff a.k.a. Misses Fixit, a.k.a. Pedo Killer. I was running for Assembly 42. I guess I'm still running for Assembly for- 42. In any event, uh, there are a lot of things that you know are wrong with the election in Nevada, the Primary in Nevada. And I want to ask you, do you guys have any kids or grandkids? Don't you want your grandkids to grow up in not a totalitarian country.

IVANOFF

America is the only country that is not either with a king or totalitarian or communism. This is the last place on earth that there is some kind of freedom and that's what we're trying to protect. You, you don't believe me? Can you mention another country that has the freedoms that we do? There is no other country, Mister Michael Naft, that has the freedoms that we do. And we are about to lose it. And if you have an-... You should be loyal to your kids. I don't know if you read The Constitution and not just read it but understand it. If you did, you would know those elections were absolute fraud because they shouldn't be recognizable from the outside which party the person is voting for. Because I heard from other people that they were actually including two different places, one for Republicans, one for all others, and we don't know if they just took these and threw it away.

So, i- it's not just the, the one thing. I'm sure... I just walked in, so I haven't heard the other people, but I'm sure you've heard a lot, and, uh, I just beg you to think of your kids and their future, and your grandkids, because I know you don't care about mine. Thank you.

JIM BUTLER

Jim Butler. Uh, Clark County Commission consists of Jones, Michael Naft, William McCurdy, and Tick Segerblom as, uh, the ultra-left wing black according to what I'm reading right here. I want to thank you for housing the homeless in your campaign signs, you know. I want to thank, uh, Joe Lombardo for being able to fail up. You know, October 1st, he's getting... now he's going to be Governor. That makes everybody feel mighty safe. Uh, this town sucks now. It really do-... it sucks now. I've been here 30 years. I know the old-school Vegas, and I know this s***, and I'm not very happy with yous. (crosstalk)

LORENA CARDENAS

Hello. My name is Lorena Car- Cardenas. I wasn't going to speak, but it's really hard to sit in the audience and see the same faces that are very stomach-turning to us because we've had such a bad experience, and the smirking, I mean, it's just... it's pretty disgusting to... this is the kind of reception we get from people we elected, we put up there to make decisions, and it's very disheartening. But we've come to a point now with the election that there is no election integrity. There really isn't. And my question is, how can you go wrong by asking for an audit of the election? At worst, the numbers would stay the same, but at... I mean... so we don't lose. Nobody loses in that. It's a win-win. You either restore election integrity, and that's all that you lost, right? Or we certify and find out something was wrong. So, I'm just saying, we should really try to, uh, do an audit of this election, and, uh, I think we all come out winning in that situation.

I also wanted to ask about the, the secret ballot NRSs. I'm not really familiar with that, but I did read that it wasn't supposed to contain the, uh... the precinct number, the, uh, voter information on the outside of the envelopes for everyone to see, and that these envelopes, when they were Republican, they were being placed somewhere else. So that was basically alerting the people that were receiving the ballots which party you were, uh, voting in. So that, itself, I mean, there should have been a secret ballot. It should have been kept private, and it wasn't. It... That is illegal. That process, uh, was illegal in this whole election. So just... one thing alone being illegal isn't enough to de-certify the election? And if it's not, why not? Shouldn't it be legal the whole way through in order for us to have integrity in our election process? Is it not worth it to you? Thank you.

GIBSON

Next speaker.

CLARK BOSSERT

Hi. My name is Clark Bossert, C-L-A-R-K B-O-S-S-E-R-T. And, obviously, you

BOSSERT

all have heard plenty of information, and it's my understanding that you all have received letters with evidence of everything that's been discussed here, so I don't need to berate that anymore. And I know that this is not fun. But what I want to say is that it's not too late to do the right thing. And whether, whether you... you know, from a Nonpartisan standpoint, do the right thing being there's plenty of evidence that there was big election irregular- irregularities, and I could go into my own testimony and my friends who received multiple ballots, ballots for people who didn't live at their addresses. I had multiple ballots with unique identifiers, and of course, it's illegal to cast more than one, so I didn't. But these are all things that you know that you're aware of, and so what I'm asking is, it's not too late to delay the certification or to call for some kind of, um, you know, paper ballot vote or something else. And so, I'm really encouraging you... It's not too late to do that, and we're all watching.

And so, you know, I... you read, like, New York Times, it says, "Democracy Dies in Darkness," and the Democrats say, "every vote counts." And that couldn't be further from the truth as far as how we feel as a community. It feels like none of the votes count and our democracy is dying in a lack of transparency. And so, this is super concerning, this is why we're here. I know this isn't fun to sit through, but the whole purpose of being a leader is that you lead at the hard moments, not the easy ones. Anyone can lead through an easy time. So, we're asking you. Whether it takes a 10-hour committee session to decide, "Hey, you know, we really ought to reconsider our commitment to certifying this election." Or whatever it is, we're just asking, would you please stand in the gap and, and do what's right? Because you know, you've had careers before this, you're going to have careers after, but this is a really pivotal moment. And you all are smart enough. You make plenty of smart decisions with whatever other careers you have. And I'm just asking you, no one in good faith can certify this election.

So, thank you very much for your consideration. And I'm not saying this, um, anticipating that you'll disregard it, I really honestly am saying, please consider delaying the certification. Uh, because, you know, the government has a relationship with the people that it governs and right now that is super fractured, and we can't go on for an indefinite period of time with this broken relationship. And there's a lot that you can do to make it better today. Thank you.

CHARLES ERNEST

My name is Charles Ernest. Last name is E-R-N-E-S-T. I came here today just to listen. I'm going to ask you guys each a question. From everything I've heard, there needs to be an investigation. Mister Naft, will you vote for an investigation?

GIBSON

Under our rules, we're not able to respond to you...

ERNEST

What?

GIBSON

... like that unless... No. That's the fact. We're not able-

CROWD

(crosstalk)

ERNEST

Are you kidding me?

GIBSON

... to respond. We can inquire. You'll see what happens at the end of the meeting when we take action. So that's what we can do. That's the rule. Do we like it all the time? No.

ERNEST Well, guess what? The rule needs to change. I'm sorry. This is a disgrace. (crosstalk)

GIBSON Is there anyone else who wishes to speak?

MELISSA CAMPION Hi. My name is Melissa Campion, C-A-M-P-I-O-N. I also have a... I wasn't planning on speaking. Um, I have a question, though. I live in Commission District F, and, uh, my Commissioner isn't here, so can you tell me where Justin Jones is? Is that a question you can answer?

CAMPION

GIBSON I... Oh... Here... The ones who are not here, the one who is not here is traveling. He's not able to be here today. Okay?

CAMPION Okay-

GIBSON Yes, ma'am.

CAMPION ... so will he get...

GIBSON He, he w-...

CAMPION So, he won't get a vote in this because-

GIBSON He will not be-

CAMPION This isn't something...

GIBSON ... voting today.

CAMPION Okay. Um, okay. And I just, to reiterate what everyone else said, um, my husband actually ran for the Commission. Um, really, really disappointed in the things we saw, in the, um... ju- just the... There is no election integrity. Um, I, personally... When I went in to vote, um, they asked for... I... I was going into my purse to get my I.D., "Oh, no, no, no, no. We don't need that." Okay. Great. So, then they said, um, "You know, can you sign the little forms..." or, "Sign the key pa-..." Uh, whatever, the little pad, and I did. But I signed M. Campion, because that's how I sign quickly. Well, I saw it popped up, Melissa Campion, my full name, and I was like, "Oh, do you want me to sign my full name?" They're like, "Eh, no. Don't worry about it. No big deal." So, I know it didn't match. I didn't sign the same name, even. They didn't make me resign.

So tha... I mean, they didn't verify my signature, they didn't verif- my... verify my ID, which I knew they didn't need that. Um, and then they, again, called out, you know, "Republican voter." Yeah, sure. And directed me to a, a machine. So, it's just... i-... there's just too many things that were not, um, not normal, right, that I think it does, um, justify an investigation. So, that's what we ask of you guys. To not certify the election but to just look further, um, in all of the things that just don't make sense.

GIBSON Thank you.

CAMPION Thank you.

GIBSON Next speaker. The p-... The public comment period is closed.

ITEM NO. 2 Approval of Agenda (For possible action)

GIBSON We'll proceed then to the next item which is the approval of the agenda. I will entertain a motion on the agenda.

MICHAEL NAFT Move approval.

GIBSON There's a motion to approve the agenda. Any discussion on the motion? Please cast your votes.

WILLIAM MCCURDY II Aye.

GIBSON Motion carries. And that's Commissioner McCurdy who had to step out but is still on the, uh... uh, still in the meeting by phone. The next item, Miss King.

ITEM NO. 3 Receive a report from the Registrar of Voters; canvass the returns of the Primary Election held on June 14, 2022; and direct the Registrar to submit a copy of the abstract of votes cast to the Nevada Secretary of State within in ten (10) days after the election. (For possible action)

YOLANDA KING Item Number 3 under your business section of the agenda is to receive a report from the Registrar of Voters, to canvass the returns of the Primary Election held on June 14, 2022 and direct the Registrar to submit a copy of the abstract votes cast in the Nevada, cast to the Nevada Secretary of State within 10 days after the election.

GIBSON Thank you. Mister Gloria.

JOE GLORIA Good afternoon, Commissioners. For the record, Joe Gloria, Registrar of Voters, Clark County. I'm here today to present the Canvass Report. I want to note that in the packets I provided there's some information in there related to The Canvass Letter that I will eventually read into the record. There's an Official Summary Results Report, also, certification paperwork that lets you view exactly what we do to statutorily certify the system and the accuracy of the tabulation and also mo-... some election stats. And the election stats are provided simply for you to see that the mail ballot turnout is definitely starting to show a consistent trend. Um, the majority of voters are voting by mail and so we need to make sure and keep that in mind in future elections. At some point, we may need to think about, uh, decreasing the number of in-person locations so that we can balance staff and-

GLORIA And the reason that we'd want to shift that staff, s-... ch-... we can sip... ship more, uh, resources to the mail-ballot process. I've also-

AUDIENCE No! (inaudible) (crosstalk)

GIBSON Okay, so here's, here's the thing-

GLORIA

I've also provided you an election in-

GIBSON

S- so... Excuse me, Joe

GLORIA

... in one of the vote (inaudible)

GIBSON

Just... Mister Gloria, just a minute. So, we got to be able to hear this, right? I mean, it's got to be on the record. There are two ways to do that. (crosstalk) No, there are two ways to do that. The best way is that all of us stay here in the room, and we listen to the report. You had opportunity to make public... public comment. There will be another public comment period. You are going to have plenty of opportunity to voice your concerns. But we've got to be able to hear what this report is. And there are some things that will be in this report have... that have not been submitted in writing to us. We need to be able to hear those things, too. So, please. Mister Gloria.

GLORIA

Thank you, Mister Chair. Uh, as I start off, I... as I always mention in the canvass report, it's a community event. When we put on an election it takes help from the citizens as well as many people internally and externally from the county. Uh, support from the County Commission and County Management put us in a place to succeed. The new poll book implementation was a great success. Working with the new vendor, KNOWiNK, has given us a capability to report much more accurately and give us more tools, uh, to identify the discrepancies that we see in our reports. New work areas and additional facility allowed us to process mail in one location, which was a great improvement for us. We want to thank RPM for all of the work that they put into it. Uh, there were a lot of delays in getting the equipment that they needed to get us what we needed in order to set up in the new location across the street and also to set up the new layout so that we could provide more opportunity for observers to monitor tabulation in our mail ballot processes.

County staff to thank, other than the Commission and County Management, I would be doing a discredit if I didn't mention all the people that help us, uh, to put the election on. Bob Leek and his staff. The IT s-... that we ser-... received was, um, excellent. Uh, the support staff that they gave us and the additional staff that they provided to make sure that we were able to properly test our new poll book and get that rolled out for the Primary Election was, was excellent support from Bob Leek and his staff.

Also, a note to... on Don... Dan Walker and his cyber team who also con-... put in a great effort to make sure that all of our information was safe. Dave Johnson and the Automotive Staff, D.A. Lisa Logsdon who was new in elections but did an, an excellent job in support. Thank you, Lisa, for your work. P.I.O. Rep, Dan Kulin, who was pretty much by my side throughout the voting process to assist with many different things that we had occur during the course of the day. And then also a special thanks to the Clerks from Las Vegas and Henderson. They provided resources and actually put them in the field for the County. The Clerks actually went out and some of their staff to admin rover and many locations during several days of the early voting period and on election day. So, we gi-... we give them credit for going above and beyond in doing that for us.

County Payroll, H.R., and Purchasing, Training and Recruiting, Darise Hoffman-Curry and her staff had a lot of work, and a-... There were a lot of deadlines that, uh, we had to meet there because they had to create new documentation for the poll book which was completely different from what we were previously using.

GLORIA Over 3400 poll workers were trained. Mail-in registration staff, Kathy Smith, and, of course, the mail ballot process folks who worked very hard in the off season to implement the use of new equipment that gave us the capacity to read a much larger number of, uh, ballots more efficiently. Warehouse, Jeff Martin, who takes care of the voting machines and ensures that they're properly programmed, and all of the logistical support. Our new IT Manager, Noemi Esparza, had a lot to learn and came on late in the election cycle, but did an excellent job. And of course, my Admin and Assistant ROV Lorena Portillo and Julie Barker who do a tremendous amount of work in supporting the election.

I want to talk a little bit about the certification and the audits. We are statutorily required to put an Accuracy Certification Board together. Four of those members were members of the City Clerks that we're supporting. Keep in mind, I mentioned before, but we are supporting all the Municipal Elections on our cycle now. So, Mesquite, Boulder City, North Las Vegas, Las Vegas, and Henderson are all now on our ballots. Four of those staff members were on the Accuracy Certification Board and we had one member from the Democratic Party and one from the Republican Party. Everything went off without an- anything to report, and you can review the reports that I have in your folder if you want more information. Of course, the hash code audit was run, the VV pat audit that's also statutorily required and the audit of the Mail Ballot Processing Unit.

GIBSON Who were the members of the um, the Accuracy Certification Board? Can you list those for us?

GLORIA Actually, they're in your packet, Commissioner. I don't ha-

GIBSON But I want... uh, do you have that in front of you? I can read the names. Lisa Mayo-DeRiso.

GLORIA That's correct.

GIBSON ... Stacy Campbell, April Parra, Jeff Smith, Tammy McKay, Jackie Rogers. Were there others?

GLORIA That was it. Six members.

GIBSON Okay.

UNIDENTIFIED Yeah, but we all know a Republican (inaudible)

GIBSON Just y-you had your opportunity. Go ahead, Mister Gloria.

GLORIA With that Miser Chairman, I'm gonna go ahead and read the, uh, canvass, uh, report into the record. The results of the June 14, 2022, Primary Election were canvass comparing the computer printouts of ballots counted and the results thereof with the official ballot statement for each of the 913 precincts utilized in this election. There were 190 irreconcilable errors in the 288,683 ballots cast in the 227 precincts. 67 were in the mail. Mail returns caused by voters who voted their initial ballot, then updated their voter registration prior to the May 31st deadline. 88 extra votes were cast, 40 during early voting and 48 on Election Day. 35 voters voted in the wrong precinct during the early voting period. However, there were no tabulation errors in the precincts and the foregoing irreconcilable discrepancies would not alter the outcomes of any race in this primary election. (crosstalk) 1,706 provisional ballots were cast during the election. 1,594 were verified and counted.

GLORIA 73 were rejected because the voters were not registered to vote. 25 were rejected because the voter did not provide adequate proof of residence or identification.

AUDIENCE (crosstalk)

GLORIA One voter voted in the wrong district or precinct, and 13 were rejected due to our inability to confirm residence at a non-business address.

Audits were performed according to 293B on the hash quote of our ICX voting machines and the VV pat rolls for 2% of all machines used in the election. No pre-no discrepancies were identified. The Accuracy Certification Board also certified the functionality of our tabulation system to include our mail ballot readers, ICX voting machines, Agilis Mail Ballot Processing Machine, and tabulation system.

All systems were found to be 100% accurate in the tabulation of votes and processing of mail ballots. The tests were performed before the start of early voting the day before election day and a post-election test the day after the election. There were no tabulation errors in the 913 precincts. Therefore, as the duly appointed (crosstalk) registrar of voters of Clark County, Nevada, I do hereby certify to the Clark County Board of Commissioners, that the results of the canvass of this election are deemed certifiable.

AUDIENCE (crosstalk)(inaudible)

GLORIA M- Mister Chairman, before we, uh, began the meeting, I wanna go ahead and clarify exactly what you were, uh, asking me on election night when we first released. We had a report that went out on our Election Night Reporting all of the data that was there for the, uh, contest that were voted during early voting and the mail that we had read that far was accurate. However, our turnout was incorrect on the software that we used to put out that election night report. We spent the rest of the evening until the final report trying to get that, uh, fixed in the software, however we were unable to do so. So, we went to our redundant system and put out the final unofficial results that night on our old ENR system, and all of that information was accurate and correct.

UNIDENTIFIED Great. They weren't (inaudible)

GIBSON All right.

GLORIA That's all that I have, Mister Chairman. If you have any questions, I'll be happy to answer them.

GIBSON Uh, uh, a couple of things. Um, have, if you received affidavits from these people who have, uh, come forward to speak today, uh, offering their observations of irregularities, do you have affidavits of this?

GLORIA Yes, we do. We have EIVR reports that I've reviewed with the Secretary of State. Uh, many of these were not actually given directly to our department that were submitted to the Secretary who, he and I reviewed them together. Um-

UNIDENTIFIED How did you certify it? (inaudible)

AUDIENCE (crosstalk)

GIBSON Okay. And they, they were all, were all of the irregularity, excuse me, the irregularities, um, discussed and reviewed?

UNIDENTIFIED They've ignored them. They ignore them. Wait

GLORIA Yes, they were.

GIBSON Okay. What about evidence of, uh, the multiple ballots that were sent out and things like that. Have you received evidence of such things?

GLORIA Any ballots that are returned to our office other than the Post Office returning undeliverable ballots are immediately looked into in the Voter Registration System to determine whether or not, um, that's a ballot that we should be removing from the system or a voter who is no longer living at the address. And then we have Federal requirements through the NVRA on what we need to do with those.

So, we have to send a notice to that voter and give them 30 days to respond after which we can inactivate them. But everything that's returned to our office is researched. And we do look into the system to see what the issue is.

GIBSON And, and were all of your actions compliant with the requirements of the State, which are well beyond our control. Were those, were all of the rules and regulations, um, followed in terms of the-

GLORIA The State and Federal guidelines.

GIBSON ... state... Yeah, the State and Federal guidelines.

AUDIENCE (crosstalk)

GLORIA That is correct Mister Chairman. They were.

GIBSON Thank you. All right. Thank you very much. Any, are there questions of Members of the Board? Do you have questions of Mister Gloria? (crosstalk) That's enough, please. That's enough. We've heard you. We, we heard you before, we hear you now. It's not, it's not your turn now. You get another, you're gonna get another turn in a few minutes, but it's not your turn now.

AUDIENCE (inaudible)

GIBSON Did, do any of you have questions of Mister Gloria?

NAFT Mister Chairman, if there are no further questions, I move for approval of Item Three.

AUDIENCE (crosstalk)

GIBSON Okay. So, there's, there's a motion to certify the election. And let me just look at the action. So, we've accepted the canvass. Do we, do we, is our action an actual canvass, or is our action a certification, Mister Gloria?

GLORIA Mister Chairman, I believe that your action should be to certify and instruct me to send to the Secretary of State.

UNIDENTIFIED No.

GIBSON So there, your motion then is to certify.

NAFT Yes.

GIBSON Any, any, is there any discussion on that motion?

UNIDENTIFIED Yes. (inaudible)

GIBSON Please, please cast your votes. Please cast your votes.

MCCURDY Aye.

AUDIENCE (inaudible) (crosstalk)

GIBSON Any, uh, have you, are, there are questions that the vote is in, and the vote is unanimous. The election is certified.

UNIDENTIFIED boo, unreal, unreal, unreal (crosstalk)

GLORIA Thank you, Commissioners.

ACTION: It was moved by Commissioner Michael Naft, and carried by the following vote, that the Board certify the election results and direct the Registrar to submit a copy of the abstract of votes cast to the Nevada Secretary of State.

PUBLIC COMMENTS

GIBSON So, the next item of business is -

AUDIENCE (crosstalk) (inaudible)

MARILYN KIRKPATRICK I'm just gonna get a water. (inaudible)

GIBSON We'll be in, we'll be in recess for 10 minutes. This meeting will be in recess for 10 minutes.

The meeting went into recess at 3:22 p.m. and reconvened at 3:34 p.m.

GIBSON We're back in session in our meeting. This is the final period for public comment. Our rules require that, uh, that we allow up to three minutes per person. We're going to, uh, allow up to one minute per person. We invite you to come forward. And, uh, the first person looks like you're ready, sir. So, move. Come on, come on in.

MCGRAW Once again. Good afternoon. I just have one question.

GIBSON So, here's, here's the thing because of the way our, we keep this record, we need

GIBSON everyone to give us their name. Spell their last name again. I'm sorry for that-

MCGRAW My name is, uh, Shawn McGraw, M-C-G-R-A-W. Okay. I just wanna ask one question. Have any of you or you two ever served your nation in any way? Military, public service, police officer, anything like that? North or south yet? East. West? No. All right, because if you did, Hey gentlemen, how you doing? Hey. Okay. Um, because if you did, you would stand up and defend the Constitution of the United States against all enemies, both foreign and domestic. You, all you up here. I am a disabled veteran. Okay. I sacrificed my body. I bled for my country and now I'm standing up here along with all my patriots here, fellow veterans demanding that you stand up for the Constitution because this right here is an outrage and I've never, ever been involved in politics before or anything.

GIBSON Thank you. And thank you for your service.

AUDIENCE (crosstalk)

GIBSON Next speaker.

KEENAN Socorro Keenan, S-O-C-O-R-R-O. Last name K-E-E-N-A-N. I'm very disappointed in all of you and I'm sure every, I know God is. I'm very, very, very disappointed. You know, we always give you don't deserve any credit. You don't give us any credit. If you don't care about us, why should we care about you? Um, just remember that. Remember we all, you, you wouldn't be able to take what you dished out today. I promise you that, but you know what? You can still do a 180 right now. If you wanted to, you're afraid. You're so afraid. All of you, you don't want it. You don't wanna look any of us in the eye. And we will be crossing visions here and there. And we do know each other. We will be meeting each other somewhere somehow, but you don't understand that you really disappointed everybody who has their eyes and looked up to you. I knew your mother Tick. She's a great woman, wonderful woman, but what happened?

AUDIENCE (laughs)

KEENAN You know, I know you too, Ross, since you were a kid. Now, the thing is we have to start looking and Marilyn you've been lacking all the way through the whole thing.

GIBSON Thank you, ma'am thank you.

SUSAN PROFFITT Susan Proffitt, P-R-O-F-F-I-T-T. I just wanna make two comments. First of all, your Constituents could save a whole lot of tax dollars. If you would just roll back and stop having this kind of an election process. Go back to the one day, all paper. And there will be no more shenanigans on the machines. We've got proof of it. It's going to court, right? Okay. The other thing I'd like to point out, because somebody that was listening on TV wanted to point out the fact that how could they a certify this? When they haven't even contacted me? They told me they were gonna get back in touch with me two weeks ago. They have not gotten in touch with me. They made me vote at a certain machine. I was the only person who came in the, the tent in Silverado. Okay. And she said they made her vote at a specific machine, and she didn't wanna vote at that machine. This was an incident report. You guys really need to read these incident reports.

GIBSON Thank you. That item was covered in the report. Yes.

IVANOFF Katrin Ivanoff, I-V-A-N-O-F-F again, uh, I just wanna tell, I'm not talking to you cause you guys are not listening, but I'm talking to the people that are listening on internet, on TV, whatever you guys are listening. Those two Democrats that are running for Governor are now the only choices. Brandon Davis libertarian is also running against them. If everybody that voted for Joey Gilbert vote for him, we have a chance to put a decent person in the governorship. Also, please vote for Sigal Chattah, and also for Jim Marchant and look at for Libertarians on the ballot, vote all the Libertarians in, vote all the Republicans in and vote. Everybody that hasn't been in office in. Everybody that has been in office needs to be out of the office regardless of their party affiliation. Thank you.

GIBSON Next.

UNIDENTIFIED (inaudible) I'm thinking about, I'm thinking about it.

BENNETTS Pam Bennetts Well, congratulations. We now have “nevadafornia” Woohoo. It's awesome. I really just, I, I, I look at all of you. I looked at you back there. You laughing all the time. You laughing, you laugh, you think it's funny too. I'll give Gibson credit. He didn't laugh. He just looks at me or looks at everybody. It is disgusting. 2000 Mules came out. I don't know who has the proof. Well, I kind of know who has the proof, but I'm not gonna tell y'all 'cause it doesn't matter anyway. It's coming out and you guys are gonna look so bad. Just like when we told you the COVID vaccine was bad. A thousand athletes have died, and you all sat there and thought it was funny, before. Now, How's it looking? Not so good for y'all the Pfizer documents came out. How's that looking for you now? 6 months later, not so good either, but y'all sit there and you just certified. What you know is fraud.

UNIDENTIFIED That's right. (crosstalk)

BENNETTS And we don't even have to guess because we have the proof this time, we weren't stupid. We, we've got the proof.

UNIDENTIFIED We've got the proof.

GIBSON Thank you. Next person.

DAVIS Mary Ellen Davis, D-A-V-I-S. I was there. I got videos. I got a video of a vehicle backing into the warehouse and dropping off boxes and boxes, brown boxes, just cardboard boxes. And I have the video. The guy said, this is the last batch. As he drove away in an SUV that had out of state license plates. What was he delivering? What was he dropping off? Because it wasn't ballots. It wasn't the ballots that they brought into the box into the election headquarters. What was it? I got video. I got, I got proof. I got proof, brother. I hope you pay. 'Cause God's watching you.

UNIDENTIFIED He doesn't care. He's God-

GIBSON And you submitted that proof to whom?

DAVIS I gave to her.

GIBSON No, I mean before today,

AUDIENCE (crosstalk)

GIBSON Be quiet please. Who...

DAVIS Susan -

GIBSON Before today, who did you submit it to?

DAVIS I gave it to Susan Proffitt.

GIBSON Today?

DAVIS Just now.

GIBSON Okay, Next speaker, please.

CARDENAS My name Lorena Cardenas uh, this is towards, uh, Joe Gloria's comment of asking for more, uh, for less in person uh, voting. Uh, it isn't it, his job to make sure the election process is as accurate as possible. If mail-in voting leaves a bigger opportunity to cheat than in person, why would he ask for less of that? Why would he ask for less in person? If he's not directly asking for more fraud, he's literally, he was standing here asking for more fraud because that's the M.O. This is how you guys all plan to stay in power. You're gonna cheat. You're full of fraud. You and you know this, the people out here, Vegas, nobody likes you. Nobody likes you. We can't stomach you. You know, the only way to stay in power is by cheating, but we're gonna fix that somehow. We're gonna get rid of you somehow. We're gonna fix this whole voting election process that has been so rigged. It's disgusting to us. What you've done, especially to our kids. All these kids are suffering cause of her stupid decisions.

GIBSON Next speaker, please.

CARDENAS Ya gonna pay for that somehow.

AUDIENCE (crosstalk)

JOHN CARLO Hey guys. Uh, how much time do I have?

GIBSON You have one minute and you-

CARLO All right, well here's the thing. Well-

GIBSON We need both. We need your first and last name. Spell your last name.

CARLO John Carlo, C-A-R-L-O. You're looking at someone who was, uh, just running for office. And let me just tell you, we are being very nice to you guys. What you don't want is another January the 6th. That's what you don't want. And we are being so kind to you guys, but Mister Gibson, you're probably gonna see me at your house again. Miss Kirkpatrick, we've already been to your house. Mister Tick, we've already been to your house. Miss Ross Miller, your house might be next. Michael Neff, guys we, we're not gonna stop until we get an election. What have I told you? Mister Gibson, I want an, an audit and you ignore me. That's why you're not gonna get my vote. But we are being so kind to you guys, and we are so kind. An unjust balance is an abomination unto the Lord, Proverbs 11, Verse One. You guys are godless, you are merciless, and you know what? The wrath of God abides upon you. You need to repent, and you need Jesus Christ.

AUDIENCE Amen.

GIBSON Next speaker, next speaker.

MILLER So, I, I just wanted to address what, uh, what happened with, uh, Mister Joe, Gloria? I mean he came, Vem Miller. I apologize. V-E-M Miller. So, I'm talking purely evidentiary basis on, on, on, uh, doing proper investigations. This gentleman just came up here and said that the, I guess, extra ballots, some people returned them. And based upon that, that's enough evidence to show that there was nothing wrong that happened. If you guys are serious about really canvassing and finding out if there was issues, you would actually canvass, you would call people. You would find out how many extra ballots they had because this idea of individuals policing themselves and returning ballots to the, to the Election Commission is preposterous because that's just not a realistic- that's not how things happen in terms of extra ballots. And I think if you guys were really serious, you would start canvassing. You would find out how many people got extra ballots. That's what a diligent investigation would do. But I rec also recognize that that's clearly not the intention of this Board. And that's really sad because we're presid- we're literally presiding over the destruction of this Country. And it's very sad because this Country was founded on courageous individuals and I, and I'm sad to say, that's not what I'm seeing in front of me right now.

GIBSON Next speaker.

MYRON HUGHES Gentlemen, my name is Myron Hughes. I was born and raised in Nevada. Lived in Mesquite my whole life. But, but I raised my family in Las Vegas. Now this election, I can't say anything about. Last election, I received personally 3 mail-in ballots plus I was registered in Las Vegas. I received 2 mail-in ballots in Mesquite because I own property there and a mail-in ballot in Las Vegas because I own home here. And I was registered here. Because I'm an honest man, I tore those mail-in ballots up and threw them away. Came down and voted where I'm register, registered to vote. Now this year, it happened that I had to renew my driver's license this year. And the Motor Vehicle Department changed my registration against my will. And I did not receive a sample ballot from the Las Vegas area where I was registered to vote. And I did receive one in one of the places, Mesquite.

GIBSON Thank you.

HUGHES I like to ask a question before we (inaudible)

UNIDENTIFIED Let him speak. (crosstalk)

GIBSON Just, just a minute, We'll turn on the microphone. So, you can ask your question. Go ahead.

UNIDENTIFIED Thank you.

HUGHES Who made the Motor Vehicle Department, the Registrar of Voters and made it possible to register the very day you vote? Cause that creates vote fraud.

GIBSON The Nevada State Legislature and the Governor. Next speaker.

AUDIENCE (crosstalk)

GIBSON Next speaker.

BRIAN DAVIS Brian Davis, D-A-V-I-S. I believe that was, uh, back in, uh, 2002, right to uh, American Voters Act or something like that. That's why we, uh, put that in the DMV for registering voters there. Um, so courage. Courage is why we fought in World War II. Why we defeated the Nazis. It's why we do what we do. And we fight for election integrity. It's why we're all here. We have courage to pursue the right thing. The truth of the matter. If you don't have courage, you may be labeled a coward. If you're labeled a coward and you go down that road and that's what God calls you, those are the people that get thrown into the pit. The people that take the mark and the cowards. Don't be a coward. Be courageous. Don't be fearful. Shine the light of truth. If you think that there's something wrong, if you think that there's something not right, take the difficult road. Be courageous. Don't be a coward.

GIBSON Next speaker.

ROBINSON Mindy Robinson, M-I-N-D-R-O-B-N-S-O-N. You just heard from an entire room of people about how invalid this election was. How the, they were announced that the Republicans sent to different boxes. How nothing mad, how all these mail-in. You just heard all this fraud, undeniable completely illegal election. And then the guy we think that did everything that rigged it stands up and said, no, I'm, I'm fine. Everything's good. Everything's kosher. And you're like, okay. And without discussion, you certified it. And then you laughed at us as a room of your own constituents got angry about it. Wow. So, you know, we've been catching testimony the whole time from people so that we can sue you just so you know, and we weren't just imagining fraud. We have video, we have pictures. We have testimony from poll watchers. So, enjoy getting dragged thru the media for the scumbags you are.

GIBSON Next speaker, next speaker.

UNIDENTIFIED You're going down.

ST JOHN Oh my God. Carolyn St. John S-T space J-O-H-N. (laughs)

AUDIENCE (laughs)

ST JOHN That was great. Yeah. And all the money that you got to do this that you think is gonna be like your little nest egg. We're gonna take it.

UNIDENTIFIED Yep. Yeah. (crosstalk)

ST JOHN In court. How about that? And you think you're so smart. You are like the epitome of cowardly, you're liars. How do you even look your children in the face? If you have any, you probably have great-great-great-grandchildren. How do you look him in the face? And you're young. You have to go through a life. No. You know, with everybody knowing what you did to the citizens of Nevada for money, you had to do it for money. 'Cause what else, what else would you profit by. Certifying it from this guy who lied. You know, every it's like we know hello and more and more people are waking up every day. So, if you think you're going to have a nice life after this, you're not, eventually it's going to catch you.

GIBSON Next speaker. (crosstalk)

SLACK Hi, Alexandria Slack, last name S-L-A-C-K. And this is my first time being in any sort of politics or the first time doing something like this. So I just have to kind of ask, um, because I'm not really sure what just happened after hearing Joe Lagoria or Joe Gloria, and then you guys kind of came to a decision and I'm not really sure how that happened. And I was wondering if you can help explain that. And I'm being completely honest because I've never done this before. And that would just kind of, I'm not sure what just happened.

UNIDENTIFIED They voted yesterday. Tell us.

SLACK No, or yes.

UNIDENTIFIED Tell us, tell us how it happened. They don't care.

SLACK Okay, okay, but really can I just have like, I'm just generally have no idea what just happened and I'm just asking for clarification without them behind me.

UNIDENTIFIED They won't tell you. They won't tell you.

GIBSON Well, the, the, really what happened here is we have received reports. We have received hundreds of emails and letters. All of us have received the same kinds of things that you're talking about. And from people who share a completely different view from you. We have heard, (crosstalk) we've re-, we've heard the things you had to say here today. Mister Gloria made a report. We had received a bunch of data that is behind the stuff that he, he reported upon. I mentioned a moment ago that one of the, one of the irregularities was in fact, a part of the report that was submitted. It was a, it was a part of, it was a part of the report that was submitted that Mister Gloria just reported on. Nothing, nothing from that, that particular, uh, vote that we just heard about the woman who, who is waiting to hear from the Election Department in that particular ballot, it did not affect the outcome.

It wouldn't have mattered how she voted. It would not have affected the outcome. We heard that report from Mister Gloria. (crosstalk) We have now heard the report. We've heard your testimony. We've reviewed everything we've received. We've even been com- we've even been in communication with and tried to respond to media reports about all of this. And we took action. And our action is final with, with respect to the Certification. If you all have evidence that you have, or have not submitted to a court, you have every right to do that. And some judge will determine what if anything to do after that. But our action is the final action on the Certification of the Election. Next speaker.

SLACK Thank you.

UNIDENTIFIED (inaudible) you already submitted an affidavit. (inaudible)

MICHAEL HUTCHINGS Michael Hutchings. H-U-T-C-H-I-N-G-S. You guys can't certify this election. If you have any question of anything, one little bit, you guys need to stop, redo it. 200 grand to do it. Whoopee we pay that every day. We pay you guys. You work for us. We're asking you to do a job. You're telling us no. Flip it around, make the right decision. We could be wrong. If we're wrong, we do the audit. We go away. Happy. If we're, if we're right, we're saving America.

UNIDENTIFIED They don't wanna save America.

HUTCHINGS If you don't wanna save America, go to f***** planet zero.

AUDIENCE (laughs)(inaudible)

GIBSON Next speaker.

WITTEMAN My name is Donna Witteman, W-I-

GIBSON Pull the microphone to your mouth if you would please. Thank you.

WITTEMAN Sorry. My name is Donna Witteman. And um, like I said before, I was a early voting worker. And I took the training. The training was really a joke. They mostly taught us how to wipe down everything. Um, they really didn't teach us anything. They didn't teach us nobody how to work on the pads. No, we didn't have a monitor to look at. We didn't have a ballot to look at. They didn't tell us that you could change your party. If you were, if you were a Independent, you could change your Democrat or Republican. They didn't tell us that. It was, it was a joke. There really needs to be something done about the way that the training is done. So, the people who are working know how to do it and know how to answer questions because they're leaders did not even know, which is pretty sad. Makes us look like real fools. Thank you.

GIBSON Next speaker.

FRANK KELLY Good afternoon. My name is Frank Kelly, K-E-L-L-Y. I'm a retired military officer and like the rest of my, uh, comrades in the room, I bled for this Country. I created a situation so that we could be in today. I've been sitting back listening and trying to analyze what's going on and I don't have access to the data that you reviewed. I have no idea how much, how little and how dep-, how much in depth you looked at things. So, we have to accept the fact that you, what you've said is correct. I, uh, I doubt seriously that this has been looked at in the depth that's required. But I think in the next step, when it goes to court, that probably people will look at it more, uh, closely, and that actions have consequences. And perhaps some people will go to jail over this. I don't know, but one way or the other, I hope we can get to the truth for all of our sakes, because frankly I'm not feeling good about what's going on. And I'm very disappointed that, uh, that I have this feeling. But I want America to be America like I grew up in, like I fought for. And like I was a Commanding Officer in the Air Force for, so thank you.

BARRELLO Hello. C-H-R-I-S-T-I-N-E-B-A-R-R-E-L-L-O. I'm sorry, Mister Gloria. I have to disagree. Things are not perfect, anything in life. And, um, that's why it's hard for everybody to understand the quick vote. Um, that's why, if there's an imperfection, look it over, fix it. I mean, like I said before, it could happen to you guys too. And if the tables were turned, um, everybody would be, you know, wanting an equal and fair election. I know two or three are on the ballot, so I don't know how it doesn't make sense to me, how it's fair for you guys to vote, but I'm learning. I'm new to politics, but I think nothing is perfect and we are not working together to fix it at all. It's just so divided and I think that's what they want. So, if there's a medium to work together to fix this, um, let's start to fix our State, our County, our Cities. We have to work together. This isn't working. Thank you.

SEIP Walter Siep, S-E-I-P. um, I'm kind of excited about today. I didn't think there were any people ever here interested in election integrity. Uh, I think you got a broken system that's working. You heard about it in 2020, and you've heard about it here.

SEIP Are we gonna hear about this in November? Same thing? I hope you do something about that reviews. I do agree with Mister Gloria about one thing, 125 voting locations are too damn many.

GIBSON Next speaker. Then the public comment period is closed, and this meeting is adjourned.

There being no further business to come before the Board at this time, at the hour of 4:01 p.m., the meeting was adjourned.
