Call to Order

1. Receive staff presentation and discuss items on the TUESDAY, SEPTEMBER 20, 2022 agenda.

At 6:00 p.m., Sami Real, Planning Manager presented items on the September 20, 2022 agenda. Commissioner Vivian Kilarski stated that item #6 (UC-22-0386) would be pulled off consent and heard separately.

2. Discuss new or upcoming ordinances.

Sami Real, Planning Manager, explained that the Board of County Commissioners (BCC) had a discussion today, Tuesday, September 20, 2022 related to cannabis lounges. Current Planning was directed to prepare an ordinance to allow cannabis lounges (consumption lounges) to include separations that differ from the state and allows waivers to allow reductions and separations that meet state requirements, which will allow for outside consumption with a special use permit and other provisions. This upcoming ordinance will be for review at the last meeting in October. Commissioner Vivian Kilarski asked if the Planning Commission would start to see cannabis lounge type applications. Sami Real, explained that there was no recommendation change to the final decision body and that these items will continue to go to the BCC meetings.

Sami Real, Planning Manager, explained that a previously adopted ordinance that eliminates the nonconforming zone boundary amendment process goes into effect on Thursday, September 22, 2022 and will be put into effect for future plan amendments with conforming zone changes instead of nonconforming zone changes.

3. Discuss administrative items.
